The third annual National Tax Protest Day is being jointly sponsored by the Society for Individual Liberty, the Libertarian Party, and the National Taxpayers Union.

As SIL states: "The average American is fed up with taxes and politicians. On top of Watergate, unemployment, the energy crisis, and the CIA revelations, he now learns that while the cost of living went up 12% in 1974, the increase in all taxes was twice that! It is up to LIBERTARIANS to direct this ill will towards the IRS and the State."

Come to Washington's Headquarters on April 12th! We already have 1000 "Taxation is Theft" leaflets from SIL to distribute. Bring signs! Some suggestions: "DOWN WITH TAXES", "CUT STATE SPENDING", "ROLL BACK TAXES", "LESS GOVERNMENT, LESS TAXES". You get the idea! Be creative, do your own thing! Bring an original!

Don't forget to write anti-tax letters to your local newspapers and to your Congressmen and State legislators. Down with taxes! One Percent for Freedom!

April 12th has been designated as National Tax Protest Day. Throughout the United States, groups of people will be turning out in protest of the confiscatory taxing policies of the Federal Government. Several demonstrations have been planned, with many of them scheduled to be held at IRS headquarters.

In keeping with the Spirit of the Day, and in recognition of our particular situation here in the State of New Jersey, the NJLP will sponsor a demonstration to protest the proposed State Income Tax. This theme has been chosen in order to attract the various local and state taxpayers' groups in the state, in the hope that they will recognize our oneness of purpose on this issue. Approximately thirty such groups have been contacted and advised of the nature of the program, its scope, and thrust.

Basically, we are relying on the initiative of our members and those in the taxpayers groups to form the base of the demonstration, along with a heavy bombardment of the press announcing the demonstration. Hopefully, this bombardment will net us the proper media coverage and also encourage non-members to attend as well. For NJLP members, the following actions are strongly urged:

- 1. Write letters to the editor and press releases to your
- local newspapers advising them of the event.
 2. Call local radio stations to the same effect.
- 3. Get together with local taxpayers groups or concerned people and make posters and write slogans to be recited.
- 4. Circulate petitions against the tax stating that those who sign the petition vow to vote against any Assemblyman or State Senator who votes for any new or higher taxes (see article on the Taxpayers Petition) and bring the finished product to the demonstration.
- 5. Start car caravans to the demonstration site, displaying prominently anti-tax signs on the cars. Use megaphones (if available) to tell people about the protest, its time and place, and urging them to come.
 - 6. Use acronyms when making signs, such as:

Steer or Stop Tax The Off Evil People Axe Legislators Banners are also welcome. Old sheets and the like make perfect banner meterial. A suggestion for a banner would be "Thorough and Efficient" means Theft and Expropriation! Use your imagination!

Literature will be available on a limited basis at the demonstration from SIL, The Federation of New Jersey Taxpayers, and the Libertarian Party. We should try to distribute it to those passers-by who seem interested; therefore, try to design your posters, banners, and signs to be hung on your person or on a car, so that your hands will be free. It would also be advisable to bring your own refreshments because there are no concessions in the protest vicinity. You should plan to arrive at the demonstration area about 12 noon on April 12th. Come out to support the anti-

TAXPAYERS PETITION

On March 11 & 12, petitions from the Federation of New Jersey Taxpayers were mailed to 67 NJLP members (other members had already received copies at the general meeting). The following note from Kathy McAdam, Recording Secretary, was enclosed: "In an effort to fight taxation in NJ, the NJLP is participating in the petition drive organized by the FNJT. Please get as many signatures as you can and remember that each one will help to halt the increas ing government encroachments upon our freedom."

The petition read as follows:

TAXPAYER'S PLEDGE

The undersigned N.J. taxpayers PLEDGE to vote against any Assemblyman or State Senator who votes for any new or higher taxes.

We have received very little feedback from our members so far as to how many signatures they have been able to obtain, but one member had 170 signatures and at least two others had over 50 signa-

We hope the NJLP members became active in this petition drive because it could help to prevent a state income tax and/or other higher taxes in New Jersey.

EIGHT LIBERTARIANS STEP FORWARD

Eight libertarians have thrown their hats into the ring for the upcoming Assembly elections in November. They are: Thomas Palven of Howell, Philip DeBlock of Kearny, Jane Rehmke of Ber-nardsville, Bill Schetlick of Newark, Ronald Wishart of Manalapan, John Conard of Toms River, Jill Fingold of Oldbridge, and Daniel Piro of Fort Lee.

FROM THE CHAIR

A meeting of the State Committee was held on March 2 at the home of Mary Mason. The following State Committee members were present: Raiph Fucetola, Kathy McAdam, Tom Palven, Jane Rehmke, Bill Schetlick, and Fred Stein.

NEWSLETTER: After discussion of a tentative newsletter budget, the State Committee decided that ten issues of the newsletter should be published this year and that copies should be sent to the National LP Chairperson, the Free Libertarian Party of NY, the Pennsylvania LP, the National LP News, our Region 7 Representatives, and Reason magazine. Copies will also be sent to "other state LP publications with which we have a reciprocal arrangement for the purpose of placing the other newsletters in the NJLP Party library."

Bill Schetlick stated that the newsletter should contain all the news of party happenings and libertarian and taxpayer activities in the state and that the emphasis should be on news of our own state. Nothing should take precedence over immediate news.

PARTY HISTORY COMMITTEE with Kathy McAdam as Committee Chairperson. This committee shall keep an NJLP scrapbook.

VOTER RESEARCH COMMITTEE with Bill George as Committee Chairperson. This committee shall obtain demographic and voting pattern information about the NJ electorate.

CANDIDATE SCREENING COMMITTEE with Jane Rehmke as Committee person. This committee shall screen potential NJLP candi-Chairperson.

FUND RAISING COMMITTEE with Bill Schetlick as the Acting Committee Chairperson. This committee shall raise funds for the NJLP.

MEMBERSHIP COMMITTEE with Tom Palven as the Acting Committee Chairperson. This committee shall service and expand the NJLP membership.

The State Committee extended its appreciation to the acting Voter Research Committee for a fine job on its report submitted before the meeting by the acting Chairperson, Bill George. The committee members are John Conard, Phil DeBlock, Stevenson Enterline, and Ron Wishart. The report contained data obtained from the 1974 NJ Legislative Manual and shows the NJ assembly districts and their 1973 voting patterns. LIBERTARIAN VICTORY

The taxpayers of New Jersey can hold their heads high. By a large majority of municipalities, the budgets were voted down. The people showed their frustrations with high taxes at the polls.

In Essex county, which is a highly urbanized county, and where liberals control both parties; the budgets went down in 18 of the 21 municipalities. Even in Governor Byrne's hometown (West Orange) the budget was defeated. In Irvington (the largest population for a town in the U.S. Census of 1960, and where Fred Stein once lived) the budget was smashed by a six to one ratio.

But we should not stop here. We, libertarians must get more active at the local and state level. Here we can exert our influence most effectively. If you want a written report on what bills and laws are presented in our State, write New Jersey Legislative News, Box 412, Trenton, NJ 08603. NJLP State Committee Member Richard Solyom (1 Horizon Road, Fort Lee, NJ 0/024) has been very active in his lobbying efforts for the taxpayers in New Jersey. If you want to help him and thus help yourself against high taxes, contact him.

National Tax Protest Day... What does it mean for us and our program?

The question can best be answered by a quick jaunt back into history. As you know, the American Revolution began as a tax protest; that is, the British, having levied unfair and confiscatory bills of revenue, were treating the colonists as second-class citizens. As a result, the colonists wrecked havoc on the collectors, merchants, and representatives of the crown. Upon examination of this specific instance of tax protest, we notice that the taxes really were not that heavy; rather, there were a proliferation of small, seemingly insignificant taxes on various commodities and printed matter. Why such an uproar over such a puny, inconsequential matter? Apparently the colonists were concerned with the principle of taxation, per se, and what the acceptance thereof implied. Their reaction exposed a deep insight into the nature of the relation between economic and political freedom. They were politically astute enough to see the future implications of this piddling levy; that their tradition of self government and local autonomy would be destroyed if the tax was not challenged on principle.

We are the modern-day colonists. We recognize that the same implications exist today as they did two centuries ago... Like the colonists, we are politically astute... Like the colonists, we began as a small, currently unpopular, grass roots movement... Like the colonists, we will succeed if we stick by our principles.

Plan to attend the demonstration on the 12th of April. Bring your slogans, your signs, and your spirit. Don't let the new revolution die before it gets started.

The New Jersey Libertarian Party thinks that President Ford's call for reduction in taxes is only one way to deal with the economy. With the reduction of taxes, consumers will have more money. INCOME TAX BLAMED

In answer to a recently published letter Mr. Petrovich recommends economic freedom through socialism. PRESS RELEASE

The following press release was sent to sixteen NJ daily news-papers by the Issues and Publicity Committee:

The New Jersey Libertarian Party met in New Brunswick and reaffirmed their drive against any new or increased taxes. The Libertarian Party is now actively engaged with other taxpayer groups in getting signatures on a petition against an income tax. The petition reads as a taxpayers pledge to vote against any politician who votes for any new or increased taxes.

At the Libertarian meeting, Howard Katz from the Committee to Reestablish the Gold Standard was the principal speaker. Mr. Katz proclaimed that since our gold standard was abolished in 1933 our paper currency has continually depreciated; and thus inflation and an unbalanced budget was a result. Mr. Katz believes that a sound money system which ensures that each man receives the product of his own labor, is necessary for the existence of a strong middle class.

LIBERTARIANS WANT THE TAX LINE HELD

The New Jersey Libertarian Party yesterday voiced its opposition to any new or increased taxes in the state.

The organization, along with other taxpayer groups, is circulating a petition which is a taxpayers' pledge to vote against any politician who votes for new or increased taxes.

A press release announcing the March 9 meeting had been sent to the sixteen newspapers, but we don't know if any of them printed it. Please let us know if you see anything at all about liber-tarianism in the newspapers. We want to know if any of our efforts are paying off, and we certainly can't afford a clipping service.

PARTY FIGHTS INCOME TAX

The New Jersey Libertarian Party, which calls for little or no governmental intervention in economic and personal matters, has gone on record in opposition to a state income tax.

Fred Stein, vice chairman of the party, said 60 delegates to a recent state convention unanimously voted against any form of tax on the incomes of state residents.

He said the delegates also adopted a resolution calling for a reduction in state expenditures and property taxes by at least 1 per cent a year.

Roger MacBride of Virginia, a speaker at the con-

Roger MacBride of Virginia, a speaker at the convention held in East Brunswick, predicted the demise of the Republican Party, comparing it to the fall of the Whig Party of the 1850's.

Stein said the Libertarian Party "is committed to both economic freedom and civil liberties. It is working to establish a voluntary society without government intervention into the lives of individuals."

ECONOMIC NEWS BRIEFS

For the last two months the president and the Congress have been grappling with the problem of exactly how to ameliorate the outflow of dollars to foreign countries, especially to the OPEC nations. Recent developments in the international money markets find the dollar fading poorly, and France has upvalued its gold hoard to place it more in line with the market price. Whether one chooses to recognize the facts or not, a kind of mini—panic has set in; that is to say, the flight from dollars into Swiss Francs and gold has been more pronounced as of late. Any number of solutions have been bandied back and forth, ranging from additional gas taxes and import quotas to rationing...somehow the Arabs have gotten hold of the government's printing presses.

Apparently, the Market has foiled the bureaucrats again ——
President Ford's plan to make America free of Arab dependence by
1980 seems to be doomed at least for the time being. Ford's
plan was comprehensive (however incomprehensible) in that it included subsidies to encourage domestic research and development
and, at the same time, provided for a decrease in the importation
of foreign crude through a series of the above-mentioned measures.
The enigma developed as a direct result of sustained high prices
in the energy markets...the capital that was directed toward this
field has created an overabundance of supply and prices are in a
downward trend. Entrepreneurs are now in search of a better return on their investments and this tendency has made further research and development in oil unattractive. What is Ford to do?
Will he let the market operate? Not on your life! Instead Ford
has proposed "price floors" which will keep prices artificially
high. Fortunately, the Congress has not been able to get together
with the Chief Executioner for any real deliberation and therefore, we can be assured that the market will have already righted
itself by the time any real action can be taken. Hopefully this
trend will continue in the future...

and I am the first to wish them luck.

It is a bad mistake to revile those who prefer, by temperament and/or ability, to conduct living-room discussions, or who want to work with students and young people, etc. I believe the term "bovines" was applied to describe those who don't engage in activities which the NJLP regards as worthwhile.

I will send you \$3.00 in hopes that some rather more mature people will take charge of the newsletter. If you wish to curse at one another, use masty language, and hurl personal insults back and forth, I'd like to see you do that on your own personal letterheads and not in newsletters which come into my home.

I subscribe to any libertarian publication in order to learn what I can about the great world of enemies to us all. I'm not at all interested in your personal likes and dislikes except as they concern the Common Enemy.

The first issue of the NJLPN has arrived -- that is, the first issue under your editorship. May I correct the second half of the second sentence of your editorial? It should read: "... so if you like something about it, let us know."

So... I'm letting you know. It was great! Very informative. And, having myself attended the convention as a new member, I find the ${\hbox{NJLPM}\over\hbox{NJLPM}}$ an accurate reporting of events. Reprinting Letters to the Editor is a good idea. It will offer encourage—

ment to others of us to do the same.

Regarding the title of the newsletter, it is my opinion that it should be named THE NEW JERSEY LIBERTARIAN. It seems to me that in the early stages of development of this political party, the party identity should be maintained. One way is through a readily identifiable name and publication. As the party grows, the publication may grow to the point of active circulation beyond the limits of the strict party membership. If it does, I believe we will appreciate a title that is highly identifiable with the movement itself. While the titles already suggested relate to $\underline{\mathsf{some}}$ aspect or principle for which we stand, they are just that -- limited. The title should be suggestive of our total view -- which, politically, is Libertar-


