#### ASSEMBLY CANDIDATES

#### DAN PIRO - CANDIDATE FOR ASSEMBLY

Dan Piro is a candidate for assembly in the 37th assembly district. This district is located in Bergen County and consists of Fort Lee, Englewood, Englewood Cliffs, Teaneck, Tenafly, Bergenfield, Leonia, Edgewater, and Cliffside Park. Dan's objective in running for office is to win — within the framework of his libertarian value system.

Dan is formulating a plan which will identify the actions he and his advisors believe necessary to successfully market Dan's candidacy. He is taking a leave of absense of two to four weeks in the fall from his job to campaign fulltime. In addition, he plans to spend \$400 to \$600 of personal funds towards the campaign. Dan is seeking \$3000 in campaign funds. He anticipates that the first \$1000 will be applied to printing expenses (\$800), telephone, travel, and misc (\$200), and at least 80% of the excess will go toward newspaper advertising. Of even greater importance than money, campaign helpers are needed. Over 20,000 apartments must be reached with campaign literature, and another 10,000 to 20,000 pieces of literature must be distributed in the streets. This canvassing effort will require about 500 hours of people time. In addition, help will be needed in telephone campaigning during the last two weeks of the campaign. Readers in Dan's district are asked to assist in the campaign by making their phones available for toll free local calls.

Dan is 27 years old, married to an attorney, and is a professional management consultant specializing in financial planning. He is currently an officer of the Chase Manhattan Bank. #### WISHART FOR LIBERTARIAN ASSEMBLY

Why run? 1. To get the Libertarian Party known as a political party and as an alternative to the Republicans and Democrats in order to prepare for some LP victories in the next few years.

2. To educate the voters and politicians to the libertarian philosophy so that if we don't win, at least like the Socialists our policies might prevail.

I believe that for both reasons every LP member should consider running for some office every year. A press release from Ron Wishart, LP candidate for Assembly, carries a lot more weight and interest than does a letter to the editor from Ron Wishart, libertarian letter writer. I am not pushing my own name because hopefully, as a result of this campaign, next election we will have several Libertarians in western Monmouth County who will want to run and I can work for them.

Ayn Rand's works provided my introduction to libertarianism while I passed thru various conservative groups in search of one that included her ideas and acted on them as well. My idea of utopia is a voluntarily funded government limited to merely protecting us from force and fraud, but I can't see arguing with anarchist libertarians until we begin to get close to utopia. I do believe some sort of voluntarily funded legislature, court system, and police force are necessary to define such questions as how much pollution can I emit before I have violated someone's property rights. Libertarians still debate such questions and we must expect that even in utopia libertarians will be in the minority. I see a need for a voluntarily manned and funded defense force because I believe the communists when they say they will destroy what's left of capitalism.

Tom Palven is my campaign manager and once the question of financing is settled (or when contributions begin to arrive) I will appoint a treasurer to do battle with the state election laws. My opponents in the 11th district are incumbent Democrats Salkind and Kozloski and Republican challengers Marie Muehler and former Essex County Assemblyman Jerry Burke. I am the only independent.

A few of the themes we intend to promote are:

1. The debate over school financing via income tax vs. property tax is misdirected. The real issue is "Who should pay for education, the parents or whoever the parents can force to Pay?"

#### CONARD FOR LIBERTARIAN ASSEMBLY

CONARD CALLS FOR END TO LIBERTY SHORTAGE

"The State nowadays will guarantee you anything," says
Conard, "except Life, Liberty and Pursuit of Happiness."

John J. Conard, NJLP Assemblyman candidate for the Ninth
District, has kicked off his Ocean County area campaign with a
May 20 DAILY OBSERVER press release calling for a sharp reduction
of all State interference in N.J.'s social and economic problems.
"The State," Conard says "seems to have a 'solution' to every
'crasis' except the Liberty Shortage."

In announcing his candidacy, Conard, who joined the NJLP and the National LP in November '74, struck at the immoral premise of taxation, calling it a means of controlling people by limiting their range of choices and freedom of action. He identified it

as legalized theft.

Conard's May 20 release attracted attention from the OCEAN COUNTY REPORTER which ran a front page article by Kurt Loder. The product of a 2½ hour press interview with Conard, the article accurately stated the Libertarian viewpoint, gave a run down of the LP platform and concluded with several trenchant quotations.

Conard has appointed Lucille Bender, an NJLP member from Deal, as campaign manager. Bender, who has been a Libertarian "all her life" has had many battles with the N.J. State Education Bureaucracy. Overcoming much of the red tape, she now operates, in spite of frequent State harassment, a successful nursery school business wherein Libertarian principles are a matter of daily practice with the children.

Conard attended Trenton State College for English teaching, but abandoned this profession after his initial experiences in public school practicum. Now an independent insurance adjuster, he finds this industry no less strapped by government inter-

ference.

Having built his own home in Toms River, N.J., he experienced first—hand the indignation of local building regulatory czars and too often heard the typical statist platitude that "we're only doing it for your own good." To Conard, this is the epitome of the statist/collectivist theme of Man as a helpless ignoramous who can do nothing for himself unless he achieves the status of a government bureaucracy—thereby receiving a miracu—lous omniscience or, failing in this, an omnipotence of last resort.

Following is a statement from Kenneth R. Kaplan, candidate for Assembly in the 26 th District:

Who would want to spend Memorial Day weekend in a hotel in Chicago? Well, the members of the LP Executive Committee and interested observers, including NJLP member Bob Steiner, did just that, spending two solid days at the LaSalle Hotel in the heart of Chicago discussing and voting on important details concerning the functioning of the party. As is usual at gatherings of libertarians, the debates were long as we sought to air all views and work within the principles.

The meeting officially opened at 10 a.m. Saturday (Most of us had arrived Friday night and started caucusing at the bar.) with the usual reports of the officers and members. I reported that NJ is one of the spots to concentrate on in '75 with our 5 Assembly races.

The committee accepted the affiliation petitions of three states: Iowa, Nebraska, and Alabama. Other states may be affiliated before the national convention and will be permitted their two basic delegates.

Bob Meier reported on the extremely successful "1975 Conference on International Liquidity and Monetary Reform" held in New Orleans. With nearly a thousand attendees, the party netted about \$20,000. Everyone at the banquet was exposed to the LP through a literature packet and a speech by Roger Mac Bride.

Ed Crane commented on the suit in opposition to the Federal Elections Campaign Act Amendments of 1974 in which the LP is a co-plaintiff. He filed an affidavit and had to undergo several hours of detailed questioning. As far as I know the case is still pending.

It was announced that Bob Meier will assume the position of National Director. He has moved to California and will be traveling around the country assisting state organizations, with special emphasis on the 1976 Presidential Campaign.

The longest debate concerned the problem of allocation of delegates to the New York convention. There is some evidence that at least one state "questimated" their membership figures on the high side, and that that may have deprived other states of delegates. Late Saturday, Phil Manger (Ed. Note: Our other Region 7 Representative) presented the case against the Virginia party, which resulted in a challenge being issued by several state parties on Sunday. The Execom voted to turn the matter over to the Credentials Committee.

Saturday night, the Illinois party hosted a banquet (the usual "rubber turkey") with remarks by Ed Crane, Andrea Millen, Karl Bray, Dave Nolan and Fran Youngstein. After that, a large group of us went 'out on the town' to the elegant 'Pump Room'

at the Ambassador East Hotel.

On Sunday morning the first order of business was electing new members to fill vacancies on the Execom. (Scott Royce had resigned in November, Karl Bray resigned due to his legal diffi-culties with the IRS and the possibility of a jail sentence to keep him inactive for a while, and Bill Westmiller resigned as secretary to take on the responsibilities of California chairperson.) First, Greg Clark of Michigan was elected secretary, and then Kay Harroff of Ohio and Jim Blanchard of Louisiana were elected to fill the at-large seats. The new members bring a great deal of talent and experience to the Execom.

The other important business on Sunday was the election of committees for the Presidential Convention next September. Here are the members and their home states:

#### THE PRESIDENTIAL CONVENTION

,

The National LP annual convention will be held from August 28 to September 1 at the Statler Hilton Hotel in mid-Manhattan. Activities which will begin on Mon. August 25 have been "designed to stimulate interest in the event among non-delegates and even non-LP members." Estimates are that 600 delegates and alternates will be in attendance.

"Highlight of the Convention will be Saturday morning when the LP's 1976 Presidential ticket will be selected. To date, Roger MacBride of Virginia, Guy Riggs of New York and Kay Haroff of Ohio are the announced candidates for the Presidential nod and Jim Trotter of California has announced for the Vice Presidential spot. A special Sunday night banquet featuring enter-tainment from the talented New York Free Libertarian Party con-tingent will honor the Presidential team."

Committee activities will start on Tuesday, August 25. "... Particular interest has been developing over the 'star-studded' Platform Committee and its deliberations will be in a room large enough to accommodate 200 people..."

"Throughout the Convention speeches will be given by leading libertarian activists,... David Friedman,... Murray Rothbard... D.T. Armentano, John Hospers and news commentator Jeffrey St. John."

"The official opening of the Convention will be Thursday morning with the report of the Credentials Committee...."

"On Friday morning, the Convention is scheduled to begin debate on the new Libertarian Party platform on which the 1976 Presidential ticket will run...Since some of the foremost libertarian thinkers in the country are on the committee, many are anticipating an outstanding LP platform to come out of the Convention."

#### KAY HARROFF FOR PRESIDENT

"Kay Harroff, 1974 candidate for U.S. Senator from Ohio, has announced her candidacy for the LP nomination for President.

"Harroff became active in Republican politics in the early 1950's, read Atlas Shrugged in 1960, and founded the Cuyahoga County (Cleveland) Draft Goldwater Committee. After Goldwater's defeat, she left the Republican Party. She joined the LP in 1972, and was founding Chairperson of the Ohio LP. In 1974 she ran for U.S. Senator as an independent (due to harsh ballot laws she could not appear as LP) against John Glenn and ran an active campaign that yielded about 80,000 votes. Harroff was recently elected to the National Executive Committee of the LP, is once again state Chairperson of the Ohio LP, and is currently a businesswoman in Cleveland."

'Harroff says she decided to seek the nomination because, 'I was concerned that the Libertarian Party put forth candidates with a clear-cut, unique, libertarian image. I hope to put to rest, once and for all, that conservative, right-wing label the news media have tried to stick on us.' She feels that the LP can expand its appeal to groups which only the left has in the past appealed to: blacks, chicanos, gays, feminists, pris-

oners, and students..."

#### GUY RIGGS FOR PRESIDENT

"Guy W. Riggs, longtime political activist and twice a libertarian candidate for the New York State Assembly, has announced his candidacy for the presidential nomination of the Libertarian Party."(LP NEWS May-June 1975)

In the announcement of his candidacy dated May 15, Riggs proposed a contract between himself and the LP if he obtains the nomination and answered the following questions:

1. "A libertarian politician is a contradiction in terms." "That's right, when a libertarian tries to play the present-day political game. So I would change the game by bringing honor and respectability to politics."

"First, I would avoid entirely the war-like terminology and

attitude infesting current politics....Selling the concept of the minimal state aggressively is all that's necessary."

"And second, I would not disparage any political competitor.

Preparing the minds of Americans for freedom would require my full attention, and references to my political competitors would be for the comparisons nesessary to that end...."

2. "I've neither held political office nor been in a major campaign." (continued on p.5)

(Ed. It does get discouraging because we often see little feed-back for all our efforts, but that is true of almost any educational endeavor. It may not be evident at first that we are getting our ideas across to anyone but the few who are already predisposed toward our views. You may not ever find it out, but you may have planted a seed of freedom in someone's mind with this one letter; someone may have gained insight or courage because of your outspoken stand for freedom. This could be true for everything that we all say or do in our work toward liber-ty. Someday the cumulative effect of the efforts of all people like you will be obvious. Truth is on our side!)

Enclosed is a copy of a letter I sent to the jury commissioners. The newspapers who got copies declined to publish it, probably deliberately. They're not radical freedom-fighting journalists, and maybe they figured it would affect my trial.

Just before the gubernatorial election, I registered to vote - primarily to be eligible for jury duty and their longawaited questionnaire.

The questionnaire they sent said at the top that failure to complete it and return it "promptly" might make it "necessary" that I appear before the jury commissioners. At the end it said any false information would make me subject to penalty for contempt of court. Not the most tactful invitation I ever

I've received no response from them yet. That's fine with me- I never considered myself top-grade martyr material. However, if they make a fuss, it might as well be with me. I've no assets they can attach, no way to pay a fine, and too visibly frail to survive the cage. And it'll be good practice for when ERA gets me drafted.

I hope you'll print it in the newsletter. There's some disagreemant among L's (Ed. libertarians) about the jury busi-ness, but the enclosed letter is my way of dealing with it, and I'll stick by it....

Laissez-faire über alles, Mary (Mason)

Enclosed, blank Prospective Juror Questionnaire.

I consider the form to be an element of a coercive system which violates one's fundamental right to liberty. It is coercion bordering on the bizarre that you attempt to cause me not only to appear in court, but there to reach a decision against my will.

I assume that my refusal to answer the questionnaire is a violation of law. If I am to be forced to appear before jury commissioners, it will necessitate direct physical force on the part of the state's agents. If I am subject to punishment for contempt of court, it is not just, particularly since no punishment can equal the contempt I have for the court.

This is a letter which I hope other Libertarian News readers will use in corresponding to their senators and representatives:

Senator Mike Gravel United States Senate Washington, D.C.

January 2, 1975

Dear Senator Gravel:

In 1970-71, you effectively lead a battle to end the draft. There is a new battle to fight in 1975. The basic freedoms of this nation are being threatened gravely by the unethical, illegal, and irresponsible manipulation of the monetary system of the United States. During the past year, this has resulted in a serious inflation. This inflation has robbed our senior citizens of the purchasing value of their savings, it has played havoc with our international trade, and it has distorted business decisions throughout the country. The possibility of a runaway inflation, which will incapacitate our economy, now exists. A continuation of deficit spending policies by the federal government will serve to bring us closer to the horror of a worthless currency. I strongly urge you to lead the fight to save the country from the horrors of inflation and recession. To accomplish this, I have outlined the following program: 1) Gold: to enable senior citizens to protect the purchasing

value of their savings, enact legislation which will allow banks to receive gold deposits in time deposit accounts paying 3% interest in gold. Allow the banks to count these gold deposits as part of their reserves.

Pass legislation which will change the official U.S. exchange rate on gold to \$200/oz. in 1975 and raising the rate to \$300/oz. by 1977 in small steps. This will serve to reduce the balance of payments problem of the U.S. Government and will act as a stabilizing force in international trade.

- 2) Social Security: enact legislation which will reduce this program to serve only those citizens who are more than 35 years of age and who elect to remain in the system. This program is no longer needed by the masses of the American working force, it is going bankrupt, and it serves as a regressive tax. By ending the program and the tax, it will be possible to stimulate the economy in a non-inflationary manner.
- 3) Economic Regulation: enact legislation which will "decontrol" the economy. This will be accomplished by establishing an <u>Economic Decontrol Council</u> which will have the power to suspend specific business and industrial controls, price controls, quotas, and other restrictions. This is similar to the approach taken in Germany after WWII. It lead to a spectacular economic recovery.
- 4) Military Spending: reduce the Defense Budget by 3%. Enact legislation to change the nature of military contracts from "cost plus" to fixed bid.
- 5) Budget Surplus: lead an effort to reject any budget which does not reflect a surplus of at least 2%.

This program calls for leadership which transcends political expediency. You are one of the few individuals in Congress with the courage and persistence to provide this type of leadership. I urge you to act now on the basic program outlined above.

#### JACK CONARD FOR ASSEMBLY

John J. Conard, who is running for Assembly in the 9th District, has already received coverage in two of the local news-The following statements are exerpts from an article in the May 20, 1975 issue of the DAILY OBSERVER, Toms River:

"... The specific focus of the Conard for Libertarian Assembly Campaign will be upon the necessity to reduce the current levels of state interference and control over the private and corporate lives of all individuals and businesses in New Jersey."

"In a prepared campaign statement, Conard said he hopes to demonstrate to citizens of the 9th District that both the district and the state political and economic problems can be resolved, 'but only if enough citizens come to realize that our current problems in public education, unemployment, decay of the cities, mass transit, energy, and the state's own fiscal problems

really be the private affairs of individuals."

"The thrust of the Libertarian effort in New Jersey is opposition to further taxation, specifically the income tax, and a one per cent a year reduction in both state revenues and expenditures."

"Although the Conard campaign will make use of this issue and party plank, Conard said he hopes to point out that the underlying premise of taxation is "fundamentally immoral" because 'it denies the individual his inalienable right to life, liberty, and property.'"

"Taxation is a means of controlling people by limiting their range of choices and freedom of action, Conard said, all in favor of the state's 'freedom' to do as it pleases with the fruits of individual labor which it has forcibly extracted from individuals."

"This is a process of legalized theft, " said Conard. The following statements are from a  $\underline{front\ page}$  article in the May 28 issue of the OCEAN COUNTY REPORTER (circulation that edition, 71,694):

"'I'm not going out to sell myself,' Conard notes - evincing for a moment the contempt he would seem to share with a growing number of his fellow Americans for conventional politicians. 'I want to sell a principle. That's what I have to offer. I don't have me to sell.' "

"That principle is beguiling in its simplicity: Libertarians believe that every human being has the sole right to his own life — and the products of his labor — and that the initia tion of force against any individual - whether by governments, pressure groups or common criminals - can never be justified."

It continued with the following evaluation by Conard: " 'The public school system,' he says, 'teaches people either to dominate or become subservient. And everybody in the country goes through the same educational system. I think children can learn to become independent thinkers - if they're let alone. As it is, parents are forced to pay taxes to support government schools, and children are forced to go to them. But the needs of children are not a claim on my or anyone else's life. We should institute a voucher system so that parents can send their children to whatever private schools they wish; and ultimately we should abolish public schools - against which private schools cannot afford to compete - altogether. "

"...A rugged individualist himself (he recently finished building his own home from the ground up), Conard contends that absolute individual freedom — and the protection of individual rights (which, he adds, should be the government's only func-

tion) are the key to curring the current national malaise."

"'Freedom is very demanding, he says, 'It demands that people use their minds to the fullest extent. Whenever a person reverts to coercion or force, he is admitting his refusal to think.'

Approximately 30 NJLP members and guests enjoyed an NJLP-sponsored party on Sunday June 1 at the home of Jan's and Tom Palven of Howell Township.. It turned out to be a great opportunity to talk to four of our five candidates for the state assembly and to just socialize with other libertarians.

During the party we were joined by a reporter and a photographer for the ASBURY PARK PRESS who had been contacted about the get-together. The reporter stayed for a couple of hours and interviewed the four candidates and other NJLP members for about an hour. The result was a <u>front page picture and article entitled</u> "Libertarians See Selves As 19th Century Liberals" (the page two continuation of the article was headed "Libertarians Are Realists") in the June 2nd edition.

The following statements are excerpts from the newspaper article:

"Think of a society without taxes, welfare programs, Social Security, labor unions, price controls, and free education."

"You are thinking about the goals of the Libertarian party." "...'Our chances of getting elected aren't terribly great', admitted Kenneth R. Kaplan of Orange, a candidate in the 26th District."

" 'But we'll keep trying,' added John J. Conrad (Ed. it's Conard), Toms River. 'We'll get more votes than the other minority parties.' "

"...As they explained it yesterday, party members believe in a laissez-faire economic system - a free market without any government interference."

" 'Call it 19th century liberalism,' said Schetlick." "At the same time, the party would have no laws regulating

the behavior of the citizenry. Government functions would be almost nonexistant.

"The primary responsibility of government would be to serve as an arbitrator for disputes among citizens. It also would be

empowered to raise armies and maintain defense."
"Calling the welfare and Social Security programs 'giveaways,' the candidates said government, through an implied 'threat of force,' is meddling in the business and personal lives of the citizens."

"Economic disincentive,' they called it...."

"Social programs destroy the desire to work and succeed..."
"If somebody else can do it for us, then we can do it ourselves," said Daniel J. Piro, Fort Lee, an Assembly candidate in the 37th District...."
"On wages and working conditions, Schetlick said they would be determined by the standards of an onen market."

be determined by the standards of an open market."
"In New Jersey, the party is waging political war against

the income tax proposed by Gov. Brendan T. Byrne."

"As Piro put it: "Twelve years ago, the state budget was one-half billion dollars. Now, the proposed budget is \$2.8 billion. That's a factor of almost six. That's what we call the 'fed up factor.'"

"The candidates agreed voters will be receptive this year to candidates outside the major parties, although they said their goal is as much to educate the public about Libertarian ideas as to win political victories...."

In answer to the article in the Asbury Park Press, Tom Palven, NJLP Executive Secretary, sent the following letter to the reporter, Mr. Glen Serafin:

Your coverage of the Libertarian Party picnic was unexpectedly excellent. The exposure it gave the movement should at least convince some that the word "libertarian" can be used in the presence of women. It accurately reflected the views of the persons you interviewed. For your information, however, some libertarians have a slightly differing view of unions.

Some feel that unions have had a function in correcting certain abuses in the past and may continue to do so. What we are opposed to is government interference in the relations of unions and management eg. <u>laws</u> supporting closed shops and preventing 'discrimination' against union organizers. We believe that a person providing employment has the right to hire or fire any person he pleases unless bound by contract.

In a dispute between labor and management may the "right" side win or a compromise be reached, but in any case the bureaucracy should stay out. We are as much opposed to cozy relationships between big businesses and government, their access to public funds in the form of subsidies, and such hidden subsidies which burden the consumer as tariffs, as we are opposed to big

We blame neither unions (higher pay) or business (higher prices) for inflation because with a closed money supply if the cost of one thing goes up the cost of something else must necessarily go down and there would be no inflation. Inflation is caused by rate of spending and particularly the increase in the money supply by government (The Federal Reserve). Every diction ary defines inflation as such no matter who our officials and their economic mouthpieces choose to blame.

(Ed. Note: Murray Rothbard defines inflation as any increase in the economy's supply of money not consisting of an increase in the stock of the money-metal. - See What Has Government Done to Our Money? , p. 23.)

- 2. The current hysteria over apartment zoning, court zoning decisions, and home rule would have never occurred if it weren't necessary to zone children out of town in order to keep taxes
- 3. The trouble with my four opponents is that they are all honest do-gooders. There is a limit to how much dishonest politicians would steal but there is no limit to how much of other people's money that do-gooders will give away to buy votes.
- 4. The only difference between a government and a thief is that when a thief takes your money he doesn't come back to run your life and business.

The following letter written by Ralph Fucetola III, NJLP State Committee member, appeared in the June 4th issue of THE RECORD:

#### TAXPAYERS FEDERATION: TIME TO LAY BOTTER MYTH TO REST

Now that the state Supreme Court has attempted to enforce the Botter decision by reallocating educational funds (an act that many - including members of the court - consider a usurpation of power), it is time to lay to rest the myth of the Botter decision.

The decision was based on the "finding of fact" that the quality of education is directly and primarily related to per capita spending. This finding is simply erroneous. I can understand how Judge Botter made his finding — even Judge Weintraub admitted that the only evidence ever produced before Judge Botter compelled that finding.

At the nonjury trial of the case in 1971, ten "experts" testified for the plaintiff that there was a significant correlation between per pupil spending and the quality of education. Two "ex-perts" testified for the "defense" - and agreed. There was no real defense. A fair review of the trial transcript leaves no other conclusion.

I say that there was no defense because there is considerable evidence that there is <u>no</u> significent connection between higher and higher school spending and the quality of education. In fact as a recent Rand Corporation study shows, nearly 80 percent of all

increased school funds go to higher salaries!

But the court has never seen this evidence, and the public has never been told that <u>Robinson vs. Cahill</u> et al. was a sham. It is time the New Jersey Legislature acted to nullify the Botter myth. We urge the adoption of either S.C.R.-3 or A.C.R.-169. Either bill would let the people decide by referendum whether they want locally funded, locally controlled schools or another expensive state bureau to provide ever higher salaries for teachers and "experts".

"All I have here are hunches; not all mine, by any means; that Americans are getting so tired of politics—as—usual that a lack of political experience would not be detrimental at all. Furthermore, accompanied by sensibly presented libertarian alternatives, it could be a real vote-getter ..."

3. "I am a salaried man with family obligations and no bank-roll."

"Now we're getting to what I regard as the real moment-of-

truth for the Libertarian Party...."

Americans distrust a person, most especially one in politics, who does something for little or nothing. They ask, 'What's he really in this for?'. I predict my answer would get their positive attention like it's never been get before tive attention like it's never been got before.

And second, I want to eliminate the risk of bankrupting the Libertarian Party Corporation."

"By now, I have said enough to show that I will present a definite alternative at the convention. I believe I will be the best of the very good ones offered because, by the most consistent practice of the principles we all preach, my promotion of Libertarianism would be the most effective..."

"...If I become your candidate, there will be many times you'll be asked, 'Who is Guy Riggs?', and you'll be able to give an answer which will finally put America on its proper political

Because Morris County knows the state will share the cost. As long as the voters are allowed to grab someone else's money, you are a fool to believe they will not grab tooth and nail. Conservatives want to spend money on the police state (FBI, CIA, Defense, etc.) Liberals want to spend it on welfare and regulatory agencies. The following letter was written to Jack Conard on April 30 by a person who has since joined the NJLP and become Jack's campaign manager. We thought you would like to see what just a small amount of publicity and follow-up literature can accomplish in terms of reaching people with similar views.

Dear Mr. Conard,

Thank you so much for your letter and the literature which I received this morning.

I'm the kind of person who knocks on doors and talks to people to bring about any changes in the injustices all around us. Mostly I have become well known and a little influential in our area through complaints against our local school system. I have been trying for the last few months to remove my children from "public school" to have them privately tutored at home. When I began I had no idea that I didn't have this right. I quickly learned that not only did I not have this right but if

I pursued I might eventually lose custody of me "own" children.

do my best.

We, the members of the Libertarian Party, challenge the cult of the omnipotent state and defend the rights of the individual. We hold that all individuals have the right to exercise sole dominion over their own lives, and have the right to live in whatever manner they choose, so long as they do not forcibly interfere with the equal right of others to live in whatever manner they choose.

Governments throughout history have regularly operated on the opposite principle, that the State has the right to dispose of the lives of individuals and the fruits of their labor. Even within the United States, all political parties other than our own grant to government the right to regulate the lives of individuals and seize the fruits of their labor without their consent.

We, on the contrary, deny the right of any government to do these things, and hold that where governments exist, they must not violate the rights of any individual: namely, (1) the right to life — accordingly we support prohibition of the initiation of physical force against others; (2) the right to liberty of speech and action — accordingly we oppose all attempts by government to abridge the freedem of speech and press, as well as government censorship in any form; and (3) the right to property — accordingly we oppose all government interference with private property, such as confiscation, nationalization, and eminent domain, and support the prohibition of robbery, trespass, fraud, and misrepresentation.

Since governments, when instituted, must not violate individual rights, we oppose all interference by government in the areas of voluntary and contractual relations among individuals. People should not be forced to sacrifice their lives and property for the benefit of others. They should be left free by government to deal with one another as thee traders; and the resultant economic system, the only one compatible with the protection of individual rights, is the free market.
