At this writing, the coveted Row C ballot position in five New Jersey counties (Camden, Hunterdon, Middlesex, Monmouth and Somerset) is up for grabs, John Anderson won his fight for a random drawing for ballot position involving the Libertarian Party and ten other parties or candidates.

Superior Court Judge Herbey S, Moore found in favor of Anderson, thereby displacing the LP. The clerks of three of the affected counties have indicated they will appeal Judge Moore's order; Somerset County Clerk Lawrence Olson indicated further that the placement of the LP was consistent with past practice since the 1965 case of Richardson v. Caputo.

Late Extra: Libertarians lost all five Row C positions in the November 26 drawings, dropping to Row D in Monmouth and Middlesex, Row F in Somerset, and Row I in Camden and Hunterdon (See revised listing on back page). A small consolation is that John Anderson fared even more poorly, drawing Row D in Somerset (his only substantial gain), E in Hunterdon, F in Monmouth, G in Middlesex, and K in Camden.


NAME DROPPERS

Iran invasion plan reported

Thank you, columnist Anderson!

Jack Anderson!

We who have resisted draft registration thank you, Jack Anderson, for vindicating our struggle and for confirming our beliefs about why Pres. Carter really wants to sign up millions for the draft. Now we know that the only difference between Jimmy Carter and Ronald Reagan is that Carter wants to start a war before the election and Reagan wants to start one after it!!!

WASHINGTON—A startling, top-secret plan to invade Iran with powerful military forces has been prepared for President Carter. The ostensible purpose is to rescue the hostages, but the operation also would exact military retribution.

If the plan were carried out, it would create a crisis on the eve of the election. Political studies show that support for presidents always has sourced dramatically during a national crisis.

(White House deputy press secretary Rex Granum said in a statement:

("The suggestion that this or any other administration would start a war for political benefit is grotesque and totally irresponsible. The allegation made by Jack Anderson is absolutely false.

("With respect to the Persian Gulf, the president has said that we consider this region an area of vital interest. Therefore, while it is necessary to have plans for dealing with any external threats to countries of the region, we have no intention whatever of initiating any conflict ourselves, and neither the president nor any other responsible official has expressed any intention to take such an action either in October or any other time.

("Erroneous and totally irresponsible reports such as the Anderson column increase the danger to the American hostages in Iran, impede efforts to obtain the release peacefully and iconardize American increases in the area generally.")

and jeopardize American instances in the area generally.")

The tentative invasion date has been set, suspiciously, for mid-October. Sources say Carter has assessed the political consequences and has concluded that the invasion would be popular with the electorate.

This raises a disturbing question about Carter's motive. The person he really wants to rescue, sources suspect, is himself. They say he is willing to risk war to save himself from almost certain defeat in November.

My associate, Dale Van Atta, has been ferreting out the jigsaw pieces of the invasion plan, detail by detail, for three months. He has seen documents so secret that the code word used to classify them is itself classified. I am now able to report how our armed forces plan to invade and hold portions of Iran. I know the code name of the operation. I also can reveal that a "cover plan" has been devised to disguise the true intent. As part of this cover plan, troops and supplies already are being mobilized in the Persian Gulf area, and "training exercises" have been initiated.

I don't intend to publish the code designations or other secret details. There is a danger that too many specifics could give the Soviets an insight into our methods. But I believe the American people are entitled to know that the president is ready to risk their fortunes, perhaps their lives, on a desperate political gamble.

Sources involved in the planning fear Carter's determination to get re-elected has distorted his judgment. Some feel this strongly; others admit it rejuctantly. They describe Carter a extremely intense, coiled, rejentlessly pushing toward his objectives.

In other words, his judgment about this dangerous venture is not shared by all of the professionals who are helping him plan it. Nor has he consulted presidential rivals Ronald Reagan and John Anderson, who might inherit the fruits of his aggression.

The invasion plan, of course, does not become operational until Carter decides the military forces are ready and the weather is right. Up until 24 hours, even 12 hours, before D-Day, he can halt the assault. There are also alternate plans, with minor or major variations, that he could invoke.

So the president can deny, at least technically, that he plans to invade Iran. But he cannot truthfully deny that such a plan is in the works and that he has expressed the intention to go ahead with it. Van Atta has seen the documentation; he has spoken to several witnesses.

My decision to expose the plan is influenced by the experlence of the New York Times before the Bay of Pigs invasion, in which Cuban exiles, with a promise of direct U.S. military action, tried an invasion on Cuba's south coast, only to be crushed by government forces. Details of that invasion plan were leaked to the Times, which sat nervously on the story.

A week before the abortive April, 1961, invasion, the Times published a few cautious details but withheld the heart of the story. During the immediate aftermath, a frustrated President

"John F. Kennedy denounced the Times for publishing hints of the operation.

"Every newspaper," he said, "now asks itself with respect to every story, 'Is it news?' All I suggest is that you add the question, 'Is it in the interest of national security?' "

But two weeks later, Kennedy confessed to Times editor Turner Catledge: "Maybe if you had printed more about the operation, you would have saved us from a colossal mistake.

It is with this in mind that I have decided to reveal the gen-

eral outlines of the plan to invade Iran.

Here is the background for Carter's invasion planning. On Jan. 8, Carter was asked at a press conference about rescuing the hostages. A military rescue, he warned, "would almost certainly end in failure and almost certainly end in the death of the hostages."

Then, polls began to indicate that Carter could lose several crucial primaries to challenger Edward M. Kennedy. A major complaint against Carter, the polls showed, was his tendency to mope about the hostage crisis rather than do something about it. So he ordered the April rescue attempt, which, of course, was a disaster.

Now, with his re-election in jeopardy, he is proceeding with

invasion planning.

The invasion program's cover and alternate plans have interlocking elements that would explain the military preparations without betraying their true purpose. For example, the Saudi Arabian rulers are so worried about an Iranian-style revolt that they have asked for U.S. military support in case the royal family comes under siege.

Carter has agreed to the request, and some planners have been told this is the reason for all the Persian Gulf military activity. Other cover stories have been invented about standby

forces and training exercises.

Sources familiar with the documents identifying Iran as the real target fear that the limited invasion Carter favors could ignite a major war. The objective of saving the hostages, they say, is not likely to be achieved.

Van Atta has determined that the primary invasion target is

Iran's Kharg Island in the Persion Gulf-plus, possibly, some

of the southern Iranian oil fields.

Kharg Island has the oil terminal through which 90 percent of Iran's crude is pumped into tankers for export. Not long after the hostages were seized, contingency plans were developed for an assault on Kharg Island.

Various alternate plans were prepared, ranging from a surgical strike on the pipeline that connects the island with the oil fields to a military occupation of the island complex.

"The plan was originally designed to compensate for not getting the hostages, kind of a tit for tat," said a top source. They'd have the hostages; we'd have their oil depot.'

Here are some of the jigsaw pieces of the invasion plan: • Carter made a secret decision last February to shift a spy satellite to cover the area. But it did not begin transmitting photos until June and they are still being analyzed.

• More recently, 500 Air Force personnel were quietly transferred to Egypt. They were followed by a squadron of F-4 aircraft that began "training exercises" with the Egyptian air force.

• The United States has been helping the Egyptians upgrade their air bases, which would be vital staging areas for an Iranian operation. Ultrasecret communications and military equipment also have been shipped to Egypt.

• A special logistics force has been deployed at Dlego Garcia,

the only U.S. base in the Indian Ocean.

"This logistical force could sail to a designated Persian Gulf area port in about five days," says a secret memorandum to Carter. "There it would be met by the combat troops who have arrived by airlift. From this rendezvous point, they would draw their equipment and proceed to the objective

• Finally, the plan calls for four of the Navy's 12 carrier task forces in the Indian Ocean. Two already have arrived; one is in the Mediterranean ready to move quickly through the Suez Canal; a fourth could reach the Persian Gulf in time for the operation.

The "winds of 120 days," a period of violent wind and dust storms that began in May, would hamper military operations in Iran during the summer. The president can argue, therefore, that October is a good time for the invasion.

As I've stressed, the invasion plan will not become operational until the president gives the green light. He would need some pretext for the invasion, such as the trial or execution of a hostage, sources say. But one planner acknowledged that "a justification could be easily publicized beforehand."

Meanwhile, Carter Is continuing his secret diplomatic efforts to secure the release of the hostages. He would prefer to bring them home by peaceful means before the election. But sources close to the operation say that if the peaceful efforts fail, as expected, the president intends to activate the invasion plan. The risk, of course, is war.

There already have been ominous rumblings out of the Kremlin, warning of retaliation if Iran should be attacked. A Soviet-U.S. clash over Iran, of course, could become the opening skirmish of World War III.

The president is not unaware of the danger. He has directed the intelligence community to produce a secret estimate of how the Kremlin will react to a limited invasion of Iran.

Military analysts are confident at least that the Iranians cannot stop a U.S. assault. A three-star general told me that Iran's armed forces are in a "state of chaos."

The Soviets, however, have a powerful military juggernaut in the Persian Gulf area. It includes 10 warships and 16 support ships, with others on the way. Seven airborne divisions and several air mobile brigades also can be rushed to Iran.

Analysts have narrowed the Soviet response to four options: (1) military intervention; (2) diplomatic opposition; (3) official

indifference, or (4) clandestine cooperation.

Here is how key sources in the intelligence community appraise the Soviet attitude:

- They agree that the Soviets would rather deal with Carter than the unyielding Reagan. This already has been signaled through their faithful ally. Cuban President Fidel Castro, who said he won't do anything to embarrass Carter before Novem-
- To reduce the danger of a confrontation with the Soviet Union, Carter is expected to sound out the Kremlin about his October plan. There is a distinct possibility that the Soviets would bring heavy pressure on the Iranians to release the hostages.
- The Kremlin might even be inclined to cooperate behind the scenes to help free the hostages by military means. Sources say the Soviet KGB knows the location of each hostage and might help a U.S. rescue force. This would hand Carter a dramatic coup just before Americans go to the polls. The grateful Carter, in turn, might lift the grain embargo, reactivate the strategic arms limitation treaty ratification push and give the Soviets access to more U.S. technology.
- There is another, more sinister scenario. Intelligence reports say the Soviets have their own designs on northern Iran. Working through the communist Tudeh Party, they are maneuvering to gain control of the northern provinces. They might condone a limited U.S. Invasion in the south, therefore, if the United States will keep hands off the north. This could result in partitioning Iran into Soviet and U.S. spheres of in fluence. The analysts, however, say such a deal is unlikely.

But one thing is certain. The president would be foolhardy to go ahead with an October invasion of Iran unless he obtains a back-channel understanding with the Soviets.

Half an hour after the U.S. rescue team crossed into Iranian airspace on their abortive April rescue mission, the Soviets were alerted. A U.S. reconnaissance plane detected communications signals "consistent with the Russians being placed on alert." Later, Carter put through a hot-line call to the Kremlin to explain the mission.

COMMENTARY

As we prepare this month's newsletter, what was initially described in most news reports as a border dispute between Iran and Iraq has become a good deal more complicated. This is the type of situation in the Middle East which all too often in the last year has turned the generalized fear of World War III into a more specific panic.

That the Carter administration is woefully underqualified to deal with the situation in the best of times is manifest. Six weeks before Election Day is regretably not the best of times, and our President has demonstrated a tendency toward sabre-rattling when the pollsters bring bad tidings. Sadly, unless the Clark TV spots have been miraculously effective, our best hope for being alive on Inauguration Day may lie with Ronald Reagan committing a large enough gaffe that Jimmy is only required to continue his established pattern of indecision.

To those who might find the preceding a bit too cynical, we would only point out that Number One was conspicuously absent during primary season because he was too immersed in the hostage crisis, but failed to offer even an oblique reference to the hostages during his acceptance speech.

Along with these cheery thoughts we offer a reprint of a Jack Anderson column that most of our "vigorous free press" chose not to run because it represented a threat to our "national security." (Our compliments to those journals that didn't see its publication as an unbearable blow to the edifice).


