FROM THE CHAIR

GET IT TOGETHER

The recent success of the petition drive should provide all libertarians with a feeling of accomplishment. We are offering the largest slate of candidates in NJLP history.

This growth also creates the added responsibility of having better coordination of various activities throughout the state. The following guidelines should help bring about some semblence of communications within our organization.

County Committees: The County committee groups will, as our growth continues, become the backbone of the NJLP. Acting within their respective communities these groups organize, educate and mobilize voters to support the NJLP. In statewide elections local campaigns must be coordinated with the state wide effort. All mutual campaign efforts must be worked out in advance. County Committees are still part of the state party and should provide the State Committee with monthly reports at the S6 meeting each month.

Non-Organized Counties: Some counties already exist where we have enough membership to form a county committee. Where possible this must be done immediately to provide the organization necessary for effective political action. The Chair nor the State Committee can provide the local touch needed to assure success.

State Party Organization: While the County Committee is the critical group for party building the organization for successful political action and impact is the State Party. The time when we have fifteen or more active county committees who will send representatives to a State meeting has not been reached. Until that time the General Party Meeting is and will continue to be critical in bringing our members together. These meetings should be attended by all.

Individual Effort: The history of almost any political action group is repleat with the fact some do most of the work all the time. We must begin now to acquire the broadest involvement of all of our members. Many simple jobs remain undone. Since the convention I have been working almost full time at trying to gain publicity for our statewide effort as well as

making the media contacts that will be most helpful during the campaign months ahead.

This period of full time involvement will end within the next month. The only way we can maintain a high mark of visability will be to divide up much of the work.

No one or two people can run the NJLP. We can however have a task force of volunteers to assume some of the jobs that must be done.

We need a group of people to volunteer one or two days a month for typing and phone calls in the party office.

We need people on the Local level to work out of their home calling local groups to obtain speaking engagements for our candidates.

We need someome to maintain the party archives.

All in all we need you!

The drive to acquire and file the required petitions to get our candidates on the ballot in November came to a frantic conclusion Thursday April 28th.

Petitions were filed to permit as of this writing, 32 libertarian candidates on the ballot in the General Election.

The entire venture warrants the congratulations to all of you who helped on the drive.

Monmouth County turned in over 500 signatures for the Primich campaign. In addition, both Monmouth and Essex filed slates of local freeholder candidates.

INDIVIDUAL RIGHTS

Rights pertain only to the actions an individual may take in his own behalf. Rights cannot impose upon others an obligation to act. Civil order is the condition under which individual rights are recognized, respected, and protected by law. Examples of basic individual rights are:

- 1. Right to life. Each individual has the right and responsibility to exercise sole dominion over his own life. Each individual has the right to pursue the lifestyle and course of action that best sustains, enhances, and protects his own life, recognizing that this equal right in others must not be violated.
- 2. Right to liberty. Each individual has the right to remain autonomous from any form of coercion, interference, or impingement by any individual or group of individuals or government that would impede his pursuit of action, thought, or security, recognizing that this equal right in others must not be violated.
- 3. Right to property. Property is defined as those goods, mervices, materials, products of labor, or real property which are acquired without the use of coercion, trespass, or fraud. Ownership is the freedom to use, maintain, improve, control, protect, consume, destroy, or dispose of property as the owner sees fit, recognizing that this equal right in others must not be violated.

CIVIL ORDER

JUDICIAL There are no crimes against society, the State, or the people. There are only crimes against individuals; and these are crimes of violence or threat of violence, property loss, or fraud. Justice is the earnest attempt, by due process of law, to extract reasonable restitution from a person convicted of a crime and to convey that restitution to the victim. It is also the removal of habitual criminals from free society and the fair settlement of contract disputes. The lack of understanding and appreciation of these points by the courts, and by the public at large, has led to the near collapse of public confidence in our courts and the failure of our courts to administer justice. The court system role should be: to establish the guilt or innocence of the accused by objective rules of evidence and due process of law, to determine the amount of restitution the victim is entitled to receive, to prescribe the method of restitution to be made by the convicted person, to determine the disposition

of "habitual" criminals, and to settle contractual disputes. All persons should be equal before the law and be entitiled to due process of law. Due process is the action of law to determine guilt in a manner designed to protect the individual rights of all persons concerned, both accused and accuser. We hold that individuals may settle their differences outside the jurisdiction of the courts, if both so agree. Until such time as persons are proven guilty of crimes, they should be accorded full respect for their individual rights. We are thus opposed to reduction of present safeguards of the rights of the accused. Toward these goals, we advocate:

1. Full protection of the rights of the accused, including complete access to all records, information, or evidence connected with the charge(s) against him. Any person found violating these rights should be held

criminally liable,

2. Full restitution of loss incurred by persons arrested, indicted, tried, imprisoned, or otherwise injured in the course of criminal proceedings against them which do not result in their conviction by the accuser, be it a law enforcement agency or a private individual.

3. No individual should be detained or otherwise denied freedom of movement without formal charges being filed immediatley following his arrest. We advocate termination of all "preventive detention" procedures

all "preventive detention" procedures.
4. The removal of bail requirements. An individual awaiting trial should be held only when there is sufficient cause to believe that he would willfully avoid trial appearance or

commit injury to persons or property.

5. That no person should be tried for a crime without complaint of the individual whose rights were violated. In the case of murder or incapacitation of the victim, complaint of the victim would be assumed unless indicated otherwise by the victim prior to his demise or incapacitations.

6. The right to trial by jury regardless of the classification of judicial pro-

cedure.

7. An end to the practice of plea bargaining and all other procedures which obscure the course of justice.

8. The repeal of all laws establishing any category of crime applicable to minors for which adults would not similarly be answerable, and an end to the practice of jailing children accused of no crime. We further advocate the abolition of a separate juvenile court system.

9. Enactment of legislation which would enable a judge to permanently remove an "habitual" criminal from free society.

10. That no person convicted of a crime should be allowed to escape justice soledy due to judicial error, but may seek restitution for such violation of his individual rights in a separate legal action.

TAXPAYERS RALLY DRAWS THOUSANDS

APRIL 17, 1977 (North Arlington) Income Tax Repeal Rally II was held as planned by the coalition of taxpayer's groups, including the New Jersey Chapter of the National Taxpayer's Union. NJNTU co-sponsored the event at the State House in Trenton, New Jersey, on Saturday, April 16, 1977. Several thousand taxpayer activists from throughout the state met, exchanged views, and vocally expressed their demand that New Jersey's "temporary" state income tax be repealed immediately and permanently.

The program was structured as a "Town Meeting" with a Town Crier, and a messenger on horseback delivering the demands to Governor Brendan Byrne's luxurious mansion in Princeton, some 10 miles from the State House. After approving continuing united taxpayer's action against what was labelled "extortionate taxation", the event went on to a mock trial of the four politicians (including the Governor and Chief Justice) who were most responsible for the doubling of taxes in New Jersey in the past decade. The men were found guilty and sentenced to carry the Rally's petition to the State House doors. The "Governor" also got a well-deserved pie in the face. Winding up a peaceful demonstration, the Town Crier exhorted all present to persevere in the fight against "Tax Slavery".

The NTU Chapter, in cooperation with United Taxpayers of New Jersey, arranged to have the proceedings filmed under the direction of John W. Doswell, multi-media producer of New York City. It is expected that the film will be the basis for a planned documentary regarding the National Taxpayers Rights Movement.

An NJLP State Committee meeting was held on April 13 at the home of Kathy McAdam. Among the topics dealt with were the nomination of Mike Fieschko for assembly in the 17th district, which was approved by the Screening Committee.

The purchase of the film, "The Incredible Bread Machine" was mentioned, at a cost to the party of \$190, including shipping charges. Ken Kaplan offered to lend the money

to make up the difference in cost.

The convention for next February was discussed, with the request for volunteers to chair a committee. The date suggested, February 11, was unanimously passed. The voting for the committee chairperson of the convention will take place at the general meeting.

County Fairs were discussed. Also, the exploration of procuring a tent in which we could show the "Incredible Bread Machine" was talked about. A motion was passed to create a state fair taskforce.

Bylaw changing was mentioned in regard to party membership and will be voted on at the next general meeting.

Party fund raising possibilities were discussed with a number of ideas for obtain-

ing funds suggested. Cal Beatty suggested that we need issue development for the coming campaign. He distributed and discussed an alternative state budget put out by the Taxpayers Association. He asked for input on where to calculate

address reduction attempts. Bob suggested doing a citizens response to the budget and reducing the budget by repeal of the T. & E. and expiration of the income tax.

Other items, Mike Fieschko agreed to coordinate the petition drives, with the filing of petitions by April 25 for Dr. Primich.

FROM THE OFFICE OF FRANK PRIMICH FOR GOVERNOR

RESTORATION OF THE TWO PARTY SYSTEM

Advocates of the Two Party system have great arguments on behalf of their contentions.

Using Europe with such examples as Italy, France, and England makes multi-party politics appear to be a formula for chaos. The ancient Asians and the emerging Africans offer little hope for any stable system. Russia and its satelites are gruesome examples of declared One Party government.

A Two Party system sounds great. I wish we had one here.

The American Public has been led to believe that there is a choice on Election Day. Actually, you are asked to pick between a Demlican and a Repubocrat. Your great American prerogotive is to try to vote out the encumbent before he becomes too firmly entrenched.

To justify the power, size and cost of government requires a never ending series of crises. Many such crises never really existed, but were merely projected by distortion of fact and exploiting the public's fear of the unknown. The real crises, when analysed, can inevitably be traced to governmental ineptitude and intrusion.

In time of crisis we often hear that reassuring term Bipartisan. It ironically implies that rather than playing politics, as is their custom, they will honestly address themselves to the problem at hand.

Ever increasing public awareness of the pervasive curruption that exists at all levels of our present government is creating a crisis for the politicians. Their response is a variation on the bipartisan theme. The Election Reform Laws do little to resolve the existing problems. They do however, effectively limit any Third Party effort to alter the status quo. As a fringe benefit, they will now allow the oppressed taxpayer, who may be adamantly opposed to the policies of either party, the privelege of subsidizing their campaigns.

I advocate a real Two Party system. In one such Party that I shall designate statists, until they can find a deceptive psuedonym, I would put all those dedicated to Big Government or Big Brother. This grouping should include the Democrats, Republicans, Laborites, Conservatives, Liberals, Socialists, and Communists. Let them each work from within to advance their pet approach to confiscating the earnings of the American people, and redistributing those earning to their favored pressure group after extracting their customary exorbitant service charges.

In the Second Party I would group all those dedicated to limited government, and opposed to restrictions of individual liberties, both civil and economic. This would include Tax Protextors, wage earners, small businesspersons, Civil Libertarians, free-market advocates, home-owners, tenants, Medical private practicianors, Gay Libers, anti-establishment youth, draft opponents, floodplain victims, etc.

This Party would not require that I think up an appropriate name, for it already exists. It is called the Libertarian Party.

The afternoon events before the banquet are \$8.00 The banquet alone is also \$8.00



"The Mannings" by Fred Mustard Stewart Arbor House New York PP.648

This book is a powerful work of fiction that in some ways parallels an Ayn Rand novel. The story evolves around a determined individualist industrial climb to success. The biographical story of the hero sometimes borders on unethical means to a just end. The author clearly demonstrates the immoral behavior of business in its deals with government. The writer in his story, presents us with an interesting analysis of dollar diplomacy. He vividly portrays a debate that occurs in underdeveloped country; that being a clash between industrialization versus tradition.

The Hero, Mr. Mannings attacks Socialism by arguing that Socialism helps no one but the greedy bureaucrats, while Capitalism is also greedy, but you can get better and final results. Mr. Mannings portrays a heroic act by defending his property at the risk of being shot by a Union agitator. There are many

fine examples of Mr. Mannings defending his rights and lifestyles. At the risk of losing his son, he refuses to give in to blackmailers.

The Hero is not only determined in business but also in love. The Hero steers a straight course to marry the woman of his ideal. He excels in his choice. There is a bit of irony between the romance of Mr. Mannings' and that of his daughter. Mr. Mannings married a Jew and thus was subject to rampant anti-semitism that occured in France before World War II. This racism is exposed as being irrational. The reader is treated with some good historical and socielogical conditions that were present.

The style of writing is free flowing and in time sequence. If your interest lies in business, history, romance, or politics this book is for you.

CONTINUED FROM PAGE 2. VICTIMLESS CRIMES

We advocate the repeal of all laws creating "crimes without victims." We hold that it is never a proper function of government to p pass or enforce laws concerning personal conduct except in so far as that conduct constitutes a violation of individual rights. Victimless crime laws have generated crimes of violence, human suffering, anguish, and disrespect for law in catastrophic proportions. Victimless crime laws have exacerbated all of the various "social ills" they were created to prevent, and they have been the main cause of the most vicious and corrupting institution in America boday -- Organized Crime. Victimless crime laws have been enacted and enforced in violation of the most fundamental rights of individuals and have no legitimacy insta free and just society. Therefore, we advocate:

- 1. The repeal of all laws prohiting the cultivation, manufacture, sale, possession, or use of drugs, and the elimination of all medical prescription requirements for purchase of drugs, vitamins, and similar substances.
 - 2. The repeal of all laws regarding consensual sexual relations, including prostitution and solicitation, and the cessation of State oppression and harrassment of homosexual men and women, that they at last be accorded their full rights as individuals.
 - 3. The repeal of all law regulating
 - or prohibiting gambling.
 - 4. The repeal of all laws regulating or prohibiting usurious interest rates.
 - 5. The repeal of all conspiracy laws.
 - 6. The repeal of all laws interfering with the right to commit sucide, since such laws infringe the ultimate right of an individual to his own life.
 - 7. The use of executive pardon to free all those presently incarcerated for the commission of these "crimes."
 - 8. The repeal of all smuggling laws.

WISHART SPEAKS AT COLLEGE

Because of the publicity generated in Monmouth County during the last campaign, the Libertarians of Monmouth County were invited to send a spokesman to appear before a class at Brookdale College, Monmouth County's Community College, on March 23d. The appearance was videotaped for playback to other classes.

Ron Wishart represented the group and debated representatives of the Republican, Democrat, and Communist Parties. A full range of state and local issues were covered in the two hour discussion. As might be expected, the Democrat took credit for providing everyone with food, roads, parks, education, medical care, etc; the Republican said his party was for those things too, but not as much; and the Communist claimed it's the fault of those running dogs of imperialism that all these things hadn't been distributed equally. Ron reminded the class that any government created "right" to these things has to be paid for by someone and that means someone else's rights must be violated to transfer property from one individual to another.

His response to the others' call for regulation, controls, or nationalization of the "monopoly" oil and gas industry was that as unhappy as we might be with these companies, it's not a monopoly as long as many companies are competing with each other, but it certainly would be a monopoly if the government took them over. Then we would get oil like we get the mail.

At the end, a few students spoke with Ron and took literature, and three people signed the petitions. Ron summarized the Libertarian position by reading the pledge we take when we join the NJLP: "I hereby certify that I do not believe in or advocate the initiation of force as a means of achieving political or social goals."

The following week Bonnie Swirsky, Elizabeth & Jeanne Macron, Chris White, and Ron Wishart gathered signatures three times on campus.

Members take note: At the next general meeting, the members will be asked to vote on the following proposed bylaw changes:

- 1. To add the word "voting" in front of the word membership as it appears in the original bylaws regarding payment of dues. The purpose of this change is to permit the creation of a class of non dues membership to be available to all citizens who work and live in N.J. It is hoped that by doing so we will broaden our base of support.
- 2. To allow county chapters to designate someone other than their chairperson to serve on the State Committee.
 Two proposals have been suggested.

a. To have county chapters elect their state committee representative.
