County College, Candice Martinez; to put together a very professional and informative talk show. "Common Sense" airs weekly on Monday nights from 6-7pm and features a guest every week and a panel consisting of the other members of the show who question the guest and chime in with comments as Bobb directs the conversation.

So far the panel of "Common Sense" have hosted the NJ Libertarian Party Chair, Jay Edgar; the Chair of the NJLP Open Government Advocacy Project, John Paff; the Vice Chair of the Northeast Pennsylvania Libertarian Party, Lou Jasikoff; former Libertarian candidate for United States Senate, Jason Scheurer; Joe Goodman, a young Marine; and Fred Buehler, a real estate agent and small business owner. Each of these guests brought their own views to some lively debate while explaining just what libertarianism is as a political school of philosophy and just what the Libertarian Party does to bring this message from the people to the government.

There is already a full slate's worth of guests scheduled for next month. June 14th Dr. Roger Butler, a former CIA analyst and Chair of the Political Science Department at Rowan University will join the panel. Dr. Butler is a specialist in the Federal Government and the Presidency and will discuss the Constitutional role of the President as opposed to the many popular assumptions of and modern expansion of power in the role of the Executive. On June 21st Dr. Spencer Meredith, a political science professor at Rowan University and specialist in American foreign relations with Russia and former Soviet nations will be on the show to talk about the current political situation in Eastern Europe and Central Asia. On June 28th Candice Martinez will interview the Mayor of Gloucester Township in Camden County, David Mayer. Mayer was formerly an Assemblyman from the 4th Legislative District and head of the Democratic Party in Gloucester Township. He is employed as a professor of state government and public administration at Rowan University and as a lawyer for Comcast.

"Common Sense" often receives call-ins from listeners and even one walk-in. Several local businesses have purchased commercial airtime: Right Now Recording, Greentree Tobacco, Lumar Home Restoration and Landscaping, and The Political Emporium.com. There have also been several people who have donated personal funds to help keep the show going: Chris Feeney, Bill Kern, and Kevin Ferrizzi. All of these people and businesses have contributed to promoting the message of the Libertarian Party and the cast of "Common Sense" is thankful to each of them. Every show has been centered on the move toward less government and more responsibility as the key to attaining our freedom of thought and action. Unfortunately, not even these contributions are enough to keep the show going and much more help is needed. 
In Memorial

Julian Heicklen Released from Jail and All Charges Dropped

Libertarian activist Julian Heicklen was arrested on May 25th while distributing Fully Informed Jury pamphlets at the Federal District Courthouse in New York. He was originally charged with Resisting Arrest and Disorderly Conduct. Witnesses to the arrest saw no evidence of either count.

After being held on Riker's Island he was released on June 8th and all charges were dropped. The following is a message he sent after being released:

Hi Tyranny Fighters:

Because of circumstances beyond my control, I had to cancel my Las Vegas trip. I will not be at the Las Vegas, NV courthouse on Monday, June, 14, 2010, nor at the Burlington, VT courthouse on Tuesday, June 22, 2010. However I will be distributing FIJA Literature at the following courthouses on the following dates. Please join me to observe, take pictures, or participate.

You are welcome (encouraged) to join me to observe, take pictures, or distribute literature. I will provide the literature.

I have a person who contacted me about participating in Hartford, CT, and Springfield, MA. Jim Freeman contacted me about Boston, MA. Unfortunately, I have lost his contact information. If any of you know his Email address, please send it to me.

My cell phone is still in the possession of the NY city police. I can neither make, receive, not respond to *NJ Libertarian* telephone calls. I have not yet had a chance to read my 706 E-mails. If your E-mail requires a response, I will answer, but do not hold your breath.

I have been summoned to appear for jury selection on June 28, 2010, at the Bergen County, NJ courthouse. I am sure that I will be the only person there who wants to be selected to serve. If I can remember my own instructions and act dumb enough, I might be selected.

April Steering Committee Minutes

Chair Jay Edgar called the April 25, 2010 Steering Committee meeting to order at 1:14 pm in Tumulty's Pub, New Brunswick. Other committee members present were Kevin Ferrizzi, Ken Kaplan, Russ Conger and Emerson Ellett. Absent: Walter Luers and Joe Siano.

Secretary's report

The Convention business meeting minutes were approved.

Treasurer's report

The convention cost \$2714.40, at a net loss of \$645.28.

The party has \$5700 in the General Fund, \$480 in the Federal Fund and \$2500 in the State Fund.

Kevin has filed the required papers with ELEC regarding the party's newly elected officers.

A motion that "Monthly pledgers who donate at least \$60 per year to the General Fund will have their membership renewed automatically" carried.

On-going business

Newsletter - The March-May issue will go out within the next two weeks.

Membership - At present we have about 175 members. Joe Denise has agreed to take on the job of Membership Chair.

Candidate petitioning status:

Joe Siano has about 70 signatures. Jay will send petitions to Russ Conger. Derek Demarco: no report.

Radio show (1360 AM, Mondays 6-7 pm). The 4th show is scheduled to air April 29. A motion authorizing the NJLP to expend \$100 for the May show carried. Jay will archive the shows at <u>njlp.org/commonsense</u>

National Convention delegates

Jay is the NJLP's only registered delegate. Several proposed delegates are not members; Jay has informed them that the deadline for membership is April 30.

County organizations

At present there are three:

South Jersey (Gloucester, Camden, Burlington, Ocean) chaired by Joe Denise; there are no State Board representatives from the individual counties.

Mercer, David Trend, chair; no county rep.

Central Jersey (Somerset, Middlesex, Union) where there is no chair but Frank Warren is vice chair and rep from Somerset; Darren Young is Union rep.

Mike Lewin is beginning to organize North (Hudson, Essex, Passaic, Bergen). The unorganized counties are Monmouth, Sussex, Warren, Hunterdon, Morris, Atlantic, Cape May, Cumberland and Salem.

New business

Picnic (Saturday July 17). Two venues are under consideration.

Legislative action committee. Jay proposed developing Tools for Citizens, such as how to recall officials, providing sample recall petitions, how to deal with property tax assessments.

Third party coalition

Jay has attended some meetings of a newly formed Third Party Coalition, but has made no commitments.

The next meeting. The State Board is scheduled to meet June 6 at 1 pm inTumulty's Pub, New Brunswick.

The meeting was adjourned at 3:19 pm.

2010 National Convention Report

The 2010 Libertarian National Convention was held over Memorial Day weekend.

The convention was very well attended. There were about 100 more delegates than the last non-Presidential convention. (I believe there were somewhere over 530 delegates attending) Unfortunately the New Jersey delegation was much smaller than what we were allocated. We had four delegates, myself, Kevin Ferrizzi, Dan Karlan, and Tim O'Brien. I strongly recommend that our members attend our National Conventions and regret that we had not started earlier in promoting the convention and finding delegates who would want to go.

Most of Saturday was spent discussing bylaws changes. Dan Karlan, as chair of the bylaws committee, presented the proposals to the delegates. Some interesting ones are summarized here.

There was a proposal to allow electronic vote tabulation. The proposal provided safeguards against malfunctions or fraud. The proposal ensured paper copies, paper receipts and the ability and mechanism for manual recounts. I supported this proposal. However a group of vocal paranoid Luddites pressured the body into a NJ Libertarian

negative vote with chants of "Diebold". Later during the lengthy Chair voting many wondered if this was the correct choice.

Prior to the convention, one of our members felt that the members who were not going should still be able to vote in some way on issues at the convention. A bylaws proposal was presented that would allow for mail in ballots for bylaws changes. I had originally supported this proposal, but after hearing discussion and thinking about it, I ended up voting against it. During discussion the cost was one issue that was brought up. Another, and the reason I voted against it, was the lack of a debate opportunity or the ability to hear argument made by other delegates. Even though I had read through many of the proposals and come to a conclusion already, the discussion that ensues by the delegates during a convention is invaluable and had changed my mind on several issues. This proposal failed. Perhaps the correct way to do this is to have software that lets you attend as a delegate remotely. This software would need to be able to stream the convention discussion, ensure your credentials, and allow you to vote at the same time as delegates who are present. Even this solution is not perfect. There are many individuals at the convention who are lobbying for or against candidates, platform changes, or bylaws changes and handing out fliers and promotional materials. In addition, the personal discussion that we have at the convention is invaluable in making correct and educated choices.

Dan presented the possibility that if our presidential candidate was ever to achieve 5% of the vote, the candidate four years later would be eligible for matching funds. Even though our party does not support taxpaver funded campaigns, we have no power to stop our candidates from accepting such funds. He pointed out that this puts us at risk of a takeover by a non-libertarian faction. (At this point someone in the crowd had a coughing fit that sounded much like name of the lovable elephant in the children's cartoon series Babar.) The proposed solution was to only allow delegates to vote on our presidential nominee if they were members prior to the previous Presidential general election. This was found unacceptable to the delegates because it disenfranchised new members and trumped the rights of the state affiliates to select delegates. The proposal failed.

On Sunday we spent the morning debating Platform changes. The most controversial was a watering down of 3.4 Free Trade and Migration. The Platform committee made two separate recommendations. The first one strengthened our platform by adding the word credible to:

However, we support control over the entry into our country of foreign nationals who pose a credible threat to security, health or property.

This change passed by a large majority. This should stop future embarrassments like the when Ronnie Ferguson issued a press release under the LP name demanding a round up of immigrants during the swine flue panic.

The second proposed change was rather outrageous and very unlibertarian. It removed text that stated that government should not constrain the flight of individuals escaping tyranny. It watered down the definition of economic freedom by removing the recognition of the market exchange of human labor as deserving of protection. It also added some nonsensical language about those "not requiring public assistance" being welcomed into our country (perhaps meaning that there are people who require public assistance?). After a spirited debate, this change was voted down by a large margin.

Immediately after lunch I took the floor and made the following motion:

I motion to suspend the rules to have the delegation adopt the following resolution:

The delegates of the 2010 National Libertarian Party Convention demand the immediate release of libertarian activists Julian Heicklen and George Donnelly. We further urge that the federal government cease harassing peaceful activists and respect the right of free speech.

I had not expected the response I received. I had to pause after the first sentence until the cheers and applause died down before I could finish the rest of the resolution. I had expected most delegates to not know what I was talking about, however almost everyone there were already aware of Julian's and George's plight. I spoke to the motion. One gentlemen, Sam Sloan, spoke against it. Oddly he introduced himself as being the person contracted to publish Julian's book. He argued that Julian had broken a rule (distributing literature near a courthouse) and that Julian would just get himself arrested again. The crowd booed him down. The resolution was brought to a vote and was supported by almost everyone.

The Libertarian National Committee chair's race occurred on Saturday afternoon. There were three rounds of voting. The first round of voting had Wayne Root leading with 200 votes, followed by Mark Hinkle with 113, Ernie Hancock with 82, Myers with 70, and George Phillies with 55. (None of the Above had 10) Our delegation was split evenly between Wayne and Mark. George was automatically removed at this point. Myers volunteered to drop out and asked his supporters to vote for Mark Hinkle.

At this point it became apparent to me that Hinkle would most likely win the election. Wayne Root represents the "big tent" libertarians. He wants us to be less pure when it comes to freedom in exchange for more supporters and votes. Every other candidate represented the "principled" libertarian, who would never compromise on our beliefs in an effort to become elected. So even though Root was in the lead I did not see him getting many votes from anyone else.

The second round of voting had Root at 223, Hinkle at 210, and Ernie Hancock at 87. (NOTA had 9 votes). The NJ delegation remained evenly split between Wayne and Mark. At this point Ernie Hancock was removed from the ballot. Mr. Hancock is a very good speaker and is very principled libertarian. However he often expresses kooky 911 conspiracy theories. For this reason, many (and myself) would not support him. He was originally my first choice, however after hearing his 911 truth nonsense I dropped my support.

The third and last round of voting had Mark Hinkle at 281 and Wayne Root at 228 (NOTA had 19 votes). Our delegation had changed our voting at this time with one delegate deciding to support Mark having us at three for Mark and one for Wayne.

In my opinion Mark Hinkle was the best option and will make a good chair. The Barr nomination introduced a split in the party between the Compromisers and the Purists. This split has cost the party members, however was the reason so many libertarians attended this off year convention. Mark Hinkle's election will go a long way to repairing this rift and bring the Libertarian Party back to its principles.

Happily, this Convention represented a return to principled libertarianism and a rejection of the rightward drift of our policies. This was evident in the vast numbers of delegates who refused to compromise on immigration, non-interventionism, and in the support of Mark Hinkle for chair.

Also elected Sunday were Mark Rutherford as Vice Chair, Alicia Mattson as Secretary, and James Oaksun as Treasurer.

I left early on Monday. During Monday's session the At-Large members were elected. Those elected include Kevin Knedler, David Nolan, Bill Redpath, Wayne Root, and Mary Ruwart.

Save Ginny!

Longtime NJLP activist Ginny Flynn must go to Germany to get special medical treatment to try and save her life. She was diagnosed with a rare and lethal cancer Leiomyosarcoma in January 2010. Thanks to the federal Food and Drug Administration (FDA) and other medical restrictions she and her husband (currently dormant NJLP Newsletter Editor) Len have to travel to Prien Germany for the treatment.

The treating physician Rigdon Lentz, MD is an expatriate American doctor driven out of the USA and prosecuted and fined by FDA for botching the clinical paperwork requirements for his cancer treatment device. The "immunepheresis" device removes blockers that cancer cells have to hinder the body's immune system (Tumor Necrosis Factor [TNF]). It is approved for sale in the European Union but not here in the USA.

Contemporary American sarcoma treatments lack any curative likelihood. Current chemotherapy and radiation options give at best a few months of tumor suppression not any remission of the disease. Of course, health insurance pays only for these deficient "approved" treatments and the more experimental yet promising techniques require private funding. One month of Dr. Lentz's therapy costs 51,000 Euros and compares to USA chemotherapy (about \$5,600 per **day** for drugs/doctor/lab etc. at Memorial Sloan Kettering Cancer Center in Manhattan).

On Saturday, June 12, 2009 Ginny was admitted to Riverview Hospital with a hemorrhagic stroke. She is conscious and able to communicate, but her condition remains serious. The stroke likely arose from use of heparin begun 10 days earlier to combat a blood clot ("deep vein thrombosis" or DVT) found in her iliac vein. The DVT apparently arose from chemotherapy not the cancer.

Ginny was the Editor of the New Jersey Libertarian for a dozen years in the 80s and 90s plus she ran as a Libertarian candidate for U.S. Congress, Freeholder, and Governor (1985?). She attended several national LP conventions as a delegate from New Jersey along with her husband Len. She has been the school secretary for a private elementary school in Holmdel for many years. Lately she has enjoyed her two grandchildren Evie (3) and Tommy (6 months). Ginny and Len will have been married 43 years in August.

Ginny has helped her family & friends, the libertarian movement, and private education for most of her life. Now is the time for you to help her. Please monitor developments and plan to attend a testimonial dinner plus support a fund-raiser this summer to help her.

Proposed By-Laws Changes

The following bylaws changes will be considered at the July 17th General meeting:

Proposal #1: The Bylaws and Rules Committee proposes to add definitions of Bylaws and Platform Committees. Under Meetings and Committees, we propose inserting **6e Bylaws Committee** and **6f Platform Committee**, with the following short paragraphs for these, respectively:

6e Bylaws Committee

The Bylaws Committee shall consider proposals for amendments to the NJLP Bylaws, Convention Rules, and Business Rules, and report to General Meetings. The Chair of this Committee shall be chosen by the members of the Committee. Any member who fails to participate for three (3) consecutive meetings shall be dropped from the Committee. Meetings may be held by teleconference. Agenda preference at General Meetings is to be given proposals that have been considered by the Bylaws Committee.

6f Platform Committee

The Platform Committee shall consider proposals for amendments to the NJLP Platform, and report to General Meetings, though actual changes may be made only at the State Convention. The Chair of this Committee shall be chosen by the members of the Committee. Any member who fails to participate for three (3) consecutive meetings shall be dropped from the Committee. Meetings may be held by teleconference. Agenda preference at General Meetings is to be given proposals that have been considered by the Platform Committee.

Rationale: the critical parts of both these paragraphs is the empowerment of the Committees to conduct business by teleconference or video-conference. It must be specified how the Chairs of those committees are chosen, and we have discovered through experience that attrition erodes the Committee membership.

Proposal #2: To address the problem (created in November 2003), prevent the Steering Committee from nullifying a Rules adopted by the State Board, and similarly prevent the State Board from nullifying a Rule adopted by a General Meeting.

We propose deleting the entirety of Business Rule under 15: Amendments and instead adding the following to Bylaws Article 15: Amendments, as new sections e and f:

e. Any Business Rule may be suspended, rescinded, or amended by a majority vote of a body that is larger than the body that adopted it. Any Business Rules may be suspended, rescinded, or amended by a two-thirds (2/3) vote of the body that adopted it. No Business Rule may be suspended, rescinded, or amended by a body that is smaller than the body that adopted it.

f. All Business Rules shall be regarded as having been adopted at a General Meeting, with the following exceptions:

1. Fiscal Policy provisions have been adopted by the Steering Committee

2. County Organization Dues Share provision has been adopted by the State Board.

Proposal 3: Requiring a County Representative to submit the name of a designee to substitute for him in the event of an absence is too limiting in this age of electronic communication. Allow such notification by e-mail, too:

Article 6, Section c, sub-section g: Change "in writing" to "in writing or by e-mail" in the second sentence.

Proposal 4: We eliminated Budget membership category some time ago, but there's a vestigial reference that should be removed:

Business Rule 9, Section b, remove the last sentence ("Budget members will receive their 4 newsletter issues in January, March, June, and October.")
