MEETING

Over 20 people attended the May 18th meeting of NJLP. Andrea Millen, chairman of the Free Libertarian Party of New York, delivered a short message, exhorting members of NJLP to "find something for themselves" in the party, while Paul Streitz, FLP candidate for Councilman-At-Large, discussed the "merchandising" of libertarian ideas and candidates.

The gubernatorial campaign was outlined by Lydia Longinotti- about four press conferences will be held by Goodson to formally announce his candidacy, and explain in detail his position on selected major issues (Ecology and the Energy Crisis, Crime and the Judicial System, and Taxes). Joe Salerno, John Biddle, and Fred Stein volunteered to do research for the position papers. Larry Totams will be in charge of fundraising for the campaign, while Jane Rehmke and Robert Steiner will cooperate to answer TV editorials. Joe Salerno will continue in his platform capacity to review Goodson's positions on the various issues for the party.

In other business, Don Meinshausen resigned as Treasurer and was replaced by Larry Totams. Election of delegates to the LP convention was judged unnecessary since we have been advised by LP that there will be no "voting" issues. We hope to have some good eyewitness reporting on the convention for the July PREMISE from the several NJLP members who will be attending.



NO NOOSE IS GOOD NOOSE?

The question of the acceptability of capital punishment is a tough one for libertarians who, while viewing murder as the most horrible use of force imaginable, are reluctant to grant representatives of the victim (be they government or otherwise) the right to "vengance". One reason cited is that force is justifiable only in defense of rights, and the victim's right to life can no longer be defended. Another is that justice is confined to retribution, and a dead man can not be recompensed. The question can be dealt with, however, in another manner.

First, a hypothetical situation. While leaving the Golden Nugget Saloon, Matt Upright is shot in the back by Black Bart. Dying, Matt turns and draws his own revolver and aims it at Bart. Upright knows he's a goner; he is not, therefore, defending his life. Does he have the right to pull the trigger- to "drag Bart down with him"?

Common sense says yes, but why? The answer is that an implicit offer has been made by the agressor to deal on a different moral plane than the rational. Bart has declared his willingness to "do business" with Upright on the terms of savages – Upright, through his own actions or those of his representatives, may respond to the invitation or not, as he wishes.

Apart from solving the purely pragmatic problem of what to do with murderers, there is a moral just-ification for capital punishment- the right of a person, directly or through his agents, to enter into an arrangement offered by someone else. That's why, in all those movies, Matt Upright always says (just before pulling the trigger)..." If that's the way you want it...."

An appeals court in Trenton ruled that the state does not have the right to reduce welfare payments to a woman when her boyfriend moves in with her.....Jane Rehmke is trying to organize a libertarian "flea market" to raise money for the campaign. She's looking for a good location, trucks or station wagons, and junk to sell.
