HOSPERS ADDRESSES NJLP!

Nearly 50 people attended the October 20th meeting of NJLP, and heard Dr. John Hospers deliver an extended talk on the problems caused by government.

Hospers began by discussing the effects of rentcontrol, pointing out that New York City, which has retained rent-control since WWII while most other cities have dropped it, has the worst housing problem in the country. On inflation, he noted that in 1972, the government increased the money supply by about 9%, and then blamed everyone but themselves for the resulting inflation. Hospers said that the energy crisis is real and phony - that there is a long-range crisis (which technology can, if left unhampered, deal with) and a short-range crisis which is man-made. Government policies have discouraged oil companies from expanding production, specifically in the area of refineries where no building has been done recently because of possible government intervention. Pollution controls which make engines less effecient have contributed to the problem, Hospers said. He described a recent trip to Alaska where the people are incensed over government restrictions on their oil production. He said the pioneering spirit is very much alive there, and that a small secessionist movement has attracted considerable attention.

Hospers called for the legalization of gold and repeal of legal-tender laws, and pointed to 3 factors in the growth of government:

- (1) the politicians' lust for power,
- (2) the public's desire for "security" and "free" services,
- (3) educators who cater to the state.

Of these, Hospers said the educational establishment is the worst enemy because of their influence on the young, and their promotion of the view that the bureaucracy is doing good things.

Hospers closed with a moving account of a speech he gave to a philosophical society in Iowa, his home state. The speech concerned "Liberty", and while the predominantly Marxist philosophers were dumbfounded at what he was saying, his friends and relatives could not understand why anyone should have to go to college to learn such obvious truths. Hospers assured them that he had not learned about freedom in college.

In an extended question and answer period, Hospers said that he thought the present conflict between anarchists and minarchists was silly, since 'we are on a train hurtling toward 1984, and we should be turning it around before we worry about how far back we want to go'. In response to another question, Hospers said that the first thing he thought a libertarian president should do would be to free the economy. He blasted the 'established rich', like Nelson Rockefeller, saying that Rocky had moved from spending his father's money to spending the taxpayers', and decried the fact that these same people had set it up now so that no one else could amass the fortunes which they had inherited.

It was a most exciting afternoon, and we are indebted to Dr. Hospers for sharing his time and genius with us.

NOTES.....In a poll taken by the Home News on the gubernatorial election (80 people polled), Goodson was the only minor party candidate to get a vote.....Editorial replies to the endorsement of Brendan Byrne were taped by Lydia Longinotti and broadcast by WCBS-TV and radio in New York, and by WCAU-TV and radio in Philadelphia (the CBS affiliate). All replies were similar to the radio speech on CBS, a copy of which is enclosed....WNEW-TV channel 5 in New York guoted John Goodson at the beginning of their late-night program on the minorparty candidates. Goodson said he would not attend because the show would be a "zoo-o-rama". A reporter for the Hackensack Record apparently agreed, writing that "perhaps John A. Goodson, the Libertarian party candidate, showed the most insight ...when he refused to appear"......Goodson's contract was released to the press about two weeks before the election (see last page of PREMISE).... David Barg, student at Princeton, addressed Political Science Class at Somerset County College on Goodson and libertarianism..... Kay Harroff, chairman of Ohio LP, has declared for Senator in '74, and needs 10,000 signatures by Feb. 6 to get on the ballot (she currently has 1,350).... Newspaper ads for Goodson are planned for two daily NJ papers before the election.....Goodson was interviewed by Home News, and by students of Rutgers and Ocean County College (one interview for Rutgers on videotape).

Not the lesser of two evils

Since the upcoming gubernatorial election is the first chance I have to legally vote, I had hoped I would have the chance to be able to make an intelligent and informed distinction between honest and responsible candidates of the major parties. On the afternoon of Wednesday, October 3, I saw and heard gubernatorial candidate Brenden Byrne speak to a group of Rutgers' students. Although I admittedly went to the meeting with preconceived notions, Mr. Byrne. instead of dispelling those ideas in my head, merely confirmed them.



Candidate offers voters

NEW BRUNSWICK - The Libertarian Party's gubernatorial candidate has offered New Jersey residents a contract that would legally bind him to the positions he has taken during the campaign.

"Politicians should be just as responsible as anyone who sells a service," John A. Goodson said. "But it seems the 'truth-in-advertising' laws have overbooked them."

The contract, which can be obtained from the party at a cost of one dollar, provides space for the signatures of Goodson and a witness.

It specifies eight planks in the party's platform, including repeal of the sales tax, repeal of all anti-pornography laws, and laws prohibiting gambling, and elimination of all subsidies to industry.

The contract specifies that Goodson will "make no statements nor take any actions in my official capacity as governor which would contradict" the platform.

"I further agree that, should I be found in any court of , competent jurisdiction to have violated this contract, I will immediately resign my position the contract as governor."

(In a recent editorial, WCBS NEWSRADIO endorsed Democrat Brendan Byrne for Governor of New Jersey. Here with a reply to that editorial is Lydia Longinotti, Campaign Manager for John A. Goodson, the Libertarian Party candidate in that race.)

The WCBS endorsement of Mr. Byrne lauds him as being flexible and pragmatic, but what that really means is that he has no principles whatever.
