## SIANO TAKES OFFICE

The sky was overcast and rain pelted the fallow fields of Kingwood. But despite the gloomy clouds overhead, a ceremony in the little white former one-room schoolhouse, which is now the township Municipal Building, marked a new dawn in New Jersey politics.

It was January 1, 1982 and the Township Committee's annual reorganization was the focus of attention. The meeting lasted barely 40 minutes, but it was apparent soon after starting that Committeeman Richard Siano would be a force to be reckoned with for the New Year.

Despite the expectation that the Libertarian Party's breakthroughs would come in the West, Siano became the first Libertarian to be elected in a partisan race outside Alaska when he defeated Democrat Andrew Madaychik, a former mayor, in a special election held on Dec. 29. In the Nov. 3 general election, Siano and Madaychik had tied with 308 votes each, and Republican Mayor Sam Leon trailed with 225. In the special election, the Libertarian scored an impressive 383-208 win over the Democrat. No GOP candidate was nominated, but Leon managed to get 24 write-in votes.

Siano showed his commitment to the principles enunciated during his campaign with his very first vote--a "no" on the election of Committeewoman Jane Bainbridge as the township's first woman mayor. Both before and after his first vote, Siano indicated that he could not, in good conscience, support Mrs. Bainbridge because of her avid promotion of property tax revaluation--Siano's biggest single issue

## National LP Chairwoman Alicia Clark

LP National Chair Alicia Clark has confirmed that she will attend NJLP/10, the 10th Anniversary Convention of the N.J. Libertarian Party, March 12-13 at the Beacon Manor Hotel, Route 35, Point Pleasant Beach. Alicia's husband Ed was the LP's candidate for President in the 1980 election, where he received nearly one million votes.

Other Libertarian leaders confirmed to attend NJLP/10 include Kathy Jacob, National Director of Students for a Libertarian Society, Don Ernsberger and Dave Walter, co-founders of the Society for Individual Liberty, and our own Dick Siano.

during his hard-fought campaign. He refused to bow to expediency despite his "minority of one" status.

Not everything at the reorganization went against Siano, however. Mayor Bainbridge found herself in the minority position as Committeeman Allan Niebuhr joined the Libertarian on several votes: Siano's choice of Ryman Herr for Township Attorney was approved 2-1, with Mayor Bainbridge opposed. Considering the fact that Siano had been elected only three days before reorganization, Niebuhr proposed that some appointments be delayed for further study. Mayor Bainbridge disagreed--another 2-1 victory for Siano.

The Libertarian Committeeman won delays in appointments for Recreation Director, Fire Marshal, Construction Code Official and Municipal Court Prosecutor--all by 2-1 votes.

Township Committee meetings have been poorly attended, and poorly covered by area newspapers, because they were held on the third Friday of each month. At Siano's urging, the meeting date was changed to the third Monday (at 8 p.m.). Mayor Bainbridge reluctantly agreed. A 3-0 vote to change the meeting date!

With the apparent split on the Township Committee, 1982 should be an interesting year in Kingwood. And with Mayor Bainbridge's term up this year, back-to-back victories for the Libertarian Party can't be ruled out. Siano has three years to show that libertarian principles can be applied at the local level. He could use a little moral support from us just by attending the Township Committee meetings once in a while.

## COMMITTEE MEETINGS

## State Committee

On December 12, 1981 the NJLP State Committee met to discuss plans for 1982. Present were George, Siegel, Flynn, Swirsky, Furlong, Steele, Hurley, and John Schafer for Siano. Absent were Shapiro, Rothhouse, Lofgren, and Short.

The committee considered an offer by National LP Chairwoman Alicia Clark to conduct a fund-raising solicitation at the NJLP convention with proceeds to be split in half between national and the state party. The NJLP would have to pay all her expenses, including half her air fare from California. The Committee unanimously voted to decline her offer, in order to raise the funds independently for the NJLP.

The State Committee then unanimously endorsed the present editorial policy of the New Jersey Libertarian to "avoid personal attacks in the newsletter." The committee noted that all NJLP members can communicate with other members at their own expense by requesting a copy of NJLP members' addresses. The intent of the motion was "to avoid the waste of party resources in interpersonal feuds."

The Committee accepted Ginny Flynn's resignation as NJLP Speakers Bureau coordinator. Anyone interested in serving in this role should contact Bill George at 201/462-2504 (days) or 654-3954 (evenings).

Discussion of strategy for 1982 produced two suggestions for Libertarian candidates. First, school board elections, though nonpartisan, had three advantages for libertarians: low expense, no financial disclosure, and no salary if elected. At the meeting two NJLP members announced their intentions to run for local school board.

Second, Jonathan Steele and John Hurley will solicit NJLP members who are willing to run for any office. The Committee felt that candidates should be located first then a strategy may be formulated if desired.

The meeting concluded with a vote to fill the At-large vacancy on the Steering Committee. John Schafer was chosen over Tom Palven. None-of-the-Above was crushed to find he (?) received no votes whatsoever. (Maybe next election ...)

## Steering Committee

The NJLP Steering Committee met on January 16, 1982 with George, Siegel, Swirsky, Flynn, Schafer, and Furlong present and Shapiro absent. NJLP Treasurer Swirsky presented a report on 1981 NJLP income and expenses, and she announced a balance of \$333.65 in the NJLP account.

The proposed NJLP Bylaws were received from the Bylaws Committee and several amendments were made. The Steering Committee then unanimously approved the amended Bylaws. These Bylaws (enclosed with this newsletter) will be voted upon by the NJLP membership at the 10 AM business meeting on March 13 at the NJLP convention in Point Pleasant.

The meeting ended with Les Heller appointed as Director of Internal Education for the party. Anyone interested in this effort should call Les at 609/758-2082 or 7440.

### 1. NAME

The name of this association shall be the New Jersey Libertarian Party, hereinafter referred to as "NJLP," and the association shall be incorporated under Title 15 of the laws of the state of New Jersey.

### 2. PURPOSE

The purpose of the NJLP is to organize the means for promoting Libertarian ideas and institutions.

### 3. MEMBERSHIP

A. Membership is open to anyone who lives or works in the state of New Jersey who certifies in writing that he or she does not "believe in or advocate the initiation of force as a means of achieving political or social goals." Thereafter, such a person shall become a member upon payment of dues.

B. Members shall be furnished, upon request to the Treasurer, a copy of the membership list at reasonable cost of reproduction, provided that the private list may be used only for official NJLP business and may not be disclosed to any other organization or non-member individual.

C. No member may spend or commit NJLP funds except as authorized by the Steering Committee, State Committee, or a General Meeting.

D. All NJLP officers, Steering and State Committee members, and other NJLP officials must be NJLP members.

### 4. MEETINGS & COMMITTEES

#### A. General Meetings

1) General Meetings may be called by the State Chair, Steering or State Committees, or by 10% of the entire NJLP membership plus five members.

2) At least two (2) weeks written notice shall be given for a General Meeting. General Meetings may be called as often as the notice requirements are met.

3) Any decisions made by the Steering or State Committees may be appealed to the next General Meeting, where it may be overturned by a two-thirds (2/3) vote, except that no valid financial commitment made by the Steering or State Committees shall be repudiated.

4) A 2/3 vote at any General Meeting may remove any person from office in the NJLP, provided that notice of consideration of the removal of that person from office was included in the written notice of the General Meeting.

#### B. State Convention

1) Full authority shall be vested in the State Convention, which shall be held once a year, no earlier than February 1 nor later than March 31, at the call of the Steering or State Committees.

2) Delegates to the State Convention shall be chosen in accordance with written procedures which have been approved, without modification, by a 2/3 vote at two consecutive General Meetings. In the absence of such procedures, each member shall be deemed to be his or her own delegate without privilege of proxy.

3) The Officers, three Trustees, and three Steering Committee at-large members shall be elected by the State Convention.

4) The State Convention shall have the sole power to set dues and to adopt the NJLP platform.

5) There shall be no charge to members for participating in the business session of the State Convention.

6) Candidates for statewide office shall be nominated at the

State Convention. In the absence of approved procedures for selecting candidates for other offices, such candidates may be nominated by the delegates.

#### C. Steering Committee

1) The Steering Committee shall consist of the NJLP Officers and three at-large members elected by the State Convention for a term of one year, plus any additional members chosen by petition.

2) The Steering Committee shall have full authority to act for the NJLP between Conventions and General Meetings. The Steering Committee may approve expenditures, draft positions, select candidates after the annual State Convention, and recommend the creation of County Committees. It shall also give advice and consent to the appointments made by the State Chair as provided herein.

3) The Steering Committee shall meet at the call of the State Chair or 25% of its members. At least 10 meetings per year shall be held, some of which may be joint meetings with the State Committee.

4) At least ten (10) days notice shall be given for all meetings, but lesser notice shall suffice if all members agree.

5) Each voting NJLP member or delegate at the State Convention shall cast one vote for one, two, or three candidates for at-large member. The three candidates with the highest number of votes shall be elected with ties broken by run-off elections among those tied.

6) A Steering Committee member may designate in writing an alternate for a meeting which the member cannot attend, and this designee shall count toward the quorum. The alternate may vote if the other Steering Committee members approve.

7) Steering Committee members chosen by petition shall be NJLP members who assume their posts by filing with the Secretary a dated petition of appointment signed by at least 10% of the entire NJLP membership plus five (5) members. No member may sign more than one such petition at one time, and the member may remove his or her name at any time. Any Steering Committee member by petition whose support falls below the level noted above, whether by loss of signatures or growth of the NJLP, shall be notified and have until the next General Meeting to obtain sufficient signatures or else cease to be on the NJLP Steering Committee.

#### D. State Committee

1) The State Committee shall consist of the Steering Committee and additional members selected by the County Committees.

2) The State Committee shall have the authority to fill any offices or at-large Steering Committee member vacancies.

3) The State Committee shall meet at the call of the State Chair or 25% of its members at least four (4) times a year, some of which may be joint meetings with the Steering Committee. At least ten (10) days notice shall be given to each meeting, but lesser notice shall suffice if all members agree.

4) County Committee representatives to the State Committee may be selected by any procedure acceptable to county committee members which is consistent with these Bylaws. Each county is entitled to one State Committee member (not counting Steering Committee members).

5) The State Committee may act for the Steering Committee at their joint meetings, unless the Steering Committee members specifically vote otherwise.

### 5. OFFICERS

The NJLP Officers shall consist of the State Chair, Vice Chair, Secretary, and Treasurer. They shall be elected at the State Convention for a term of one year.

A. The State Chair shall preside over all NJLP meetings; be general spokesperson for the NJLP; execute all resolutions by the

Steering and State Committees, General Meetings, and the State Convention; create and appoint standing and special committees (subject to the approval of the NJLP Steering Committee); and appoint or remove the Party Counsel and Newsletter Editor, both actions subject to the approval of the Steering Committee.

B. The Vice Chair shall assume the duties of the State Chair in that person's absence and generally assist the State Chair.

C. The Secretary shall maintain, record, and report minutes of all meetings, including the State Convention; carry out other such duties as directed by the State Chair; and assume the duties of the Chair if that person and the Vice Chair are both unavailable.

D. The Treasurer shall maintain and make available proper financial records and report them to all meetings; prepare and submit any government or other financial or tax reports as required; maintain the NJLP membership list; and prepare and mail renewal notices.

## 6. TRUSTEES

Three Trustees shall be elected, one at each State Convention, for a term of three (3) years. The Trustees shall have only that authority which is granted to the trustees of corporations not for profit under the laws of the State of New Jersey. Any NJLP member, including any officer, may be a Trustee.

## 7. OTHER OFFICIALS

A. Party Counsel, who must be an attorney in New Jersey.

B. Newsletter Editor

## 8. AFFILIATIONS

A. The NJLP shall be affiliated with the Libertarian Party.

B. Any officer or NJLP official shall be deemed to have resigned if he or she is a candidate for office representing any political group other than the NJLP.

C. All NJLP candidates shall run under the designation "Libertarian Party" in partisan elections.

## 9. COUNTY COMMITTEES

A. County Committees must be approved by both the NJLP Steering Committee and a General Meeting. Ordinarily, the NJLP shall recognize a County Committee formed at a County Convention attended by at least 25% or a minimum of 10 (whichever is lower) of the NJLP members in the geographical area the Committee proposes to represent. However, recognition may be refused by a majority vote or withdrawn by a 2/3 vote of any General Meeting. Conversely, any County Committee not meeting the above Convention criterion may nevertheless be accepted by a 2/3 vote of both a Steering Committee and a General meeting.

B. A County Committee may include more than one county, but such a County Committee shall be divided upon the petition of a majority of the NJLP members in any constituent county, at which time the latter county will be represented independently.

C. The County Committee shall have the authority to select candidates for offices of political districts which exist entirely within the county (or counties) of that County Committee. Candidates for offices of political districts which exist within two or more organized counties may be selected jointly by the County Committees in these counties. Any disputes arising out of these joint selections shall be adjudicated by the State Committee.

D. Any candidate selected by the County Committee must be a member of the NJLP or of that County Committee.

E. County Committees shall maintain a level of ongoing activities

as established by the State Committee. The Steering Committee shall review the activity of all County Committees at least twice annually and will present its recommendations to a General Meeting or the State Convention for action.

F. The Steering Committee may appoint County Organizers for unorganized counties for the purpose of establishing County Committees therein. County Organizers may attend and participate in State Committee meetings but cannot vote.

#### 10. IMPLEMENTATION

A. The Steering Committee shall have the authority to adopt rules to implement these Bylaws and the Certificate of Incorporation. Such rules may be adopted, amended, or abolished by any General Meeting.

B. Except as otherwise provided in the Bylaws and the Certificate of Incorporation, Roberts Rules of Order, Newly Revised shall govern all NJLP meetings.

#### 11. QUORUM

A. Unless otherwise specified, a majority of the members of any NJLP committee constitute a quorum for that committee.

B. A quorum for a General Meeting or the State Convention shall be 10% of the entire NJLP membership.

#### 12. VOTE

Unless otherwise specified, the number of votes required (such as a two-thirds, majority, etc.) to carry a motion is determined by those voting with abstentions not counted.

#### 13. AMENDMENTS

A. These Bylaws may be amended by a two-thirds vote of any General Meeting or the State Convention, with notice of the proposed amendments given in the notice for the meeting.

B. The Certificate of Incorporation may be amended by a 2/3 vote of the entire membership at any General Meeting.

#### 14. RATIFICATION

These Bylaws shall take effect immediately upon approval.

(Approved unanimously at the 1/16/82 Steering Comm. meeting)

#### NEW BYLAWS SYNOPSIS

The proposed NJLP Bylaws are generally a rearrangement of the present (1980) version with a more coherent structure. New or significantly changed sections are: 3.A, 4.B, 4.C.2, 4.C.6, 4.C.7, 4.D.4, 4.D.5, 5.A, 5.D, 7, 8.C, 9.B, 9.C, 9.E, 9.F, and 14.

New 3.A conforms to the actual statement on the NJLP membership application. Part 4.B is new as a unit, but all items except 4.B.5 are in present Bylaws. New 4.C.6 allows alternate to participate in Steering Committee meeting.

Sec. 4.D.4 allows County Comm. to select State Committee Representative rather than require the

County Chair to be the Rep. New 4.D.5 restores State Comm. ability to act for the Party (now they can only fill Steering Comm. vacancies). If no quorum at State Comm. meeting then Steering Comm. would "vote otherwise."

Sec. 5.A & D are more specific. Parts 8.C and 9.C are new but reflect current NJLP policy. Part 9.B allows immediate "secession" by a county from a multi-county Committee, without requiring General Meeting approval. New sections 9.E and F address County Committee activity and create NJLP organizers.
