## CALENDAR OF EVENTS

Dick Siano, Chairman of the Hunterdon County Libertarian Committee, tied his Democratic opponent in a three way partisan race for Kingwood Township Committee. He and the Democrat, Andrew Maydechek, each polled 308 votes, while the Republican and incumbent Mayor, Sam Leon, trailed with 225. A "special election" will be held on Dec. 29th between Siano and Maydechek.

Siano centered his campaign around three basic issues. The first was deregulation--he opposed restrictive building, fire, and zoning ordinances. Second, he came out against the property revaluation now being prepared for in his town. He promised that, if elected, he would try to delay revaluation as long as possible, then fight the state law. He also pointed out that the \$32,000 cost of the process of revaluing is a considerable expense in a town with only about 800 taxpayers. Third, he opposed the \$400,000 budget the town committee has prepared for land and construction of a new municipal building.

Siano and fellow local libertarians worked hard on his original campaign and are working even harder now. The township committee of three is now composed of two Republicans plus the seat just lost by Mayor Leon. The Democrats want that seat badly, but Siano is cautiously optimistic. MOYERS CAMPAIGN

Regardless of anything else that can be said about Jack Moyers' campaign for Governor this year--and there is sure to be plenty said at the December 12th State Committee meeting--the fact remains that the Libertarian Party now holds the balance of power in New Jersey politics.

Admittedly, other candidates for Governor have an equally valid claim. But the fact remains that Jack Moyers' 2255 votes by themselves are greater than the vote difference between Kean and Florio.

Of course, Jack's vote was conceivably higher--or lower--than that figure. But that will forever remain in the realm of conjecture. With only 1677 votes separating the two major party candidates--the closest N.J. election in 100 years--a recount was sought by Florio to determine whether Kean had, in fact, won. A special three judge panel ruled unanimously on November 17th that the recount would be restricted only to the votes for Kean and Florio and would not include votes for

Moyers and 10 others.

The election had been predicted as "too close to call," but it's doubtful whether anyone had thought it would be this close. As in other situations where the voters feel they might "waste" their ballot on a Libertarian Party candidate, the vote for Jack Moyers was held down. Not answering two of the most important questionnaires in the state didn't help any either, but long time political observers have conceded that it's doubtful the vote would have broken into five figures under the best conditions, given the preconceived closeness of the vote.

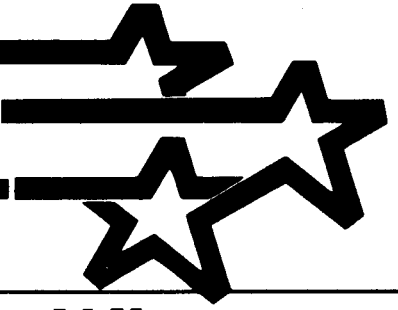
Already, the two major parties are blaming the closeness of the vote on the "other" candidates. Legislation is being prepared to increase signature requirements to get on the ballot.

Those who "wasted" their vote on Kean may be surprised if he starts pushing for a state wide property tax, as some of his staff people have indicated privately.

## Who He Is — Why He Can Win

### BIOGRAPHICAL SUMMARY

Richard L. (Dick) Randolph was born in Salmon, Idaho in 1936 and moved to Alaska in 1960. A former schoolteacher, he established his own successful insurance business in Fairbanks in 1964, which he still operates. He is a past state officer of the Junior Chamber of Commerce, a licensed pilot, and an active sportsman. Dick and his wife Lydia have five children, ranging in age from 13 to 23.

### POLITICAL BACKGROUND

Dick first became involved in politics as a volunteer for the Republican Party in 1964. In 1970, he was elected to the state House of Representatives from Fairbanks and was re-elected in 1972, but he resigned from the legislature and left the Republican Party in 1974 in protest of policies with which he could not in good conscience agree.

In 1976, Dick became acquainted with the Libertarian Party, then a very small organization in Alaska, and volunteered to be State Chairman of Libertarian presidential candidate Roger MacBride's campaign. Dick's enthusiastic promotion and recruitment produced six per cent of the vote for MacBride in Alaska (ten per cent in Fairbanks)—a record-breaking showing for a new, small party.

In 1977, Dick was elected to the Libertarian National Committee, a post to which he has been re-elected twice. His political activities during this year focused primarily on building the size, strength, and influence of the Libertarian organization.

In 1978, Dick ran for and was elected to the Alaska House of Representatives, becoming the first elected Libertarian office holder. In 1980 he was re-elected—finishing first in a field of 18 candidates and nearly doubling his 1978 vote total—and was joined in the legislature by Fairbanks Libertarian Ken Fanning.

### POLITICAL ACCOMPLISHMENTS

During his first Libertarian term, Dick built statewide recognition of and respect for the Libertarian Party and himself through his principled positions on state issues, positions which combined responsible criticism with creative new solutions. With the addition of a second Libertarian legislator in 1980, Libertarians became a true alternative political force in the state, effectively holding a "balance of power" in state politics and spearheading successful and well-publicized moves to reduce the role of government in the lives of Alaskans.

Dick played the leading role in repealing the state income tax, first by sponsoring a statewide initiative petition calling for this move, then by leading the legislative fight to make the repeal a reality. He has also played a key role in efforts to privatize land ownership.

### CAN DICK WIN?

Dick Randolph has been a winner all his life—a man who has succeeded by combining deep, principled convictions with sound, realistic judgment. His personal electoral victories thus far have reflected years of hard work in building an effective statewide grassroots organization of Libertarians and many others who share his views and respect his courage.

Libertarians are the third major political party in Alaska, and they come closer to Alaskan values on such issues as taxation, land use, and individual rights than do the other two parties. The present governor was elected with only 39 per cent of the vote in a four-way race; Alaskans are used to thinking and voting independently, and care less about party labels than about principles, issues, and the character of the candidates.

Dick Randolph has the recognition, the talent, the organization, and the statewide respect to be the next governor of Alaska. He needs and deserves maximum support in his pathbreaking effort.

Once again the Republican Party has shown its contempt for blacks and Hispanics by instituting the "National Ballot Security Task Force" in New Jersey's major urban centers.

Vote fraud is a very real problem, and not just in the cities. But the way to insure an honest election is to have challengers in those areas where the number of votes for a political party has been consistently low. The laws concerning challengers are very permissive, and it is possible to shift people around from district to district.

But the Republican Party wanted to take the easy way out. Like something the U.S. Labor Party would be expected to do, the GOP plastered signs all over the urban areas and sent in people wearing armbands. Some reportedly carried sidearms as well. This fosters a police state attitude which is not conducive to good will. The same people could have been credentialled as challengers, minus the armbands and guns.

The Republicans' problem is that they haven't made an attempt to appeal to black and Hispanic voters. GOP committee-people are virtually non-existent in most cities. On the other side of the same coin, the Democrats take these votes for granted. Consequently, voter turn out in these districts is extremely low.

Here is an opportunity for libertarians to make major inroads with a minority outreach program that recognizes blacks and Hispanics share many of the same problems as whites--in addition to the burden of welfare dependency fostered by mostly white politicians and bureaucrats.
