'85 CONVENTION PREVIEW

Ed Clark, 1930 Libertarian Presidential nominee, will headline the list of speakers at the 14th annual NJLP state convention.

This year's convention will be held March 23rd at American Legion Fugle Hummer Post #65 at Lake Ave. (Route 27) and Holly St., Metuchen.

The full package--breakfast, lunch, dinner and six speakers--will be \$30 if ordered before March 6th or \$35 if ordered before March 13th.

Clark, who also managed the 1984 campaign of LP nominee Dave Bergland, is in the unique position of having been at the center of the last two Presidential races, and he is expected to provide some interesting insights on both campaigns, as well as suggestions for 1988.

Ed will be speaking at 7:00 PM, and his talk will be accompanied by an international buffet featuring hot foods of seven different countries.

Andy Melechinsky, pro se attorney and founder of Constitutional Revival, will speak at 12:30 PM during the luncheon buffet featuring cold cuts and a "surprise" hot dish. Melechinsky is perhaps best known for his efforts to abolish the monopoly on legal services enjoyed by lawyers, and many of his fights have centered around state and local issues. With the Governor and Assembly elections this year, his ideas will be of particular interest.

The hot buffet at supper will cost \$25, while the cold buffet at lunch will cost \$12.50 if ordered before March 13th.

HEROES OF THE REVOLUTION

A continuing series dedicated to the unsung heroes of the Libertarian Revolution, people whose daily efforts swell the ranks of libertarians everywhere and assure the ultimate victory of our noble cause.

PART III -- "BUNGLING BUREAUCRATS"

The founder of the Soviet police state V. I. Lenin writes in his State and Revolution that commerce should be organized on the lines of the postal service." What a marvelous lesson for pampered and spoiled Americans, basking in luxury beyond that enjoyed by kings a century ago brought to them from the free market (or what is left over from it), to ponder Lenin's prescription while they try to reason with a cement-headed clerk at the Post Office or the Bureau of Motor Vehicles!

Friends of ours visited Russia recently and found the "workers' paradise" to be incredibly poor. Discussions with the hand picked KGB tourguides found them to be strong CRITICS of the Soviet economic system. Every Russian seems to know the Soviet economy is awful: inefficient, corrupt, and wasteful with endless multiple lines to purchase inferior, shoddy products.

Yet few Americans have seen this final result of Lenin's plan for themselves. The tremendous comparative wealth of the U.S.A. is taken for granted by people here and the connection of socialism with poverty is forgotten. Calls for government planning and "cooperation" of government and industry (correctly called fascism, see Charlotte Twight's book America's Emerging Fascist Economy) fill even the business sections of most newspapers and popular news magazines.

To the rescue come the bungling bureaucrats to enlighten and wake up even the most fat and contented Fabian as he steps into the fairy-land of government services.

We hoped to rent a post office box one afternoon and found an insolent attendent who told us he needed a half hour to fill out the paperwork! So he couldn't even begin since it was 4:35 and he was going home at 5:00. Then there is the #%&\$* Division of Motor Vehicles.

These bastards refused to issue a registration for a school bus because "it wasn't in the computer" despite obvious evidence that a transposition of license numbers had occurred.
