Tax protest leader and candidate held 'hands across' some issues at meeting

The monthly meeting of the Somerset-Middlesex Area Libertarians (SMAL) was slated to be "controversial and informative," pivoting around Gov. Jim Florio's \$2.8 billion tax-increase package.

Monday night's meeting at the Holy Trinity Lutheran Church did prove to be informative but the anticipated heated exchanges between John Budzash, co-founder of Hands Across New Jersey, and Assemblyman Anthony "Skip" Clmino (D-14), a staunch supporter of Florio's package, never materialized.

That's because Cimino never materialized.

The state assemblyman who is serving his second term in representing parts of Middlesex, Somerset and Mercer counties, contacted John Paff, a SMAL member on Saturday to say he would not be able to attend because of a personal commitment.

attend because of a personal commitment.

After contacting a number of replacement speakers, Paff managed to secure Somerset County Free-holder Michael Pappas, who is seeking re-election. While the tone of the meeting was obviously not going to be the same without a staunch Florio sup-

mismanage the money, they're not fired, just kicked over somewhere else."

Meanwhile, Budzash said he is dead set against the \$135 million bond issue approved by the Legislature by an overwhelming margin. While the bond was proposed to stimulate construction of affordable housing, the HANJ leader is encouraging taxpayers to vote against it.

"We want affordable housing but not added taxes (real estate). Don't put the burden back on the tax-payer," he said. "And that is a direct quote from Gov. Jim."

Zimmer and Budzash shared similar views as they fielded comments from the audience, with the exception of the fact that Zimmer said he will vote "yes" for the housing bond issue.

Regarding disbursement of funds for school districts, Zimmer said, "I'm offended when people say I'm a racist. Regarding the plight of the urban schools, it's not the kids I'm against; it's the people who don't need the money," he said, reiterating Budzash's sentiments that the money is going into the wrong pockets. "Obviously, the suburban schools are going to be under tremendous pressure."

porter orating, at least a second speaker was going to be heard.

But it was instead the voice of congressional Republican candidate Dick Zimmer, not Pappas. Pappas apparently left the church hall after inadvertantly being told by a member that he was not at a "Hands Across" meeting!

Zimmer, who was also invited, then made his way to the podium.

"Well, I guess since I'm filling in, if Skip were here he'd tell you it (tax increases) is Kean's (former Gov. Tom) fault. Or, he'll tell you it's the Supreme Court's fault," Zimmer quipped.

Libertarian Howard Schoen, a District 6 candidate for Congress, introduced the group to the philosophy shared by his political party, the third largest in the country.

"The Libertarian Party has very strong views on taxes — we're against them. The way to reform taxes is to cut them or do away with them," he said. "John (Budzash) has given the people a realization that they do have power."

With that, Budzash told the group of about 35 that HANJ is zooming in on two issues: school funding and the housing bond issue.

"We are for school funding in (the) poor districts, but the money is not going to the students — it's going in someone's pocket," he announced. "We need accountability in the schools. As it stands now, there are no restraints against these people. If they

He also stated that Florio's aim to tax the rich was off balance.

"The rich, who Florio is talking about taxing, are the investors and employers," Zimmer said. "(With that) You're going to lose jobs and commercial and residential real estate."

The closest moment to an hypothetical enactment of Cimino vs. Budzash was when the speakers were challenged by Somerset resident Daryle Jenkins. Jenkins, who had the floor for several minutes, yelled out that he would much rather put his trust in the governor than someone who by his own admission didn't vote in the last election (Budzash) and someone who's using the tax crisis to advance his own political career (referring to Zimmer.)

But the men attempted to defend their positions, with Zimmer contending he is not a "Johnny come lately" following behind the "Hands" group.

"I admire what 'Hands' has done, but I've been there all along," Zimmer said. "And, I've been kind of lonely."

Meanwhile, Budzash said he didn't vote because he simply didn't care for any of the candidates but that through his present efforts, he is redeeming himself.

"I'm doing this now because I realize the importance of being involved. I volunteer about 65 hours a week for this and whether we're right or wrong, this has gotten everyone involved," he said.

Freeholder candidates debate trash, taxes

CANDIDATES FOR Monmouth County freeholder were clearly distinguishable along party lines in a meeting yesterday with the editorial board of the Asbury Park Press in Neptune.

The two Republican incumbents supported a trash incinerator and the county's spending and taxing habits while a Democratic challenger took opposite stands and a Libertarian candidate said neither major parties wants to scale down county activities and spending, as she does.

None of the candidates presented views different than those they have previously expressed publicly and in interviews.

Republicans Harry Larrison Jr., Ocean Grove, and Thomas J. Powers, Aberdeen Township, are being opposed by Democrats Frank G. Abate, Marlboro Township, and Burton Morachnick, Long Branch, and Libertarians Virginia A. Flynn, Marlboro, and

Marshall Bienstock, Howell Township. Morachnick and Bienstock did not attend yesterday's session.

Larrison described the trash burner planned by the freeholders as the "most modern plant in the world." He noted its distinct characteristic would be a component to collect some hazardous and recyclable materials before the balance of the county's garbage was burned.

Composting of trash, which many opponents of incineration favor, can't produce a toxin-free material for agricultural and other uses, he said.

Abate said the same presorting approach planned for the incinerator could be applied to composting. He said the county could spend a couple million dollars to fund an experimental composting process for municipal waste, and if it worked, each municipality could set up its own composting facility.

Abate said incinerators have produced toxic ash and violated environmental standards, and Larrison said Monmouth County's plant would not be able to operate if it didn't meet state and federal requirements.

Mrs. Flynn said she didn't know enough about incineration to have a position whether it is safe. But, as a Libertarian, she said she believes trash management should be left to private industry, not the government. If there is a problem with a county operation, she said, "taxpayers have no place to go but (to) sue themselves."

Through the campaign Abate and Morachnick have tried to paint the all-Republican, five-member Board of Freeholders as free-spending.

Yesterday, Abate said county tax bills over the past decade have climbed just as the state budget, with which the public is angry. He said he would look if some management jobs should be eliminated and whether some other spending is necessary during the current tight economy.

Larrison said the county tax levy grew 210 percent between 1980 and 1990 while the municipal levy in Aberdeen, where Morachnick was mayor until January, rose 145 percent and Marlboro's increased 508 percent. During the three years Abate has been a Marlboro councilman, the township's tax levy rose 129 percent, Larrison said.

Abate said he didn't know whether Larrison's figures were accurate, but that Abate's political party was in the majority during just one of those years. He said he voted against the budget one of the two years Democrats were in the minority.

Powers said the freeholders have negotiated smaller pay raises for unionized workers in the past few years and are cutting some parts of the budget to curtail the growth in spending next year.

Having listened to the Republican and Democrat candidates, Mrs. Flynn said, "Nobody's talking about cutting back." Mrs. Flynn, who acknowledged she doesn't expect to win election, said, "I'm running to change people's minds . . . about how things can be done."

Canceling the Postal Monopoly

By simultaneously proposing a 19-percent postage increase and a series of service cutbacks, the U.S. Postal Service has inadvertently fueled the fires for postal privatization. Supporters of deregulation are looking closely at New Zealand's competitive postal service; privatization critics would rather ignore it.

New Zealand "corporatized" and deregulated its postal service in 1987. The government maintained ownership of the corporation but ceased subsidies and ended its monopoly on letter delivery. This forced the postal service to operate profitably while facing competitors. The law requires the postal service to continue serving every address in the nation.

To restructure its postal service, the government closed more than two-thirds of its post offices and allowed private retailers to set up contract stations. Since decontrol, the net number of post offices has increased by 17 percent. On-time delivery of first-class letters has increased from 84 percent to 99 percent,

while automation and contracting out operations have reduced the postal workforce by one-fifth.

Postage rates went up by 40 percent in the two years prior to decontrol; they have been stable since. Yet the postal service has gone from annual losses of \$37 million to yearly profits of \$76 million.

Will studying New Zealand's experience provide lessons for the United States? In the Wall Street Journal, Postal Rate Commissioner John Crutcher said: "U.S. Postal Service officials who go to New Zealand return chastened and silent. The U.S. post office is not the cheapest or the most efficient in the world; it's only the biggest."

NJLP STEERING COMMITTEE MEETING

The New Jersey Libertarian Party Steering Committee met on October 6, 1990 at the Karlan residence in Cranbury. Present were Karlan, Zeldin, Stefanelli, Edelston, Kaplan, and Schoen. Absent were Flynn and Radder. Dan called the meeting to order at 2:03 PM.

Treasurer Lou Stefanelli handed out his written report to the committee. Last month's record membership has been maintained. This year's heavy outreach program has greatly increased the number of people who have expressed an interest in the LP. In addition, Lou has received the names and addresses several hundred inquiries from National.

The committee authorized up to \$200 for a mailing to solicit new memberships from among the prospects and inquiries. This will be handled by Development Coordinator Sam Edelston.

Sam will also create a press release for shortly after Election Day, seeking Libertarian candidates to run for state and local office next year.

The posters approved at the September State Committee meeting were printed and they were used at the September 23 "Hands Across New Jersey" rally in Trenton. A sample was shown to those committee members who hadn't yet seen it, and they were impressed.

The committee voted to sell National 25 of the posters, at cost, for use in other parts of the country. If this catches on, bulk ordering at much better prices may become possible.

The Chair will continue to look into options regarding the NJLP phone message and report

back to the committee.

At the September State Committee meeting, the question was raised as to whether LP officials must formally file lists of its candidates in order for the designation "Libertarian Party" to appear with their names on the ballot. The answer is, no. As for improper use of our name by unauthorized candidates: Since we are properly incorporated, it's our name to use...and if anyone else tries to misuse it, it's our right and responsibility to challenge them.

Dan Karlan reported that the Bergen County Libertarians met with good attendance. Their official contact person is now Lee Altman.

The meeting was adjourned at 3:54 PM. Amazing.

No one is holding a gun to the heads of American drivers, forcing them to purchase gasoline. If consumers are upset over higher prices, they can decrease their consumption to reduce their gasoline bills.

IRS seizes \$344,000 boat from A.C. dock

Brigantine man subject of probe

ATLANTIC CITY — The "For Sale" sign was still attached to the Fishing Well as the new owner prepared to move the 36-foot vessel Thursday from its berth at the Frank S. Farley State Marina.

But Mitchell S. Kramer wasn't aware someone else had taken possession of the gleaming white fishing boat he had purchased last year and now was trying to unload

It seems the Internal Revenue Service isn't in the habit of warning owners it is about to seize property it believes they obtained illegally.

i don't know anything about it This is the craziest thing I've ever heard of," Kramer, who lives in Brigantine, exclaimed afier learning of the boat's fate from a reporter.

He refused further comment and ended the telephone interview by hanging up.

The IRS alleged Kramer violated federal currency laws when he bought the boat March 11, 1989, from Avalon Pointe Marina in a deal valued at \$334,000.

Edward J. Litchko, chief of the IRS Criminal Investigation Division, said Kramer purchased the Blackfin Combi by using the trade-in value of his old boat,

\$9,800 in eash and \$118.220 in bank checks and money orders

The checks and money orders 21 of them drawn from eight New Jersey and Pennsylvania banks between Feb. 24 and

March 10, 1989 — were individually made out in amounts ranging from \$1,000 to \$9,800.

Federal money-laundering laws prohibit the "structuring" of currency in amounts of less than \$10,000. Businesses and banks are required to report transactions of \$10,000 or more so government financial regulators can monitor large movements of cash.

Kramer's boat was seized Thursday under a civil warrant to prevent it from changing hands. As long as Kramer remained the owner, the IRS had the authority to confiscate it.

Kramer has not been criminally charged but remains the target of an IRS investigation into possible money laundering and income tax evasion, Litchko said.

The probe will attempt to determine where Kramer, a pharmacist, got the cash that he converted into checks and money orders. He could face felony charges for each check and money order that was used to buy the boat, Litchko said.

The boat was taken by IRS agents to the U.S. Coast Guard station in Atlantic City, a short trip from the marina. Kramer may challenge the seizure under an IRS appeal process.

"He can come in and attempt to prove that we should not have seized it, but he would have to tell us where he got the money from," Litchko said in an interview from his Newark office.

An IRS affidavit made public Thursday and the agency became suspicious of Kramer after investigating large bank deposits made by Avalon Pointe Marina that were unrelated to the sale of the Fishing Well.

The IRS discovered Kramer's purchase while inspecting the marina's business files.

Government has too much control over our lives

Gov. Florio has made a grave political mistake. Yet at the same time, he has provided the average New Jersey citizen with a rare, enlightening glimpse at what New Jersey government is really about. Florio's mistake was to raise taxes using a baseball bat instead of the traditional politician's use of smoke-screen rationalizations. This in turn has allowed us to see what our government has become: a group of people with power at their disposal that they use to control the rest of us.

Now is the time to return that power back to the people. We must again assume the power and the right, as guaranteed by the Constitution, to control our own lives, our own bodies, and our own property through voluntary cooperation with each other.

Take auto insurance. New Jersey law says citizens must have car insurance. This gives insurance companies a guaranteed market and removes incentive for lowering

prices. The government tries to "regulate" the price-gouging, thus adding to the expense of insurance companies doing business in the state. Guess who ends up paying for it?

The solution is voluntary auto insurance. You could insure yourself against liability for damage you cause, and also insure for payment of damages that result from being hit by drivers with no insurance or assets. The competition between insurance companies for these two markets would lower the price of insurance to a level that matches the risk inherent in the act of driving.

There are many other examples of savings that could result from limiting the power and coercion of government. Just remember: voluntary cooperation, free markets and limited government intervention mean lower taxes.

In modern America

Founding Fathers would be outlaws

Before the brief public enthusiam for the U.S. Constitution's bicentennial disappears down the national media memory hole, it might be instructive to consider some of the ironies that surround it, together with the venerated Founding Fathers, and those who today invoke their names and the Constitution with ritualistic platitudes.

I'm not talking about Thomas Paine, the great popular patriot of the American Revolution, who declared: "Taxation is theft!"

Nor Daniel Webster, inveighing against the draft: "Where is it written in the Constitution that you may take children from their parents... and compel them to fight the battles of any war in which the folly or the wickedness of government may engage it?"

And I don't mean Thomas Jefferson, who advised Americans to engage in "friendly trade with all nations; entangling alliances with none."

These gentlemen would today be in hiding from the IRS or Selective Service.

But their problems pale when compared to the kind of trouble George Washington would find himself in.

That's because the Father of Our Country was also the Johnny Appleseed of marijuana for North America. This fact has been clearly established by Washington's own letters and journals.

In a letter to Alexander Hamilton in 1791, Washington asked: "How far . . . would there be propriety, do you conceive, in suggesting the policy of encouraging the growth of cotton and hemp in such parts of the United States as are adapted to the culture of these articles?"

The hemp referred to, is, of course cannibis sativa, otherwise known as marijuana or pakalolo.

Some conservative scholars, in trying to deal with the agonizing dilemma that these disclosures pose, have tried to suggest that Washington was really only interested in the use of hemp for rope, and not for recreational purposes. But in his diary for Aug. 7, 1765, the future commander-in-chief wrote: "Began to separate the Male

from the Female hemp . . . rather too late."

Sexual separation of marijuana plants is irrevelant for rope making; it is, however, a vital and traditional part of marijuana cultivation, when the purpose is pharmacological.

In an enthusiastic letter to an unidentified doctor, Washington wrote: "I thank you as well for the seeds as for the Pamphlets which you had the goodness to send me. The artificial preparation of the Hemp from Silesia is really a curiosity. . . ."

Writers faced with the evidence, but still unwilling to admit that the Father of Our Country might have been a pothead, have fallen back on the argument that Washington was probably using the drug as a pain killer for his frequent toothaches.

But as Robert Anton Wilson has pointed out, "Considering the passion shown in these records, the toothaches must have been very frequent." Further, according to Wilson, "There seems to have been no marijuana on this continent before the 18th century, and the chief cause of its wide dissemination was the enthusiasm of George Washington."

Well, where do these shocking revelations leave us?

1, for one, like to ponder what would happen if the Founding Fathers were alive today and observing the bicentennial of the constitution.

In my mind's eye, I can see old John Hancock filling out his W-4 form with a flourish.

I can see Thomas Jefferson applying for his Social Security card and then running down to the post office on his 18th birthday to register for the draft.

I like to imagine Ronald Reagan dispatching the Coast Guard down the Potomac to raid the pakalolo fields at Mount Vernon.

But most of all, I like to think of Congresswoman Pat Saiki forcing George Washington to submit to a urine test.
