

## Six extra inches wins approval for carport

BRIDGEWATER - An extra six inches was all it took for the Zoning Board of Adjustment to approve a carport at a Sycamore Avenue home.

"We made it five and a half feet, and that was it," said Clara Macchio, whose application with her husband Frank to build a carport at their home on Sycamore Avenue was approved by the board on Dec. 18.

Although the Macchios hope to install the carport "as soon as possible," the couple had been discouraged by the board's original decision in November to postpone a vote until December.

At that meeting, board chairman Charles Herbek had insisted that the couple return with a professional engineering survey and accompanying drawings, in place of the crude sketch they had presented.

At the time, most board members were concerned with the proposal to extend the 10-footcouple's garage, which is 15 feet, 9

line. According to Macchio's measurements, the end result would have placed the edge of the carport five feet, nine inches from the property line.

Under the new plan, however, the carport will be set back six more inches, or six feet, three inches from the property line.

A notation by the Township Engineering Department pointed out that state building codes call for such structures to be no closer than five feet from the property line.

The Macchios, who live on a fixed income, told the board in November they could not afford to hire an engineer. In addition, they said affordability was the main reason they chose to build a carport, rather than expand their garage, which some board members suggested.

The purpose of the carport, the couple told the board, would be to provide additional protection, mainly from snow and rain, for their second car in order to prevent maintenance problems durwide carpor from the side of the ing several trips a week Clara makes to visit her mother in a inches away from the property nursing home in Queens, N.Y.

#### NJLP STATE COMMITTEE MEETING

The New Jersey Libertarian Party State Committee met on January 5, 1991 at Dan Karlan's parents' home in Cranbury. Present were Karlan, Stefanelli, Flynn, Edelston, Kaplan, Schoen, Montelione, and Paff. Zeldin, Radder, Hill, Meinshausen, Kerr, Peters, and Agnew were absent. Dan called the meeting to order at 2:10 PM.

Dan opened the meeting by notifying Howard Schoen that due to increased NJLP membership he was now one signature short for his Steering Committee Member-at-Large position by petition. Howard has until the NJLP annual Convention general meeting to obtain one more signature.

Sam Edelston announced his intention to continue as Development Coordinator but resign from the Steering Committee. John Paff's suggestion for an NJLP advertisement in Salem County's newspaper Today's Sunbeam was given to Sam to follow up with John Hill. A copy of Ken Kaplan's letter to the editor about bicycle helmet laws was circulated.

County reports followed and showed increased local LP activism in the state. Claudia Montelione told the group that the Libertarians of Monmouth County were working on a position paper on insurance. Ginny Flynn is LMC's "demonstration coordinator."

John Paff passed out a written report about activities of the Somerset Middlesex Area Libertarians. SMAL has five standing committees, most of which are meeting regularly: Recruitment, Program, Public Relations, and Political Awareness. WCNJ radio invited SMAL to do a weekly radio program for \$50/hour. The SMAL PR Committee has requested information from all local radio stations and will follow up.

South Jersey and Mercer County representatives were absent and no reports were available. Lee Altman will continue as Chairman of the Bergen County Libertarians.

The newly organized Morris/
Essex County Libertarians had interesting guest speakers at two recent meetings. In November they heard Sophie Ben-Shitta, Publisher of Mentertainment, a Go-Go trade magazine, speak about censorship. In December Victor Davidoff, a Russian Libertarian, talked to the group about the freedom movement in the Soviet Union.

After a 15 minute recess the committee reconvened at 3:05 PM to receive the Development Coordinator's draft "Possible NJLP Goals for 1991." The group agreed to discuss the document on Sunday evening January 6 at 6:00 PM.

Dan Karlan presented the proposed NJLP budget for comment and revisions. Dan noted the need for a paid position for an NJLP Public Relations person.

The State Committee unanimously passed a motion to set national LP dues at \$20 for renewals or new members signed up through the state party with \$10 going to national LP and \$10 kept by the NJLP. This dues schedule will become effective on February 1, 1991.

The group discussed possible changes in the state LP organization and meetings. Two Bylaws Amendments were recommended for submission to and approval by the NJLP membership at the state convention on March 9, 1991. These are: (1) reducing the quorum requirements in Section 11 Part B for general meetings from 10% of members to 5% and (2) changing Section 4.A.(1) from "10% plus 5" to "5% plus 5" of members to call a meeting.

### Draft view is 'ridiculous notion'

To the editor;

The report appearing in the Nov. 25 Argus, regarding support by West Milford officials for the reactivation of a local draft board, can't go unchallenged.

It would appear that our local leaders have swallowed, hook, line and sinker, the ridiculous notion that we need a draft to protect us from Iraqi conquest.

President Bush is lying to the American people about Iraq. However, all important posts in both the Reagan and Bush administrations have gone to CFR members. Past Secretaries of State Alexander Haig and George Schultz are CFR members. James Baker and Richard Cheney are both CFR members, as

# Not everyone voted for the major party candidates

AREA VOTERS cast hundreds, and in some cases thousands, of votes for independent Congressional and Senate candidates.

In the race for U.S. Senate won by incumbent Democrat Bill Bradley, John L. Kucek representing the Populist Party was top vote-getter of the three independent candidates. He received 19,957 votes compared to the 970,940 votes cast for Bradley.

Libertarian candidate Louis Stefa-

nelli received 14,230 votes and Socialist Workers Party candidate Don Mackle received 7,942.

In the 13th Congressional district, where Republican Rep. H. James Saxton was re-elected with 99,688. Independent candidate Howard Scott Pearlman, who ran under the slogan "World Without War," received 4,131 votes. The district encompasses parts of Ocean, Burlington and Camden counties.

In the 3rd Congressional district, which includes Monmouth and Ocean counties, independent candi-

date Richard McKean, the anti-abortion candidate, received 4,377 votes. Libertarian candidate William Stewart received 1,833 votes and Populist candidate Joseph A. Plonski received 871 votes. Rep. Frank J. Pallone Jr., D-N.J., was re-elected to his seat with more than 77,800.

Independent Carl Peters was the top vote-getter among independent candidates in the 4th Congressional District, where Rep. Christopher H. Smith, R-N.J., was re-elected with 100,089 votes. Libertarian candidate Peters received 2,178 votes; Judson

Carter, who ran under the slogan "In God We Trust," received 1,034 votes and Populist party candidate Joseph Notarangelo received 1,206 votes. The 4th District includes parts of Monmouth, Ocean, Middlesex, Mercer and Burlington counties.

In the 6th Congressional District, where winner Rep. Bernard J. Dwyer, D-N.J., received 63,615 votes, Populist candidate Randolph Waller received 2,348 votes, and Libertarian candidate Howard F. Schoen received 1,782. The 6th District includes parts of Middlesex, Union and Monmouth counties.
