## MARROU CAMPAIGN GAINING NATIONAL SPOTLIGHT

The Marrou for President campaign has been receiving nationwide exposure on a variety of big-time media outlets. According to the November, 1991, issue of the campaign's "Plans & Progress" newsletter, Andre has appeared on the MacNeil-Lehrer NewsHour, CBS Nightwatch, Sonya Live, and Crier and Company.

In addition, Andre was a featured speaker at a tax protest rally in Washington, DC. The campaign reports that even though the rally was sponsored by Citizens Against Government Waste (CAGW), a Washington Times article gave Andre seven times more mention than CAGW while the photo accompanying the article depicted Libertarians holding aloft a Marrou for President banner!

## JURY NULLIFICATION CALLED "UNFORTUNATE BUT UNAVOIDABLE"

*"Jury nullification is an unfortunate but unavoidable power. It should not be advertised, and to the extent constitutionally permissible, it should be limited. Efforts to protect and expand it are inconsistent with the real values of our system of criminal justice."*

The Political Awareness Committee of the Somerset-Middlesex Area Libertarians (SMAL) provided the following information on the New Jersey Supreme Court's opinion regarding jury nullification. Aside from the tortured language, it is not enjoyable reading.

"The fundamental defect in jury nullification is obvious. It is a power that is absolutely inconsistent with the most important value of Western democracy, that we should live under a government of laws and not of men. There are many manifestations of the concept of a "government of laws," and one of the most important is its operation in the administration of criminal justice. It is there that the sovereign is visibly restrained, it is there that we can see most clearly the application of this hard-earned rule, the rule that no one, to the extent man is capable of achieving this goal, no one, shall be found to have violated society's commands unless that command is first announced and then only

after a group of free people, hearing all the evidence, determine that the accused has violated the command. With jury nullification, these free people are told, either explicitly or implicitly, that *they* are the law, that what the sovereign has pronounced ahead of time either may or may not be followed, and that if they want to, they may convict every poor man and acquit every rich man; convict the political opponent but free the crony; put the long-haired in jail but the crew-cut on the street; imprison the black and free the white; or even more arbitrarily, just do whatever they please whenever they please.

### Jury Nullification

EDITOR:

To those of you interested in jury nullification, there is presently a man in prison who might not be there now had the judge properly charged the jury concerning its power of jury nullification. After the trial the following took place during jury deliberations upon the judge receiving a note from the jury:

"THE COURT: And I'll say to you very candidly, ladies and gentlemen, this is the first time in fifteen years on the bench I received a note like this.

It says:

'Dear Judge, we are having the following problem: Despite your instruction that a conspiracy may exist for as short as half an hour on a day and that all jurors believe that a conspiracy existed in this case on at least one day, one of the jurors is having a problem answering question two on the form because of the language, quote: Between February 12, 1989 and July 25th, 1989, end of quote. One of the jurors is unable to apply the law to count two as it was charged by you. This juror does not think that the law as charged by you is

*fair and just. We need your instruction concerning this issue.'*

As I said, this is the first time in fifteen years I've had a juror say they cannot apply the law.

All I can say to you, ladies and gentlemen, is when you were selected you took an oath...to apply the law as it existed. I don't make the laws. You don't make the laws. They are made by the Governor and the Legislature. I apply the law as they make it...As I told you, I am the Judge of the law. I determine what is the law, and if I'm wrong, there are appellate courts that will reverse me, but not by you jurors.

You must accept the law as I charge it to you, and I accept the law as I understand it to be, and so the suggestion that someone thinks the law is not fair and not just is simply not acceptable. You promised us and you took an oath.

All I can say is that I can't force any one of you what to do. I can only tell you what the law is. I can remind you what oath you took, and I will ask you to determine what are the facts and to apply them as they exit (*sic*) whether you like it or not."

Isaac Wright was convicted of being a drug "king-pin". He is married and has a young daughter. He has been sentenced to life imprisonment with no parole for 30 years. His life is ruined by this conviction. If you are interested in helping, you can write to him at:

### Designer Licensing Debated

EDITOR:

I wish to reply to Michael V. Picorne's letter (*Sept., 1991*) about the Software Designers Licensing Act. I, too, am greatly troubled by the introduction of that bill, but for slightly different reasons.

While I agree with Mr. Pierone on several points, I do not agree that the licensing or certification of professionals in our field is inappropriate or unnecessary. The reputation of everyone in our occupation is degraded by those individuals who, either out of incompetence or malicious intent, deliver systems that are so slow, "buggy" and difficult to use that they are effectively useless. I believe Mr. Pierone is correct when he states that licensing would not necessarily protect the gullible software purchaser from such people.

As a libertarian, I find it difficult to advocate new legislation, particularly at a time when the government at all levels seems to be too large and too powerful already. But I believe this type of legislation is inevitable. Software vendors and buyers alike will eventually insist on it.

As libertarians, though, we can take the lead in this matter by advocating the form that the new laws will take. A license or certification at least assures the managers they are getting someone who has met the minimum basic requirements for the job as defined by the industry at large.

We need a law that sets down unambiguous guidelines for the assignment of liability in a transaction involving software. Most software vendors would like to limit their liability to the performance of their products. But recent legal precedents seem to suggest that the vendor's liability also extends to damages to the customer caused by flaws in the programming. Developers need to know where they stand so they can take steps to minimize their risk, like hiring software designers.

## Libertarians taking new look at nation's woes

### Party wants taxes eliminated, government reduced

NEWTON — Libertarian Party leaders said Tuesday the nation's economic crisis could be solved if taxes were eliminated, the size of government reduced and government functions privatized.

Officials for the party, which they claim is the third largest and fastest growing in America, hosted a program entitled "Tax Free America!" at their monthly meeting at the Unitarian Universalist Fellowship. About 12 people attended the meeting.

Mike Pierone, 35, of Vernon, chairman of the Sussex County Libertarian Party, said Libertarians believe that government's primary function is to defend in-

dividual liberties, not provide goods and services.

When government goes beyond its mandate, he said, it becomes illegal.

"Libertarians are not saying we need no government," Pierone said, "but we need government that goes back to the citizen-governor not professional governors."

Pierone said many politicians are in office so long and are so removed from contact with their constituents, except for special interest groups, that "they begin to believe their own press releases."

According to Murray Sabrin, Ph.D., 44, assistant professor of finance at Ramapo College, guest

speaker at the meeting, the Libertarian Party offers a second, not third party alternative to voters.

"Both parties (Republicans and Democrats) believe taxing and spending is necessary. They only differ on what to spend the money on," Sabrin said.

Sabrin said that on Nov. 5, New Jersey voters said a resounding "no" to Gov. Jim Florio's tax increases.

"Republicans now have veto-proof majorities in both houses," Sabrin said. "The ball is in their court. Will they punt or run with it?"

"They have an historic opportunity to streamline government," he said.

Sabrin said the only valid level of taxing and spending in society is zero.

"Taxes are sucking the life out of the economy," he said.

Taxes reduce the amount of money available for investment and often are duplicated at various levels, he said.

Sabrin noted the irony of politicians in the United States promoting socialistic programs in transportation, school systems, welfare and proposed national health care at a time when socialism is collapsing in countries around the world.

Privatization of government services, he said, will eliminate those which are unnecessary to

society, such as elected officials and bureaucrats, and cause employees to find jobs in the private economy where they would be paid wages based on the worth of their services not on union demands.

Sabrin said about 50 percent of Americans receive a government check.

"It's sucked everyone into its web," he said. "We've become addicted to government and have to break the habit."

Sabrin said the current welfare system for the nation's poor is an honesty issue.

"Someone's misfortune doesn't entitle them to someone else's income," he said.

## IN THE COUNTIES

The counties organizations are once again proving they are where the "real" action is taking place. The following represents a summary of some of the libertarian activities that have occurred recently in the state. If you or your local group has news or information that they would like to have covered, please send it to the *New Jersey Libertarian*.

### BERGEN COUNTY

Efforts to secure a permit to hold a free-speech rally in a county park continue. BCLP Chair Lee Altman reports that it took four attempts--twice by mail, twice in person--to file an application with the county Parks Department. The first three times the department stated it had never received the application. Now that the LP has been denied permission, the ACLU has agreed to investigate the issue further for possible action.

### MONMOUTH COUNTY

A course entitled "Taking the Offensive in Court" is forming. The members of the LMC are sponsoring the classes on knowing your rights and handling yourself in the courtroom. Know what to do when confronted by the "authorities." Find out how to sue, when to sue and who to do it to. The instructor is Bernard Laufgas of The Public Watchdog and the course will be 5 sessions long at a place to be depending upon how many people are interested. So far, it is reported 6 people have signed up; another 10 are needed to make it worthwhile. Claudia Montelione requests you contact her at (908) 583-8721 for more information.

### SOMERSET-MIDDLESEX COUNTY

The Public Relations Committee reports that the South Brunswick chapter of Hands Across NJ taxpayer group is operating a computer bulletin board. The board's phone number

### SUSSEX COUNTY

Ramapo College professor Murray Sabrin addressed the November meeting of the SCLP and called for an end to all taxes. Sabrin noted that the tax-and-spend philosophy had generated a self-perpetuating entourage of career politicians and bureaucrats. He further stated that the situation had become so bad that some 50 percent of all Americans now receive a check from the government in one form or another. The meeting received excellent coverage in the regional newspaper (See the article reprinted elsewhere in this issue--Ed.).

SCLP Chairman Michael Pierone reports that membership in Sussex County continues to grow and that two more individuals joined as a result of the meeting.

State Committee representative Tony Federici reported that an Operation Politically Homeless outreach effort was successfully organized this past summer.

### CFR: AMERICA'S SECRET DICTATORSHIP

The Council on Foreign Relations (CFR) is a little known private club based in New York City. CFR "conservatives" say: "Let's wait for more reforms before we give the Soviets financial aid." Option C, the common sense option which is deleted, says: "Wait! Where in the Constitution does it say the government can confiscate our money by force and give it away to Communist murderers who now claim to be 'democratic socialists'?" Can you see how we're being manipulated? Anyone who chooses Option C is an "extremist" guilty of "McCarthyism" oblivious to the realities of "global interdependence" and the need for a "New World Order." In other words, anyone still believing in national sovereignty and individual liberty is a fool!

What exactly is CFR's game plan? It is to slowly diminish the sovereignty of the United States, to turn the US into a socialistic economic basket case, and merge us into a global government under the absolute authority of the Rockefeller created United Nations. The Soviet Union is the outside bogeyman created and financed by CFR elites for the purposes of scaring us into the UN for the sake of "peace."

Celebrity endorsements, by themselves, are not much. However, the impression left by such actions are tremendous and generate free publicity for the campaign.

Andre Marrou and vice presidential candidate Nancy Lord have further decided to join forces and run a "unified campaign" in an effort to get more bang from their efforts.

Much more is planned. Andre promises to keep on running TV commercials in New Hampshire (they've run more than 50 to date!) as well as to begin airing their 900-number ads. This venture will enable such commercials to become self-funding: this will not only save the campaign money but will perpetuate the outreach nature of the message.

## CONTRIBUTIONS ESSENTIAL

Of course, campaigns need money and presidential campaigns need gobs of it. Thus, Andre is asking for contributions of \$25 to \$1000. ## ROLL OUT THE BARREL !

On November 7th, a bill legalizing home-brewing of up to 200 gallons of beer was signed into law by Governor Florio. The Somerset-Middlesex Area Libertarians, along with Edmund Busch, actively supported the bill (see *July, 1991, issue of New Jersey Libertarian, page 1*).

Busch, a home-brew enthusiast, visited the Division of Alcoholic Beverage Control's office on November 8th, the day following the date of enactment, and demanded a home-brewing permit. Since no permit procedure has yet been established, Busch was given a "letter of authorization" at no charge. It is believed that the Director of the ABC, former state senator Catherine Costa, will propose rules for the imposition of a permit fee in the near future.

## LIBERTARIANS GARNER THOUSANDS OF VOTES IN GENERAL ELECTION

Three NJLP legislative candidates received thousands of votes in the recent elections. Helen Radder, Ginny Flynn and Don Jameson, ran for state senate and two general assembly seats, respectively, in the 12th legislative district which covers parts of Monmouth County.

The candidates participated in four televised debates on local cable channels sponsored by the Asbury Park Press, Hands Across New Jersey and

the NJ Chiropractors Association. Helen noted that the chiropractors wanted greater freedom to practice, but called for restrictions on those who would compete against them.

The libertarians spent nothing on their campaigns yet received 2-3 percent of the vote. Ginny received 1,350 votes (2.7%), while an independent candidate, who was a former two-term Englishtown mayor and 12-year school board member, spent some \$3,000 and received only 500 more votes.

Many Republicans were swept into office on the basis of the libertarian anti-tax mood of the electorate. Already, they have begun distancing themselves from their campaign rhetoric that implied a complete repeal of the tax program enacted in 1990. Now they say they only intended to roll back the sales tax from 7% to 6% as called for in their party's platform; the rest of

the tax program may be left in place.

Democrats, though, may do it for them. Senate President John Lynch (D-17) has stated he has heard the will of the people and he will introduce a bill to repeal the entire Florio tax program. The Assembly does not seem willing to go along, calling the proposal "irresponsible."

Many observers see the initiative as a ploy to force Republicans into a position where they would have to restore most of the taxes. Assembly Speaker-elect "Chuck" Haytaian (R-23), however, is receptive to the idea as it will give the Republicans a clean slate from which to cut government. Whether other Republicans agree remains to be seen.

Sen. Randy Corman will assume his new legislative responsibilities with the rest of the Senate and Assembly on January 14. Quick action is expected on a number of issues. Republicans control both houses by veto-proof margins, 58-22 in the Assembly; 27-13 in the Senate.
