

# SCHOEN REFORMS BOARD OF EDUCATION NEWSLETTERS

NJLP member Howard
Schoen challenged a December 1995
newsletter published by his local Edison Township (Middlesex County)
Board of Education last September, on the grounds that it promoted support for a six million dollar bond referendum, using funds taken from all local taxpayers, including those opposed to the bond issue (See Libertarian Blows Whistle on School Board, NJL, October 1996).

Schoen also cited a phone bank script and draft letters to the editor, also prepared at taxpayer expense but not used, as promotional in nature and therefore an abuse of the board's authority.

That referendum was defeated anyway, and the newsletter Schoen challenged was found blameless by state Education Commissioner Leo Klagholz on April 11 of this year.

However, Klagholz told the Edison school board that they should establish guidelines to prevent the kind of abuse Schoen alleged. He said they should "exercise due diligence in establishing the parameters of informational material to be prepared at board expense, whether by staff or specially contracted consultants."

This advice will be heeded, according to School Board member David Dickinson, who now says that "caution is always appropriate when you are dealing with a budget and referendum".

Meanwhile, a new bond issue and referendum are planned, and the newsletter the Board of Education published and distributed to inform citizens about it is free of promotional content, according to both the Board and Howard Schoen.

Board member Joseph Both said "This one was for informational purposes. There was no place where it said you have to or should (vote in favor)." Schoen was quoted in the local paper as saying that "It seemed like they were just describing the budget without a lot of puffery."

That local paper, *The Metuchen-Edison Review*, covered this story at length, mentioning Schoen's party affiliation, in the April 18 issue.

#### **CRACKS IN THE FACADE**

A story in a recent issue of *Civil Engineering News* made a point that, while insignificant by itself, may indicate a larger movement of public opinion in a libertarian direction.

The story, entitled Why you shouldn't "comply with all laws", notes that contracts for the services of civil engineers routinely stipulate that the designs and plans prepared by these engineers shall "comply with all laws, regulations, ordinances, and statutes of any government authority which are applicable to this agreement or the consultant's performance."

The story, written by an attorney who often represents engineers, goes on to declare that "This standard can be frustratingly elusive in practice" because of "confusing, arcane, contradictory, changing requirements imposed by building codes, government regulations, and state and federal statutes".

He ends the piece with this: "...compliance with all laws is not a guarantee, but a goal".

One of they ways to gauge the Empire's durability is to watch the responses of apolitical persons -such as engineers- to its actions. If engineers as a group tend to see this as a problem, then they as a group will be likely prospects for support of the LP's program of fewer laws, and reduced scope of laws.

#### **RULES FOR REBELS**

In the April issue of World Press Review, a story from The Independent of London offered a series of guidelines for those attempting to peacefully displace corrupt, despotic governments.

Although the story used photos and examples from the opponents of the communist government of Serbia, the principles cited are as just as valid for opponents of the Republicratic government of the USA.

A few of the principles suggested, with the start of the elaboration for each:

- 1) Be Nice
  - The regime will call you terrorists and madmen. Give them no examples to make the charge stick.
- 2) Heroes
  - A figurehead can be a real asset, making the movement more than a group of faceless, anonymous people.
- 3) Have Fun
  - The most successful movements use entertainment to get and keep people smiling.
- 4) Take it Easy
  - Italy's Giulio Andreotti said "power tires only those who don't have it". Pace yourselves and avoid burnout.
- 5) Watch TV
  - Keep the media spotlight on you. TV news is vital, especially for rural audiences.
- 6) Come Together
  - Build a broad-based movement and avoid creating divisions you'll have to heal if and when you get power. Encourage the police, army, and members of the ruling party to join you.
- 7) Be Gradual
  - Only ask for things the totalitarians have already signed up for, thinking the commitments can be ignored.
- 8) Think Ahead
  - Prepare for the day when your protest movement becomes a government.

#### JOHN PAFF COVERED AGAIN IN SOMERSET PROSECUTOR IMBROGLIO

Libertarian Party of Somerset and Middlesex Counties (LPSMC) Vice Chair John Paff is leading the charge of many Somerset County residents for a "clean" new prosecutor to replace disgraced and convicted former prosecutor Nicholas Bissell.

Paff heads a non-partisan local group called Citizens for Justice (CFJ), which is actively trying to influence the selection of the next prosecutor. Specifically, they are attempting to prevent the appointment of Republican political insider John Richardson of Somerville, whose past associations with Bissell and disgraced former Bridgewater Township Prosecutor Francis X. Hermes suggest ethical questions that Paff would rather not have to ask.

The efforts of CFJ were reported in a front page story in the May 8 issue of the Somerset Messenger Gazzette. Paff and his Libertarian Party title were cited in the story, which reported rumors of Mr Richardson's imminent appointment by Governor Whitman.

In addition, the editorial in the same issue dealt with this sensitive subject by saying that, although

"Mr Richardson is an affable lawyer who has served the county Republican Party well.",

his past actions

"cast serious doubts on Mr Richardson's judgement. And though Mr Richardson may otherwise be fully qualified to be Somerset County Prosecutor, he...has to...be well above suspicion.

"The next prosecutor must be an independent person with minimal ties to what Citizens for Justice in Somerset County correctly calls "the good of boys club."

# PRESSER ENDORSED AGAIN, COVERED IN THE NEW YORK TIMES & PHILADELPHIA INQUIRER

NJLP candidate for State Assembly in the Eighth Legislative District **Dr Janice Presser** of Moorestown is making a habit of getting endorsements. After making NJLP history by getting our first endorsement for legislature from a major newspaper in 1995 (from the *Courier-Post*, the largest newspaper in South Jersey), she picked up three endorsements last year in her bid for Congress; one from the *Burlington County Times*, and two from radio talk show hosts.

This year, the same two hosts, Jim Gearhart and Dennis Malloy, both of New Jersey 101.5 radio, have endorsed her again, before the Republicrats even held their primary elections!

The two hosts are heard throughout New Jersey, and Gearhart has himself been the topic of a feature story in the Star-

Presser, whose campaign is managed by her husband and Burlington LP Chair Barry Perlman, was covered in the Philadelphia Inquirer on March 30, in a story entitled "Last of the big spenders? Candidate certainly is not". She was also covered in the Sunday New York Times on April 20.

# FINANCIAL TRENDS OF THE REPUBLICRATIC EMPIRE

Bill Clinton often tells people that his administration has now "brought down the deficit" the US Government runs each year to around one-hundred-billion dollars.

Many are impressed by this, because they confuse the *debt* and the *deficit*. The debt is the amount the government has already borrowed and spent, and for which we are liable. The deficit is the amount they are borrowing and spending *this year*, which will be added to the debt. Reducing the *deficit* simply slows the speed at which we are bankrupted by the *debt*.

Mary Q. Public is so busy managing her own life that she doesn't notice, let alone protest, the continued expansion of her share of the federal debt, currently at about \$21,000 per person for past Federal borrowings alone. This year's additional borrowing of about \$100 billion will add about four hundred dollars to each person's share.

This situation has few historical parallels, as described here by Paul Kennedy:

"Even if federal deficits could be reduced to a 'mere' \$100 billion annually, the compounding of national debt and interest payments by the early twenty-first century will still cause quite unprecedented totals of money to be diverted in that direction. Historically, the only other example which comes to mind of a Great Power so increasing its indebtedness in <u>peacetime</u> is France in the 1780's, where the fiscal crisis contributed to the domestic political crisis."

#### LIBERTY ROUND TABLE STUDENT ESSAY CONTEST

The Liberty Round Table has announced its first essay contest for students. There are two first prizes; one of \$750 for the best essay from a college student, and one of \$500 for the best essay from a high school student. The Liberty Round Table encourages young people to fight this trend toward nationwide involuntary servitude. The best entries will "expose the immorality of enslaving our young in a vain effort to prop up the state's failing welfare programs". Especially desired from the entries are practical "how-to" guides that instruct other students in how to 1) evade the requirement, 2) protest the requirement, and 3) cause embarrassment and regret to the perpetrators of the requirement.

#### TEN POINT CHECKLIST FOR STATE LIBERTARIAN PARTIES

This checklist was brought back from the March LP leadership conference in Washington by NJLP Chair LenFlynn. Read it and compare the NJLP to it. Wherever we come up short, in your opinion, is where your help is most needed.

#### A successful state Libertarian Party...

- 1) Maintains an accurate, up-to-date database of members and prospects,
- 2) Promptly sends a professional information package to prospects, and renewal notices to members,
- 3) Is constantly prospecting for new members,
- 4) Publishes a decent newsletter regularly, publicizing activities and successes,
- 5) Has a bank account and is constantly raising money,
- 6) Offers candidates for public office,
- 7) Sponsors and publicizes regular public meetings which are interesting and productive,
- 8) Holds regular meetings of party leaders to plan strategy and projects,
- 9) Has an organized media outreach plan, including press releases and conferences
- 10) Has leaders dedicated to growth and professionalism, who have vision and avoid factional divisions.

# BYLAWS AMENDMENT PROPOSED

At the Steering Committee Meeting of May 18, the following changes in the bylaws were endorsed, and will be voted on at the July 12 General Meeting: A new paragraph "g" will be added to Article 5, Part D, State Board section 4: G.

"Representatives are expected to serve their counties by attending State Board meetings regularly. A Representative may designate in writing an alternate for a meeting which the Representative cannot attend, and the designee shall count toward the quorum and be allowed to vote. Failure to attend two (2) Board meetings by a Representative or Alternate during a term shall result in the Representative's seat being declared vacant. Vacancy takes effect upon the call of the roll at the beginning of the second missed State Board meeting."

This phrase will be added at the end of Article 5, Part D, State Board Section 4, Paragraph A:

#### EDITORIAL: HALFWAY MEASURES AND COM-PROMISES

The NJLP Convention in March narrowly defeated a resolution praising the former Lincoln Park (Morris County) School Board for attempting to create a voucher system. The arguments in favor included the idea that, while vouchers do not free homeowners from paying for others' education, they at least free parents who can't afford both property taxes and private school tuition to choose their child's school, thus making them partially free, or freer than they are now.

The arguments against this resolution pointed out that, under a voucher system, public officials would still be in control of the money, thus bringing the corrupting influence of politics into private schools, which are currently oases of freedom from such influences. This is a compelling argument, as we have seen politicians at all levels take our money and then promise to return some of it if we jump through certain hoops and behave in certain ways.

It's not hard to imagine elected board of education members snooping through every private and parochial school in their district, digging up dirt on teachers or tracking down some unpopular tenets of the religions taught in those schools, in an effort to deny voucher money to some and establish public control over others. "Saint Mohammed of Israel School shouldn't get any voucher money until their teachers join the NJEA, assuring our community's children of quality instruction" is just one of the many outrageous demands we would have to contend with, in a voucher system.

However, we Libertarians need to decide when compromises or halfway measures <u>are</u> acceptable, as we are clearly not living among people who will countenance a restoration of the Constitution or Bill of Rights anytime soon. Is compromise <u>never</u> acceptable?

Should we not accept tax credits (an idea of NJLP Chair Len Flynn's), but only tax cuts? Should we endorse a reduction in the number of situations in which assets can be forfeited without trial, or should we denounce someone who proposes this as a backslider for not insisting on the complete abolition of asset forfeiture? Should we eagerly accept slight tax cuts, or demand the whole loaf of economic freedom? Should we endorse an easing of the penalties for smoking marijuana, or reject that as an inadequate substitute for legalizing all drugs? Should we refuse to accept a restoration of the Fourth Amendment until the rest of the Bill of Rights is also respected?

What we need is a guiding principle for deciding when - if ever- compromise is acceptable. What do you think? Should we have such a guideline? If so, what should it be?


# MY ENCOUNTERS WITH THE EMPIRE

My name is Bob Mondgock, and I'd like to tell you why I'm the Libertarian candidate for State Senate in New Jersey's 30th Legislative District.

It all started in 1985, when I wanted to create a pond on my property. I received permission to dig this pond from the Army Corps of Engineers, the Burlington County Soil Conservation District, and the Township of Mansfield (Burlington County). I even received a manual from them which describes exactly what to do and how to do it, which they acknowledged giving me in later court proceedings.

Despite my efforts to do this responsibly, my family and I have been harassed by the New Jersey Department of Environmental Protection ever since. Although I have not been charged with any crime, they have kept me tied up in litigation which has now cost me over \$85,000. They've also told me I can't sell my home, and they've ordered me to donate \$12,180 to a "wetland mitigation bank". And yet, during this litigation, they've testified in court that I've caused no harm to the environment.

During this ordeal, I've tried to work
with both Democratic and
Republican politicians in
an effort to resolve this
situation, without success.
They just aren't representing us. The system lacks
a link between the common man and government. Somewhere, something is missing. We need
to create a vehicle
through which our voices
may be heard.

#### NEW JERSEY GETS DUMPED ON BY REPUBLICANS -AGAIN!

#### **EPA TO THE RESCUE**

Last November, the EPA proposed an arbitrary tightening of national air quality standards (see EPA EXPANDS RULES, January 1997 NJL). The proposal includes lowering the ground ozone emissions level from twelve parts per billion (ppb) to eight ppb. In addition, an entirely new topic of regulation would be particulate matter (pm), or flecks of solid material smaller than two-and-one-half microns across. These particles are so small that at least twenty-eight of them would fit on the width of a human hair. Sources of these microscopic particles include everything from power plants, farms, and fireplaces to lawn mowers, firecrackers, and cow manure.

However, the EPA's own Scientific Advisory Committee reported that there is no "adequately articulated scientific basis for making regulatory decisions concerning a particulate matter 'National Ambient Air Quality Standard'", and admitted that the rushed rule-making process "did not allow adequate time to analyze, integrate, interpret, and debate the available data on this very important issue."

Such regulatory overkill is especially worrisome in those counties classified as "non-attainment zones", which would have to impose even tougher auto inspection, maintenance, and commuting regulations than other counties. In New Jersey, these "non-attainment zones" include twelve counties:

Atlantic, Bergen, Camden, Essex, Gloucester, Hudson, Mercer, Monmouth, Ocean, Passaic, Union, and Warren.

The impact wouldn't be just economic; lifestyles would have to be significantly altered, especially in urban areas. Arnold Rightsy, Environmental Law Professor at George Washington University, says that, unless urban areas are "willing to give up automobile use to a large extent, they will probably never meet the standard." Thus, on the flimsiest science, the EPA's proposed regulations would over-regulate most New Jerseyans, not just "big polluters".

Current enforcement of the 1990 Clean Air Act costs local government and business \$50 billion annually. The EPA estimates that tightening these standards would cost another \$11.6 billion, on top of an annual regulatory expense already costing \$667 billion. Who pays? The consumer -at the fuel pump, grocery store, and electric bill.
