Libertarian opposes 3 state bond issues

TRENTON — Jack Moyers, the Libertarian Party's gubernatorial candidate, has criticized the major party candidates for endorsing three state bond issues appearing on the ballot next Tuesday and trying to "bamboozle" the public into believing bond money is free.

Moyers said yesterday bonds do not "mysteriously pay for themselves."

Democrat James J. Florio and Republican Thomas H. Kean favor "new bond issues which will benefit the banking-insurance-legal industry at the great expense of the taxpayer."

To revive the state economy, Moyers proposed "turning our major cities into free ports by repealing licensing procedures which benefit only special interests and lawyers and which are barriers to employment and free trade.

"In the absence of stifling legalism and high taxes, light assembly industries could thrive as they do in Singapore and Hong Kong," Moyers added.

The NJLP's 10th Anniversary Convention has been scheduled for March 12-13 at the Beacon Manor, Point Pleasant Beach. Here is the tentative agenda:

A cocktail reception for the convention speakers will be held Friday at 8:30 p.m., with an open bar for two hours and hot hors d'oeuvres.

Registration will begin Saturday at 8:30 a.m., with a breakfast of coffee and danish following at 9 a.m. NJLP Secretary Leonard Flynn will deliver the convention's keynote address.

A business session to elect party officers will be held at 10 a.m.

Workshops with New York Free Libertarian Party Chairman Gary Greenberg on victimless crimes and LP National Vice Chair Sheldon Richman on business regulation have been set for 10:30 a.m.

At noon, there will be a buffet luncheon and an address by Nancy Plent on her experiences with "unschooling."

Peter and Phyllis Breggin will offer a workshop at 1 p.m. tentatively entitled "Love and Liberty."

At 2:30 p.m. another business session will be held to nominate candidates for U.S. Senate and Congress and to adopt new By-laws.

"Defending America: How Much is Enough?" is the subject of a panel discussion moderated by former Monmouth County LP Chair Ronald Wishart at 4 p.m. Confirmed panelists are Bette Bono of the Coalition for a New Foreign and Military Policy, Charles Wiley of the National Committee for Responsible Patriotism, Gary Greenberg, and Sheldon Richman.

A cocktail hour at 6 p.m. will give everyone a chance to unwind before the banquet at 7 p.m. featuring an address by Peter Breggin on the "Psychology

of Freedom." The dinner fare will be prime rib.

A complete convention package will be in the \$50 to \$60 range, with separate events available as well.

Various organizations will be invited to include material in a convention packet, and there will also be literature tables.

Normal room rates are \$25 single and \$30 double, but for our convention attendees all rooms will be \$25.

IMPORTANT: We will only be allowed a 3% overage on meals by the Beacon Manor. If you want a meal you must get your reservation in ON TIME. We will not be able to sell extra meals at the door.

STATE COMMITTEE MEETING

On October 17 the NJLP Steering Committee met at the Flagship Restaurant in East Brunswick. All members were present except Jo Ann Balint. The group approved the 1982 NJLP convention package (see article) and approved \$25/year to subscribe to the national LP's newspaper clipping service.

Barry Siegel proposed and the Committee supported a 3 day regional conference near Atlantic City to be held in conjunction with a NatCom meeting in August 1982. Barry will coordinate with National LP Rep. Dave Walter on the project.

A special State Committee meeting will be held on Saturday December 12, 1981 to generate more county libertarian activity and to plan strategy for 1982 campaigns. The Steering Committee voted to support national LP holding a June 1982 candidates' school in New Jersey.

Finally, the Steering Committee voted unanimously to approve a motion to pay the NJLP Treasurer \$25 per month and maintain the Treasurer's present responsibilities for accounting (\$10/mo.) and membership (\$15/mo.) activities. This authorization is effective until the 1982 NJLP Convention. The Committee asks NJLP members to come forth with alternatives, suggestions, or their own proposals on performing this important and essential party activity.

Your editorial, "Soviet Insecurity," (10-14-81) reflects the bi-partisan policies which have involved this nation in four major wars in this century and brought us to the brink of nuclear holocaust. It is a hypocritical government policy and does not represent the desires or interests of the American public or even of the people of the so-called friendly nations we're supposed to be protecting.

The security of the Russian government is indeed threatened — and deservedly so — considering what a vile, murderous regime it is. Surrounded by hostile or untrustworthy governments, it can neither feed its own people nor trust its subjects not to flee or revolt nor look for aid from any quarter. It is, said Libertarian Ed Clark, a "cautious predator." How is U.S. security enhanced by threatening and provoking a wily, vicious and dangerous government; or arming its potential adversaries, including the bloody Red Chinese government; or meddling in the affairs of its neighbors?

DICK RANDOLPH FOR GOVERNOR '82

Dick Randolph has announced his candidacy for Governor of Alaska early so that he can have a bigger impact on the outcome. In fact, Dick will be running a full time campaign to win.
