

the business was fined for simply not posting a blank sheet of paper. The EPA fined a North Carolina subsidiary of the Marmon Group \$5,000 for inadvertently writing the company's name on line 17 rather than line 18 of a form. The EPA imposed \$600,000 in fines and legal fees on another subsidiary of the Marmon Group for failing to fill out a federal form, even though the company complied with the identical state law.

The FDA passed a new rule requiring McCurdy Fish Co. of Lubeck, Me., to gut freshly caught fish before immersing them in brine tanks. Unable to bear the additional cost, John McCurdy shut his plant down, laying off all 22 workers. This was after 20 years in business and not a single case of botulism reported against McCurdy.

The U.S. Army Corps of Engineers fined a Minnesota Framer \$45,000 for filling in a one acre glacial pothole that was making farming difficult on his property. Having fined him, the Corps made him dig the fill out.

A Maryland couple suffered devastating financial losses when the endangered puritan tiger beetle was found on their property. In order to protect the beetle, the couple was prohibited from taking action to halt the soil erosion that was jeopardizing their home. During their fight with federal agents, 22 feet of their property plunged into the Chesapeake Bay.

Tuang Ming Lin, a Vietnam refugee, faces a one year imprisonment and a \$300,000 fine because federal agents accused him of running over "five suspected Tipton kangaroo rats" while tilling his 719 acre farm in Bakersfield, Ca. Federal agents have already seized his \$50,000 tractor.

If you think our only constitutional guarantee not yet usurped by congress is the Third Amendment protection against quartering of troops, think again. It is under siege. But it's animals and insects we must quarter instead of soldiers. There's a Western solution to this aspect of congressional heavy-handedness. If you spot an endangered species on your land, shoot, shovel and shut up.

Michael Rowe broke the law when he built a firebreak around his Riverside, Ca. house. His house was saved while most of his neighbors lost theirs in the fires that erupted in Southern California last year. It's that kangaroo rat again. Acting on the demands of environmentalist to protect the kangaroo rat, congress prevented homeowners from building firebreaks in or around the rat habitat. This is yet another example of invisible victims of congressional policy: Devastated homeowners blamed the fires and winds instead of the environmentalists and congress.

That's on the California side. In 1993, \$500 million in construction was halted in Orange County, Ca. by the Fish and Wildlife Service to protect the 2 inch Pacific pocket mouse.

This is just a sampling of congressional folly compiled by the Washington-based Americans for Tax Reform Foundation. We can't just stop congress from doing stupid things; we must eliminate its capacity to do so. First, we must force congress to respect the Tenth Amendment and, second, reduce its financial resources by limiting what it can spend.

Minutes of the N.J. Libertarian Party State Board Meeting of 9/18/94

The chairman called the meeting to order at John Paff's house, Somerset, at 1:21 PM. Present: Layman, Flynn, Ellett Stefanelli, Campbell, Paff, Quarles, J. Eden Girardeau, Glatter, E. Macron, Mehaffey, McInerney and Weissman. Absent: Grindlinger, Muentz, Peters and Savicky. Also

present were L. Eden and Ronald R. Tamburro.

The minutes of the Steering Committee meeting of August 21 were accepted, and the treasurer's report was received.

On-going business:

By-Laws implementation election of County Representatives.

Stefanelli reported that the changes authorized by the State Convention have been made. With the election of Terry McInerney as the Monmouth county representative the State hoard election process authorized by the Convention is complete. The old State Committee is defunct. This is the first meeting of its successor. The county representatives to the Board were nominated in writing by members residing or working in the counties; they were elected by ballot mailed from the NJLP. The hope was that members in unorganized counties would get to know each other during the nominating period and form a county party. Of the twentyone counties in New Jersey nine are represented on the State Board Two of the organized counties are not represented because no one in those counties submitted a nomination to the Secretary, as required by the by law changes.

Membership: Campbell requested that those planning to run an OPH booth contact him. Fund raising. Layman stated that an appeal for a specific purpose will be made after the November elections.

CATV show. Ellett reported that demonstration tapes are being circulated to CATV management's in Monmouth and Ocean counties. (Contact Emerson Ellett @ 908-774-3684 if you would like these tapes to air at your local access station)

Media relations. Paff and Wiessman RESOLVED, that the NJLP appropriate \$325 for the purchase of Prof. Walter Williams' weekly column. PASSED. (The column will run in the N.J. Libertarian for one year, the idea being that members will use it to convince their local paper to carry it.)

Electoral strategy. Layman will inquire of all members who live in towns that have winnable local races if they are interested in running for office in

<u>Campaigns.</u> Ben Grindlinger, U.S. Senate, raised \$2,300 at Freedom Day; he has also held a rally in Trenton opposing the Haiti intervention Robert Heitner, Sussex County Freeholder, has raised \$14,000 of his

\$20,000 budget; his signs blanket the county; he has been attacked by Republicans and has appeared at every "town day" where he has distributed blue spruce seedlings; he will take a leave of absence to campaign full time. Austin Lett, Chatham Township Council, has scheduled a fund raiser with Gene Burns as headliner; he has ten activists working, but more are needed; volunteers, please contact Stefanelli. There was no report on the Bacon (5th U.S. district) and Derby (Cumberland county clerk) campaigns.

Old business: 1995 convention. Stefanelli, E & J Macron, Campbell and Vicki Newman have volunteered to plan the convention. Others are welcome to join them. NJLP Platform committee. E. Macron, Dan Karlan, Flynn, J. Eden and Paff have gathered six state platforms to assist in the preparation of our platform, which will be available after the November elections.

State as Resource for the Counties; Flynn reported that 3,000 tip boards are available at a cost of 2 1/2 cents each, and that 100 bumper stickers are on order. RESOLVED, that the NJLP spend up to \$459 for the purchase of 5,000 LP "What Happened to Your Family Budget" leaflets with the NJLP's membership form on the back panel. PASSED.

Business return mail and other costs: Flynn reported on the cost of BRM, for the consideration of the fund raising committee. Ellett reported that he received a quote of \$175 for 5,000 #9 business return envelopes.

Relationship between the Steering
Committee and the State Board:

The new by-laws committee of Campbell, chair, and Flynn, Paff, Glatter and McInerney will propose changes that will clarify which body makes policy, authorizes expenditures, approves candidates, sets objectives and determines what can be done for the counties, as for example, by providing candidate training classes. At Weissman's suggestion the ca committee will also address how the NJLP can be protected from takeover, perhaps by requiring the gubernatorial candidate to win delegates from the counties, or by requiring new members to wait 90 days before being eligible to vote for state candidates whose jurisdiction crosses county lines.

Operation Safe Streets: OSS is the LP's solution to crime. RESOLVED, that the NJLP purchase 5,000 OSS flyers modified with the NJLP's membership form at a price NTE \$250. FAILED (for lack of a distribution plan). RESOLVED, that the NJLP

purchase 100 copies of Patient Power for \$125. FAILED (for lack of a distribution plan). RESOLVED. That the NJLP reimburse Paff for the OSS kits purchased for the State Board. PASSED. ■

Is Your Country or Town Breaking the Law?

Since 1987, the Somerset Count Prosecutor's forfeiture accounts, containing millions of dollars in seized and forfeited cash and property, have been audited by Thomas C. Wagner. Wagner, a certified public accountant, is a former business partner of Nicholas L. Bissell, Jr., the Somerset County Prosecutor.

Over the years Bissell's forfeiture accounts have been the subject of controversy. In Nov.1993, for example, Bissell admitted that he privately sold two forfeited cars-a 1984 Maserati Biturbo and a 1981 BMW-to a local car dealer for \$7,000 without the public auction required by state law. When asked to comment on this incident, Bissell said "It was a flat-out screw-up. I'm not going to put any window dressing on it. It was a screw-up."

At about the same time, a Courier News editorial railed against the inaccessibility to and the incompleteness of Bissell's forfeiture records. The editorial gave several examples of paper trails on seized cars vanishing and instances of record-keeping being incomplete. It also pointed out that the Somerset County Prosecutor had twice submitted all his quarterly forfeiture reports "all at once after the year ended." None of these deficiencies, however, were revealed in Wagner's audits.

Finally, in March 1994, the United States Attorney's office subpoenaed the bank records of Bissell's forfeiture accounts. The feds have a policy of not confirming or denying who the targets of their investigations are. Bissell assured the press, however, that the feds told him that he was not the target of this investigation. When asked, the feds refused to confirm or deny Bissell's statement.

Despite all this controversy, the county Freeholders did not change the auditor of the forfeiture accounts until September 1994. The Freeholders changed their minds only after I presented them with a ruling from the Department of Community Affairs (DCA) that Wagner, who is not licensed as a Registered Municipal Accountant, was not qualified to audit government funds pursuant to the Local

Fiscal Affairs Law. According to Beth Gates, director of the DCA's Division of Local Government Services, Somerset County's "failure to have all forfeiture accounts held by the Prosecutor's office audited annually by a registered municipal accountant is clearly a violation of the Local Fiscal Affairs Law." Gates' ruling was in response to an inquiry that I filed with her office.

The day after I received Gates' ruling, the Freeholders hired a registered municipal accountant to audit the forfeiture funds, but only for the 1993-94 year. After I threatened to file a complaint against the county, the Freeholders grudgingly agreed to hire the new accounting firm to also audit the accounts for previous years.

My wrangling with the Freeholders on this issue generated no less than five headline stories in the local papers. It took me over two years get the County of Somerset to remove Wagner as auditor of the county's forfeiture accounts. Now that I have Gates' ruling on file, we can quickly correct similar illegal audits that exist in other towns and counties. Four protesters had been arrested for burning their water bills in protest of a 90% rate hike. This was done at a gathering outside a public hearing held by the borough council.

The hearing was attended by 200 residents unhappy with this new tax increase. But only four burned their water bills. Al Arena, Kris Pfeifer, Genevieve van der Veken and Catherine Bradley.

The charges were based on "the states right to enforce safety". The state's position was that there needed to be a permit for this burning and "The state is allowed for safety reasons to control public expression".

This story bears notice to keep in the forefront of our thoughts the extremes the state can go to with the seemingly most innocuous power to arrest, detain and prosecute its citizens.

The judge has not rendered an opinion in this matter. My guess is the judge will make some statement about the necessity of obeying the law, and either fine these criminals and suspend the fine or find them guilty and not impose any penalty. I don't expect the judge to completely dismiss a state's claim to the right of enforcement of its laws.

The Libertarian Party was present at the courtroom along with 20 other supporters and Hands Across America. Members of the Somerset and Middlesex Chapters of the Libertarian Party handed out flyers which read: "These citizens shouldn't even be here today. They stand accused of no crime, or even failing to pay their sewer bills, but daring to speak out against theft of their money through taxation", said Ray Babecki, area chairman of the Libertarian Party.
