### "Libertarian Appointed to City Task Force"

#### Rent Control Revision & Modernization

**Immed Release Oct. 4, 1995,**  
**Hoboken, NJ:** Michael Buoncristiano has been appointed by the Hoboken City Council to a task force on rent control and modernization. Buoncristiano, as President of the Hoboken Homeowner's Alliance, has been active in efforts to deregulate rents in the city and supported a Vacancy Decontrol Amendment last year was passed by the City Council and later rescinded when a tenant activist group blocked passage through a successful petition. Rather than bring the issue to a referendum, city officials chose to rescind it in light of upcoming School Board and Council elections. In July, Buoncristiano again pressured the newly elected Council to reexamine the issue.

Mike Buoncristiano is President of Avanti! Direct Marketing Services, Inc. He is also Hudson County Organizer and County Representative to the State Bd. for the NJ Libertarian Party.

You cannot fail in what ever you undertake if you are honest, responsible, trustworthy, thrifty, industrious and true to

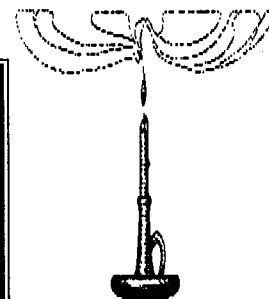
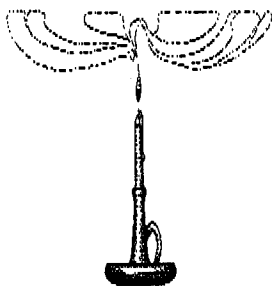
your word.

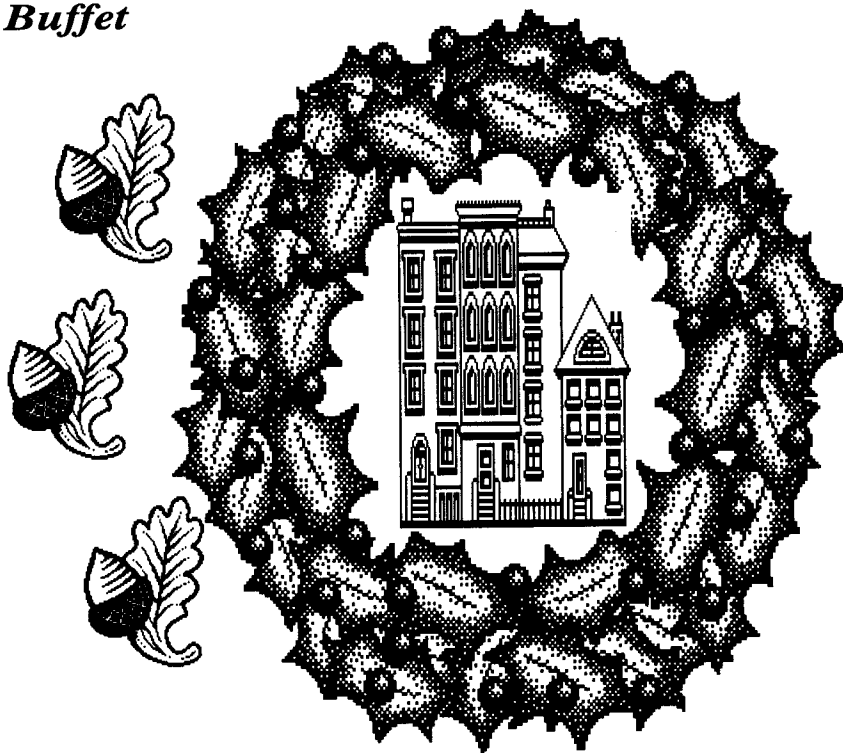

## ***Bizarro - DYFS is Bizarre***

### ***Editor***

The headline reads: "Mom jailed for defying home schooling order." But the article does not say that. Frederica Bizarro is the mother of a mildly learning disabled 15 year old son. She removed her son from the West Caldwell school system to educate him at home. She did this with the approval of the School Officials, which had reviewed the curriculum designed by Professor Beverly Kling of the special education department at Kean College in Union, N.J. Mrs. Bizzarro has 18 years teaching experience in the Newark School system.

Nothing too radical here. The mother is a state certified teacher, the Professor is a state employee specializing in a state devised program called special education, the school officials have approved the plan, also certified by the state in their positions and all this is allowed by state law "as long as they provide instruction equivalent to what is offered in school. The law does not require testing, but parents must prove that their instruction is adequate if they are challenged.

Now if everyone involved here is certified and approved by the state, and the curriculum is approved by all of these state certified employees. Where did the objection come from? A guardian assigned by DYFS **suspected** educational neglect and asked for the testing. Seig Heil! The parents refused and a complaint was filed in Superior court. Judge Camp ordered the testing. Seig Heil! Mrs. Bizarro spent the night in jail while her son was taken to DYFS land for IOWA basic skills testing. Can all kids in public school pass the Iowa basic skills test?

To Mrs. Bizarro's credit she resisted the officers and now has a criminal complaint to contend with. Of course the County Sheriff showed up personally to get his picture in the paper with Mrs. Bizarro in handcuffs.

This is worth your time to investigate and DYFS is one of the most Seig

Heil agencies I have ever been aware of. How did this "guardian" come to this "suspicion." Educational neglect is rampant in the public schools- how does it become the business of the state if a mother (with 18 yrs. experience) is following the state plan? Did she follow it enough, not enough? Will DYFS sign a complaint against all the school teachers in the Newark public schools? Will DYFS sign a complaint against Mayor Sharpe James for educational neglect? Will DYFS take over the school systems?

Federal government's National Conversation is \$1.6 million

"boondoggle for blabbermouths"

WASHINGTON, DC — The federal government doesn't think Americans talk enough. So the National Endowment for the Humanities (NEH) gave away \$1.6 million of taxpayer's money yesterday as part of a new program to encourage a "National Conversation."

"Only in America!" marveled Libertarian Party spokesman Bill Winter. "Only in America would the government pay people \$1.6 million to talk more. I mean, this is the nation of Rush Limbaugh, New York cab drivers, and Bill Clinton's State of the Union speeches! Insufficient chatter is not generally perceived to be one of America's most pressing problems."

The National Conversation program is designed to get "Americans to think and talk about themselves" and stimulate discussion "about what the American people are as a nation," according to news reports. The money was distributed in grants around the country to "creative people," communities, and civic groups.

NEH spokesman Gary Krull said the \$1.6 million will be spent on "guidelines, moderators, and meeting rooms" for the National Conversation. "I'm not a government bureaucrat, so maybe I'm missing something, but Americans seem to have no problem finding places to chat

— on talk radio, in coffee shops, on the street, and on the telephone," said Winter. "And we seem to manage our conversations quite nicely, thank you, without federally subsidized moderators and guidelines."

"Americans used to believe in free speech. Now NEH bureaucrats believe in expensive speech — expensive, tax-subsidized speech. Here's the Libertarian Party's two cents worth of conversation: Abolish this preposterous program. End this boondoggle for blabbermouths," said Winter.

## ***Senate Bill No. S-974 Ballot Access***

(sponsored by Sen. Schluter) makes several changes in the state's election laws. Most notable is a significant reduction in the number of votes a political organization (such as the Libertarian Party) needs in order to be recognized as a "major" political party. A copy of the bill can be ordered by calling 800/792-8630.

### ***Official Statement***

This bill revises the provisions of "The New Jersey Campaign Contributions and Expenditures Reporting Act" which govern the establishment and permissible campaign financing activities of legislative leadership committees. It also revises the statutory definition of a "political party".

Under a 1993 revision of the Reporting Act, the presiding officer and the Minority Leader in each house of the Legislature are permitted to establish a legislative leadership committee to receive contributions and make expenditures to promote the election of candidates for public office and the passage or defeat of public questions. There is no requirement that these committees include members of the legislative party of the presiding officer or Minority Leader who establishes them.

### ***Under this bill:***

(1) Authorization to establish legislative leadership committees is extended to the leader of any minor political party conference in either house of the Legis-

lature. This provision would place minor party leaders on the same footing as a presiding officer or minority leader of the Legislature, who, unlike any other elected public officer, has specific statutory authority to create and control a campaign financing organization (i.e., a leadership committee) which is separate from and in addition to the person's own candidate organizations).

(2) Each legislative leadership committee would have to include at least four members of the appropriate legislative party, elected by the members of the appropriate legislative party conference. If the party conference of a minor political party included four or fewer members, all would be members of the leadership committee.

(3) No campaign contribution or expenditure by the committee could be made except upon the affirmative vote of a majority of the elected legislative members (or, in the case of a minor party conference having so few members that all are members of the leadership committee, by a majority of all of those members).

(4) A legislative leadership committee would be prohibited from making any contributions or expenditures except in connection with general election candidates for the office of member of the Legislature.

(5) The threshold of electoral support required to qualify a party as a political party for purposes of holding a primary election under New Jersey election law would be reduced from 10% to 3% of the total vote cast in the State in the preceding general election for members of the General Assembly. There is authority (*Vogler v. Miller*, 660 P.2d 1192 (Alaska 1983)) that a statutory definition of a party requiring 10% of the votes cast in the preceding gubernatorial election to qualify for a place on the gubernatorial primary ballot constitutes an undue restriction on access to the ballot.

Ten new restrictive ballot access bills pose a "threat to fair elections" WASH-

INGTON, DC — As Colin Powell, Jesse Jackson, and Ross Perot ponder independent campaigns for president or new political parties in 1996, they had better watch out — Republicans and Democrats are working overtime proposing new laws to keep them off the ballot. "While millions of Americans clamor for more political choices, Republicans and Democrats across the country are busy writing new laws to protect their two-party monopoly on power," charged Steve Dasbach, Chair of the Libertarian Party, America's third largest political party. Dasbach said restrictive ballot access legislation has already been filed in 10 states in 1994 — Alabama, Alaska, California, Florida, Georgia, Idaho, Illinois, Maine, New Hampshire, and New Mexico. "These proposed laws would make it more difficult for non-Republicans and non-Democrats to get or stay on the ballot," Dasbach explained. "This should concern not just Libertarians and fans of Mr. Perot, Mr. Jackson, or Mr. Powell, but all Americans who want greater choice when they step into the voting booth." Dasbach said that Libertarians and other third-party activists have managed to beat back or stall some of the unfair new laws. "But this problem won't go away, especially if third-party candidates do well in 1996," he said. "The problem is that Republicans and Democrats write ballot access laws that — surprise! — favor Republicans and Democrats." Dasbach said ballot access laws in America are already "unfair and restrictive" compared to many other nations around the world. "For example, a new party formed in the United States for the 1994 election needed to collect 3,501,629 valid petition signatures to run a full slate of state and federal candidates," he said. "By contrast, a new political party in Russia needs only 100,000 signatures to get on the ballot for all offices; and only 10,000 signatures are required in South Africa. "It's deplorable when Russia and South Africa can boast of greater democracy than the United States. And these proposed new laws would only make it worse. They pose a genuine threat to fair elections and democracy." ADDITIONAL INFORMATION: 1994 Ballot Access Hall of Shame These pro-

posed bills would raise the number of signatures required to get on the ballot, or add additional requirements to get or stay on the ballot, or create more restrictive deadlines, or throw structural hurdles in the process of getting on the ballot. 1. New Hampshire: To become a "major" political party and obtain automatic ballot access, a party must gain 3% of the vote in the governor's race. Under HB-333, a political party would also have to register 1% of the voters (one of the highest requirements in the nation) within two years of earning "major party" status — or get booted off the ballot. TARGET: The Libertarian Party, which lawfully earned "major party" status three elections in a row under the state's previous 100-year-old law. STATUS: Passed by the House. The State Senate stripped out the anti-third party provisions, and the bill is now heading for a conference committee. 2. Illinois: SB-34 would prohibit paying people to circulate ballot access petitions on a per-signature basis. TARGET: Third parties, which must collect 100% to 1,000% more petitions than their Republican or Democratic counterparts. Even with paid petitioners, it's difficult for new parties to gather the required signatures. By restricting their ability to hire people to help, this bill would make it all but impossible. STATUS: Passed the State Senate; now before the House Rules Committee. 3. Idaho: HB-270 pushes back the petitioning deadline for non-presidential independent candidates by three months from June to April. TARGET: All third parties and independent candidates. STATUS: Signed into law on March 14th. 4. California: SB-418 and AB-1532 would prohibit paying people to register voters. TARGET: New third parties. Since new parties almost always qualify for the ballot in California by doing paid registration drives, these bills would make it immensely more difficult to qualify. STATUS: Defeated in the State Senate on a tie vote, but could be reconsidered any time. 5. Alabama: HB-66 would boost the signature requirements for independent candidates to get on

## ***Minutes of the N.J. Libertarian Party State Board Meeting of October 15, 1995***

The chairman called the meeting to order at Tumulty's Pub, New Brunswick, at 1:07~PM. Present: Flynn, Ellett, Stefanelli, Grindlinger, Konek, Mehaffey, Pfeiffer, Quarles, Bryant, Brown, Buoncristiano, E. Macron and Peters. Absent: Wiessmann, Dondes, Howley, Imbriale, Mecum, Pearce and Saint-Andre. Also present were Perry Willis, National LP Director, Mike Panella and Dan Karlan NATCOM representative.

The minutes of the Steering committee meeting of Sept. 17 were accepted amended, and the treasurer's report for the General-fund were received.

The LP has moved into presentable offices in the Watergate complex in Washington. The media has come by, and CNN aired a report. National membership stands at ~13,000 (NJ. is seventh, behind CA, PA, TX, MI, FL and NY, at 63 members per million. The no. 1 state in ppm is NH, at 195, the lowest ND at 14 ppm). A membership solicitation to 250,000 freedom-oriented people is planned. The mailing to the first 40,000 will soon go out. National is working on a welfare reform outreach package. In response to questions Willis stated that the media would be more impressed by 218 House candidates in 1996, the number required to govern, than by 50 state ballot access; thus the drive to get 218 candidates on the ballot and 50 state ballot access. As to the endorsement of NAFTA (and the international bureaucracy that it created) that was the NATCOM position based on some briefings by the Cato Institute. The LP itself has not endorsed NAFTA or GATT. National does not believe it can do a first rate Job of producing TV commercials; however it may undertake a major ad campaign in 1997, which could be spun off to the state parties. Willis will contact Rosselle about recruiting UWSA members; in anticipation that that organization will disband..

Standing committee recruitment and membership Saint-Andre will evaluate the entire process, including the info-pack, which at present contains LP literature and an NJLP membership application form. Counties should contact Stefanelli for a list of lapsed members, who are among the most promising recruits. ~E-Fund-raising—Mehaffey— See State Headquarters Office Committee. Public relations. Pfeiffer has resigned. Wiessmann and Buoncristiano have joined. County Committee reports. Camden county is organized, thanks to Pfeiffer, Mehaffey and the other members who came to the organizational meeting. Pfeiffer plans to organize Bergen county next.

Buoncristiano has revitalized Hudson county. Middlesex is preparing newsletters tailored to individual townships. Monmouth recently staffed an OPH booth at Allaire State Park.

Ongoing business and ad hoc committee reports: The Lett t Connors Campaign Chatham Township Comm.. is reaching between 50-100 households per weekend by going door-to-door. However, more volunteers are needed. Call Federici (201-764-7289)- Figueroa, 15th assembly District, is campaigning hard Presser and Howley; no report.

By-Laws (Flynn). RESOLVED, that the proposed by-laws changes distributed today be deferred to the Dec. meetings of the Steering committee. PASSED. Platform-Committee Quarles; The next meeting is Dec. 2. A draft will be available by the Convention next March. CATV (Ellett). Grindlinger will contact a Mercer county mail delivery of tapes, thereby obviating the need to deliver them in person.. Call 908-774-3684 if interested in being a guest or having the show aired in your area. Newsletter. Stefanelli will give the editor the latest information concerning bulk mail rates and postal regulation 1996 Convention Stefanelli. The Illinois LP chairman may be invited to speak on the on-going effort to establish a libertarian constitution in a Serb area that is presently part of Bosnia. Maine: LD-1091 would double all petition requirements for any third party or independent candidate to get on the ballot. TARGET: All third parties and independent candidates. STATUS: In committee. 7. Georgia: SB-148 would push the petitioning deadline for third party candidates back from July to May 9th, eliminating almost two months of petitioning time. TARGET: All third parties. STATUS: Passed the legislature; vetoed by the governor. 8. New Mexico: HB-1070

would double the number of signatures needed for the candidate of qualified minor parties to get on the ballot. TARGET: All current and future qualified minor parties. STATUS: Passed the legislature, now before the governor. 9. Alaska: SB-5 would push back the petitioning deadline for all non-presidential independent candidates by two months from August to June. TARGET: All third parties and independent candidates. STATUS: Signed into law on June 1st. 10. Florida: SB-2309 would make the filing deadline for write-in candidates more restrictive. TARGET: All write-in candidates. STATUS: Signed into law on May 2nd.

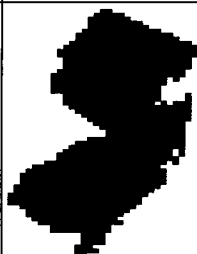
