

SWIRSKY RUNS FOR CONGRESS

Englishtown - Walter Swirsky, here has been nominated by petition to run for U.S. Representative from the 3rd Congressional District in November.

Swirsky will be running on the Libertarian Party line headed by Roger MacBride for President and Hal Cundari for U.S. Senate. Nine other Libertarian candidates for Congress will be running state wide.

Swirsky, a consultant and sales manager for Triple M Enterprises, has lived here for the past six years with his wife Bonnie and three sons ages 6-11. He plans to run an active campaign in order to achieve a large protest vote over the current politics of "tax, tax, tax, spend, spend," Swirsky wants to return the country to a "renewed prosperity" by "getting the bureaucrats out of the way."

He stated that "Italy is supposed to have the most laws on the books of any government and they stifle its economy. England seems to be trying to catch up and its economy is falling apart too."


ROGER MACBRIDE '51, THE LIBERTARIAN CANDIDATE

While his classmates are celebrating their 25th reunion at Princeton this June, Roger MacBride '51 will be barnstorming Iowa and Minnesota in his 1943 DC-3 as the Libertarian Party candidate for President. An advocate of minimum government and maximum individual liberty, he will have visited almost every state by the end of summer, whistle-stopping (via plane) in the manner of Harry Truman in 1948, espousing a political philosophy that draws heavily upon the ideas of Thomas Jefferson. MacBride readily describes himself as a Jeffersonian and regards Andrew Jackson as one of his heroes....


He does not like to be thought of as a fringe candidate. "They're candidates who, like Terry Sanford, failed to find voter support because they were in the market of shared ideas," he said. "Our ideas are different from the whole pack." ... "Our country's biggest problem is that we're over-governed. The Libertarian Party wants to systematically dismantle govennment intervention in personal, social, and national affairs. It's not at all revolutionary —we're updating the ideas of America's first Libertarian revolution in 1776.

'Basically, there are three areas in which change needs to be made: The first is foreign affairs. This country ought to be a benign Switzerland with a foolproof defense. I'm not talking about isolationism. That's economic -- raising tariffs. I'm talking about real, true internationalism, breaking down trade and travel barriers. Traditionally, and I'm going back to Jefferson and Madison, we were noninterventionist until 1917 when Woodrow Wilson-- the worst president this country ever had -- turned around the policy and got us into our worst war. We've been involved in three major wars since. We have troops, 2,300 military bases, CIA and State Department personnel all over the world, bribing and browbeating nations, And the world is a helluva lot less safe now than in 1917. It's time to recognize the absolute bankruptcy of Wilson's policy.

"The second area is the problem of government intervention in civil liberties. People have to be freed up to live as they wish." He listed the laws he would repeal: in particular, those regarding so-called "victimless crimes," such as consensual sexual relations (including homosexuality and prostitution), gambling, the right to commit suicide, and drug use.

"Before 1914," he says, "we had no drug problem. Then the government established a drug law that has had the same effect as Prohibition. England considered a drug law the same year, but did not enact one. Last year, England had 300 addicts, we had 90,000, not to mention how many more were unreported. Let people smoke pot; let drug users get their heroin fix at the corner drug store. They're no harm to us."

MacBride would eliminate compulsory gun registration and all forms of censorship, including restrictions on pornography. He would get rid of the Federal Communications Act and stop tax funding of the Corporation for Public Broadcasting. All government regulation of broadcasting would be ended and private ownership of broadcasting rights would be provided to give the electronic media First Amendment parity with the print media.

The third subject on which MacBride hammers away is federal control of the economy. "The U.S. supports monopolies," he says. "Amtrak, Lockheed, CAB -- not one single new airline has been allowed to enter the market since the creation of the CAB. The so-called new companies are all mergers. won't allow price reduction either. The ICC puts floors under the rates truckers can charge. That hurts the small trucker. The Federal Reserve System has invaded fiscal and monetary fields -- it pumps money in one day, dries it up the next. I call that malinvestment. The Fed has reached the end of its tether in its investment management. I'd end the existence of the Federal Reserve Bank, do what Andrew Jackson did when he abolished the Second Bank of the United States. We got along fine for 80 years (except for the greenback era of the Civil War until Wilson established the Federal Reserve in 1913. He also gave us the income tax that year and you know what a choker that's become. We want to protect the consumer, let the free market operate as best as it can. Profit attracts competition, and for those with inferior products, the winds of the free market can be cold." ...

LETTER TO THE CHAIRMAN OF THE PRUDENTIAL INSURANCE CO.

June 5, 1976

Dear Mr. MacNaughton:

Your address before the Newark Rotary Club has recently come to my attention. I commend you for your forthright remarks.

I am writing to inform you of the existence of the Libertarian Party. We share with you the view the lengthening shadow of Government encroachment on the lives and property of the citizenry is clearly inimical to the continuing development of an orderly society.

The Libertarian Party is an advocate of liberty, committed to voicing in both the political and academic realm the idea that the individual is entitled to a maximum of freedom in all fields of human action.

We stand for the proposition that government has no right to regulate our lives, that its only functions are to deter and punish force and fraud in society and to maintain a strong defense of the country.

Our supporters have come from both the left and right in the contemporary political spectrum; former liberals who recognize the abject failure of governmental social engineering projects and counter-productivity of government meddling in the economy and fromer conservatives who recognize that free enterprise presupposes freedom in the social as well as economic realm.

The Libertarian Party is now organized in all 50 states, having been founded in 1971; is perhaps the third biggest political party in the country; and expects to on the ballot in as many as 40 of the states this year including New Jersey, in which it also will be running a U.S. Senator, ten congressional candidates and several local candidates.

I have enclosed some literature for your use, and would be delighted to meet with you, say over lunch, in order to expand on the Libertarian Party's positions in more detail. We think that it is most important that prominent business executives such as yourself who appreciate the risks of expanding government become more thoroughly acquainted with the mission and goals of the Libertarian movement.

I have also enclosed a return envelope in the event you wish to make a contribution to our effort. As you may know, there is a rather direct correlation between dollars and votes in any political campaign. We urgently need financial support to communicate our ideas to the voting public, whom we believe are seeking a fresh alternative to the two major parties presently controlling our country.

To the Editor:

The term "Libertarian Party" embodies two concepts -- "Libertarian" and "Party." Some people believe that these concepts are diametrically opposed; I do not.

There are some who would stress "Libertarian" almost to the exclusion of "Party."
These are the people who will vote "no" on something relating to organization even while recognizing its merits, just to assert their individuality. Of course, this is their right, but it does little good for a "Libertarian Party."

On the other extreme are those who would stress "Party" almost to the exclusion of "Libertarian." These are the people who urge that our principles be "diluted" so that we might "win." But in so winning, have we really won? This group of individuals also has the right to promote its point of view, but I would contend that this attitude does little good for a "Libertarian Party" also.

What really hurts is that we can maximize the effectiveness of our party without, at the same time, compromising our principles—and it's really not as difficult as it may seem at first glance. It depends upon our candidates—who should really be the party's closest link with the non-libertarian public—and their willingness to keep a few basic tactical considerations in mind:

- 1. Campaign on issues affecting the voters' everyday lives, bringing in ideological concepts to back up your positions on these issues. In almost every Libertarian campaign in the past, there has been an intellectual bias. Our candidates have talked in terms of abstract ideology, sometimes bringing in concrete issues merely as examples. Reversing this order should result in greater understanding of libertarianism, as well as more votes.
- 2. Campaign against the incumbent and ignore the other major-party challenger. In a conceptual sense, a Libertarian candidate should be perceived to be running against the incumbent. The incumbent's ideology and VO-TING RECORD must not be off-limits.
- 3. Campaign on your own level. If you run for State Assembly, don't talk about withdrawing from the United Nations! This is VERY IMPORTANT in establishing a serious, viable candidacy in the eyes of the public. If you don't believe this, just take a look at how the U.S. Labor Party is shunned.
- 4. Never -- well, almost never -- mention the incumbent's name in your press re-

leases. And NEVER mention the name of the other major-party challenger. The Democrats and Republicans have advertising budgets hundreds of times larger than ours, so why dissipate our meager resources by giving THEM publicity? I could conceive of using the incumbent's name in an extremely negative circumstance. Otherwise, DON'T DO IT!

5. Campaign as much as possible as a "team" with other Libertarian candidates.
Our candidates have chosen to run under the LP label, so I can't see why they should be adverse to identifying with our party. It also makes sense tactically, giving an appearance of viability which is sorely needed in a third-party effort.

I requested the opportunity to speak on campaign tactics at the NJLP State Committee meeting of June 4 in the context of establishing the much-needed position of "Congressional Campaign Coordinator." Unfortunately, the topic was relegated to the bottom of a list containing 15 or 16 topics. By the time we got down to it, 1 a.m. or so, everybody -- including myself, I must admit -- was too tired to discuss it in any coherent fashion.

I was prepared to consider taking a leave of absence without pay from my job for the month of October at a personal loss of about \$1,200 in income to assume the responsibility of the "Congressional Campaign Coordinator." But the reaction to my proposal that night made me reconsider.

As libertarians, we should all realize that freedom and responsibility go hand-in-hand. In order to fix responsibility on a particular person, he/she must have the greatest degree of freedom of action. For suggesting this in connection with the proposed campaign position, however, I was labeled as being "authoritarian" and challenged to produce my "credentials" of "expertise" to even ask for such a large amount of responsibility.

Hopefully, there are some Libertarian candidates out there who really are serious about maximizing their potential impact in the electoral arena. I offer my advice to you in the above five points in hopes that it will be put to good use. If you candidates feel I can be of some help, contact me directly and we can see what we can work out --without the State Committee. "Along these lines, Swirsky said, "I don't think it is a coincidence that New York City, which pioneered in city planning, is now pioneering in bankruptcy. A State Committee meeting was held on June 4th at the home of Walter and Bonnie Swirsky. The Essex County and Bergen County by-laws were approved. The picnic, which will be held on July 18th, was discussed and \$200. was made available for refreshments. The Committee agreed to replace the August 14th meeting with a candidates conference to be held on August 14th. Dan Piro will chair the conference. He was allocated \$50. for mailings and room reservations.

The State Committee approved a letter drafted by Dan Piro asking that Chairperson Bill Schetlick resign in order to take over the responsibility for campus organizing. Kathy McAdam officially resigned as News-letter Editor. Bob Ryley was appointed to replace Kathy. Ken Kaplan was appointed Acting Chairperson in the event that Bill Schetlick resigns as State Chariperson. Statement of Principles

NEW JERSEY LIBERTARIAN PARTY

We, the members of the Libertarian Party, challenge the cult of the omnipotent state and defend the rights of the individual.

We hold that all individuals have the right to exercise sole dominion over their own lives, and have the right to live in whatever manner they choose, so long as they do not forcibly interfere with the equal right of others to live in whatever manner Governments throughout history have regularly operated on the opposite principle, that the State has the right to dispose of the lives of individuals and the fruits of their labor. Even within the United States, all political parties other than our own grant to government the right to regulate the lives of individuals and seize the fruits of their labor without their consent.

these things, and hold that where governments exist, they must not violate the rights of any individual; namely, (1) the right to life — accordingly we support prohibition of the initiation of physical force against others; (2) the right to liberty of speech and action — accordingly we oppose all attempts by government to abridge the freedom of speech and press, as well as government on the contrary, deny the right of any government to do censorship in any form; and (3) the right to property — accordingly we opp see all government interference with private property, such we opposes all government interference with private property, such as conflictation, national zation, and eminent domain, and support the profibition of robbesty, trespass, fraud, and misrepresentation.

Since governments, when instituted, must not violate individual rights, we oppose all interference by government in the areas of voluntary and contractual relations among individuals. People should not be forced to sacrifice their lives and property for the benefit of others. They should be left free by government to deal with one another as free traders; and the resultant economic system, the only one compatible with the protection of individual rights, is the free market.
