The NJLP Steering Committee met on September 23, 1985 at Patti's Restaurant in New Brunswick. Present were Maiullo, Friedlander, Hoegberg, Flynn, and Swirsky. Absent were Kaplan and White.

The members noted that the new party phone was operating perfectly. The new phone number is 201/ 937-9674 (corrected from the 8/24/85 meeting report).

Rick Hoegberg reported that a radar detector ban introduced by Assemblyman Schwartz was withdrawn following a letter from Rick and a subsequent discussion between the two. The committee appreciated Rick's effort and noted that a cogent letter could occasionally have a desirable effect on legislative happenings in Trenton.

Danny Maiullo noted that Citizen Advisory Boards might be a good way for libertarians to spread our message and work for useful political goals. He said one should ask to see the municipal code and look therein for these committees.

The committee voted unanimously to support the NJLP Chairman's decision to withdraw his nomination to fill the vacancy for Regional Representative and maintain "None of the Above" as was duly elected at the recent national LP meeting in Phoenix, AZ. Danny will notify national LP of this action. A survey of issues and priorities from Dale Hemming was delegated to Steve for response.

Based on a suggestion from LP election expert Richard Winger, the committee voted unanimously to initiate proceedings to allow voters to register as Libertarians in New Jersey. Danny will handle.

#### HEROES OF THE REVOLUTION

A continuing series dedicated to the unsung heroes of the Libertarian Revolution, people whose daily efforts swell the ranks of libertarians everywhere and assure the ultimate victory of our noble cause.

#### PART IX--"MINDLESS MEDIA"

The founders of our nation knew the importance of a free press so that the citizenry would be well aware of government and be able to exercise control through watchful vigilence. But nowadays what was supposed to be the watchdog press has instead become a lap dog for government and a prime supporter of statism.

One need only read the obnoxious editorial pages of America's "leading" newspapers or listen to major network TV newscasters to confirm their statist bent. Rarely are free market approaches to contemporary problems offered, and other Libertarian positions (e.g. repeal of victimless crime laws like the mandatory seat belt law and narcotics prohibition) are hardly ever heard. Instead endless tinkering with the status quo is offered in the name of reform, while the real issues are buried in meaningless statistics and rhetoric.

The major media are truly "mind-less" in their avoidance of principled debate about the true issues: individual rights, private property, and government denial of both. The socialist perspective of what is best for "society" (whatever that really means!) is always the criterion upon which a (nearly always statist) solution to some problem is offered.

Examples are legion. Several years ago I cancelled my Wall Street Journal subscription when the WSJ featured two South American commentators praising the "strong" (i.e. Fascist) leadership in Chile after the CIA engineered overthrow

and murder of Marxist ruler Allende. They said the Chilean people "wanted and needed" their new dictators!

The New York Times is so socialist in its economic commentary that
one wonders if Marx and Engels have
returned. The Times forever praises
government intervention into business, labor, education, and politics. Only when its rear end is in
the fire (e.g. the Pentagon Papers)
does the Times suddenly become
anti-state (and then only briefly).

Then there are the TV commentaries like 60 Minutes and the evening newscasts. Once more state based "solutions" to everything take center stage. Can you imagine Frank Reynolds or Mike Wallace advocating nonintervention, deregulation, and private property?

Following the lead of these opinion leaders, local media often repeat the expanded government line, so the public is buried by statist claptrap at every level. Is our cause then lost since the saving Libertarian message is buried by mountains of media manure? Surprisingly, NO!

The American people are not so stupid to believe all the garbage they read and hear, so they have developed a healthy skepticism for the media. Indeed their cynicism of modern politics is enriched by the emptiness of the media's views. And this is even reflected by jaded political reporters.

One most encouraging aspect of LP political campaigning is the astonishment of such reporters when they meet Libertarian candidates for the first time. Our frank, honest, and consistent approach to the issues amazes them, and they are surprisingly receptive to LP campaigners. As one reporter told NJLP candidate for Senate Harold Leiendecker last year, he was the "only one who answered the questions" the reporters had asked the candidates.

So the statism of the mindless media contains the seeds of its own destruction: the cynicism of its brighter reporters and the wisdom of the skeptical public. And if the evils of statism are still not getting through, then the American public can just look next door ...

Dear Friend of Liberty,

I am writing to you on behalf of my husband, Paul Jacob, to let you know what has transpired in his battle with Selective Service and the Department of Justice.

Paul was convicted of failing to register with the Selective Service System on Tuesday, July 2. He was sentenced to 5 years in prison with  $4\frac{1}{2}$  years suspended and 2 years of community service. Bond, pending appeal, has been denied both by the district judge and in an emergency bond hearing in front of an appellate judge of the 8th Circuit.

Ed Clark, Libertarian Party presidential candidate in 1980 and Ron Paul, former Congressman from Texas testified in Paul's defense. Their testimony was excellent and, I think, did have an impact on the jury. The jury was out for 2 hours before rendering their verdict of guilty. A member of the jury made comments to a friend of Paul's that he had kept the jury out because he felt the law was both unconstitutional and unjust. He went on to say that most of the jurors basically agreed with Paul's philosophy and respected his sincerity, but felt that, based on the jury instructions, they had to return a guilty verdict. Of course, the judge did not allow instructions regarding jury nullification.

As of this date, Paul is being held in Saline County Jail, Benton, Arkansas awaiting transfer to a federal facility. We have not been able to learn from the Justice Department when Paul will be transferred or to what prison he will go. I know Paul will appreciate any letters of support and I will let you know as soon as his address is confirmed.

As Paul stated when being taken away by federal marshalls: "They can imprison me, but they can't change my mind about the draft." And I know they can't change our minds either. We have the opportunity and the responsibility to make sure that the government knows they haven't won the issue. They may win in the courts, but what can we expect when the judges' salaries are paid by the federal government?

We seek your continued support which can come in many ways. I urge you to write not only Paul, but also Ben Sasway and Andy Mager and let them know you agree with the stand they are making. Second, write letters to the editor of your newspaper, or Arkansas newspapers, in support of the resistance movement. Finally, pledge continued financial support for Paul's appeal. The proponents of the draft have a full-time, tax-supported legion of lawyers to defend their cause, but resisters have only as much legal expertise as they can buy.

Additionally, we now have childcare expenses we didn't have when Paul was free. The closest federal prison is 200 miles away and it will be costly for Jessica and me to visit him. If you would like to help with such expenses it would mean a great deal to me personally.

Your contributions and especially your words of encouragement have been crucial in helping us sustain this battle. For Paul, I thank you.
