## *Libertarians Mark Second Anniversary of Informing Jurors*

On Tuesday, Sept. 5, 1995, national Jury Rights Day, the Libertarians on Monmouth County (LMC) celebrated the second anniversary of their ongoing effort to inform jurors of their right to judge the law as well as the facts. Beginning at 8:00 AM, LMC members passed out Fully Informed Jury Association (FIJA) leaflets to prospective jurors and members of the public at the Monmouth County Court House in Freehold.

The Monmouth County Libertarians and other activists passed out an estimated 5,000 FIJA leaflets in the past year, according to FIJA coordinator, Emerson Ellett of Ocean Township. Ellett says, "Jurors are not meant to mere cogs in the machine. Their purpose is to apply justice and fair play to the law."

September 5th is the date in 1670 that jurors refused to convict William Penn for preaching the (then) illegal Quaker religion to a (then) unlawful assembly (his congregation). The jury by refusing to convict provided a basis for

our First Amendment rights of freedom of speech, religion, and assembly.

The fully informed juror is something I became familiar with through my membership in the Libertarian Party. FIJA is, in my opinion, on one of the most important quests of any political purpose. The principal of jury nullification will go a long way in correcting government excesses, if the public is informed and believes in their right to disregard the law when they see fit. I spent approximately 10 years in court every day listening to arguments and legal citations. This is never mentioned and in fact the jury is questioned about their intention to accept the law as given by the judge. Naturally everyone says yes, they will accept the law as given by the judge and that further, the law lies within the exclusive purview of the judge. Someone is lying. The judge is.

FIJA has organizations coast to coast giving out literature. Does everyone have the right to exercise jury nullification? Go to it! The one thing I did see was the acquittal of defendants for the wrong reasons. All you have to do is say not guilty.

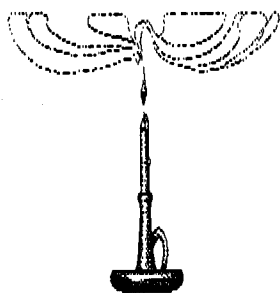

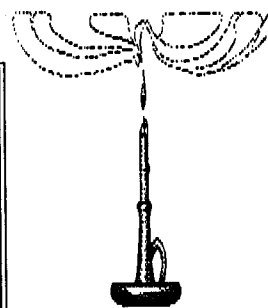

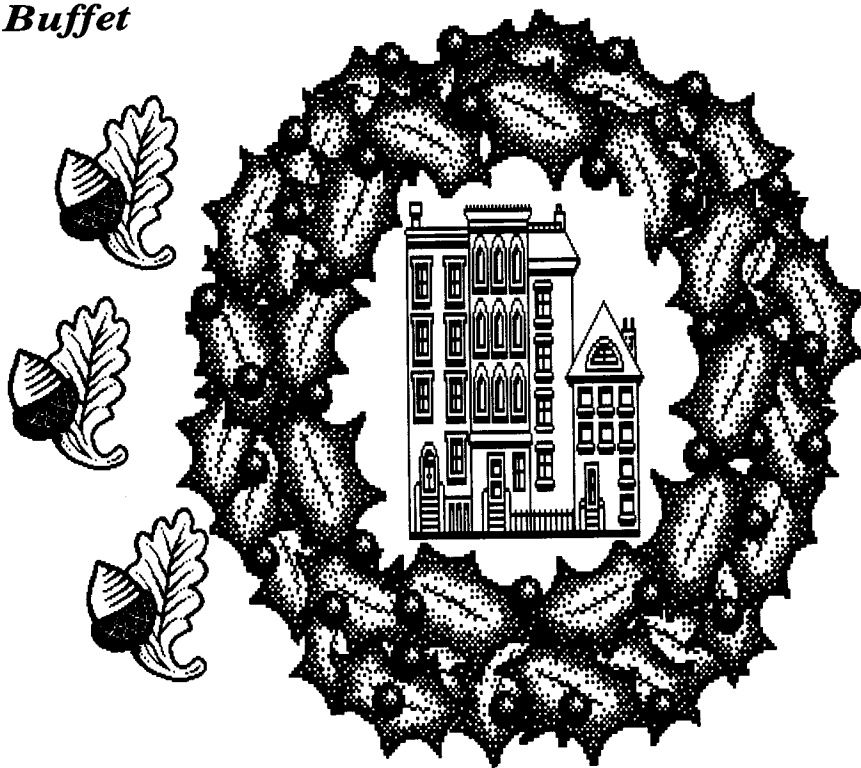

## The 'Yes, Do Something' crowd is wrong about affirmative action

The Legislature has appropriated \$1.125 million for the Center for Hispanic Policy, Research and Development (Line 13, page 120, of the state budget).

I think I can save the state of New Jersey more than a million dollars.

I've done the research. It's from an obscure and little noticed document entitled, "The Declaration of Independence."

It states, "We hold these truths to be self-evident that all men are created equal, that they are endowed by their creator with certain inalienable Rights, that among these are Life, Liberty and the pursuit of Happiness."

Odd as it may seem, I've always believed that this was and should be our official policy not only toward Hispanic Americans, but toward all Americans, and all people.

This is my lead into a discussion of affirmative action, which I like to call Yes, Do Something.

Advocates of Yes, Do Something like to talk about the existence of racism and bigotry and the need to do something about it. We all agree there is a need to do something about racism. But officially what we are doing about it is to spread and institutionalize it.

I am in favor of a color-blind society, of a society that treasures merit over ancestry. This is, after all, the country that first rejected hereditary monarchy. It's a part of our culture that even poor people who grew up in log cabins can grow up to be president.

I don't regard it as a good sign that our government is filling the world with forms which ask citizens to describe their racial ancestry. I always wondered how people find a way to fill in these forms. There should be only one box... Ameri-

can citizen. Or better yet, none at all.

The thing to do about racism is not to practice it. To teach our children that it is silly, foolish, hurtful and counterproductive. To treat it with disdain when we encounter it, and to try and overcome it in ourselves when we find it coloring our judgment.

All of us are in favor of Yes, Do Something as a general statement of how we feel. But there are less and less of us who think affirmative action is the something that we should do.

Quotas and special treatment are not the American way; they don't wipe out bigotry, they foster it.

I'd like very much for my government to stop classifying people by their ancestry, to stop treating people differently based on it, and to follow the policy set forth by Thomas Jefferson in the Declaration of Independence.

That this is the right thing to do, to me is just self-evident.

# How to unclog the courts, and have fun

A year ago, I noticed an ad in my town's weekly newspaper asking for volunteers for the town's nascent Community Dispute Resolution Committee (CDRC). Responding is one of the best things I ever did.

Recently, my three-person panel of dispute mediators resolved two of three disputes before us. These two disputes — over a barking dog and a series of loud noises — have been a festering irritant to the parties involved, a time-consuming drain on local police and courts, and an unpleasant footnote to many neighbors' lives.

Normally, such cases are handled in municipal court. There, at least one of the parties can be found guilty or responsible, and a sentence imposed by the judge. Sometimes, the dispute is aggravated rather than ameliorated because the loser is bitter about their "defeat."

Astute judges realize that these cases can resurface much more serious matters if not resolved, but the remedy prescribed by law doesn't always solve the problem.

Thus, the CDRC was created to relieve the crowding on court dockets, give minor disputes the independent consideration they require, eliminate the hurdle of determining guilt or innocence, and give bystanders a way to help.

The marvelous and unique feature of

the CDRC is that the disputants sculpt a legal remedy to fit the situation, much as a dentist makes pieces that fit our mouths exactly.

The way it works is simple: The CDRC mediators meet the disputants at a table in the otherwise vacant courtroom. If the disputants can agree on any specific arrangement to settle the problem, the mediators write an agreement which all parties sign.

The agreement is legally binding, and the court case is dismissed. The mediators can't be drawn into involvement in the litigation. Everything said is confidential and inadmissible, and only the written agreement, if any, is public knowledge.

The advantage is that the agreement does not have to fit a legal strait jacket. For example, a neighbor craving quiet might get the rock band next door to agree to an inflexible rehearsal schedule. Yes, municipalities can write noise ordinances to satisfy hermits, but the process is clumsy and political, and tramples freedoms along the way.

Besides, a plaintiff can sometimes get more in a consensual agreement than any law could entitle them to. If the guy next door works at night he might not want to settle for what a typical noise ordinance will give him.

Noise complaints are good examples of what a CDRC handles. Others are harass-

ment, trespass, vandalism, offending pets and money disputes of \$200 or less. The local judge chooses the cases, and the volunteers give one night per month.

The Superior Court's training for the CDRC was fun; the five seminars included "acting" the roles of each party at mock mediation sessions, and taught me a lot about human nature. I expect that the negotiating skills many of us began to acquire will be valuable in many different situations in life.

New Jersey's courts offer other volunteer programs as well; the all-volunteer Child Placement Review boards (CPR) monitor children placed outside their homes by the Division of Youth and Family Services, and make recommendations to the judges controlling these cases.

Juvenile Conference Committee (JCC) volunteers examine kids who commit minor crimes and formulate plans that include restitution and/or punishment. Judges can then make the plan legally binding.

Other volunteer programs exist and more may be on the way. If you don't have much time or money but you're interested in helping shape our society while acquiring useful social skills, I suggest you visit your county courthouse and inquire, or, if you're already sure you'd like to do it, go directly to your municipal court and volunteer.

It's easy to complain about the way things are. It's more difficult to improve them, but it is immeasurably more satisfying.

# ***Make Your Sheriff Number One***

Historically the highest ranking peace officer in the county has been the Sheriff, who is elected to a three year term. The legislature, however, has subordinated him to the county prosecutor. Like the Soviet procurator, the prosecutor owes his allegiance to the central authority rather than to the people. He is appointed by the governor to a 5 year term. He serves at the pleasure of the attorney general who in turn is an appointee of the governor. Thus the Sheriff, the only elected peace officer in the county, the one directly accountable to the people, has been overshadowed by the law enforcement officer, the county (state) prosecutor. This state of affairs could lead to disaster in New Jersey, should the federal attorney general work through her counterpart in Trenton, and, through her, directly with the county prosecutor. Rule and oppression by appointed officialdom could thereby become the established norm.

It is unlikely that the lawless killings of innocent people by Federal police at Ruby Ridge, Idaho, Waco, Texas and elsewhere around the country would have happened had the perpetrators worked through the County Sheriff. Because they have totally militarized (they cross train with rangers and special forces) they will probably not cease their murderous activity voluntarily. We therefore endorse US Rep. Chenoweth's Sheriff Check-Off Bill (number not yet assigned) which is based on Hamilton's observation that; "Where the whole power of the government is in the hands of the people, there is less pretense of the uses of violent remedies in partial or occasional distempers of state." The Federalist Papers #21.

To check said distempers Mrs. Chenoweth's bill, also known as the Civil Rights Act of 1995, would require Federal law enforcement agents to obtain written permission from the County Sheriff before making an arrest or search--except for crimes in commission, when people are in imminent danger or when the Sheriff is under investigation. Specifically the Federal Agent would have to provide in writing the name of the person to be arrested or searched, a clear statement of the probable cause for the action or a federal warrant, and the location, date and time of the action, and, when applicable, a description of the property sought. The Sheriff could refuse permission for good cause. Permission, if granted, would be valid for 48 hours and would have to be requested every 48 hours thereafter. Official duty could not be used as an excuse for violations and anyone aggrieved could file a civil action to obtain appropriate relief.

The bill would undoubtedly reduce Federal bloodshed and is entirely in the spirit of the 10th Amendment: The powers not delegated to the United States by the Constitution, nor prohibited to it by the States, are reserved to the States respectively, or to the people."

The U.S. Marshal, BATF and FBI, the principal Federal offenders at Ruby Ridge and Waco, perpetrated one of the largest nonmilitary mass murders in our history. Clearly they cannot be entrusted with the power they now hold. Write your Congressman today at the House of Rep. Washington D.C. 20515, and urge him or her to cosponsor Mrs. Chenoweth's Bill. Also contact Senators Bradley and Lautenberg at ZIP 20515 and ask that they introduce the measure in the Senate
