## Cheney Nets More than 10% in Haddonfield Race

Henry Cheney, college student and South Jersey LP founder, won 10.17% of the vote in the Haddonfield Borough Commission election on May 8<sup>th</sup>. The non-partisan race was hotly contested in the well-to-do borough, with residents expressing their preferences with ribbons attached to fences and porch railings.

Praised for being the only candidate to introduce issues in the election, Cheney met with voters at various speaking engagements, and ran an active campaign. For a youthful contender in his first run at elected office, the results were encouraging, and it's hoped that Henry won't stop with one attempt.

## Piercing the Fog

From Sandy Hook to Barnegat, historically lighthouses have served to bring New Jersey mariners safely to shore. Today, it's politics which generate the stormy seas and fog which are leading Garden State voters to

their doom. But here and there you can see a light leading voters to safety.

The NJLP has instituted a program to salute those who through their activism serve as beacons of hope. It's called the *Lighthouse of Liberty* awards program.

Once a year, the NJLP will recognize those who, through their hard work as volunteers have performed outstanding service to sustain and promote the NJLP. In effect, it's a continuation and elaboration of the recognition awards which were bestowed at our last State Convention.

To receive a *Lighthouse of Liberty* award, an NJLP member will need to meet five of the following eight standards:

1. Registered to vote.
2. Attended a minimum of one NJLP meeting.
3. Helped at a minimum of one NJLP event or demonstration.
4. Worked on an ongoing NJLP committee or in support of an ongoing NJLP activity.
5. Run for or served in public office.
6. Worked on a Libertarian Party political campaign in New Jersey or the nonpartisan campaign of an NJLP member.
7. Have a letter to the editor published in a publication circulating in New Jersey.
8. Recruited a new member.

Some of these standards are easy; for example, simply attending the State Convention will meet Standard No. 2. Others are more difficult, such as Standard No. 5, which requires you to at least make a bid for public office. But they all have something in common: they reward work done to maintain and build our party.

To be sure, many non-members do excellent work promoting liberty or the general program of libertarianism. At times a person achieves a special victory, such as being elected. The program recognizes this by allowing for the award of a special *Certificate of Appreciation* or a *Certificate of Accomplishment* on behalf of the NJLP.

The *Lighthouse of Liberty* award, however, is specifically designed to salute those who help promote the NJLP. It will reward work done at any level of the organization and in any field, be it, for example, on the newsletter, for the Convention, on a committee such as fundraising or for circulating nominating petitions.

The State Chair will appoint the committee that will determine recipients and the awards will be bestowed at the annual State Convention. Anyone who has specific questions or would like more information can contact Pat Bontempo at PDB10752@aol.com.

## The Second Amendment in a New Millennium

The first commentary by the US Supreme Court on the individual's right to keep and bear arms is embodied in the decision in the Dred Scott case.

Dred Scott was an elderly slave, owned by U.S. Army physician Sanford. When Sanford brought Scott from Missouri, a state which at the time permitted slavery, to a non-slave territory, Kansas, a group of abolitionists brought suit against Sanford on Scott's behalf. The suit was meant to free Scott through the court, since Scott was now on free soil.

The court, however, reasoned that Scott did not have any legal standing to bring suit, since he did not belong to the group of citizens of the United States that was protected by the Constitution.

The court's exact comment on this issue was: "The words "people of the United States" and "citizens" are synonymous terms, and mean the same thing. They both describe the political body who ... form the sovereignty, and who hold the power and conduct the Government through their representatives.... The question before us is, whether the class of persons described in the plea in abatement [people of African ancestry] compose a portion of this people, and are constituent members of this sovereignty? We think they are not, and that they are not included, and were not intended to be included, under the word "citizens" in the Constitution, and can therefore claim none of the rights and privileges which that instrument provides for and secures to citizens of the United States."

Although we realize today that this is an unacceptable interpretation of the meaning of the Constitution, it was indeed how the situation was regarded by many people at the time, including jurists.

What is especially important to us in this case is the fact that the court, in its decision, saw fit to enumerate many of the rights of citizens of the United States.

Once again, the court's words on the subject are: "It [the Constitution] would give to persons of the negro race, who were recognized as citizens in any one State of the Union, the right to enter every other State whenever they pleased, singly or in companies, without pass or passport, and without obstruction, to sojourn there as long as they pleased, to go where they pleased at every hour of the day or night without molestation, unless they committed some violation of law for which a white man would be punished; and it would give them the full liberty of speech in public and in private upon all subjects upon which its own citizens might speak; to hold public meetings upon political affairs, and to keep and carry arms wherever they went. "

Those last few words are equivalent to a verbal "shot heard 'round the world," even in spite of the court's overall decision. These comments reflect the fact that there was no misunderstanding of the meaning of any of the elements of the Bill of Rights, or how they were to be applied.

I wonder what Rosie O'Donnell would have to say about this?

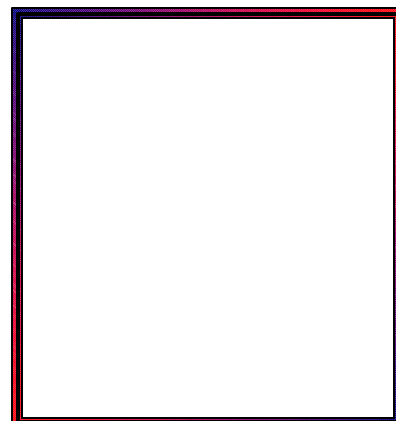

## Legislators Attempt To Stop "Invasive" Student Surveys

**TRENTON** – On March 18, 2001, Assemblyman E. Scott Garrett (R-24) introduced Assembly Bill 3359, which would require New Jersey school districts to get written, parental consent before administering certain types of "surveys" to government school students. An identical Senate bill, S-2332, was introduced on April 23, 2001 by Senator Anthony R. Bucco (R-25). According to Garrett's office, a 1999 questionnaire given to middle and high school students by the Ridgewood, Bergen County school district triggered the bill. Although the district claimed that the survey was "anonymous and voluntary" it was considered "invasive" and resulted in students and parents filing a federal civil rights action.

The questionnaire consisted of 156 questions which pupils answered by filling in a circle that corresponded to each question. In one section, students were instructed to indicate whether they "Strongly Agree," "Agree," "Not Sure," "Disagree," or "Strongly Disagree" with the following:

- I get along well with my parents.
- If I break one of my parent's rules, I usually get punished.
- It is against my values to have sex while I am a teenager.

In another part of the survey, students were asked whether they, in the past twelve months, engaged in the following activities "Never," "Once," "Twice," "3-4 Times," or "5 or More Times:"

- Stolen something from a store.
- Gotten into trouble with the police.
- Hit or beat up someone.
- Damaged property just for fun (such as breaking windows, scratching a car, putting paint on walls, etc.).

Still other questions asked pupils how many times over the last two weeks they had imbibed alcohol, took specific types of illegal drugs, or had driven a vehicle after drinking alcohol. Inquiries were also made into students' past violent and criminal behavior and sexual activity and proclivities.

# *Libertarian Lou on the Loose*

## **SERVING TIME SHOULD BE THE CRIME**

Can you imagine living in a country where all the citizens are required to serve time; going through metal detectors watched by armed guards; being subject to strip searches and forced medication; and required to attend certain mandatory classes where politically correct thought is taught? Where troublemakers are identified early and often, and further punishment is given until they conform – stamping out creativity and independent thought.

Of course, being government run, these institutions would be managed by inept government officials who ignore basic liberties and sovereign rights, and violators of the arbitrary and ridiculous rules would have no right of appeal or trial.

Where are you picturing this prison environment? The old Soviet Union or Nazi Germany? Communist China or Cuba? A third world military dictatorship?

Guess again. These penal conditions describe government run public schools right here in America, but let's remember the students haven't committed any crimes. At least, not what libertarians would consider crimes. Some recent "crimes" committed in New Jersey:

A fourth grader from Upper Elementary School was suspended and ordered to undergo a psychological evaluation after mentioning to a friend his intent to "shoot" a classmate with a paper wad.

A hearing impaired 12 year old in Branchburg was ordered to stop signing on a school bus and suspended for three days (later overturned) because it was disruptive and posed a safety hazard.

An exemplary high school student in Long Branch was suspended for a day for dying her hair pink.

Four Sayreville kindergarteners were suspended for three days for pretending their fingers were guns and saying they wanted to shoot each other.

Want more? Some of the "crimes" committed by students from around the country:

In Danville, Virginia eight middle school students were suspended for one week after they were caught sniffing Kool-Aid.

A 12 year old in Omaha, Nebraska was expelled for possession of blunt edged scissors.

In Reno, Nevada, a 10-day suspension was given to a middle school girl for making a list of students that "frustrated" her.

A student wearing a White Zombie (rock band) T-shirt was suspended in Westerly, Rhode Island. The student sued and the school has spent over \$60,000 in legal fees defending the lawsuit.

Drawing a Confederate flag gets a suspension in Derby, Kansas; flying a Confederate flag on your truck gets you suspended in Chesapeake, Virginia; and in Icard, North Carolina you get suspended for wearing a Confederate flag T-shirt.

For a glimpse of the future, look to Canada. A Halifax student was suspended and may face criminal charges for wearing Dippity Do hair gel and Aqua Velva deodorant to school in violation of the school's no-scent policy. And in Cornwall, nine students were suspended for having lunch at a Hooter's Restaurant during a two-hour free period on a class trip.

Zero tolerance policies, containing zero common sense, have led to the town of Lockney, Texas becoming the first school district in America to require drug testing for all its sixth through 12<sup>th</sup> graders.

Presumed innocent? Restrictions against unreasonable search and seizure? Freedom of expression? School officials believe these rights are quaint ideas sometimes mentioned in history classes, but certainly not applicable to students in government schools in America.

My parents and all three of my siblings were/are teachers in government run public schools and I taught at the university level for three semesters. So, let's be crystal clear here; it is the system that doesn't work, not the teachers, many of whom are even more frustrated with the system than the students or parents. After all, how do they find time to teach when they are required to enforce all these crazy school policies?

Absurd rules that waste time and resources while stigmatizing students are just a small part of the problem with government run public schools. The problem is so severe that thousands of parents choose home schooling and private schools, and George W. Bush declared national literacy a "national emergency."

America, famous for its commitment to freedom and liberty, allows a near-monopoly in education that unnecessarily punishes the students, delivers a poor product, offers indifferent service, and resists innovation. The libertarian solution -- get government out of education entirely.

Food, shelter and clothing are some of life's necessities, but we don't rely on the government to grow food, build houses or run garment factories. Letting the free market rule has provided constant improvement with innovations in product quality, service and price in other industries. Why not education?

Fundamental change is needed that can only come from the forces of competition brought on by free enterprise in education. Many say education is too important to be left to the free market. I say education is too important to be left to government.

### *Freedom Rocks with Poker Face*

What could be better than hard rocking tunes?

Hard rocking tunes demanding liberty.

When looking for a monthly addition to Libertarian Links, I took a member's suggestion and checked out **libertarianrock.com**. It's a great site to appeal to teens and young adults (and middle-aged rockers like yours truly), and prominently displayed on the web page was a link to the music of Poker Face.

This Allentown band is not to be believed! With a sound described as a cross between Creed, Alice in Chains and Pink Floyd, they grab you immediately with their music. Once you slip into the Poker Face groove, they expose you to truly radical lyrics – espousing liberty, of all things!

Their latest CD, *Sex, Lies and Politik* is on its way to me right now. The band's website (PokerFace.com) is a gorgeous experience which allows you to listen to their music accompanied by intense visuals. More importantly, though, the band never lets you forget their message, and their site contains one of the best collections of founder's writings and quotes, as well as current political criticism that it's been my pleasure to read.

Enthusiastic reviews laud singer and songwriter Paul Topete's aggressive acoustic guitar, and he's backed by three plugged-in players – Dennis Beidler, Brett Griffiths and Howie Dean. The band's intense sound hammers the freedom message home in song after song. I'm sharing the lyrics to "Rather Die than be your Slave" (my favorite from *Sex, Lies and Politik*) – but, as good as they read, do yourself a favor and listen to how they sound.

About themselves, the band writes: "We are a freedom loving band playing modern music with thick harmonies. Currently, we are touring the east coast from Boston to DC. Poker Face promotes the freedom that we are supposedly destined to have in this country. In the 10 years of our existence, we have made a presence in the political community to let them know that we the people will not stand for the actions of our government as they turn America more and more into a Socialist state. Check out the music. Check out the message". Poker Face has played in Washington DC, and most recently played at the March 3<sup>rd</sup> Reform Party convention.

On the web, CD Baby.com says: "Poker Face writes political rock to wake up the masses of walking dead, soon to be NWO global plantation slaves. 'Sex, Lies and Politik' ... rocks like no other. From the first track to the last track it will have you rocking. Put it in your computer... and it has a fully interactive Freedom Tour and videos. The harmonies are rich like Alice in Chains. Have a good helping dose of *Creed*-like vocals, *Days of the New* acoustic guitars and killer riffs a la *Zepplin*. This disc takes you on a 57 minute journey of freedom on your CD player and more visuals and cool stuff for your computer. Poker Face has put together a complete package of music AND freedom literature".

Even if rock music isn't your bag, the band's link deserves to be on your list of those you frequently check. The message is as aggressively presented as the band's music, and Poker Face's fight for freedom is as irresistible to follow as their music is to listen to.
