THIRD MAN IN

It's official: Libertarian Party presidential candidate President Harry Browne is the third candidate (after Dole and Clinton) to get on the ballot in all fifty states plus Washington, DC.

As of Friday September 13, when Rhode Island officials notified campaign workers that Browne had qualified, Browne was the only non-

Republicrat to achieve this, as Perot was not yet on the ballot in either New York or Delaware. Green Party candidate Ralph Nader was on the ballot in 22 states, whose combined electoral votes are insufficient to win the election.

The Libertarian Party is the first "third party" in American history to achieve fifty state ballot status in two consecutive elections. Achieving it this time required two years, 481,000 signatures, 24 petition drives, three lawsuits, and more than half a million dollars.

On September 17, East Brunswick municipal court finally heard Township Prosecutor Michael Richmond say that the two didn't violate state trespassing laws after all. The two were arrested outside the East Brunswick Post Office on Cranbury Road on April 15 as they were handing out Libertarian Party anti-tax literature to passersby, which included many last-minute income tax return filers. Paff had refused, and Konek had not heard, the Postmaster's demand that they leave.

After a few hours in jail, \$5000 bail for each, two attorneys billing thousands apiece, two postponements of trials to accommodate unprepared prosecutors, and over five months of red tape run amok, Paff and Konek were jubilant that they do indeed have the right to speak their minds and give away their literature on public property, although the courtroom arguments focused on questions of jurisdiction.

Both Paff, of Somerset, and Konek, of Spotswood, promised to pursue damages for their false arrest and imprisonment, and the trampling of their most basic rights, aggravated by the absurdly high bail required, which a newspaper article at the time noted was less than some accused killers must post.

The story in the September 18 HOME NEWS AND TRIBUNE of East Brunswick, in referring to the defendants' promise to pursue a suit for damages, noted that "the pending lawsuit would put the two in the position of seeking money from the East Brunswick taxpayers, after a protest in which they objected to taxation."

Actually, Paff and Konek would prefer that taxpayers were not forced to indemnify police for unlawful actions.

Edison Township Board of Education of illegally using taxpayer monies to promote yes votes on a \$23.5 million bond referendum last year.

Despite the fact that the referendum proposal was overwhelmingly defeated, Mr Schoen felt it was important to enforce the law requiring that taxpayer monies not be used to advocate higher government spending and taxes.

In a petition filed with Administrative Law Judge Robert S. Miller in the middle of August, Schoen claims the board:

- -hired a public relations consultant to, among other things, prepare "sample" letters to the editor, compose a phone bank script, write a booklet, and write a letter-to-the-editor for a school official.
- -published and distributed biased literature advocating approval of the referendum. (The literature was priced in a newspaper story at \$6000.)
- -has not responded to complaints about these activities.

In the front page story in THE REVIEW of Metuchen(8/23/96) about Schoen's petition, one school board member's comments indicate that she is unaware that the law forbids expenditures of this type.

Schoen, who is also an at-large member of the NJLP Steering Committee, was away on vacation when the local paper's reporter called, so LPSMC (Libertarian Party of Somerset and Middlesex Counties) Vice Chair John Paff spoke to the reporter on his behalf. At least partly as a result of Paff's participation, the story also cited Libertarian Randall Enterline's court victory over the Hillsborough Twp Board of Ed. last year on the same grounds.



If a candidate's job is public relations, one NJLP member has an obvious advantage over most other candidates: Mike Buoncristiano is part owner of AVAN-TI!, a direct marketing firm currently under contract with the NJLP. Consequently, Mike knows a thing or two about promotion, and his campaign reflects it. Almost no facet of political activism is ignored by Mr B.; he is an active member of Hoboken's local taxpayer organization, he publishes outreach literature in two languages, he got appointed to a municipal commission, he does frequent interviews with reporters in three media, he reaches out to the special interest organizations that want liberty on some issue, he is a prolific author of letters to editors, his staff distributes press releases weekly, and, naturally enough, they do direct mailings.

The results aren't hard to notice, if you happen to live in New Jersey's 13th congressional district, which includes most of Hudson County and a smattering of towns in eastern Essex, Union, and Middlesex Counties. For over a year, there has been a steady stream of items about Mike, his positions, and our party in local newspapers like the Star-Ledger, the Jersey Journal, the Hudson Dispatch, the Hoboken Reporter, the Amboy Beacon, and other publications like the Direct Marketing News, Libertarian Party News, and Queens County Libertarian. WFUV and PBS have carried interviews with Mike and the local cable television station has aired Buoncristiano speeches as well as interviews.

As the Libertarian antidote to incumbent Congressman Robert Menendez(D), it's not surprising that Mr B. has raised over \$10,000 so far, much of it at a

campaign rally held at a posh Hoboken "Supper Club" in July.

One of Mike's more dramatic accomplishments has been getting the endorsement of the New Jersey Association of Rifle and Pistol Clubs. This endorsement was the hard won fruition of a dialogue that started months ago, and has demonstrated just how much hard work and credibility construction is required to get endorsement. As Mike says, this should make it easier for future Libertarian candidates to get similar endorsements. Of all the things Mike and his campaign staff have done for their campaign, the most durable may turn out to be the simplest, smallest feature; a red, white and blue ribbon pinned into a loop on his lapel, signifying awareness of the Bill of Rights and its importance to a free society. He and his staff have distributed many, and their popularity is expected to outlast this year's campaign.

The Libertarian Party is only twenty-five years old, but some members like Ginny Flynn were championing our cause for years before the flag of Liberty was even hoisted. The 1960's was a time when government's financial demands were smaller, but its other impositions were in some ways more dramatic, such as the exciting vacations in Southeast Asia the US Government insisted on giving young men. Some libertarians were there to put LBJ and Tricky Dick on notice that our lives were not their property, and the advent of an all-volunteer military that followed is one of the few actual rollbacks of government achieved in our time. Ginny Flynn was there, and has been helping the cause of personal freedom and personal responsibility ever since.

Ginny was earning her Master's Degree in American Literature from Purdue University at a time of profound political unrest: she is proud to have gone "clean for Gene" McCarthy, and supported George McGovern as well. In both cases, she was motivated by the obstinate insistence on war that characterized

Democrat LBJ and Republican Nixon alike. Virginia joined the Libertarian Party in 1976 and began a series of campaigns that have notified thousands of New Jerseyans about our cause, our party, and their stake in it.

The mother of two adult children, Ginny has been married to NJLP Chair Len Flynn for twenty-nine years. She owns GILENCO Enterprises, an administrative services company based in Morganville. A proud member of both the National Rifle Association (NRA) and National Organization for the Reform of Marijuana Laws (NORML), Ginny has served the Libertarian Party as a candidate for freeholder and legislature, and was the NJLP candidate for Governor in 1985. She is disillusioned with what she calls "power politics" in both of the old parties, and especially deplores it in politicians who profess to want smaller government. Ms Flynn is dedicated to the Libertarian Party because of its "commitment to individual liberty".

\$450 to settle his suit against their court administrator Joy Lenner, who had refused to let him see the records of a court case without being told his purpose and interests. This payment, combined with the previous concession by municipal Judge Rzemieniewski that Paff needn't provide such information, satisfies both of Paff's demands, and closes the case.

It's official: They MUST let you see public records.

Editor: You ask how I feel about dropping the requirement for new members to sign the "oath". If the "Party of Principle" gives up its main principles in hopes of becoming more popular, it may gain some new members who don't want to be bothered with ethical behavior, but it loses its integrity, its focus, its courage, and it loses me.- Don Hinkle, GreenVillage

SO YOU WANT MORE MEMBERS...

Editor: I am responding to your suggestion that the NJLP eliminate the "oath" which is the second requirement to join the party. Your premise is "Anything which discourages libertarians from becoming Libertarians should be cleared away from the scene, unless doing so violates our principles."

If that is the rule, then why not eliminate the first requirement; membership dues. I am sure that we could increase membership if we did not insist on new members coughing up some cash to join. We cannot know how many prospective members are dissuaded by the requirement that they pay money to join.

It would not violate any libertarian principle to eliminate the dues requirement. Those who value the work of the party will voluntarily offer to pay for it, so let's try voluntarism all the way around; make both requirements voluntary.

I would not want to see the "oath" requirement eliminated entirely. After all, the oath itself is hardly offensive. It merely reaffirms the non-aggression principle, which is the cornerstone of Libertarian political analysis. - Elizabeth Macron, Brick Twp.

THE OATH TELLS EVERYONE WHAT WE STAND FOR

Editor: As a new member I have no problem with giving an oath to the Libertarian Party as a condition of membership. Throughout my life I have pledged allegiance to the flag, public officials swear to uphold the constitution, and government employees swear not to join the Communist Party or in other ways advocate the overthrow of the United States Government.

I therefore feel that requiring members to swear that they "do not believe in or advocate the initiation of force as a means of achieving political or social goals" helps identify the Libertarian Party as democratic and not communistic. Better to let all newcomers know what we believe in than to let those who oppose our view speak for us. -Larry Ramirez, Hoboken

THE OATH MEANS NO GROWTH

Editor: I feel that the "oath" is a senseless obstacle to the growth of the LP. If it means that Libertarians promise not to rise up in armed rebellion against the government, it should be changed so that its meaning is clear. If it means that we oppose the use of GOVERNMENT force, it is ludicrous. Do Libertarians really oppose the use of force to capture and incarcerate murderers?

One reason I'm a Libertarian is because I believe that a Libertarian government can and will do a better job of combatting real crime than the Republicrats, who see crime as a useful excuse to expand their power. Not long ago, a prominent Democrat told me -straight faced that "Libertarians want child molesters to walk the streets". The oath leaves us wide open to this distortion of our position.

As we watch another presidential election slip away, with no Libertarian presence in the debates, scant media coverage, and disappointing vote totals, let's ask ourselves if we intend to get realistic in our effort to stem the tide of statism, or to keep shooting ourselves in the foot so we can whine about being victims. EDITORIAL: NOW IS THE TIME

An old proverb has it that "an ounce of prevention is worth a pound of cure". This mot suggests that some timely effort can forestall problems that require exponentially larger amounts of effort and resources to repair, once they have appeared.

That may well be the case with American politics. Libertarian Party members understand that our country and state have embarked on a course that can only result in a socialist police state. Some of us feel that we've already achieved it. One thing we can all agree on, though: the need to reverse course becomes more urgent every day.

Increasingly large numbers of the public seem to agree, if the libertarian rhetoric of Republicans and the ensuing results of the 1994 congressional elections are any indication. Unfortunately, the Republicans have demonstrated that they either don't understand the meaning of the word "liberty", or they are cynical political careerists who will say anything to get votes, or both. Thus, there is no one at any level of government who both understands the danger of our present course and is willing to risk their political careers to help reverse it. Only Libertarians meet both these requirements, yet many who agree with Libertarians decline to give meaningful support to Libertarian candidates because they only want to back likely winners.

The time is fast approaching when R's and D's will have imposed enough laws, regulations, and taxes to stop Libertarians from even appearing on ballots. Just imagine how much more difficult it will be to win our freedom back, once its defenders are banned from participation in politics. The alternatives to restoring liberty in America by electoral success are so ugly that we ought to consider them when weighing the size of our donations and the level of our involvement in Libertarian campaigns.

Washington, over 4000 new members have joined since our televised convention over the Fourth of July Weekend, bringing our paid-to-date current membership up to 19,378 as of September 5. This represents an increase of roughly a quarter of total membership-in two months.

Kohlhaas also stated that Harry Browne's campaign is eligible for \$470,000 in Federal matching funds, should he apply for them, which he is committed not to do. Browne is famous for saying "I do not believe in welfare -for individuals, for corporations, or for politicians."

COUNTY RECORDS: AN OPEN BOOK

Warren County Freeholders voted in late August to let NJLP member Mike Pierone have the county's purchase records on tape, disc, or other computer-legible format. They charged him \$150 for the efforts required to gather it, and deny that they'll ever do it again.

Perhaps the effort was too much; purchase orders for January through November 1995 were provided, but December's were AWOL. Pierone returned for the last month's records and was told they must be painstakingly keyed in from hard copies at the County's offices.

Pierone, a White Township resident, was quoted in the August 29 STAR LEDGER as saying that his goal is "to make government truly accessible to the public", and again "The way to get a grasp of what the county does is to look at the purchases".

Despite the Freeholders' statement, this may prove an important precedent for other right-to-know-via-computer cases. They are reported to be examining the public posting of the same data Pierone paid for on a web site.

At the very Freeholder meeting where Pierone's request was granted, a stranger publicly offered to pay for a copy, but Pierone promised to provide it free of charge, and to others as well.

NJLP STATE BOARD RESOLUTION

RESOLUTION SUPPORTING THE RIGHT OF CITIZENS TO REFUSE GOVERNMENT MANDATED "SMART CARDS" THAT CONTAIN COMPUTER CHIPS

WHEREAS, the State of New Jersey is experimenting with "smart card" driver's licenses containing computer chips that could give government instant access to a citizen's fingerprints, medical records, tax records, financial data and other personal information;

AND WHEREAS, the implementation of "smart card" driver's licenses will enable government to create a giant and detailed demographic database that can be abused to grant privileges to special interests and to harm other people; for example "smart card" computer chip technology, had it existed, could have been used to more efficiently incarcerate Japanese-Americans during World War II;

AND WHEREAS, this application of computer chip technology could be used by government for complete tracking, control, and subjugation of the people;

BE IT RESOLVED, that the New Jersey Libertarian Party supports the right of citizens to refuse government mandated "smart cards" that contain computer chips or magnetic strips used in a similar fashion.

The Editorial was entitled **PUBLIC RECORDS: A RIGHT.** It began with this:

John Paff of Franklin sued Manville Municipal Court last month when officials blocked him from seeing a court file. Newspapers picked up the story last week after Paff issued a press release. Within days, borough officials discussed the lawsuit in closed session and attempted to settle the case. No wonder.

Manville Municipal Court Administrator Joy Lenner's initial denial and the subsequent delay for Paff in gaining access is a blatant violation of state statutes empowering citizens with the right to see most public documents.

"I can't have these people telling me what I can and can't do in total violation of the law" said Paff, who is Vice Chairman of the Libertarian Party of Somerset and Middlesex Counties.

and continued with this:

This is not about John Paff or his attitude. This is not about the Libertarian Party. This is not even about the Manville Municipal Court. This is about your right to know.

New Jersey law empowers citizens with the right to view public documents during regularbusiness hours.

and this:

The responsibility of a public official is not to withhold public records, but to provide them in a timely fashion and without asking questions. Paff has vowed he will not dismiss his complaint until the borough reimburses him for the \$500 he has spent in attorney fees. "I have to take this thing to the mat", he said, "otherwise they could do this as standard operating procedure."

It's unfortunate that taxpayer money may have to be spent to settle this matter. But the sting of having to pay attorney fees may be the only way some officials will learn that citizens have the right to see public documents promptly -without delay, without questions, without hassles.

LP members and prospective members have been receiving appeals for money and time from a variety of Libertarians; the Browne campaign, the national party, the NJLP Federal Fund (which sponsors candidates for President and Congress), the NJLP State Fund (which sponsors candidates for state and local office), a variety of political action committees, and from LP candidates themselves. It's easy to rationalize rejecting these appeals, and most of us have very real financial reasons to do so.

However, many of those reasons will seem trivial to us ten or fifteeen years down the line, when we may be reflecting continued on page 10

COURTROOM SHOWDOWN ... from page 1

Sussex County NJLP members Robert Heitner, Tony Federici, Don Imbriale, and Ed Wiessmann sued the Sussex County Freeholders in March for selling the County Administration Building to the County College without first holding public hearings on the multi-million dollar proposal, as administrative law requires.

The four, none of whom are lawyers, represented themselves in the proceedings, a status known to those in law as "pro se". The four plaintiffs pled their case before Superior Court Judge Reginald Stanton in Morristown, opposing arguments made by Sussex County Counsel Dennis McConnell. This is how the episode looked through the eyes of Robert Heitner of Fredon Township., who organized the effort.

It started on February 14, when the NEW JERSEY HERALD (Sussex County's local paper) published a notice stating that the agenda for that evening's Freeholder meeting included the signing of a contract to sell its administration building to the Sussex County Community College, and THEN scheduling public hearings to debate the issue.

I went to the Freeholder Meeting that night and asked why the county would schedule public hearings about a transaction after the transaction had been completed. A former Freeholder also attended, to ask the same question. No logical answer was given. The public hearings were scheduled for March 27th and April 10th. In the 3-2 freeholder vote and subsequently, it became apparent that two of the five freeholders (all Republicans) opposed the sale, in addition to members of several local taxpayer associations.

Our research found that public hearings must be held 90 days before any PROPOSED sale of county property. The contract signed on February 14 contained no "escape clause" that allowed them to change their minds after the public hearing without the college's agreement. This clearly violated the law. On March 15 Tony Federici, Don Imbriale, Ed Wiessmann, and I filed suit in Superior Court asking for the sale to be overturned.

The public hearings were held as scheduled. At both, lengthy presentations were given by the college and the freeholder majority stating that a wonderful deal had been made. They were not there to listen to the questions, concerns, and suggestions from the public; they were there to defend their decision, which had already been made. At both hearings we presented many valid arguments against the sale, and were joined by members of taxpayer groups along with several other citizens. At the second hearing, both dissenting freeholders also made presentations against the sale.

Many articles appeared in the local paper. The freeholder majority planned to purchase a bank building as the new county headquarters, and presented lengthy arguments to support the plan, but when the owners of the bank were approached, they responded with flat denials that the building was available at all, making the freeholder majority look very silly on the front page of the paper. One of the dissenting freeholders was even quoted in the paper as intending to testify for our side in court. Other articles illustrated that this deal was rushed through with little thought about the consequences, such as where the county employees would go to work each day, which put the board majority in a negative political spotlight.

The county filed three responses to our lawsuit, the second requesting a motion for summary judgement. After several trips to the county law library, we filed a cross motion for summary judgement, which rebutted four different defenses that the county had made.

Sadly, the court kept postponing our case; first to June 7, then June 21, and then to July 12 - two days after the closing of the sale! The title insurance company required the county to put the entire proceeds from the sale into escrow, in case the sale was overturned by the court.

After that it was moved from Sussex to Morris County and heard on August 2nd by Judge Stanton in Morristown. All four of us gave short, professional presentations for our case. The Judge ruled in favor of the county, stating that the contract complied with the law simply because it referred to the law it was violating. He also cited a clause that did not exist in the contract to support his decision. The Judge shot down one argument of the county counsel and ignored all the others in his ruling. He also stated that future contracts should be "better written".

The articles about the suit in the STAR LEDGER and NEW JERSEY HERALD were very favorable, stating all the problems with the contract, which the judge ruled "adequate". This controversy received lots of media attention, most of it fair. Since we were not alone in our opposition to the sale of the County Administration Building, we were correctly viewed as advocates for overburdened taxpayers rather than as radical extremists.

Given the size and arrogance of government, opportunities to take popular stands against arrogant bureaucrats and politicians breaking and bending the law are quite common. It cost \$163 plus our time to file and pursue this lawsuit, and it was well worth the effort. I think the majority of those outside government's fan club were supportive of our efforts.
