Libertarians from nine counties teamed up to get the signatures on petitions that put Ken Kaplan on the ballot for Governor of New Jersey. The dedication of our party's volunteers made possible Ken's appearance as the third candidate in the Star-Ledger report on nominees.

Others combined to get our candidates for the Legislature on the ballots, and still others made an increasing presence in Freeholder races possible.

The petitioners that got Ken Kaplan into the Governor's race, together with their signature totals, are in the column at left. Only 800 names were needed; the volunteers enthusiastically exceeded that requirement.

Libertarians will also be a presence in New Jersey Legislature races this year, represented by Senate candidates Joe Ponczek (1), Barbara Jones (11), Ginny Flynn (12), Roger Bacon (23), and Bill Dundas (24). Bill Dundas led the NJLP in vote totals last year, garnering 7,788 votes in the Sussex County

Freeholder race.

Assembly candidates include Scott Derby (1), Keith Quarles (11), Ben Grindlinger (14), and Tim Lyons (15).

Gloucester County is leading the charge to make LP candidates prominent in Freeholder races, fielding candidates for all three available seats in their county. Their nominees are David Zarzycki, Mike Herner, and James Blakey. Ed Wiessmann is running for the Sussex County Freeholder spot on the ballot, and NJLP Chair Spencer Layman is contesting one of Monmouth County's two available seats on the Freeholder board.

As in the Governor's race. volunteers made some Legislature and Freeholder candidacies possible. Gathering signatures is a time-consuming task that can occasionally be unpleasant, but is absolutely essential to the party's growth and presence in the public consciousness. Some of the volunteers who made local candidacies possible are

(From the AP, March 7): The New Jersey Libertarian party on Sunday nominated a broker of industrial and commercial real estate as its candidate for governor.

Kenneth Kaplan, 45, has never held elective office. He has made attempts for state Senate and Assembly, and Rockaway Township Council • and Orange City Council, the of whom work in the comparty said.

"For too long the state of New Jersey has been in the grips of Democrats and Republicans who think regulating, taxing and spending are the keys to better government," Kaplan said. "It is time to come up with creative solutions that rely on common sense and voluntary action."

"For instance, thousands of units of affordable housing can be created by requiring local zoning authorities to allow single-family homes to be converted to two-family homes, and two-family homes to be converted to

The Electronic Highway: **Private Success or Federal** Disaster?

The government is trying to gain control of a powerful revolution now occurring in the information and commu- nications industries. President Clinton has called for a • national electronic data highway paid for with public funds and regulated by the government.

An electronic highway is an information and data network to which anyone with a computer, modern and phone line can gain access. A basic example is Internet, a worldwide network originally developed for use by the scientific and academic communities. Internet now has more than 1.3 million users, many puter industry.

With the 1960's flower children now in power, there • is a resurgence of the belief that Big Brother will take care of everything and that includes a high-capacity, high speed national computer network. But it is a formula for disaster.

The term "highway" enables proponents to point to the national federal highway system as a model. Fine. Ask the people of Montana or Wyoming how they like government control of their highways. Even though it made no sense in the wide-open space of the West, the federal three-family homes," he said. • government insisted on holding the speed limit to 55 for vears. Do we want such regulation on our data networks?

> Do we want the same folks who give us the Post Office to run our computer networks? Think about it: in 1915 a coast-to-coast phone call cost \$20.70 and now, almost 80 years later the cost is well under \$1.00. On the

other hand, you could mail 1,000 letters for that same \$20.00 in 1915 and now you can't send even 70. The difference is the vital distinction between private and government-controlled enterprise. The very successful Prodigy Service expanded its membership recently and found its costs outstripping its income. Before Prodigy management increased rates to customers, it cut costs and staff. Can you imagine the government cutting costs on a data network?

And then there is the issue of paying for it. Will we have another tax, on computers perhaps, to pay for a public network? Or maybe just continue to add to the national debt? Will funding for this highway be subject to the same kinds of outrageous pork that transportation bills include?

But I believe the most important issue is information control. The real purpose of an electronic data highway is to move information and government wants desperately to control it. There will be a new maze of regulation emerging with surcharges and taxes for some information but not for others. The government will even control who gets to use the network and for what. If your information is not "politically correct" then you won't have any right to use the public network.

The Clinton administration wants to take another step to erode our freedom by taking over electronic networks. It is imperative that we say no. The risk is greater than most people realize.

Battle Won in War on **Forfeiture**

NJ Assembly Bill No. 1536 (A-1536) cleared a key legislative committee on March 4, despite vigorous opposition by state Attorney General Robert Del Tufo and the state's County Prosecutors Association. The committee's meeting room, which was packed by F.E.A.R. (Forfeiture Endangers American Rights) and NJLP members and other forfeiture opponents, broke into cheers and applause as committee chairman Gary W. Stuhltrager cast the deciding vote in favor of releasing the bill to the full house with a favorable recommendation. The bill passed the committee by a 4-3 vote.

Also voting for A-1536 were Assembly members Robert Brown, Harriet Derman and Lee Solomon. Those voting against the measure were Monroe Jay Lustbader (a co-sponsor!), Byron Baer and Frank Catania.

The bill now proceeds to a vote before the full Assembly. An identical bill in the state senate, S-1226, awaits action by the Senate Judiciary Committee. Free copies of these bills can be ordered through the Office of Legislative Services, CN 068, Trenton, NJ 08625 (609-292-4840 or -4841).

Bergen. Karlan has received mailing labels from Stefanelli; he will contact all members in order to form a viable organization. It was noted that Bergen has more members than any county in the state.

Cumberland. Roselle reported that Paff spoke to 19 people about forfeiture at the last monthly meeting. Irv Homer, the talk radio personality, has been invited to speak April 25.

Hudson. J. Eden reported that there are no regular meetings. Individual libertarians are supporting the incumbent Republican mayoral candidate.

Mercer. Trend will send an article from the *Trentonian* to the newsletter editor, which relates how Carl Peters refused to give his social security number to the Dept. of Motor Vehicles, which therefore refused him a licensse; and how Carl was then sent to jail for 34 days for being an unlicensed driver.

Middlesex. Glatter reported lobbying against forfeiture and a special improvement district. The group has also sponsored a food drive and two OPH booths. Aviles participated in a radio call-in show. Gene Burns has been invited to speak at the next meeting.

Monmouth. Layman announced that Keith Quarles will run for Assembly in the 11th district. Paff spoke at the last meeting, and the freeholders will be made aware of forfeiture abuses.. A tax protest is planned for April 15 at the Hazlet post office. Morris/Essex. Stefanelli is the new chair and the organization has a full slate of officers. There are program chairs for house calls, Seminar 1s and public meetings. The group, and the NJLP, has supported the Friends of Midwives.

Salem. Stoxen is running for the Pennsville school board and Lynne Straughen is up for the Penns Grove planning board. During the winter recruiting drive the group raised \$365. Ten letters to the editor have been published in three months. Salem is working on building a voters' list for each township in the county.

Sussex. Wiessmann reported that Bill Dundas will run for Senate in the 24th district. Sussex is not opposing the two quasi-libertarian Assemblymen. Two public debates have been scheduled, on property rights in relation to the environment, and on unlicensed midwives. Sussex is visiting the homes of prospects.

Old Business:

Gubernatorial petition gathering. The Chair will ensure that all petitions are accounted for.

Member-at-large petition. Grindlinger has 39 signatures to date; 57 are required, based on March membership totals. MOTION: Resolved, that the State Committee recommend to the membership at the next General Meeting in July an amendment to para. 4.c)7 of the by-laws. If approved, member(s) chosen by petition need obtain the signatures of 5% of the NJLP membership plus 5 members' signatures versus the current requirement of 10% plus 5. PASSED. MOTION: Resolved, that the maximum number of At-large Steering Committee members selected by petition shall be three. In the event that more than three candidates receive the minimum number of signatures the three with the greatest number of signatures shall be seated. PASSED. MO-TION: Resolved, that the two motions just passed by postponed indefinitely. PASSED.

New Business:

Delegate selection. New Jersey is authorized 23 delegates to the national convention in Salt Lake City. MOTION: Resolved, that the delegate selection procedure be committed to the May Steering Committee meeting for resolution. PASSED.

Approval of the Cape May County organization. Deferred to the General Meeting (in accordance with the bylaws).

LIBPAC. The secretary will request information on the mechanics of donating and receiving funds in support of our candidates.

Bylaw revision. The Chair will draft a change to resolve the problem of selecting candidates and national convention delegates at the same meeting.

Libertarian CATV. Under discussion with Monmouth Cable.

Election signs. Wiessmann discussed the pros and cons of using the wording "Libertarian Party" vs. "Libertarian". The choice will be left up to the individual candidate. For information on dimensions, phone him at (201) 579-7941.



When he delivered his piece there were serious arguments for censorship. It was finally decided to print the piece in its entirety, and disclaim any responsibility. By printing a bold warning above the story, we warned readers not to place faith in Roark's sensationalistic reportage.

We are most appreciative of Pierone's contributions as Chair, to the party and to this paper, and we know that he gave unselfishly of his time and talents to help the NJLP without aggrandizement. Court Watch

The New Jersey Superior decide whether Henry Wallord, was entitled to compensation for damage done to his • rental building by city police executing a "no knock" warbers of a family have to work a rant there. According to court papers, Wallace sought \$900.97—the value of three doors that were broken down—when police entered one of his rental units to ar-• rest a tenant. (See Wallace v. City of Atlantic City, 257 • 480.)

The city denied responsibility for the doors, arguing • that it is allowed, "in the exercise of its police power and • without compensation, [to] destroy buildings or structures which are a menace to public safety or are a nuisance."

Wallace, acting as his own attorney, advanced two legal theories to Judge Michael Winklestein, a Kean appointee. First, Wallace argued that the police committed a tort against his property. The court dismissed this count since Wallace couldn't negligent or used excessive force in executing the warrant. Second, Wallace argued that the destruction of his doors constituted a taking under the Fifth Amendment • of the United States Constitution and Article 1, Paragraph They also say government 20 of the New Jersey Consti-• tution. After a six page analysis of the Takings Clause, • Winklestein agreed with Wallace and entered judgment against the city.

In the first case of its kind in New Jersey, Winklestein stated: "The search was con- ducted for a public purpose; i.e., a search for and seizure

of property and concomitant arrests as part of an ongoing criminal investigation. As part of the investigation the police damaged plaintiff's property. As an innocent third party he should not bear the sole financial burden of such an undertaking. Since the damage was incurred for the public good, rather than for the benefit of the private individual, the public should bear the cost." Winklestein dismissed the city's defense that Wallace's building was a "public nuisance" stating: "The fact, however, that there were illegal drug activities taking place at the premises does not render the property itself a nuisance."

Vernon teen satanists, that would be crimes if committed by an adult. The bleeding hearts Libertarian liberals will cry 'Foul', 'Unfair', and 'unconstitutional'. Let them. While they're crying, state and local law enforcement officials will have a major new weapon to fight crime statewide."

Reply by Michael Pierone:

"Thanks, Peter Bardach, for your commentary on fingerprinting juveniles. As the past Chair of the Sussex County and state Libertarian Party, I would like to correct

the impression that may have been given of our party by Mr. Bardach. The root word for Libertarian is liberty. Because our party is consistently for liberty, whether it concerns personal freedoms or economic freedoms, people who do not support one or the other mistake us for either conservatives or liberals. Neither are Libertarians the same thing as civil libertarians since we are as committed to supporting the rights of gun owners as to ending the war on drugs. We are strong supporters of individual rights, and every right in the

Bill of Rights, but we get turned off when we hear people talk about group rights, or collectivism. To liberals we seem to be conservatives and vice versa, because we do not fit on the traditional left/right political scale. Our commitment is to liberty in every arena. As to the particular issue that Mr. Bardach raised, that of fingerprinting juveniles, we are not opposed. In fact we believe that individuals need to be held responsible for their actions, whether they are juvenile delinquents or law enforcement agents."


