

Chaired by Washington DC LP Chair Gene Cisewski, this new PAC seeks to emulate his earlier work for GOPAC, the similar instrument of the Republican National Committee, which helped build the "farm team" of Republican office-holders that featured so prominently in the Republican congressional victories of 1994.

Cisewski, who authored the LP's county organizing manual, seeks to take advantage of a loophole in election laws: because LIBERTY COUNCIL will not sponsor any candidates for Federal office, there are NO LIMITS to the total any individual may contribute, and donors need not answer the intrusive questions about occupation and employer that characterize donations to candidates for Federal Office.

LIBERTY COUNCIL's priorities are:

- 1) To sponsor the re-election campaigns of existing LP officeholders like Don Gorman in the New Hampshire legislature and Bonnie Flickinger, the mayor of Moreno Valley, California.
- 2) To underwrite the most promising campaigns for challengers, like Michigan legislature candidate Jon Coon, whose name recognition in his district is 70%.
- 3) To protect the hard won official ballot status the LP risks losing in states like Texas and Maryland, where Libertarians must receive five or three percent, respectively, of the vote to maintain "official party" status.





Paff claims that Ms Lenner became "adversarial" when he refused to tell her why he wanted to see the file, a traffic case entitled State vs. Gordon Ferry. Paff says that the Right to Know Law gives all citizens an "unqualified" right to view most public documents, including this one. He says that this law gives "you an absolute right to see the records, without having to explain why..."

Paff filed the suit after receiving a letter from Municipal Court Judge Rzemieniewski telling him to appear in court to explain his request, which Paff said "didn't seem right". If successful in his suit, the court will order Lenner to allow Paff to see the file, and will order the Borough of Manville to reimburse him for court and attorney fees.

After Paff filed the suit, the judge relented, offering Paff what he originally sought, but has refused to order the municipality to pay his attorney fees. Paff has refused the offer, on the grounds that it should not cost him or anyone else an estimated \$500 in attorney fees to gain access to the records.

Further developments are expected soon in this rapidly unfolding story.

to direct their administrator to assemble all county purchase orders on disc or other computer readable format, and to make these records public, if Pierone does the necessary conversions to put these records on compact disc. Pierone is a free lance computer programmer who is specially qualified to perform the work. The free-holders agreed to do this at their August 7 meeting, and the Express-Times(Easton, Pa) reported the story on the front page of their local section the next day.

Pierone, who is also former Chair of the NJLP, has gotten coverage from the same paper before and since on this issue, and has promised the reporter who covers the county's freeholders that he'd be the "first to receive a disc" once he receives the records and performs the requisite conversions.

The August 8 story offered a glowing description of Pierone's purpose, quoting him as wanting to "make county government more open by posting the purchase records on a computer bulletin board, internet web site, or making it available to other county residents on a CD-ROM." The story went on to quote Pierone as saying "Once I get the purchase orders pried out, I'll see what else I can pry out".

Activist's Corner

More than a few Libertarian activists have complained over the years about the way the newsmedia seems to categorically ignore the LP. Candidates for state and federal office face what seems like a virtual blackout by both print and broadcast reporters in many campaigns, and they understandably feel it's unfair.

Of course, no one ever credibly said that life is fair. The twentieth century has seen a parade of ideologues trying to use government as a tool to make life "fair", and the results speak for themselves. Life isn't fair, and complaining about it is less rewarding than milking bulls or planting popcorn.

In fact, the newsmedia have good reasons to ignore most non-Republicratic candidates for high office; a glance at this year's presidential candidates reveals that some want to give Marxism another shot, one wants government to "save" the environment, and another thinks our problems will be over if only government gets us to meditate. The media would be suspect if they did take these folks seriously. Even Harry Browne says that, if he is at 1% in the polls, he "shouldn't be included" in the debates.

We Libertarians must be adults about this. Reporters are eager to cover those people and events that seem important or interesting to their readers, who have an unlimited menu of things to read, hear, and watch. If we're going to be taken seriously and get covered, WE must make the news that the public wants to know about, and it's not a hopeless task by any means.

John Paff is a good example of this. Like everyone else, Paff trips ever the outstretched legs of politicians and bureaucrats every day. Unlike some of us and almost everyone else, he does something about it: if what they are doing is illegal or just immoral, John cites them before the appropriate authorities and reporters, who cover his actions because their readers care about these same wrongs. He now has a reputation in his town and county, and reporters know in advance that their readers care about what he says and does.

Libertarians in other locales like Belmar, Chatham, Hillsborough, Hoboken, Burlington, Sussex and Warren Counties have had no problem getting covered by the media when their goals are attainable and their purpose realistic. These results all tend to confirm that what we THINK is not news, but what we DO is. Let's keep this in mind as we make plans and seek media attention. -EW

EDITORIAL

Under current bylaws, a person must do two things in order to join the Libertarian Party:

- 1) Pay membership dues, and
- 2) Sign a "membership statement" which reads:

"I do not believe in or advocate the intitiation of force as a means of achieving political or social goals."

The second of these requirements has been the subject of spirited debate many times, and was recently cited by one of the NJLP's most prominent members as his reason for not renewing his membership this year. According to Terry Dwyer, who writes a weekly opinion column for the Daily Record, a major northern New Jersey newspaper, the "oath" as some call it, needlessly alienates prospective members and reflects a "smug group that is determined to shrink".

There is little doubt that a majority of current members support this requirement, but that should not preclude us from considering its abolition. Current members include primarily those who were not offended by this requirement and had no objection to signing the "oath". We cannot know how many were dissuaded from joining by this requirement, and we also can't know how many sign it without meaning it.

In fact, we can't even be sure that all those who join do sign it; former NJLP Chair Spencer Layman declared that he had never signed it, and was admitted anyway. These facts, taken together, suggest that we ought to reexamine this requirement, and abolish it for state party membership unless compelling reasons to the contrary are demonstrated. Anything that discourages libertarians from becoming Libertarians should be cleared away from the scene, unless doing so violates our principles. Eliminating the "oath" requirement doesn't do that.



cated Libertarian volunteers who spent evenings and weekends in July to gather signatures on petitions.

To satisfy the state requirement of 800 signatures for this purpose, NJLP volunteers gathered 1932 signatures, making a challenge by either of the government parties very difficult and unlikely. NJLP officers learned from the bitter experience of having their Senate candidate bumped of the ballot by a challenge from the Republican State Committee in April that merely satisfying the petition requirement plus a few extras is not enough. In that instance, enough of the signatories gave illegible names or addresses or had changed addresses since last registering to put the total under 800.

NJLP Chair Len Flynn vowed not to let this happen to Harry Browne, and the total in this drive reflected that resolve. Veteran NJLP member and volunteer Don Meinshausen said he'd never heard of challenges disqualifying more than 40% of petition signatures. A challenge that successful in this case would have left the BROWNE/JOR-GENSEN ticket with 1159 signatures and success.

NJLP members Rob Tannen and Daryl Gibson gave the volunteers added incentives to produce by posting \$100 rewards for the most prolific petitioner. These rewards added excitement to the cyberheadquarters as Flynn made nightly postings of each day's results on the NJLP e-mail list throughout the drive, which ended on July 29th.

Several members of the NJLP who happen to be attorneys helped out by notarizing the petitions, often at inconvenient times and places, and NJLP steering committee member Jeff Pfeiffer drove to all points of the compass gathering petitions and took time out from his business on Monday July 29th to submit them in person in Trenton. Flynn had delivered the first 1617 signatures there on Friday the 26th.

- -Gun Rights Attorney Evan Nappen addressed some 35 NJLP members on the effects of Domestic Violence Laws on gun owners.
- -Mark Peterson is the new chair of the Fund Raising Committee.
- -Steering Committee At-Large Member Jeff Pfeiffer has organized a Banner Flyover for the New Jersey shore on Labor Day Weekend. An Airplane will tow a banner bearing the legend "Government Doesn't Work; Vote Libertarian" along the shore facing the beaches from Cape May to Sandy Hook.

Pfeiffer raised the requisite funds without assistance from the NJLP treasury.

-Buoncristiano delivered the new NJLP "Bill of Rights" T-Shirts, which are offered for sale at \$15 each.


