Forfeiture Endangers
American Rights (FEAR)
has announced that seven

organization are currently
being formed in California,
Georgia, Pennsylvania,
Nevada, Tennessee,
Vermont and Washington,
DC. What first appeared
to be a local reaction to
overzealous application of
forfeiture laws is now on
its way to becoming a
national movement for
reform.

that reaction to FEAR has
been exceedingly positive
and that, primarily because
of the efforts of NJLPer
Kathy Schrama, several
national organizations are
lending their support as is
a local media personality.

#### Sussex County Candidates File for Office

One of the NJLP's most active county organizations, the Sussex County Area LP (SCALP), recently announced that three more candidates had filed for office, in addition to their congressional candidate.

Bill Dundas, of Vernon, announced that he was seeking a seat on the Sussex County Freeholder Board; Jason Healy,

Paff pointed to two Washington, DC-based groups which are lending their assistance. The Institute for Justice has offered to set up FEAR's tax-free status at no cost, and the Criminal Justice Policy Foundation, an organization that had been advocating similar reforms, was excited about the idea of a single-purpose organization dedicated to this cause.

FIJA, the Fully Informed Jury Association, has also agreed to give FEAR the one-time use of its 5,000-name mailing list. Additionally, local radio and TV personality Bob Cerutti, who provides commentary on WSUS 102.3 FM and cable TV station Video 8, has donated a filing cabinet to FEAR's efforts.

Fundraising for FEAR has also gotten off to a promising start with an initial letter having raised about \$1000 in contributions. With such encouraging news being reported, it appears that the only thing forfeiture will have to fear is FEAR itself.

#### CHAIRMAN'S MESSAGE

Does anybody remember the Bill of Rights, or how many lives were given to secure them? More and more of our rights are being taken away from us. Has anyone altered or repealed any of the first ten amendments to the Constitution? NO!

Nowadays we don't bother; you see, it's much easier and safer to mess around with people's rights by reinterpreting them.

Remember the words, "Congress shall make NO LAW respecting an establishment of religion, or prohibiting the free exercise thereof?" Ask the Mormons or an American Indian if they are free to exercise this right.

How about "The right of the people to keep and bear arms will not be infringed?" We now have over 20,000 laws about guns and gun ownership that apply to us in New Jersey.

Remember the words of Patrick Henry? "Give me Liberty or give me Death." Doing the "safe" thing was simply considered cowardice back then, now it is just politically "shrewd."

## LIBERTARIANS CAN AFFECT PRIVATIZATION EFFORTS

It could suffer the fate
of similar attempts in
the past to privatize
state government
services, but momentum seems to be building to divest New
Jersey of a number of
costly, inefficient bureaucracies.

At a hearing of the Senate Law & Public Safety Committee, chairman Louis F. Kosco (R-38) claimed as "excellent" a citizens' policy group's call for privatizing state prisons. Kosco also called motor vehicle agencies "a prime target for privatization."

New Jersey Citizens for a Sound Economy (NJCSE) said that the state should turn over to the private sector all sorts of government entities, including the prison system, the Meadowlands sports complex, stadiums and convention centers.

Privatization, said
NJCSE Director Cynthia
Povich, could be "one of
the keys to solving New
Jersey's fiscal woes." It was
noted that the state's
corrections budget has
skyrocketed over the past
decade and that privatization of just one prison, the
maximum-security New
Jersey State Prison in
Trenton, could save
taxpayers \$3.4 million to
\$10 million a year.

The Assembly Appropriations Committee held a follow-up hearing on privatization where bureaucrats from the agencies that would ultimately be affected, denounced the concept.

"We're at the point that privatization could cost us more money than it saves," charged Transportation Commissioner Thomas Downs.

Of course, the state employee unions opposed the idea and many in attendance at the hearing wore black and yellow buttons that read "No privatization--CWA." The CWA, or Communications Workers of America, is the states largest public employee union.

Recognizing it as selfinterested objections, the Republican-dominated committee turned aside such protests. Assemblyman John Gibson (R-2) stated, "I think the more privatization you do, the more it improves your control."

When the Secretary of State cautioned that his office's commercial recording section should not be privatized because it was "a money-maker for us," Assemblyman Dick Kamin (R-23) shot back: "I don't know if we should look at any of your services as profit centers, because that money comes out of the private sector and into the public sector. The public sector does not create wealth; the private sector does. So it's negative for the overall economic health of the state."

As mentioned earlier, studies of various privatization projects have been held over the years in New Jersey, and all have come to nought. It remains to be seen what can be achieved in the current session of the legislature.

#### LOCAL I&R ADVANCES

State Senator Randy Corman (R-19), a former NJLP member, has won committee approval of a bill to allow New Jersey residents the right to a "localized" version of initiative and referen-

Under Corman's bill (S.239), residents in nearly all municipalities would have the right to local I&R as well as recall elections.

"A majority of the citizens in New Jersey already have those powers," said Corman, noting that 154 of the state's 567 municipalities allow residents to place a proposed ordinance on the

ballot if they obtain a prescribed number of signatures. "The rights of citizens shouldn't depend on where you live."

Corman further stated that 163 municipalities allow voters to initiate recall elections and his bill would extend such powers to all but a handful of towns. Those excluded have special charters.

S.239 would permit an issue to be placed on the ballot as soon as possible if signatures from at least 15 percent of the voters in the • last general election were obtained. If only 10 percent were obtained, then the issue would be on . the next municipal or general election ballot, whichever is sooner.

#### MARIJUANA "LEGALIZED" IN STARKS

The Gestapo-like tactics being employed by the drug warriors in Maine have upset the locals so much that in one town, Starks, the people voted to "legalize" marijuana as a sign of protest.

with battering rams, weapons out and cocked, shouting profanities," said David Wilkinson, a local businessman. "They've patterned these raids after the ones at Brooklyn crack houses, and that's outraged a lot of people.

Wilkinson heads up Maine People for Hemp.

Starks voted 45-42 at the March town meeting to legalize marijuana, even though it has no effect on federal or state laws. "It

makes politicians sit up and take notice," said activist Mi-

chael Ezzy.

"It's anti-prohibition far more than pro-pot. People just want to be left alone," said Wilkinson.

Starks' 800 residents are reported to be a combination of families that have lived in the area for generations and "back-to-the-land" settlers who have moved in over the past 20 years.

Starks was outraged when the Maine Bureau of Intergovernmental Drug Enforcement (BIDE), spurred on by federal funds, raided the farm of a 70-year old man who was arrested and charged with growing 2,600 marijuana plants. He stated he needed to sell marijuana because he didn't get Social Security.

"The most serious, distressing and dangerous aspect of the drug war," says Wilkinson, "is the fear and intimidation that the presence of this very aggressive law enforcement agency produces in ordinary people.'

Since the crackdown began five years ago, residents have been complaining about low-flying helicopters that come in at tree-top level and boisterous night raids. Those who have spoken out in favor of legalization find themselves targets of the helicopter surveillance.

The biggest concern of Starks' residents is that now they have voted in favor of legalization, the rest of the country will look at them as "the drug capital of the world."

#### CONGRESS UPSET WITH VOTERS

Finally revealing the contempt in which our "representatives" actually hold us, a political scientist recently reported that politicians in Washington are ticked off at the public.

One politicians stated "A lot of people say, 'I like a politician who takes a position and stands by it.' That's baloney!

"People want you to tell them what they want to hear. If you tell them what they don't want to hear, you don't get much credit for courage."

Lawrence N. Hansen received funding from the

Joyce Foundation and Centel Corp., a Chicago-based telecommunications company. On the condition of anonymity, 16 members of Congress--10 Democrats and six Republicans, 12 representatives and four senators--spoke with Hansen on the reasons why they believed the government always seemed to be deadlocked. They blamed the people.

"I think most of us are frustrated with the cynicism we find out there," said one. "It's frustrating to call town meetings and have very little attendance...to see that only 40-50 percent of the electorate is actually voting, as if they do not

care, and to have to face an angry mob of people who demand that the budget deficit and their taxes be reduced but who won't give up their favorite programs."

Yet Congress was assuredly not a bastion of truth-speakers. According to Hansen, "the members with whom we talked admit they are reluctant to give their constituents the unvarnished truth."

So, the next time your representative is kissing babies and glad-handing you and your neighbors seeking votes, remember his utter disdain at having to deal with the great unwashed masses.

At the convention this past March 7, the members voted to amend the NJLP bylaws to include as members anyone who pays dues to the National LP. Article 13, Section A of the NJLP bylaws requires prior notice before bylaws amendments may be considered at a general meeting: "These bylaws may be amended...with notice of the proposed amendments given in the notice for the meeting."

Although some mention of the amendment was sent on the back of the notice of the Convention mailed with the newsletter, it was buried in a long treatise on dues changes and was obviously not part of the notice of the meeting. Further, the language of the suggested amendment was not stated. I hope in the future proposed amendments will be clearly stated and unambi-

guously part of the notice of the meeting. We demand that the government follow its rules; we should at least follow our

Editor's Reply: It is understood that Mr. Schoen opposed adoption of the amendment, but he is incorrect in implying that the method of advertising it improperly violated the bylaws. The bylaws simply require "notice" to be given, which it was. And rather than a "long treatise on dues changes," the wording Mr. Schoen objects to was the proposed amendment itself; it described ex-actly what was being sought. Nor do the by-laws specify the location in which any proposed notice be published. Simply because it was on the re-verse side should not invali-date its adoption. Thus, the procedure that was followed was that which was required and no improprieties should be inferred or suggested.

#### LIBERTARIANS FILE SLATE FOR CONGRESS

April 10 saw thirteen Libertarians file their petitions with the secretary of state's office in Trenton, cementing the voters ability to have a real choice this November.

In the 1st district, NJLP at-large member Jerry Zeldin, of Laurel Springs, filed to challenge incumbent Democrat Rob Andrews; in the 2d district, Roger Bacon, of Phillipsburg, filed to oppose Democrat Rep. William Hughes; NJLP Trustee *Helen Radder*, of Farmingdale, will run for the 3rd district seat currently held by Democrat Frank Pallone; in the 4th, Benjamin Grindlinger, of Hamilton, will take on Republican incumbent Christopher Smith; in the 5th, NJĹP Chairman *Mike* Pierone, of Vernon, will oppose Republican Rep. Marge Roukema.

In the 6th district, Bill Stewart, of Keyport, faces no incumbent; the 7th district has NJLP at-large member Spencer Layman, of Matawan, opposing Republican Rep. Matthew Rinaldo; the 8th district also has no incumbent, and NJLP Treasurer Lou Stefanelli, of Belleville, has filed to run; immediate past chair Dan Karlan, will run against incumbent Democrat Bob Torricelli in the 9th district; in the 10th, a newcomer to the NJLP, Roberto Caraballo, of Newark, will take on Democratic Rep. Donald Payne;

The 10th will see Richard Roth oppose Republican Rep. Dean Gallo; Carl Peters, of Washington Crossing, will take on the freshman Republican Rep. Dick Zimmer; and NJLP Vice Chair Len Flynn, of Morganville, will have no incumbent to challenge in the 13th district.

#### GARBAGE COLLECTION PROJECT NEARS SUCCESS

A three-year campaign for pay-per-bag garbage collection system in Metuchen is approaching a successful conclusion.

NJLP Development Coordinator Sam Edelston, who has worked singlehandedly to end the crosssubsidization inherent in the traditional method of trash collection, was elated when a borough council hearing in March found most of the council to be in favor as well as most of the public.

Several people remarked that their minds had been changed by information presented at the hearing or by Sam's letter that had appeared in three newspapers the week before. The Central Jersey Home News named Sam's missal "Letter of the

A hearing on the same issue two years ago found, by a show of hands, that public opinion was running against the payper-bag proposal at a rate of 5 to 1. Sam is to be congratulated for this astounding reversal.

Assuming the council can work out an acceptable plan, they are targeting the third quarter for implementation.

While the pure libertarian position would be to get government out of garbage pickup altogether, Metchun residents have indicated they are not ready to go so far.

Pay-per-bag, notes Sam, at least introduces the notion that people should not be forced to subsidize those who use a service more heavily or wastefully.

A Sampling of Recent Newspaper Clippings

Fred Stein, an NJLP founder who was recognized recently at the state convention for his dedication to liberty, had a letter in the Central Post criticizing local zoning ordinances that had prevented a property owner from selling his land to a

developer.

"The Gaylords are victims of the political system...The purpose of zoning is to keep an area homogeneous, and to keep property values artificially high. Having minimum lot sizes and the prohibition of twoto four-family houses keeps the working class locked out of home ownership...Smallfamily farming and socialism are 19th century concepts that have drifted into the sunset. The new day that awaits for America and South Brunswick is one that is based on technology, free markets and life in subur-

· NJLP Treasurer Lou Stefanelli recently had the lead letter published in the state's largest newspaper, The Star-Ledger.

The Governor had proposed that business in the state could save jobs during the recession if they shared positions.

In his letter, Lou proposed a novel solution to New Jersey's fiscal problems:

"Since approximately 60 percent of the state's \$16 billion budget goes for payroll and benefits, fully implementing the (Governor's) plan could save the state \$4.8 billion. A partial use of this plan reducing only 1.41 jobs to one instead of the full two for one would be all we would need to completely reverse the Governor's \$2.8 billion tax increase...Sounds pretty good to me. Damn the critics, Governor...show 'em how it's done!"

Thomas O'Reilly, commenting upon an earlier letter written by Lou about the Bill of Rights in the Mount Olive Chronicle, wrote:

"The idea that an individual...which does not promote a particular concept by public speech or action is promoting an antithetical concept without public speech or action is blatantly incorrect...not advocating a specific idea does not mean you are advocating another specific idea."

reports: the Wall Street Journal ran a story on the unhappy life of an IRS agent, reporting that IRS officers suffer more assaults than any other law enforcement group--more than the FBI and five times more than the DEA, the second most assaulted group. Surprisingly, one one IRS agent has ever been killed in the line of duty

Other taxpayers have used more creative, less violent means of revenge. One agent who tried to sell his house found that an angry taxpayer had filed a false lien against his property which took two years to clear. The same taxpayer then filed a phony 1099 form saying that he had paid the agent \$166,104, a problem that was eventually sorted out.

So despised is the IRS agent that they keep their phone numbers unlisted; register their cars at their office address; and virtually refuse to let anyone know where they work. They also carry on an almost incestuous ritual of marrying one another

since apparently no one else can stand to be in their company. Yet according to the article, the agents really like their jobs and stay on for years and years.

Despite their success at prosecuting individuals like Irwin Schiff, the Journal article concludes, "there are about 160 million other taxpayers still at large."





#### TAX FREEDOM DAY: MAY 5!

After having filed your tax returns last month (assuming you are one of those "required" to file), you may have felt the burden to be a little heavier this year. Your feelings are right.

According to the Tax Foundation, a Washington, DC-based watchdog organization, Tax Freedom Day will come on May 10. Tax Freedom Day isthe mythical date on which the average person has earned enough to pay all tax obligations for the year.

As recently as the Orwellian year of 1984, Tax Freedom Day fell on April 28--the same as in 1970. And in 1930, the first year for which economists have made the calculation, workers would have earned enough on February 13 to pay the tax

collector and begun working for themselves the rest of the year.

To underscore the absolute intolerability of the whole tax mess, noted tax patriot Irwin Schiff had the book thrown at him by the US Tax Court. The IRS said Schiff had earned \$141,952 in 1979, and billed him for \$68,148 in back taxes and penalties.

When Schiff exercised his constitutional rights to appeal the decision, Judge Charles E. Clapp 2d not only dismissed Schiff's "stale and long'discredited tax protester arguments," but also ordered him to pay everything the IRS wanted, plus interest compounded daily. Then he fined Schiff \$25,000, the maximum fine the court could impose!

Yet there is a silver lining to these dismal
