Unilateral Free Trade The Trade Deficit

One of Bubba's great shows of strength and leadership is the appearance of making the Japanese submit to his view of fair trade, a non sequitur, by rattling the bugaboo of the "trade deficit." Bubba's motive is the political and monetary campaign support that is to be forthcoming from some in the automotive industry who are looking for some easy profits and excuses for their past failures.

In truth the Japanese people are subsidizing the American consumer. Isn't that nice? The American consumer can buy products at a cheaper price because of the Japanese government's ignorant trade policies. This is a policy that subsidizes Japanese industries (similar in principle to the Chrysler and Lockheed bailouts) causing the Japanese citizen to pay more for products by restricting their choices. The Japanese citizen must pay the price for their government's trade policies, not the US. Citizen.

We have new industrial capacity, Toyota, Honda, Kawasaki, all manufactured here, and we have someone to buy NYC real estate, although the recent bankruptcy at Rockefeller center may have let the cat out of the bag. We have a new importing and distribution industry, auto and motorcycle manufacturing and a steady flow of cash from Japanese investments and their thirst for oil. We

also are the pre-eminent nation for innovation, which the Japanese cannot keep up with, but readily copy for a price. We have had a huge influx of money into our entertainment industry from the Japanese. Yet they are not the biggest foreign investors in the USA. Maybe third or fourth.

The trade deficit cannot tell us anything in this age of monetary manipulation and monetary expansion. Where will American currency go, into a Japanese shoebox? No it must return to its place of origin. This whole argument is centered around the not too bright American car companies determination to get into the Japanese market, while the Japanese are already turning their heads in the direction of Asia looking for less mature and more profitable markets. The American manufacturers in their shortsightedness see a narrow market for high priced fat margin products and they seek to use the force of government and the moron in the white house to make a few bucks, but this is immaterial to American consumers, who make their choices in the market place every day. Choices Japanese do not enjoy. We have no significant excess capacity and no interest in the trade policies of Japan or any other country as long as we enjoy unilateral free trade. STATES' RIGHTS REBELLION

Citing prosecutorial threats against federal workers, the U.S. Justice Department has filed suit against Nye County, Nev. The Justice Department seeks court affirmation that the federal government owns and controls 87 percent of Nevada land.

Brave Nye County Citizens, weary of federal dictates. passed a 1993 resolution saying that "the state of Nevada. not the United States, owns national forests and other lands, and that Nye County, therefore, has the authority to manage these lands." Their position is fully supported by Article 1, Section 8, of our Constitution. which only permits the federal government to exercise "authority over all places purchased by the consent of the legislature of the state ... for the erection of forts, magazines, arsenals, dockyards, and other needful buildings." By virtue of our Constitution and a recently enacted Nevada statute, Nye County officials have full authority to arrest and prosecute federal Forest Service, Environmental Protection Agency, and Fish and Wildlife officials acting

outside their jurisdiction.

claims the government does have the right to own and control Nevada, based on the Nevada Statehood Act of 1864, whereby Nevada "forever disclaims all right and title to the Iying within said territory, and that the same shall be and remain at the sole and entire disposition of the United States." The Justice Department's be upheld in any court except one of a kangaroo variety. John Schmidt, associate U.S. attorney general, said he hopes that the suit will "put to rest the idea that any county has the right to enact laws to override the Constitution." That shows the Justice Department's understanding of the Constitution. The Constitution is the law of the land. Article 1, Section 8, has not been amended to make it subservient to the Nevada Statehood Act of 1864. Nevada had the right to be admitted to the union on the same footing as other states.

another light and in a way Congress can diffuse the conflict. Congress wants to restructure the federal government in an effort to restore fiscal sanity. Minutes of the NJLP, State Board, May 21, 1995

The Chairman called the meeting to order at Tumulty's Pub, New Brunswick, at 1:17 PM. Present; Flynn, Wiessmann, Ellett, Stefanelli, Konek, Pfeiffer, Quarles and Girardeau. Absent; Grindlinger, Mehaffey, J. Eden, E. Macron, McInereney, Glatter and Savicky. Also present was Ron Tamburro.

The minutes of the Steering Committee meeting of April; 8 were accepted as amended, and the Treasurer's report on the General Fund was received. In addition, there is \$1,497.00 in the State Fund: Ellett will send the names of contributors who requested an Amerivox Card to Grindlinger. Membership is at a new high of 551.

An Elected Libertarian's secrets of grassroots political success

Editor's Note: This essay was written in response to Daniel Walker's "A newly elected Libertarian asks: What next?" which appeared in the November/December 1994 issue of the Libertarian Volunteer.

Congratulations to Daniel Walker on his election to the Ochlockonee River Soil & Water Conservation Board. I support his excellent case for local (grass roots) activism. There are, however, even more ways to get involved locally.

First you need to get involved in non-libertarian groups and inject a libertarian viewpoint. Tax groups such as Citizens Against Government Waste and unaffiliated groups can also be a good source of government machinations that go unreported in the media.

Second, decide whether you want to be more involved in city or county government and start going to the meetings regularly. Arrive early for the meetings dressed for a business function. This will give you a chance to chat with your representatives. As with any sales presentation, start with the general and work towards the specific. Talk about frugal government then privatization of roads. You may, on your first meeting, just want to introduce yourself as someone who wants to get more involved in your community. (How altruistic of you!)

After you have gotten to know them, and visa versa, let them know you would be willing to serve on an appointed board. These [positions come up regularly and are often vacant due to the lack of people willing to serve. If you have an area of interest, let your representative know that, too. Get what appointment you can and get seriously involved.

Third, most meetings have a time when citizens can address elected bodies on any issue. Sometimes comments are limited to agenda items and/or you

must schedule your presentation in advance. Use this time to weigh in on current issues and hone your public speaking skills. You may want to join Toastmasters to expand your local contacts.

Recently, the county health and school boards were trying to implement school based health clinics with private (Robert Wood Johnson Foundation) grant money that would have increased county spending by \$5 to \$20- million annually. While addressing the board on my concerns about these agencies obligating the county in this way, a board member interrupted me. He instructed the county manager to draw up a resolution to force bureaucrats and others to come before the board for approval with the stipulation that once the grant money runs out, "that's it." This effectively shot down socialized medicine for our schools, and should have a chilling ef-

fect on future bureaucratic growth.

Fourth, get to know the recording clerk. They can be very helpful in running the government maze, and are a wealth of information.

Also get to know the folks in the media. They will remember you (it's their job), despite what may appear on the air or in print.

Don't be shy about praising the random acts of libertarianism that are committed by Republicrats. If we encourage that type of behavior, we will see more of it.

I see real opportunity in the 1998 and 2000 U.S. House races. The GOP will have had several years of control of two

of the three branches of government, and will have shown their inability to stop the growth of government. We must be ready with a network of people that mean it when they say they vote for the individual, not the party. They are legion.

Send the voting envelope and ballot to the NJLP, PO. Box 56, Tennent, NJ 07703, by July 31, 1995. It must be received by then in order to be counted. Results of this election will he announced in August.

The Teacher's Guide to the U.S. Department of Education

Abstracted from the opening remarks of Terry Knecht Dozier, Special Advisor to the Secretary of Education, in the Guide: The mission of the U.S. Department of Education is to "ensure equal access to education and to promote educational excellence throughout the Nation."

I don't know who this "teacher" is quoting, but it is revealing that the purpose of education is to *ensure equal access* and secondarily to merely **promote** educational excellence. But this is no surprise if you have been conscious for most of your life. It is nice to see it stated plainly and have our position validated by the opposition.

The Johnson O'Conner Research Foundation reported in American Demographics, (127 W. State St., Ithaca, NY 14850):vocabularies have dropped sharply among college bound 18 year olds? In 1940, such youths typically knew the meaning of 80% of the words on a standardized test. By 1992, the typical youth scored only 30% on words of comparable difficulty-----which is little better than random guessing.

Possibly someone in the field of public education has noticed this personally or may have read some data about it. But that is only if they have been awake for the last 55 years. Then again they only mean to **ensure** equal access not education.
