MESSAGE FROM THE CHAIR

"Freedom in our time!" That is our ultimate goal, and it is important that we do not lose sight of it. The only real question is how to achieve that goal. As a political party, we have committed ourselves to the political process as our means. But that does not mean only running candidates. Another way to get what we want is our right to petition the government with our grievances.

Recently, the Board of Chosen Freeholders of Monmouth County voted themselves a 56% raise. Right now there is a petition circulating in Monmouth County calling for the rescission of that pay raise which, incidentally, is retroactive January 1. I urge everyone in Monmouth County to sign the petition, and if possible, to solicit signatures for it. This is one of those rare times when a little persistence, a little time, and little else can accomplish great things. This is your chance to take the purse-strings of government into your own hands. Go for it!

Also circulating throughout the state is a petition to repeal the hated mandatory seat-belt law. You will find a copy of the petition in this newsletter. Please make copies and enlist your friends in the task of collecting signatures. Collect as many signatures as you can and forward the completed petitions to me Dan Maiullo, 750 Washington Ave. #6, Belleville, NJ 07109.

Also, please write to your state and federal legislators asking them to repeal the law and expressing your opposition to any requirements for passive restraints in autos. Emphasize the personal choice is-

sue. This is important! Most of our state legislators are opposed to the seat-belt law! It was passed due to heavy lobbying by the auto industry. They are pushing for mandatory seat-belt laws all over the country because they want to avoid the imposition of passive restraint laws. It is important to tell your legislators that you are opposed to BOTH. Once there is enough public pressure, the law will be repealed! It does not take much. Write and call them. Do it!

In the near future, a group will be formed for the specific of re-

In conjunction with the two petitions above, signatures can be collected to get our gubernatorial candidate, Virginia Flynn, on the ballot. PETITION REGARDING THE USE OF SEAT BELTS AND PASSIVE RESTRAINTS

We the undersigned hereby declare to the New Jersey State Legislature and to the U.S. Congress that we are opposed to New Jersey's new mandatory seat belt law (P.L. 1984, CHAPTER 179, No. 2304) and to any federal requirements that all new cars be equipped with passive restraints such as air bags. We do not deny the fact that such devices can save lives. We also believe that anyone who wishes to have their motor vehicle equipped with passive restraints should be free to purchase them. But we cannot support the efforts of state and federal legislators who would force all motorists to use them through legislation. Freedom of choice and not public safety is the issue here. Therefore we demand that our representatives in the U.S. Congress actively oppose any efforts by the federal government that would force automobile manufacturers to equip new cars with passive restraints. We further demand that the New Jersey State Legislature repeal its mandatory seat belt law immediately.

NOTA lost again to the slate for At-Large Representatives of Stuart Swirsky, Ken Kaplan, and Chris White. NJLP Trustees elected were Bill George, Richard Krause, and Richard Roth over Jerry Zeldin.

NOTA

All NJLP members will be listed as alternates, as is the party's usual practice. The membership unanimously allowed a vote for NOTA for each delegates position and reapproved the delegation's right to select alternates at the National Convention, in the event several members wish to take voting seats at the convention this August in Phoenix and there are not enough vacancies.

In the afternoon the NJLP held its general meeting to selected candidates for public office. All were elected unanimously.

Ginny Flynn was chosen for Governor and her campaign started with \$425 in contributions and pledges in its first fund-raising effort. Several members even made the supreme sacrifice and agreed to collect signatures on petitions!

NJLP Assembly candidates nominated were Steve Friedlander (16th District), Rick Hoegberg Dist.), Richard Krause (38th), Jack

Moyers (13th), Lucille Bender (11th), and Paul Nelson (16th). Pat Fallon was approved for Monmouth County Freeholder and Ken Kaplan had the NJLP blessing for 4th Ward Council in Rockaway Township.

Libertarians here in New Jersey and elsewhere should be concerned with some rather ominous developments to our north--namely Canada. Two ideological cases involving free speech are going on there. Two men, on Ernst Zundel and Keegstra, dared to exercise their freedom of speech regarding historical revisionmism about World War II and the "holocaust" in particular. (They both are skeptical of the claim that 6 million Jews were done in by National Socialist Germany).

Needless to say this is a very controversial topic, charged with strong emotions on both sides of this case. However, the issue isn't whether one endorses the views of Zundel or Keegstra but of free speech, and if the state can take it away under the pretense of "publishing false news" and "inciting racial hatred" (as has been done in these cases).

"I'm not a bad man, just a bad wizard." So ends the story of the Wizard of Oz, but it could just as well be the beginning of an educational tale for America's citizens, for to most of our people the workings of the regulatory process are as full of mystery — and humbug — as the silly wizard of Oz.

Opinion poll after opinion poll shows how convinced the naive voter is of the "need" of government to "protect" the helpless public from horrible businessmen —and their fraudulent and dangerous products. Dupes galore get out their checkbooks to support "Nader's Raiders" and his colleagues in the Center for Science in the Public Interest or the Health Research Group. These ardently statist groups endlessly push for banning this or that consumer product, amidst showers of praise from their mindless supporters in the super dupe media.

Objections from independent voices are lost amid quasi-scientific arguments that sway shallow newsmen while the truth is forgotten when it surfaces weeks -- or years -- later. Remember the notorious fluorocarbon ban which was desperately needed to "save" earth's ozone layer from extinction? Well recent studies put any supposed ozone depletion at such negligible levels that the harm is nil -- if any at all. Yet burns and explosions from the more flammable hydrocarbon propellents which replaced fluorocarbons are clearly not negligible to those injured as a result of this hasty regulatory folly.

This is a key to awakening the dullard voter to the idiocy of regulation: false science. But there is another one -- false principles.

As of March 1, 1985, New Jersey drivers will be expected to comply with a mandatory seatbelt law. Failure to comply may result in a \$20 fine. The only apparent opposition to this law comes from special interest group such as an organization for obese people. 
