LETTER FROM THE CHAIRMAN

The title of my keynote speech at the NJLP 1984 convention was "Libertarianism in New Jersey: What Can be Done?" For the record, and for those who missed my speech, I want to enumerate the ten key issues that Libertarians might consider concentrating upon as their legislative agenda.

- 1. Permit laws to be passed by iniative and referendum of the voters. I & R is a time-honored way of returning power to the people. It sparked tax revolts in California and Taxachusetts.
- 2. Repeal franchise tax on utility bills. This regressive tax adds 13% to the cost of already high utility charges. Money is collected from every customer, but is distributed by the whim of politicians.
- 3. Restitution by criminals to victims. It is time to recognize legally that the criminal's first obligation is to the victim, not to the state. Wages and property should be awarded, and victims should be allowed to testify at trials and sentencing.
- 4. Restitution by polluters to victims. Why not create a privately-funded entity to monitor pollution, determine the sources, and initiate legal action against polluters; with benefits going to those harmed and a fee plus percentage to the entity?
- 5. Bid out government services.
 Many services that government now performs could be done more efficiently by private enterprise. The profit motive would provide incentives for better service at lower cost. Private contractors who fail to perform can more easily be dismissed than bureaucrats.
- 6. Repeal licensing of ordinary trades. Why should hairdressers, barbers, and many other ordinary trades be licensed by the state? This merely holds down competition and forces up wages. Repeal is the answer.
- 7. Repeal farmland preservation by taxes. This elitist program gives unfair windfalls to farmers at the expense of taxpayers, yet the main benefit is aesthetic to well-off people who don't want their view spoiled.
- 8. Repeal rent control laws.
 The only practical and moral answer to

- shortages and high costs of rental units is the free market. Monopolies or controls guaranteee both shortages & higher prices.
- 9. Eliminate the tax monopoly held by government schools. In the short run, tax credits should be allowed for people who do not utilize the public schools. In the long run, all tuition should be billed directly to parents, with privately-funded scholarships for low-income students.
- 10. Cut taxes at all government levels. Eliminate or bid out as many government services as possible, and then require that both expenses and taxes be cut from the budget. For government, our slogan must be "stout is out and thin is in!"

Candidate claims Libertarians are party of true new ideas

David Bergland, the Libertarian Party's Presidential nominee, said yesterday that voters are looking for new blood and new ideas in this election year, but they are not going to find them by turning to President Reagan or whomever the Democrats nominate.

Stopping in Union yesterday for the New Jersey Libertarian Party convention, the 48-year-old California lawyer said his candidacy offers voters the only real alternative to the "same old tired political solutions.

"The major distinction between the Democratic and Republican candidates and me is that they all view the people of this country as a natural resource to be used for their own ends," Bergland said. "I have the respect for the right of everyone to live their own lives according to their own values."

He maintained he would accomplish that goal by some fundamental changes in American policy: Ending all United States military alliances and bringing all troops home from foreign

soil; eliminating the federal income tax; and phasing out the deficit-ridden Social Security system and replacing it with voluntary alternatives.

Bergland said he has few illusions about his propects. "I'm as realistic as anyone else. The odds against me being elected are pretty long."

The 11-year-old party pulled in roughly 1 percent of the popular vote in the last Presidential election with just under 1 million votes for Ed Clark.

Still Bergland, a white-haired Iowa native, has set some goals and believes that 1984 will witness the end of the two party system.

The success of the campaigns of Democrat contenders Gary Hart and Jesse Jackson attest to the fact that people are looking for something new, Bergland said.

He said he hopes his campaign, which the party expects to spend roughly \$3 million in all 50 states, will lead to Libertarian positions being adopted by those who do wield power.

"It's a battle of ideas," said Bergland, who claimed the party already has made some impact, citing moves to deregulate certain industries as one example.

But Bergland said neither the Reagan Administration nor the Democratic candidates are inclined to reduce the size or reach of the federal government.

"I've watched Reagan campaign with his well-known rhetoric about getting government off the back of people," he said. "So, it's not surprising that the only campaign promise he kept was to increase miltary spending."

As for former vice president Walter Mondale, Bergland said it is apparent that the Democrat wants to continue with the old Democratic coalition: "Offer everything to every interest group going and worry about who is going to pay for it later."

He criticized Hart for proposing a massive public works program. "To tell me that is a new idea is preposterous," Bergland said.

If elected, one of Bergland's first moves would be to scrap the income tax, which he said has led the federal government to become the major growth industry in the country since the tax was enacted in 1914

He said he would sharply cut military expenditures by disengaging the U.S. from all alliances, such as NATO, and by initiating a nuclear arms reduction race. That could be achieved by a declaration of a "no first-use" policy regarding nuclear weapons, Bergland said.

Most of all, he would move to ensure that an individual's rights are guarded and government avoids intervening in people's lives.

A lot of his aversion to government intrusion into everday life was learned during a stint working for the city of Los Angeles Fire Department. "I was once a bureaucrat, but I got over it," he said.

Bergland, a former Libertarian Party vice-presidential nominee in 1976, also would eliminate all U.S trade barriers—a move, he said, that would be a powerful inducement for peace.

He would phase out the Social Security system while providing present beneficiaries with payments from private annuities purchased with the proceeds of the sale of federally-owned land.

* 1984 CONVENTION HIGHLIGHTS *

--#DICK SIANO--

Kingwood Township Committeeman Dick Siano appeared at the convention to tell us about life "In the Belly of the Beast." (Randy Corman, Sayreville Board of Education Vice-President, was unable to attend due to his car breakdown.) Siano felt that he made progress (in terms of bringing a libertarian approach to politics in Kingwood) during his first year in office. He has just completed his second year, however, and feels that perhaps he was overly optimistic.

During his first year the committee was composed of himself, a Republican, and a Democrat. Now he sits with two new Democratic committeemen. The year began badly when the two Democrats broke with tradition and refused to make Dick, the senior committee member, mayor.

The township budget was just increased 25%--from \$400,000 to \$500,000. This is no surprise when you realize that Kingwood spends almost \$5000 per child to educate its children in the public schools.

In short, Dick has come to the realization that most voters do not see themselves as "John Q. Taxpayer," but rather as part of special interest groups—parents of school age children, senior citizens, recipients of various government subsidies, etc. People tend to see what they get back FROM government rather than how much they pay TO it.

This has led Dick to decide against running for a second term next year. Rather, he will continue to espouse libertarian solutions to problems and he will not be corrupted by trying to secure the vote of any special interest groups. He believes that his hopes for achieving libertarian goals have changed from success in the short term to long term.

Although Dick will not run for reelection next year, he is running for Hunterdon County Freeholder this year. Hunterdon County has a strong libertarian organization and Dick has worked hard to bring in

new people. He plans to seek someone else willing to run for his committee seat in 1985.

-- TAX SEMINAR --

Dr. Alfred Steever of the Constitutional Freedom Committee distributed copies of the U.S. Constitution to the audience and proceeded to instruct his listeners about their rights, or lack of them, according to the Constitution. He asserted that "If YOU don't KNOW your rights, you don't have any!"

Steever called the U.S. government a "democratic fascist state" and enumerated numerous ways in which governments at every level violate the Constitution.

--JUVENILE "JUSTICE" IN NJ--

Russ Malta, a Monmouth County Assistant Prosecuting Attorney, and former NJLP member gave convention attendees an overview of the juvenile justice system in New Jersey. Malta originally became involved with libertarianism while at Princeton University, but has had to refrain from any active involvement in politics since becoming a county prosecutor. (Regulations prevent political activity so he had to resign his NJLP membership.)

Malta discussed the major reform of juvenile law in New Jersey which took place in 1983. This included a shift in emphasis away from rehabilitation towards punishment and "protection of the public." Waiver allows the State to choose to treat juveniles as adults for some criminal acts. In addition the new juvenile code gives the court power over the entire family, not just over the juvenile.

Depending upon the circumstances, being a juvenile "offender" can be either detrimental or helpful in terms of the law. Juvesentences are much lighter than those for adults, and juvenile detention centers and reform schools are supposedly better than prisons. On the other hand, juveniles are denied their right to a jury trial and to bail. To secure these rights they must apply to be "waived up" to the adult judicial system. Also, it's important to note that if you're under 14 years of age the State denies the right to due process.

In summary, whoever coined the phrase "Children are people, too" had no knowledge of N.J. law!

--ALAN REYNOLDS--

Economist Alan Reynolds gave an entertaining luncheon address on "Beyond Reaganomics." He blasted today's "Orwellian economics" which propounds absurd convential economic thought like this: "all countries' exports should exceed their imports." Such nonsense represents the current economic wisdom that a weak currency and high taxes produce improved economic conditions!

Reynolds believes there is definitely a place for Libertarian Party candidates and he urged LP challengers to offer a real choice on the issues. He said LP campaigners should reject the problem definition of our opponents. For example, "trade deficits are NOT a problem!" is the antidote to the above quote. In addition, he said "If I were a Libertarian candidate, I'd go for gold."

Reynolds closed with a strong call for a gold standard: "People demand it, governments fear it.... People never leave the gold standard, only governments do!"

Taxes and Spending

Taxation violates individual rights and is an economic burden most people cannot afford. Today's oppressive levels of taxation are enforced by the IRS, which systematically harasses peaceful citizens, ignoring due process and the Bill of Rights.

Libertarians are not satisfied with phony "cuts" in taxing and spending, but rather believe that taxes are a kind of legalized theft which can and should be slashed immediately, and abolished as soon as possible.

NATIONAL TAX PROTEST APRIL 15

Editor, The Record:

The amoral zeal of religious true believers distracts them from seriously considering the moral issue behind the public-school-prayer controversy. That issue is: Should religion be separate from government?

If these public school (that is, government-sponsored) minireligious services were in private schools instead, there would be no problem: It would be a private choice to pray. But local school classes are mandatory meetings enforced by truancy laws and are financed, organized, and led by government representatives in order to attain government ends.

And one of those ends must not be religion. Coercing children to attend religious meetings and coercing parents to pay for them should be practices that remain in Iran, not in this country.

But coercive religionists claim that all they want is "voluntary" prayer — not "required" prayer sessions. How dishonest! It is obvious to all that every child already is allowed to pray on his own. Any child may pray before class, during recesses, or during lunch — as he chooses.

But there is the rub. Virtually no children freely choose to forgo healthy and happy play to pray. So prayer time must be mandated. Children must be taught by school authorities to set aside time for prayer. The moral principle of separation is broken. Pandora's box is opened.

"Good little children" will be encouraged by religious parents to pray during this "moment of silence." Teacher may smile on these children, but not on the others. Not until they learn better. They will all learn either guilt and inferiority or passivity.

And we taxpayers will "volunteer" to pay for all of this nice volunteerism — and for all that will follow it


