PART VII--"POLITICAL SEWAGE"

Potential Libertarian political candidates often pass up challenging establishment political candidates, not so much because of the money and manpower advantages of the Demopublicans, but due to the perceived skill contemporary statist politicians have in justifying their socialist views. Many NJLP activists are intimidated by the fear of failure in defending the libertarian position against rival statist candidates. Alas, this mistaken notion drives many good potential NJLP candidates away from direct political confrontation of the prevailing creed of MORE government.

But there are "heroes of the Revolution" working to reverse these mistaken impressions of the skill of contemporary statist polithe opposing candidates ticians: themselves! One need only listen for a moment to a debate or campaign speech to hear the equivocal nonsense from the Republicrats and you will be greatly enlightened. Their lies are so incredible, and their complicity and deceit are so obvious that even the dullest political observer cannot miss political sewage overwhelming statist politicians modern before the public eye.

In contrast the neophyte LP campaigner shines. Amid the waffling and mumbling fog of the Demopublicans comes the clear shining beam of Libertarian principle. Cynical political reporters are frequently amazed and impressed by the honest and clear libertarian positions LP campaigners give on the issues—in direct contrast to the statist politicians. In a debate between truth


and sewage, the principled libertarian wins easily.

For example, one experienced NJLP campaigner rose at a meeting to tell other libertarians that he was "a poor speaker" but ran for office because he "wanted his children to live free." What statist can bring such courage and passion to a political campaign! When a libertarian speaks from the heart, the statist opponent is helpless.

Another factor in the LP candidate's favor is the incredible stupidity of most politicians. Compared to those woodenheads anybody looks good. Remember that to be a "good" politician requires skills directly opposite to those required for productive endeavor. Instead of insight and intuition the successful statist needs conformity and obedience. Deceit and treachery will sink a businessman, but these traits are the stock in trade for a Intelligence atrophies politician. in politics but thrives in the comproductive marketand petitive place.

So it is the LP candidate who can win the battle of political debate and need not fear betraying our great cause through incompetence. Our enemies are such dolts that we cannot lose!
