## **LNC Update**

The following is my report on the LNC meeting last weekend (November 12,13, 2005).

The Treasurer reported that the LP is still running a deficit, though it is slowly being eroded. Receipts are not quite up to the desired level, though expenditures are down, and the most urgent Accounts Payable (including staff) are being met. The Treasurer asked the members of the LNC to develop a backbone, and I for one took that guidance personally and to heart.

We do not have an Executive Director; per the National Bylaws, National Chair Mike Dixon serves that function temporarily, while Shane Cory serves as both acting office manager (chief of staff) and communications director.

Shane presented a demonstration of the website addition, Libertarian Leadership School, which will offer on-line training in a variety of courses, including Ballot Access, Candidate Recruitment, and FEC Compliance, for example. There will be about a dozen in all, with more to come as the need and expertise to compile the course warrants. There will be weekly quizzes and access to experts, and the best students will be recognized at LP conventions.

We voted to outsource materials sales (including literature) to a firm run by Webb Garlinghouse, though because of BCRA obstacles he will probably have to reorganize as an LLC for the purpose of purchasing advertising space in LPNews. A motion to outsource LPNews was defeated. We heard three presentations from three different outfits interested in taking over LPNews in some form (including on-line), but the discussion (much of it in executive session, due to the need to confer with counsel) elicited important difficulties both with the outsourcing itself and in addition with each specific proposal. Another motion to make LPNews advertising-free was also rejected (objection to consideration passed).

My motion, made on behalf of the LPMA, to restore UMP (both flavors) and to set dues to \$30, was objected to, and the objection to consideration carried. (This was also the fate of a parallel motion, on behalf of Jack Tanner, to set dues at \$0.0001 with the promise from Mr. Tanner to pay \$100 into a fund for the purchase of 1,000,000 memberships at that price.)

(If I had been at the Kansas City meeting, I would have voted against setting dues to zero, because I believe it violated the Bylaws, and the measure might have failed on a tie vote, unless the Chair had voted in the affirmative. As it was, he could have defeated the measure by voting against it, creating a tie, but chose not to do so, suggesting to me that he did not oppose the move. So perhaps the measure would have passed with my vote against it anyway.)

# **Libertarians increase presence on campus**

The Rutgers Libertarians began the semester with plenty of ideas, but not too much action. This month, however, their efforts have begun to pay off, as multiple projects have materialized on campus.

The inaugural issue of the student group's monthly publication, "The Invisible Hand," was launched on Nov. 3. The newsletter offers articles from various group members demonstrating Libertarian viewpoints on topics ranging from third-party voting to same-sex marriage.

Coming only days before the last week's gubernatorial election, the issue also contains a feature on Jeffrey Pawlowski, the Libertarian Party candidate for governor who finished fourth, after Jon S. Corzine, Doug Forrester and Matt Thieke.

Additionally, the Rutgers Libertarians will be hosting tonight the first of what they hope to be a series of films documenting various aspects of their beliefs.

"Innocents Betrayed" - a documentary addressing the links between gun control and genocide - will be open to all students at 9:15 p.m. in Room 101 of Scott Hall on the College Avenue campus.

Darian Worden, chair of the Rutgers Libertarians, said the film was chosen because it focuses on the real dangers associated with what he called citizen disarmament, more commonly known as gun control.

"'Innocents Betrayed' is a well-made documentary based on thorough research," Worden said. "It shows the ugly history of citizen disarmament that is frequently ignored by the mainstream media and popular discussion."

Worden said disarmament laws preceded all major genocides in the 20th century.

"It doesn't dance around the central issue by engaging in debate about hunting and sporting 'rights' and the like," he said. "It cuts directly to the heart of the matter and is not afraid to deliver the hard-hitting truth about why disarmament laws must always be opposed."

## **Draft Minutes of the November 20, 2005 General Meeting**

Chair Ken Chazotte called the meeting to order at Tumulty's Pub, New Brunswick, at 1:22 pm.

The agenda was approved. The treasurer's report was received. The secretary presented the minutes of the November 1, 2005, Steering Committee meeting.

Chair report. The chair thanked our candidates for their efforts. He wants the party to focus on improving the infrastructure, membership recruitment and the 2006 elections.

Candidate recognition. The chair presented Certificates of Appreciation to the 2005 candidates present: James Conway, Bill Hunsicker and Ken Kaplan.

Libertarian National Committee update. Dan Karlan, LNC representative, reported on the latest meeting. He will forward his report to the newsletter editor. The 2006 LP Convention is planned for Jul. 1-3 in Portland, Oregon.

NJLP Convention. Jay Edgar has reserved the University Inn at Rutgers University for Saturday Feb. 25.

Bylaws. Of the proposed changes the membership approved two. Para. 4.a. Delete "or to the National Libertarian Party" from the second sentence. Add para. 2.e. to the Convention Rules: An NJLP Convention Rule may only be suspended by a 2/3 vote of the delegates, except Convention Rule 1., which shall not be suspended.

Newsletter. The hardcopy of the newsletter is not being delivered in a timely manner. The newsletter is, however, available on line. The hardcopy problem will be addressed under infrastructure.

County caucuses. A short recess was called for the purpose.

Project Full Slate. Resolved, (L. Flynn, Hull second) that the NJLP authorize the expenditure of up to \$300 for a fund raising appeal to support a full slate of Congressional candidates. The appeal will also call for support of local candidacies, which are essential to the long-term success of the NJLP. CARRIED.

Financial audit. Jay Edgar will call a meeting of the audit committee.

Outreach. Resolved, that Tony Federici be appointed Operation Politically Homeless coordinator. CARRIED. Tony volunteered to provide an OPH booth and literature.

Announcements.

Jay Edgar intends to seek the party's nomination to run in the 4th Congressional District.

## **N. J. Libertarian Party Steering Committee Draft Minutes of December 18, 2005 Meeting**

Chair Ken Chazotte called the meeting to order in Bill Hunsicker's apartment at 1:09 pm. Present in addition to Ken and Bill were Vice chair Jay Edgar, Secretary Emerson Ellett and At-large member Len Flynn. Absent: Treasurer Lou Stefanelli; and At large members Virginia Flynn, Robert Hull and Elizabeth Macron.

The agenda was approved.

The chair and vice chair reports are included in the agenda items that follow. The secretary had previously distributed the General Meeting minutes of Nov. 20 (no corrections noted), and the treasurer's report was distributed.

Convention report. Bradley Smith, a former chairman of the Federal Election Commission, has been confirmed as a speaker. His topic will be the theme of his book "Unfree Speech", which is critical of the FEC's restrictions on political speech. Jay reported that the band Poker Face and a representative from Bureaucrash have also agreed to participate. Jay is waiting to hear from the Free State Project.

Recruitment. Jay Edgar and David Mays are planning to hold an organizational meeting in Burlington County Jan. 18, 2006.

New committees. Ken will seek volunteers for committees to monitor state and federal issues.

Newsletter. Ken will contact Libertarian college clubs about printing the NJ Libertarian and other party materials.

Project Full Slate. Jay agreed to print the fund raising appeal. Len will issue a call for volunteers to assemble the mailing.

Financial audit. Bill Hunsicker and the chair will conduct the audit next month.

Infrastructure. The chair expressed a requirement for a monthly report on new and lapsed members by name; the dates new member packs were mailed and follow up was made; and the ability to email members. The secretary, who mails the new member and prospect packs, expressed a requirement for timely notification of new members and prospects who contact the NJLP directly or via National. The vice chair said he can provide the monthly reports requested by the chair. The chair and vice chair will investigate further and report their recommendations at the next Steering Committee meeting.

Announcements.

Bill Hunsicker, Mercer County chair, is working to find two other candidates to join him in running for Freeholder in 2006.

The meeting was adjourned at 3:06 pm.

## To the Editor

I appreciate getting the New Jersey Libertarian. We exchange publications (Ballot Access News).

I hope you publish my letter in your next issue: New Jersey is the only state that gives the Republican and Democratic Parties their own column headings on the November ballot, but which won't give it to all parties on the ballot. By "column headings", I mean the words "Republican" and "Democratic" in big letters.

Every other state that has a party column ballot format gives ALL the parties their own column headings, whether they are qualified parties or unqualified parties.

18 of New Jersey's 21 counties use column headings and party-column ballots. The only ones that don't are Salem, Sussex and Warren Counties.

Many states not only give ALL parties their own column heading, they give all parties (qualified and unqualified alike) an equal chance to get the left-most column.

It's time for the New Jersey Libertarian Party to agitate for ballots that treat all parties equally well. I telephoned each county clerk's office in New Jersey in November 2005 to get a sample ballot from each county. One of the friendly employees asked me why I wanted one. I said I was studying party columns. He said, "Oh, yes, the legitimate parties get a party column". This entirely innocent and good-natured, but serious remark, illustrates how the design of most New Jersey ballots sends a message to the voters...there are "legitimate" (Dem, Rep) and "not legitimate" parties (all the others).

I believe none of the affiliates in this region is one of the 5 largest, so the selection of the remaining 5 members of this committee is incidental.

Finally, the LNC removed the three members of the Program Committee for lack of performance. They were replaced by Sean Haugh, Bruce Dubner, and Dena Breudigam, the latter to act as Chair.

## Time to leave the United Nations

There are those in the press, many on the political left, in the so-called "middle," and some on the political right, I might add, that are of the belief that the United Nations is a force for good in the world. That it should be supported vigorously by the United States and other member nations.

I strongly and emphatically disagree.

The United Nations is a corrupt, ineffectual organization that has failed to provide peace; failed to support human rights; and has given its support to despotic and tyrannical regimes. It is also an organization that has enriched itself and its members at the expense of other's suffering, and is an organization that itself has committed atrocities on a massive scale.

Here are some examples of U.N. corruption and crimes:

Since 1991, the United Nations has passed 17 resolutions against Saddam Hussein's Iraq, and never enforced any one of them. It was only enforced when the United States and its allies took decisive action against Iraq and Saddam.

United Nations officials have taken kickbacks and bribes in the tens of billions of dollars from Saddam Hussein in the U.N. "oil for food" scandal. This program was designed to help out the Iraqi people, but they never got the aid intended. Instead, the money was pocketed by Hussein and others.

The U.N. Human Rights Commission has allowed nations like Cuba, Libya, Iran and other despotic regimes, to be members. What is even worse, these nations all have committed atrocities and crimes against their own respected people.

There are those who take the position that the U.N. can be reformed, that the organization can be made to change for the better. I oppose this pipe dream. I believe that the United States should pack up its bags and leave the United Nations.

No free nation should support a world body that caters to the worst of humanity, the worst of the world and to one that has no respect for human liberty, human freedom and free governments.

Our research so far indicates that 20,000 activists could heavily influence only states with under about a 1.5 million population, or which spend less than \$10 million on political campaigns in any given two-year election cycle. New Hampshire met the population criterion, and its distaste for big government and a generally welcoming attitude toward the Free State Project were pluses.
