Two Faces of Terrorism

Washington is often convulsed by events that have no impact on the rest of America. Not so the Oklahoma City bombing, which, in contrast to so many other actions, dominated nation and capital alike. And understandably so. It is impossible to adequately describe the horror of the terrorist attack, though many people have tried. The picture of bloodied children alone is enough to indelibly imprint upon our society the barbarity or terrorism, with its helpless, innocent victims.

Yet if it seemed like ruled and rulers could come together for one moment, it was only one brief moment. The reactions in and out of Washington were completely different. Around the Country was anger, desire for understanding, and hope for healing. In the halls of the White House and Congress was shock, followed by a race for political advantage and demand for more power. In short, everyone did what comes most naturally to them—citizens worried about their countrymen while politicians worried about their influence.

Consider first the attempt to brand critics of government as contributing to a "climate of hate" in which violence might occur. Needless to say, it is in the interest of presidents, legislators and bureaucrats alike to discourage criticism. And many have been quick to use the tragedy in Oklahoma City in an attempt to place themselves beyond reproach.

Disingenuous rhetoric will make it

hard to address the real causes of terrorism. Criticism of government does not occur in a vacuum. Forty percent of people, in a new Gallup Poll say they fear for "the rights and freedoms of ordinary citizens" at the hands of the federal government. And they do so for a reason.

The government alone has a legal monopoly on force. Only the government warrants constant suspicion and fear. Americans have seen this power exercised unjustly against citizens. The most prominent examples are the Branch Davidians in Waco and the Weaver family in Ruby Ridge, Idaho, although there are many others.

But there is also a deeper and overlooked aspect to the Oklahoma City bombing, a point that also applies to the recent World Trade Center bombing. Terrorism in the United States should not surprise us. Unfortunately, the U.S. has spent years creating and inflaming a multitude of grievances here and abroad, grievances that some misguided people believe can be resolved only through violence and murder.

For instance, the Oklahoma City bombing may have been a bizarre retaliation for the destruction of the Branch Davidian's compound in Waco two years before. Only a twisted mind could think that the terror bombing in Oklahoma City was just retribution for the deaths in Waco. But it is quite possible that the incredible abuse of government power in Waco was the motivating factor behind the bombing.

The World Trade Center bombing, too, was a predictable outgrowth of official U. S. policy. Persistent American intervention in the Middle East alone has been enough to turn the U. S. into an in-

tentional target of terrorism. Though murderously misdirected and morally wrong, the attacks are a natural response to Washington's determination to make everyone else's international conflicts it's own.

Consider the 1983 bombing of the Marine Corps barracks in Lebanon. The U. S. sent soldiers into the middle of a civil war, sided with one of the warring parties, and shelled Muslim villages as a show of strength. How, then, could anyone have been surprised when a suicide bomber reversed the direction of death, making ~241 young Marines pay the supreme price? The U.S. intervened in a distant conflict for no cause and terrorized peoples with whom it had no quarrel.

Especially dangerous today is the government's campaign to make an enemy of every living Muslim fundamentalist, wherever he or she resides in the world. There is no conceivable reason to intentionally antagonize Muslims who otherwise wouldn't even think about America. Yet Washington is speaking of alliances with obscure African nations in order to "contain" an ancient religion that has endured for centuries. Declaring a de facto war on Islam invites retaliation, and the most likely vic-

New Communications Decency Act is "High-tech Censorship"

—New Communications Decency Act is "High-tech censorship," charges Libertarians — The Libertarian Party harshly condemned the telecommunications reform bill passed by the U.S. Senate yesterday because it contained sweeping new censorship laws aimed at electronic bulletin boards, commercial on-line services, and the Internet. "The Communications Decency Act is a case of 20th century politicians using 19th century laws to control 21st century technology," charged Libertarian Party Chair Steve Dasbach. The censorship amendment, sponsored by J. James Exon (D-NE) and Dan Coats (R-IN), passed the Senate on June 14th by an 84-16 vote. It banned so-called "obscene" material from computer on-line services, with fines up to \$100,000 and prison terms of up to two years for violations. "Republicans and Democrats overwhelmingly lined up to support this high-tech censorship," said Dasbach. "It was bipartisanship at its worst. Apparently there's no gridlock in Washington when it comes to gutting the First Amendment." Dasbach said the Libertarian Party opposes the bill for numerous reasons. "This bill is censorship — an effort by politicians to restrict the freedom of the elec-

tronic press. As such, it is a clear violation of the First Amendment. Free speech is free speech, whether it is distributed via an 18th century printing press or a 20th century modem," he said, "This bill threatens to interrupt and curb the rapid evolution of electronic information systems — an area where America leads the world in innovation. It will have a chilling effect on these new technologies. A more certain way of guaranteeing permanent second-class status for American technological leadership is hard to imagine," said Dasbach. "This bill isn't needed. For example, the marketplace is rapidly moving to remedy any concerns parents might have about indecent material being available to children. Large commercial services like America On-line already offer parents a 'lockout' service to keep such material away from children. There are also commercial software products available, including the popular Surf Watcher, which monitor and limit on-line access. And, this week, three companies announced they are developing another software product to filter and block objectionable material from the Internet's World Wide Web," he said, "This bill usurps the role of parents. Senator Exon said he wants to protect children — but parents, not Justice Department bureaucrats, should determine what children see, hear, or down-

load. It's especially hypocritical for Republicans, who bemoan other government programs which weaken the family, to vote for paternalistic laws appointing Washington bureaucrats as the family censor," said Dasbach. The Libertarian Party, America's third-largest political party, was a member of an Internet coalition assembled to fight the Communications Decency Act, along with the American Civil Liberties Union, the American Council for the Arts, the Center For Democracy and Technology, the National Writers Union, and People for the American Way. On the topic of censorship, the Libertarian Party Platform states: "We oppose any abridgment of the freedom of speech through government censorship, regulation or control of communications media, including laws concerning electronic bulletin boards, communications networks, and other interactive electronic media. We hold them to be the functional equivalent of speaking halls and printing presses in the age of electronic communications, and as such deserving of full freedom."

Recover Illegal Expenditures by Government From the Desk of John Paff

If your town council or school board illegally spends money, is there any way you can force them to pay it back? Before the turn of the century "a taxpayer had no standing to prosecute a claim or demand at law on behalf of a municipality" according to *Ippolito v. Mayor of Hoboken*, 60 N.J. Super 477, 484- 489 (A.D. 1960).

However, in 1903 and 1908, the state legislature enacted two laws, currently known as N.J.S. 2A:15-18 and N.J.S. 2A:49 which permit taxpayers, under certain circumstances, to maintain a cause of action on the behalf of a municipality or to recover money or property improperly paid by a school district or municipality. The two statutes are set forth below. Note that under the latter statute, the plaintiffs' legal fees are to be disbursed out of any recovery gained.

N.J.S. 2A:15-18 reads:

If the board of chosen freeholders of a county or the governing body of a municipality fails to prosecute a claim or demand of the county or municipality, any court in which an action on such claim or demand is cognizable may, upon terms, allow a taxpayer and resident of the county or municipality to commence and prosecute an action upon the claim or demand in the name and on behalf of the county or municipality, if in the opinion of the court the interests of the county or municipality would be promoted thereby.

N.J.S 2A:49 reads:

2A:49-1. Action for recovery; jurisdiction; bond for costs. If moneys, funds or other property held or owned by any municipality or school district, or held or owned officially or otherwise for or on behalf thereof, have been or shall be, without right, obtained, received, paid,

converted or disposed of, action for the recovery thereof or to recover damages or other compensation for such wrongful obtaining, receiving, paying, conversion or disposition, or both, may be maintained in any court of competent jurisdiction thereof, by 10 freeholders of such municipality or district who have paid taxes on real estate in such municipality or school district, within 1 year, in the name of and for and on behalf of such municipality or school district. Before any such action shall be maintained, such freeholders shall file with the clerk of such municipality or school district, a bond to the municipality or school district conditioned for the payment of the costs, if any, assessed against such municipality or school district, in said action, approved as to form and amount by a judge of the court in which such action is brought.

2A:49-2. Limitation of action. No action under this chapter shall lie unless the cause thereof shall have accrued within 6 years before its commencement.

2A:49-3. Disposition of recovery. Out of any recovery had in an action under this chapter, the expenses incurred in the action by the freeholders, including payments made or to be made for legal services in an amount to be approved by the court, shall be first deducted and the balance thereupon be paid into the treasury of the municipality or school district in whose behalf the action is brought.

LIBERTARIAN CHAIRMAN RESIGNS FROM NEA — LABELS POLICIES “TEACHING-DISABLED”

WASHINGTON, DC — Twenty-year veteran teacher and National Chairman of the Libertarian Party Steve Dasbach today announced his resignation from the National Education Association and its Indiana affiliate, effective immediately.

In his letter of resignation to NEA President Keith Geiger, Dasbach accused both organizations of putting the pursuit of political power ahead of the interests of students, parents, and teachers.

“It has become overwhelmingly clear to me that the NEA is not concerned with pursuing educational excellence,” Dasbach said. “Instead, your primary objective appears to be building up your own political power-base by centralizing control over education at the state and national level.” He cited NEA support of Federal mandates, funding, and the Department of Education as examples.

“Since the Department of Education was created as a political payoff to the NEA, we have seen test scores plunge and a rising tide of mediocrity envelop our schools,” Dasbach said. “The Federal mandates and funding you think so highly of are causing ever-increasing numbers of students to be labeled learning-disabled, providing a ready-made excuse for failure. Instead of labeling kids learning-disabled, we should consider labeling your education policies teaching-disabled.”

Dasbach directed his harshest criticism at the NEA's campaign for a National Standards Board, its support for Goals 2000, and its relentless opposition to school choice. “The National Standards Board and Goals 2000, if fully implemented, will centralize control

over teacher certification and curriculum to a unprecedented degree,” Dasbach said. “As the 48 states that have approved Goals 2000 begin to implement them, textbook publishers will have no choice but to conform. Based on the increasingly discredited Outcomes Based Education (OBE), Goals 2000 will lead to further dumbing down of American education.”

“It is clear to me that the problems we face in education today are a direct result of the government's effective monopoly in education,” Dasbach charged. “Lack of competition and choice has produced a system that is stagnant, bureaucratic, and inefficient, producing less education at higher cost every year.”

“However, the NEA is fighting tooth-and-nail to block any experimentation with school choice,” said Dasbach. “You have even tried to prevent parents from home-schooling their own children. You appear to be concerned about maintaining a centralized system where you can exert political pressure, instead of allowing kids to obtain a quality education.”

Dasbach pledged to continue to support the efforts of the local teachers association to improve local education, but plans to work to get the federal government out of education entirely.

“I am convinced that the salvation of American education lies in establishing a true free market in education,” Dasbach said. “Real choice and real competition can bring the same excellence and innovation to education that we see in the private sector of our economy.”

Dasbach, 42, has been an active member of the Whitko Classroom Teachers Association, affiliated with the NEA and its Indiana affiliate, ISTA, for 20 years. He served two terms as local association president, and helped negotiate eight contracts, including three stints as spokesperson of the negotiation team.

March 31, 1995 Federal government's \$1.6 million “boondoggle for blabbermouths.”

WASH., DC — The federal government doesn't think Americans talk enough. So the National Endowment for the Humanities (NEH) gave away \$1.6 million of taxpayer's money yesterday as part of a new program to encourage a “National Conversation.”

“Only in America!” marveled Libertarian Party spokesman Bill Winter. “would the government pay people \$1.6 million to talk more. I mean, this is the nation of Rush Limbaugh, New York cab drivers, and Bill Clinton's State of the Union speeches! Insufficient chatter is not generally perceived to be one of America's most pressing problems.”

The National Conversation program is designed to get “Americans to think and talk about themselves” and stimulate discussion “about what the American people are as a nation.” The money was distributed in grants around the country to “creative people,” communities, and civic groups.

NEH spokesman Gary Krull said the \$1.6 million will be spent on “guidelines, moderators, and meeting rooms” for the National Conversation. “I'm not a government bureaucrat, so maybe I'm missing something, but Americans seem to have no problem finding places to chat — on talk radio, in coffee shops, on the street, and on the telephone,” said Winter. “And we seem to manage our conversations quite nicely, thank you, without federally subsidized moderators and guidelines.”

“Americans used to believe in free speech. Now NEH bureaucrats believe in expensive speech — expensive, tax-subsidized speech. Here's the Libertarian Party's two cents worth: Abolish this preposterous program. End this boondoggle for blabbermouths,” said Winter.

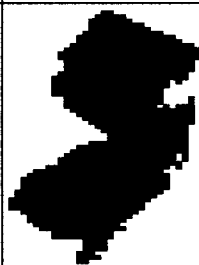
