## Platform Committee Seeks Input from Membership

On September 23, 2005, the NJLP Platform Committee held the next in a series of meetings to update and re-write the NJLP Platform. Tony Federici graciously hosted the committee at his home. (note: brown bottle next to Dan contains Root Beer, not real beer).

The NJLP Platform Committee has been making progress on reformatting our Platform in a manner parallel to the National Platform. We have, however, reached one slight difficulty, and we would like your help solving it in the best way possible. The reformatting involves dividing each plank into "Issue," "Principle," "Solution," and "Transition." For most of the planks, this does not present any serious difficulties. But several of the planks treat of such a fundamental, indivisible aspect of rights that we are unable to come up with a meaningful "Transition" statement.

Our choices are: leave "Transition" out of those planks, which can easily be interpreted as meaning we forgot to tackle this and left it out to mask that difficulty; we can include the word "Transition" but with no text following it, which can, again, easily be misinterpreted to mean we forgot to deal with this subject; or include some 'explanatory' text following the word "Transition," such as "We were unable to develop any transition proposal for this plank because there is no legitimate meaning to the term 'intermediary' between the current situation and the ideal represented by the 'Principle' and 'Solution' above."

This explanatory text might be appropriate, for example, in the plank dealing with I.6 Freedom of Religion. The example text could easily be considered too wordy and lengthy, however.

Now that you, the members of the NJLP, appreciate the difficulty we on the Platform Committee have faced, perhaps you can help us. If you have a fourth choice to offer for our consideration, or alternate text for use with choice three, please let us know. ### Town changes access policy amid opposition Citizens group objects to new Old Bridge law on release of minutes

OLD BRIDGE The township's policies regarding the release of closed-session meeting minutes has caused heated discussion both in and out of council chambers.

But according to Township Attorney Jerome Convery, an amendment to the township's public access ordinance, approved Monday night, was a necessity.

Under the existing law, he said, the township clerk could not even allow him, Business Administrator Michael Jacobs or Mayor Jim Phillips to look at minutes from closed, or executive, sessions for which those officials would not be able to look at the minutes from negotiations or lawsuit discussions without this amendment.

"It actually opens this up more to allow the mayor, the business administrator and the township attorney to review the executive session minutes," Convery said during Monday night's council meeting.

This, he said, is for the protection of the township. During negotiations, he said, tactics used by the town should not have to be revealed until negotiations are resolved and thus, officials should be able to view them before they become public documents for anyone to see.

Once minutes are given to the township attorney or another official, they can be reviewed and be redacted, or struck, in order to be kept unavailable to the public.

"The concept of the automatic release of minutes doesn't make sense, because no one is looking them over [prior to their release]," Convery told the Suburban. "There has to be a process."

Generally, he noted, at the end of five years or when a matter discussed in executive session is resolved, minutes are released as a matter of course.

A few years ago, Convery said, executive session minutes became verbatim by request of the Township Council. But under state law, such minutes are not required to be word-for-word, and this amendment means the minutes will no longer have to be recorded that way.

But, he noted, there is a provision within the ordinance that allows for a council member to give a 100-word statement to be included in the minutes.

"I believe, in reality, what this [amendment] does is two things," Ward 4 Councilman G. Kevin Calogera said during the meeting. "It does what Mr. Convery said, and it does what he didn't say."

Calogera said he believes information will be lost under the new practice.

"I have no problem with what I say in closed session, and I have no problem if that does get published," Calogera said.

The councilman acknowledged he still does not want strategies released to the public, but he would prefer that that information be removed through redacting.

Phillips said he felt that when a matter was concluded, the executive session minutes should be released. But, he said, without an attorney or some other arbiter going through the minutes, there would be no way to determine that the minutes were ready for release.

Council Vice President Patrick Gillespie said the council should not be put into the position of having to share minutes containing information on contract negotiations, since that could wind up costing taxpayers money.

"The ordinance that we're voting on now is less restrictive than the current ordinance we have now," he said.

Ward 6 Councilwoman Lucille Panos asked that a provision be included in the amendment to provide for a yearly review of executive session minutes by the township clerk or some other official. She asked that the issue be tabled until the matter could be discussed with Township Clerk Rose-Marie Saracino.

The motion to table failed, however, and the council approved the amendment in a vote of 7-2, with dissenting votes coming from Calogera and Panos.

"I still think the council has to vote to release them, because otherwise there's no control," Convery said.

Opposition to the amendment has also come from the Open Government Task Force of the Libertarian Party of Central New Jersey (LPCNJ), headed by John Paff.

In a letter to Middlesex County Prosecutor Bruce J. Kaplan, Paff states that the task force is "concerned that the ... proposed ordinance ... is partially invalid and unenforceable."

"The council is obligated, under state law, to make the nonexempt portions of its closed session promptly available to the public," Paff says in the letter.

The Prosecutor's Office responded to Paff, saying it would be inappropriate for the office to render an opinion regarding a proposed municipal ordinance.

Under the new amendment, the council must vote to release executive session minutes to anyone other than council members, Phillips, Convery or Jacobs.

Paff told the Suburban that the amendment allows Old Bridge to extend the length of time before the minutes are released.

"I don't believe the municipality has the authority to do that," he said. "I'm just disappointed that Old Bridge did that."

In July, Paff filed an Open Public Meetings Act (OPRA) request asking the township for the release of two sets of executive session minutes. The task force, he said in July, does this periodically to check on the operations and instances of noncompliance with public access laws.

## Minutes of the Steering Committee Meeting of September 25, 2005

Chair Ken Chazotte called the meeting to order in the Stefanelli-Macron residence, at 1:15 pm.

Present in addition to Chazotte were Jay Edgar, Emerson Ellett, Lou Stefanelli; and At-large members Virginia Flynn, Bill Hunsicker, Elizabeth Macron, Robert Hull and Len Flynn. Absent: none. Peggy Hunsicker was also present.

The chair and vice chair have focused their efforts on the Pawlowski gubernatorial campaign over the past month. The secretary's and treasurer's reports were received.

Assembly candidates. Bill Hunsicker reported that he and Jason Scheurer, 15<sup>th</sup> District, have opened a joint campaign account, and are considering a billboard on Route 1. Bill is the chairman of the joint campaign committee. Jason is treasurer and has received the required training from ELEC. Jason has recorded a spot on Comcast and is scheduled to speak at a League of Women Voters' forum. -- Hunsicker having recused himself and gone outside, Stefanelli moved (Chazotte seconded) that the Steering Committee commends the Scheurer-Hunsicker campaign for its initiative and therefore resolves to grant \$500 from the State Fund to support their campaign. CARRIED.

Bylaws. Resolved, that the Steering Committee authorize the release of proposed bylaws changes for publication in the newsletter. CARRIED, with two Bylaws Committee members voting against, and the Bylaws chair abstaining.

Platform. The Platform Committee has changed 70% of the NJLP platform into the Problem-Issue-Transition format of the national platform. The next committee meeting is October 16.

County organizing. The chair volunteered to organize unorganized counties. To test the concept there will be a meet-the-candidate social in Monmouth County October 11. Everyone from Monmouth County who has contacted the national party in the last year will be invited.

Financial audit. Will be addressed after the November election.

Project Full Slate. Len Flynn will circulate a draft fund raising letter to the State Board. The letter will support all 13 Congressional candidates in 2006.

Zero-based dues. Effective January 1, 2006 the national LP will implement the new zero-based dues policy. The Newsletter Editor will be asked to include in the Newsletter a notice stating "If you intend to subscribe to the national LP News, remember to subscribe through the NJLP because by doing so you will benefit the NJLP at no cost to you. Make your \$25 LP News subscription payable to NJLP and mail to NJLP, P.O. Box 558, Brielle, NJ 08730."

2006 Convention. Jay Edgar will reserve the University Inn on the Cook College campus, Rutgers University. Bill Hunsicker moved (Chazotte seconded) that the convention registration form include a statement that the Business session is free to members, and that in order to vote one must have been a member by (insert date in accordance with Business Rule 1). CARRIED. -- It was further moved (by Hull, Macron seconded) that the NJLP form a convention credentials committee. CARRIED. Bill and Peggy Hunsicker and Bob Hull volunteered for the credentials committee -- It was also moved (by Hull, Len Flynn seconded) that any member who seeks the position of chair, vice chair, secretary or treasurer shall receive a page in the newsletter subject to editorial review. CARRIED.

Announcements. Four College of NJ students have contacted the Pawlowski campaign about organizing a Libertarian Club. The chair will follow up.

## Bylaws Committee Submits new Proposals

The Bylaws Committee has several Bylaws proposals to submit.

1. At the July General Meeting Bylaws Proposal 6 was referred back to the Committee for rewording. The Proposal was to change the way Business Rules are adopted or disposed of. The revised wording follows:

An addition to Bylaws 14: Amendments, as

**e. A Standing Business Rule may be enacted, amended, rescinded or suspended only by a majority vote at a General Meeting.**

And deleting the contents completely of Business Rules 14: Amendments.

2. Purpose: to deal with troublesome members.

Proposed: Add new section; 4. e. Membership Termination,

**Membership in the NJLP may be terminated by a majority vote at any State Board or Steering Committee meeting and a concurring 2/3 vote at the immediately following General Meeting, provided notice of the proposed Membership Termination is furnished with the meeting notice. Notice of the Membership Termination action and the outcome of the Membership Termination action shall be given to the affected member by Regular and Certified US Mail. Anyone whose membership has been terminated by the NJLP shall receive a prorated refund of any current paid dues upon request to the Treasurer.**

This provision would permit the NJLP to terminate the membership of those deemed deserving. Currently NJLP Membership is available to anyone who makes a certification and pays the required dues.

3. Purpose: to address the possible new National Party dues structure.

Proposed: Amend 4. a. to; **Membership is open to anyone who lives or works in the state of New Jersey who certifies in writing that he or she opposes the initiation of force as a means of achieving political or social goals. Thereafter, such a person shall become a member upon payment of dues, if required, to the NJLP. Anyone whose membership has been terminated by the NJLP is not eligible for membership.**

This amendment would insert the words, "if required" into the second sentence, addressing a possible new dues scenario. It would also delete "or to the National Libertarian Party" from the same sentence. This

would have the effect of removing National Party(Budget) members as members of the NJLP. The National Party has created an interesting situation by reducing their dues to zero. By doing this all past expired National members \*could\* become Budget members under our current bylaws. Since Budget members receive four newsletters per year, this would create a financial burden which would be unacceptable. This amendment would also create a new sentence, "Anyone whose membership has been terminated by the NJLP is not eligible for membership." which would bring the section on "Membership" into harmony with Proposal 2, if it passes.

Proposed amend Business Rule 8. b. **Newsletter Editor.**

**The newsletter shall not publish personal attacks. (12/12/81)**

**The Roster of State Representatives and County chairs shall be published in the newsletter four times per year. (03/28/92)**

This amendment would remove the third sentence which reads, "Budget members will receive their 4 newsletter issues in January, March, June, and October. (04/25/92)". This would bring section 8 of the Business Rules into harmony with the Bylaws if proposal 3 is approved.

4. Purpose: To prevent hostile takeover of the convention and the NJLP.

Amending Standing Convention Rules:

Proposed Add new 2. e. **Suspension of Convention Rules**  
**The NJLP Convention Rules may only be suspended by a 3/4 vote of the delegates.**

Proposed amend 3. a. **Qualification for election and service: NJLP members only; and no candidate for a NJLP Officer position shall be nominated unless a Statement of Intent to seek such office has been filed by the first day of the third month preceding the month when the Convention is held. The Secretary shall receive such Statement of Intent or any other officer if the Secretary is unavailable. The Statement of Intent may be made as an announcement at the General Meeting preceding the Convention.**

2. e. would raise the affirmative vote requirement to  $\frac{3}{4}$  in order to suspend the rules.

Amending 3. a. would introduce a new requirement for candidates seeking party office. Candidates would need to announce their intended candidacy in order to be nominated at the convention. This provision would make it easier for the delegates to make an informed decision as to the election of party officers.
