A Perot for President campaign operative recently announced he was joining the NJLP following the announcement that Perot was no longer a candidate.

Herb Rosselle, the Cumberland County co-chairman of the *Ross Perot for President Petition Committee*, was courted by Salem County activist *Doug Stoxen* who was also responsible for bringing Democratic Councilman *Rick Cowles* into the Libertarian fold.

The Cumberland County members of the NJLP met in convention following Rosselle's switch of allegiance and promptly elected him chairman of the new county party. Also elected to serve was

George Barber who will serve as the local group's treasurer.

Mr. Rosselle will be submitting his motion for recognition to the Steering Committee and the next general membership meeting through NJLP Secretary *Emerson Ellett* prior to the leadership's next meeting.

FIJA Defies Prosecutor's Jail Threat

Snubbing the directive of the Morris County prosecutor who threatened FIJA Coordinator and NJLP Chair Mike Pierone with imprisonment if he should attempt to educate jurors on all their rights, the Fully Informed Jury Association distributed leaflets to prospective jurors along with a proclamation by the Governor declaring September 5 "Jury Rights Day."

Noting that September 5 marked the 322nd

anniversary of the trial of William Penn, when the jury refused to convict him for preaching what was then an illegal religion

WHEREAS, September 5, 1992 marks the 322nd anniversary of the day when jurors in the William Penn trial refused to convict him for preaching what was then an illegal religion (Quakerism) to which men that an unlawful assembly like congregation, gathered on a London street after being locked out of their churches; and

WHEREAS, the First Jury, in refusing to convict, provided a basis for the U.S. Constitution's First Amendment rights of freedom of speech, religion, and assembly; and

WHEREAS, September 5 also commemorates the day when four of these jurors signed nine words of transgression for finding Penn innocent, after which their refusal and conviction forever established in Anglo-American legal tradition that it is the right and responsibility of the trial jury to decide both on matters of law and of fact in the case before it; and

WHEREAS, the Sixth and Seventh Amendments are included in the Bill of Rights to preserve the right of trial by jury, which in turn ensure upon the jury the responsibility to defend all other individual rights named in or implied by the U.S. Constitution and its amendments, along with all the rights which attend that responsibility;

WHEREAS, the State of New Jersey recognizes these rights as true and inalienable;

NOW, THEREFORE, I, JIM FLORIO, Governor of the State of New Jersey, do hereby proclaim

SEPTEMBER 5, 1992

GIVEN, under my hand and the Great Seal of the State of New Jersey, this seventh day of August in the year of Our Lord one thousand nine hundred and ninety-two and of the Independence of the United States, the two hundred and twentieth.

Technology Remakes Media

The advent of the ubiquitous FAX machine; the wide availability of cable television; and the use of video cameras, VCRs, and more, has changed the way the media covers "news."

For example, just try to find an "evening" newspaper anymore. Or look at the growth in popularity of such voyeuristic TV shows such as "I Witness TV" which relies upon viewers sending in their tragedy of the week. Even as the networks lose their audience, cable picks them up. As ABC, CBS and NBC cutback their news bureaus, CNN runs 'round-the-clock news.

The fallout from this shake up is that if you want to be covered, you've got to move with the times. You've got to make yourself "newsworthy."

For Libertarians, it means we have to work doubly hard. It was never easy to get covered before, now we must compete for a smaller piece of the pie. Yet it is also a great opportunity. By and large (and incorrectly), Libertarian ideas are seen a "new" ideas. Thus, their presentation in the proper forum will ensure that they get covered.

First, give it a "local angle." Newspapers, TV, even radio stations are more apt to cover a story if it will somehow impact upon their audience. Even better is to have an individual who will benefit or be harmed by an action give the account rather than a "third person."

Second, make sure the media knows your event is

going to happen. No longer should we rely upon the US mail to get our releases into the reporters hands, the FAX is our best friend, to be followed up with a personal phone call to ensure that the person you sent it to actually got it.

In connection with that is to have an up-to-date list. Nothing relegates a release to the trash heap as routing it to someone who is no longer working at the media outlet, or is dead. A simple phone call will get you the exact name of the person you want. And forget the news director. You want the reporter, assignment editor or segment producer.

Included in your media list should be AP, UPI, and the other wire services. They may not pick up your story, but if they do, it goes out nationwide.

Last, understand the deadlines the various media are working with. Going to a newspaper just as they are dealing with the deadline for the next edition and even the mail boy won't pay any attention to you. Again, a simple phone call is all that's necessary to find out when is the best time to send them information. They won't object to the question, and may even appreciate it.

We are selling a product and we must meet the "market's" demands. Using a few, simple guidelines can do wonders for getting the story before the viewers, readers and listeners.

FEAR Has Resolution Introduced in Assembly

Continuing their campaign to increase the public's awareness over the outrages of forfeiture and inject a bit a sanity into the law, FEAR has succeeded in getting a resolution introduced in the New Jersey General Assembly memorializing Congress to amend the federal forfeiture statutes.

"BE IT RESOLVED by the General Assembly of the State of New Jersey," declares the resolution, **"This House memorializes the United States Congress to amend the federal forfeiture law...to provide for proportionality analysis in all federal forfeiture cases to determine whether a proposed forfeiture is disproportionate to the conduct giving rise to that forfeiture."**

Assembly Concurrent Resolution 92 (ACR.92) was introduced by Assemblymen Kavanaugh and Penn (both, R-16) at the urging of FEAR Chairman John Paff.

The resolution highlights the "grossly disproportionate" nature of some of forfeiture's worst

cases, and relying upon the Eighth Circuit Court of Appeal's recent decision which asks for Congress to re-examine federal forfeiture statutes (see story in *August, 1992* issue of *The NJ Libertarian*), it calls upon Congress to do just that.

Liberty on the Tube in Salem County

Salem County cable television viewers were treated to six hours of libertarianism over three days in September, Salem County LP vice chair Doug Stoxen reported.

Through the negotiating efforts of county chairman *Dr. Geoffrey Ellington*, the Advocates for Self-Government video series, *"Self-Government: An Idea Whose Time has come Again"* was broadcast over Tri-County Cable's airwaves on

September 8 and 13. The third date, which has yet to be announced, will be some time in late September or early October and will be offered to Salem area schools which have access to the cable system for educational purposes.

Libertarians Draw Tough Ballot Spot in Union

Candidates of the Libertarian Party drew ballot positions in Union County that will make it somewhat more difficult for voters to find them.

On the presidential line, *Andre Marrou* and *Nancy Lord* will be listed on the seventh spot--below Lyndon LaRouche and the Socialist Workers Party. However, their ballot line does put them above non-candidate Ross Perot who will find only Bo Gritz of the Populist Party below him.

Congressional candidates fared little better. Union County has been carved up in three separate districts, the 7th, 10th and 13th, with the LP's best placement coming in the 10th district where NJLPer *Roberto Caraballo* of Newark will be fourth--but only because there are four candidates.

In the 7th, LP candidate *Spencer Layman* will be listed seventh out of seven while *Len Flynn* will be listed fifth out of seven in the 13th.

Many counties do attempt to group candidates from the same party together in a line and where the LP's candidates finally end up still remains to be seen. All too often,

though, "minor party" candidates are simply lumped together on one line.

Candidates can improve their chances for garnering more votes by listing their exact position on the ballot on all their campaign materials. For example, "Joe Smith for Congress" should also include "Line H, Row 7" to help voters who want to support them find them on the ballot. The county election division can advise candidates of where they will appear.

FEAR Pickets Legislator Over Forfeiture Laws

Chanting "*Article 1, Paragraph 9, Trial By Jury Shall Not Be Denied!*" a group of 15 people protested the state's forfeiture laws in front of the legislative office of Assm. Thomas Smith (R-11) in Asbury Park. Led by FEAR Chairman *John Paff*, the group picketed Smith's office because he represents Neptune Twp. where a doctor had all of his office furniture, records, and more confiscated because he was charged with practicing psychiatry without a license.

Dr. *David J. Disbrow*, an honors student from Iowa, was an honors physician-in-training at Mimonides Medical Center in Brooklyn who scored in the top 10 percent of those who took a skills exam for doctors called the National Prite exam.

He moved to Neptune Twp. earlier this year with his parents and to earn the money for a state physician's license, set up a counselling office in the home. Prior to doing so, Disbrow called the Monmouth County Mental Health Director who assured him he did not need a license just to talk to people. As long as he did not prescribe medicine, he was free to counsel.

Just to safeguard himself, Disbrow spoke with his residency director in New York, Dr. Marvin Lipkowitz, who agreed that no license was needed.

However, on April 9, 1992, the Monmouth County prosecutor's office raided Disbrow's parent's house and confiscated everything therein.

"Not only did they take the desk and chairs that I used when I coun-

selled," wrote Disbrow to FEAR, "but they also took many other items that weren't even remotely connected to the crime they charged: household furniture, beds, a coffee maker, carpets, paintings, diplomas, antiques, personal photographs, and even my antique fountain pen collection. All together, they took about \$60,000 worth of items."

"Had the authors of the constitution intended forfeiture cases to be heard without a jury," noted a brochure distributed at the rally, "they would have specifically excepted forfeiture cases from the general rule."

The "general rule" is Article 1, Paragraph 9 of the New Jersey State Constitution which guarantees a trial by jury, except for the mentally incompetent.

Assm. Smith was targeted because he is sworn to uphold the constitution and to date he has been ignorant of what is occurring in his district. FEAR had four questions for him:

"Do you agree that the right to a trial by jury...is being denied to your constituent Dr. David Disbrow, and to others similarly situated?"

"If so, what do you plan to do about it?"

"Do you believe that the police ought to have the power to seize property based on nothing more than an accusation?"

"If not, what do you plan on doing about it?"

Leona Protest Set For September 27

The rally in protest of the sentence meted out to hotel billionaire Leona Helmsley has been confirmed, announced NJLP Chair *Michael Pierone*.

The event will take place on Sunday, September 27 in front of the United States Federal Court House located at Foley Square, 40 Center Street, in New York City. The rally will begin at 2:00 p.m.

Leona Helmsley had been imprisoned for allegedly evading income taxes of about \$1 million--even though she personally paid more than \$200

million in taxes! These specious charges amounted to little more than a high-profiled inquisition to deter others from trying to hang onto as much of their hard-earned money as possible.

Leona was curiously sent to jail on April 15 of this year. Mike had noted in a letter to the editor published in the *Star-Ledger* that the amount of taxes Mrs. Helmsley had paid was actually more than Thomas Jefferson's entire federal budget.

Tracking some 130 investment newsletters, publishing one's own, and writing a column for *Forbes* magazine allows an individual to appreciate the vagaries, nuances and ultimate superiority of the marketplace. It has certainly worked for Mark Hulbert, arguably one of the more influential voices in investment services today.

Hulbert, 36, publishes the *Hulbert Financial Digest* from his offices sequestered in Alexandria, VA, where he monitors the investment advice of an assortment of quacks, charlatans and astute

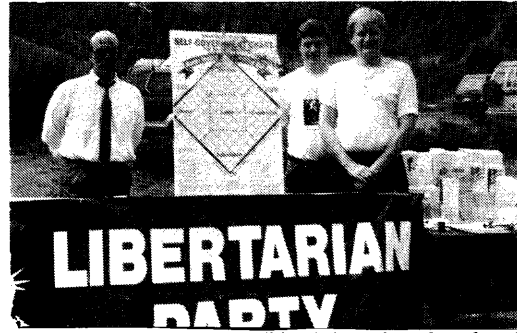
students of "The Street."

According to the September 14, 1992, issue of *Forbes*, Hulbert, a Quaker pacifist with an education from Haverford and Oxford universities, toyed with the philosophy of Hegel and Marx whose books still burden his shelves. However, Hulbert today considers himself to be--a libertarian!

To that end, Hulbert is working hard to divorce various Quaker groups from the left wing liberalism of the Democratic party. "Many of the original Quakers were successful businessmen," Hulbert is quoted as

saying, and he wants to return this religious organization to its roots of respect for private property and appreciation for the marketplace.

It is also interesting to note that the same issue of *Forbes* also carried a column regarding the resurgence in popularity of Ayn Rand's *Atlas Shrugged*, a condition suggested brought about by these difficult economic times.
