



Dem. Councilman Jumps to NJLP

For the first time in more than 8 years, New Jersey once again has a Libertarian in office.

Rick Cowles, a two-term councilman from the borough of Penns Grove, disowned his Democratic ties and joined the New Jersey Libertarian Party, making him the state's only Libertarian in office.

Not since **Dick Siano** was elected to the Kingwood Twp. Committee has the NJLP had an elected officeholder. Siano had the distinction of being the first Libertarian to be

elected to office in the "lower 48."

In a year in which the NJLP is making strides in expanding its membership (up 26 percent over last year) and reaching out to minority community representatives (former Paterson school principal Joe Clark is interested in joining the NJLP), the switch from the Democratic to Libertarian Party by Councilman Cowles is a big boost for our continued growth.

Courted by Salem County representative

Doug Stoxen, who had given Cowles copies of Bastiat's *"The Law,"* Robert Ringer's *"Restoring the American Dream,"* and other literature; Cowles proclaimed that he was ready to join the NJLP.

As of press time, Cowles had alerted the media to his change of allegiance and was planning to hold a press conference to make the formal announcement.

The New Jersey Libertarian will provide full details in next month's issue.

FEAR Pursues Legislative Action

In an important first step towards changing New Jersey's laws on forfeiture, FEAR Chairman **John Paff** reports he has won two major commitments from Assm. Walter Kavanaugh (R-16).

At the request of Forfeiture Endangers American Rights (FEAR), Assembly Bill 1536 was introduced into the legislature by Assms. John Penn (R-16) and E. Scott Garrett (R-25) to amend the state's forfeiture statutes. However, between the time FEAR representatives conferred with the legislators and the time of its introduction, several important changes were made to the bill so as to water it down.

Paff now reports that Kavanaugh and Penn have recommended two changes be made to A.1536: that

four "offensive" words be struck from the bill and that "proportionality" language be introduced.

In the first change, the bill currently would allow forfeiture proceedings to continue "if conduct con-

Chairman's Column

In a recent article, conservative syndicated columnist George Will took the Libertarian Party to task for being "frivolous" and "irrelevant." Rather than fire off an angry missive as many Libertarians surely did, and many more probably felt like doing, I chose to try an alternative track: reason.

Dear George:

Having read your piece entitled, "Libertarian extremes make a frivolous party irrelevant," I felt compelled to write you. I could see from your article that the bottom line was a genuine regret that those who speak for liberty do so in such an ineffective and easily ignored manner. Alas, I can't help but agree with you there.

I do believe the freedom philosophy as expressed by such men as Leonard Read, F.A. Hayek, Ludwig von Mises and others, is the only real chance that America and the world has to reverse socialism, which by now is so pervasive that Republicans and Democrats alike accept basic tenets of it without question.

I do not believe that the Republican party will turn out to be the party of freedom in the long run, but there are many organizations working for liberty and it is difficult to say which will eventually win the war of ideas. But I think the conservative movement is still too bogged down in such outdated ideas as trade protectionism, a failed drug policy, the effort to impose morality through law, and a variety of efforts to regulate behavior which is essentially peaceful, though admittedly distasteful to most.

The major parties have been able to successfully market their ideas even when their ideas were patently false and ineffective, while the Libertarian

party has been unable to market ideas that have stood the test of time for their effectiveness and their adherence to principle. This is primarily because much of the Libertarian party is composed of "egghead" professor types who compulsively apply the freedom philosophy to everything from local police and roads to national defense.

I do not disavow that privatizing roads would more effectively provide for transportation, but I recognize that on a list of the 1000 most important changes necessary for liberty in our times, it doesn't even make the list. I personally don't care to waste anyone's time arguing the merits of such things when there are truly important issues that have to be faced. But I submit to you that neither the Democrats nor the Republicans are facing the important issues, while the Libertarians' great drawback is that they compulsively face every issue.

What is desperately needed is for some defections from the major parties of people who understand and agree with the freedom philosophy, and who KNOW HOW TO MARKET IT!

The good news is that the Libertarian party is still so relatively small, that those of us who are committed to changing it into a relevant and non-frivolous party are having little trouble outnumber-

An End to NJN?

If state Republican legislators have their way, and it seems likely they will, New Jersey taxpayers will no longer have to foot the bill for news coverage in the state.

Under a proposal that will likely be approved by the GOP-dominated Senate and Assembly, New Jersey Network (NJN), which receives taxpayer subsidies through the state Public Broadcasting Authority, will be sold to WNET-TV in New York.

As expected, the usual lineup of opponents is castigating and lamenting the sale, claiming coverage

of "New Jersey news" will diminish if the sale is completed, despite WNET's promise to continue covering local events.

At the General Membership meeting held on July 3, Libertarians were exhorted to contact their local politicians and urge their support for the sale.

It was noted that NJN's news reporting was biased, particularly as it related to election return results where Democratic plus Republican votes always equal 100%, regardless of third party showing.

tyrant countries, the continued growth and power of the United Nations, government trains and buses.

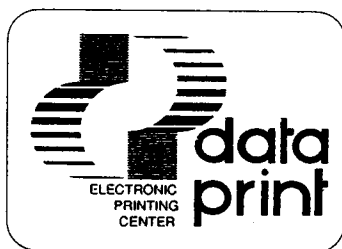
- Burdensome property taxes that reduce our status of ownership to tenancy to help pay for socialistic programs by Big Brother who controls us from cradle to grave.

Membership Up 26%!

Recruiting efforts by Libertarians continues to pay big dividends, according to NJLP Treasurer *Lou Stefanelli*.

Membership in the state party is up 26 percent over a year ago! In addition to beefing up our treasury, it also beefs up the party's political muscle.

As has been evident over the past six months, activity by NJLP members has increased. But more importantly, much of this action has been undertaken by relatively new members.

This is important for the growth and survival of the party and the movement. As long-time members settle in to a supporting role, new members are needed to take over the activist role. This growth in party membership is the life-blood of the libertarian movement.

Moreover, if Budget members are included, the vast bulk of which are National members previously not included as state members, membership is up over 89%!

Committee Meeting Highlights

The June 20 Steering Committee meeting was held at *Ben Grindlinger's* house and was called to order by *Len Flynn*, vice chair, until Chairman *Mike Pierone's* arrival. Present were *Emerson Ellett*, secretary; *Lou Stefanelli*, treasurer; and *Spencer Layman* and *John Paff*, members at-large.

• May's minutes were approved and the Treasurer's report was received. It was noted that the NJLP's lending library was not included as part of the party's assets, but that an attempt to value it would be made.

• A motion to accept a letter drafted by Paff to request ACLU assistance in permit voters to register as Libertarians was passed.

• A motion to have the secretary request that the State Committee be placed on the mailing list to receive the legislative calendar was passed.

• It was noted that the NJLP would be testifying against S.53, Sen. Rice's curfew bill, at the June 23 committee hearing. *Larla Maloney*, age 12, would testify on the party's behalf and the media had been invited.

• Pierone and Stefanelli were attempting to recruit outspoken Paterson school principal *Joe Clark* as a member. Clark has requested a membership application.

• A motion to accept *Doug Stoxen* as the Salem County organizer, with the right to collect a portion of dues from new members he recruits, was passed.

• Pierone was directed to draft a "Proclamation of Juror's Rights Day" for FIJA to be presented at

the next general meeting, scheduled for July 3. If approved, it will be sent to the legislature with a request that the Day be honored in perpetuity.

• The FIJA coordinator was recognized for sending letters to 4 county prosecutors asking what action will be taken with regard to persons who distribute FIJA flyers at the court house. The strategy is to receive a declaratory judgement that will permit the distribution of flyers, no matter what the prosecutor says. As the possibility exists that the judgement could prevent distribution of flyers at all courthouses, Flynn requested the plan first be discussed with an attorney.

• Candidates were reminded to send money to LIBPAC, the NJLP's political action committee, rather than spending their own money directly.

• Pierone authorized the expenditure of \$29 for the purchase of stamps for mailing the Mercer County newsletter.

The July 3 General Membership meeting was held at the Flynn's residence in conjunction with the annual picnic. The meeting was called to order by *Len Flynn*, vice chair.

• June's minutes were approved and the Treasurer's report was received.

• It was noted that party expenses were higher than last year's, largely because of the cost of mailing quarterly newsletters to Budget members, predominately those national members "adopted" by the NJLP.

• Flynn committed the Steering Committee to re-

ing those who cling to the past, and have an actual desire to keep the party small and ineffective, in order to cater to their world view that they are part of the elite few who truly understand free markets and liberty.

I personally am hip deep in the efforts to change our party, and I welcome articles such as yours, because I believe that the Libertarian party, if it is ever to have a greater impact, must acknowledge its weaknesses, learn from them, and move forward. But I ask you, as someone who has no problem making his views known, wouldn't it be better to join the effort to make a viable third party? Will the Republicans or Democrats ever reduce the size of the federal government? How much longer will people of good conscience be able to associate themselves with either majority party?

I believe you when you say it is regrettable that the Libertarians are frivolous, and I invite you to come and help make it otherwise. It can only happen when and if people such as

Leona Protest Postponed

The rally in front of the Danbury, Connecticut, prison where billionaire hotel queen Leona Helmsley is being held on specious tax evasion charges was temporarily postponed, NJLP Chair *Mike Pierone* announced.

Scheduled to have taken place on Saturday, July 11, Pierone had coordinated with the state chairs of Connecticut, Pennsylvania and Delaware to ensure a respectable turnout.

Pierone promised to make sure that the proper preparation would be completed before the rally when it is rescheduled. A date has not yet been confirmed.

that four OPH brochures were in short supply. A motion to spend up to \$300 on new ones was approved.

stituting a crime was prosecuted as or resulted in conviction of a disorderly or petty disorderly persons offense."

That language would be stricken to require that forfeitures could occur only if a conviction was obtained for those crimes.

This change in semantics is important in that it prevents overzealous prosecutors from pursuing cases simply for the purpose of seizing property. It would mandate that a person actually be convicted of the crime.

The second change would prohibit forfeitures disproportionate to the crime committed. In the notorious Coast Guard "Zero Tolerance" cru-sades, yachts and other sailing vessels were seized by the government for the sin of having a single marijuana seed on board. This new language would prevent such atrocities from occurring in New Jersey.

WHAT YOU CAN DO

Write to your local Senator and Assembly representatives urging them to sign on as a co-sponsor of A.1536 and Kavanaugh's concurrent resolution. As of this publication, the latter had not yet been assigned a number, but you can call the Office of Legislative Services at (609) 292-4840 to find out what it is.

Paff also reported that, in a sign of its widening popularity and improvement in its chances of passage, Assw. Harriet Derman (R-18) signed on as a co-sponsor of the bill.

In a related development, Assm. Kavanaugh has agreed to introduce an Assembly Concurrent Resolution to memorialize Congress to insert proportionality language in the federal forfeiture statutes. This is in response to a request made by the Eighth Circuit Court of Appeals (see story at right).

Court Calls on Congress to Revise Forfeiture Laws

On May 20, 1992, the US Court of Appeals for the Eighth Circuit decided *United States v. One Parcel of Property Located at 508 Depot Street* Docket No. 91-2382SD. In the decision, the court affirmed a lower court's forfeiture of Richard Austin's body shop and mobile home based on their connection with a single sale of cocaine. Austin argued that forfeiture of his home and business was so harsh and disproportionate to his offense that it violated the Eighth Amendment's protection against cruel and unusual punishment.

Not surprisingly, the court upheld its long-standing rule that the Eighth Amendment requirement of proportionality doesn't apply to civil forfeiture cases. However, the Court did urge Congress to "re-examine" the forfeiture statute and "consider injecting some sort of proportionality requirement into the statute."

Based upon this decision, a national movement is springing up to urge Congress to change the law. FEAR, Forfeiture Endangers American Rights, is leading this groundswell by circulating a excerpt of the court decision and asking individuals to write their congressional representative and ask them two simple questions:

1) "Do you agree with the Eight Circuit Appeals Court's position that the value of property confiscated ought to be proportional to the severity of the offense upon which the forfeiture is based?"

2) If so, will you introduce a bill that will inject a proportionality requirement into the civil forfeiture statutes?"

FEAR will be tracking the responses constituents receive from their representatives and senators. For more information on FEAR, or to receive a copy of the court decision excerpt, see page 7.

PRO CHILD -- PRO CHOICE

The 1990 National Libertarian Party Platform on Women's Rights states: "Recognizing that each person must be the sole and absolute owner of his or her own body, we support the right of women to make a personal choice regarding the termination of pregnancy."

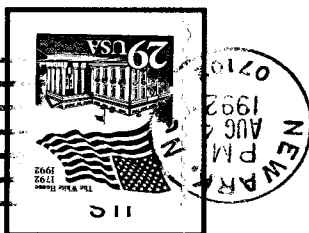

So declared NJLP Chairman **Mike Pierone** in a press release fired off to the state's media outlets after the candidates' petitions were filed with the Secretary of State's office in Trenton.

"In this year of anti-incumbency and general dissatisfaction with the status quo," continued Pierone, "we believe that the people are ready for real change in government, back to the principles of this nation's founders."
