## Libertarians to Lobby for Leona Helmsley

NJLP Chairman *Michael Pierone* announced that he is coordinating a regional demonstration to protest the imprisonment of Leona Helmsley, the billionaire hotel queen who was sent to jail on specious tax evasion charges.

In a letter to the editor of the state's largest newspaper, *The Star-Ledger*, Pierone noted that Helmsley paid some \$500-\$600 million in income taxes, an amount some 200 times greater than the entire federal budget during Thomas Jefferson's administration.

Rather than imprisoning Helmsley, Pierone suggested that monuments in her honor should be erected. Helmsley is now serving time in a prison located in Danbury, CT.

Pierone has contacted Libertarians in Connecticut, Pennsylvania and Delaware and reports that all are excited about the rally which has been scheduled for Saturday, July 11 at 2:00 p.m. outside of the prison.

Helmsley's lawyer, the noted Harvard professor Alan Dershowitz, was contacted about the event in defense of his client, but as of press time, it was unknown whether he would be on hand.

Pierone is seeking a strong contingent on New Jersey Libertarians to accompany him to Danbury. Those interested in participating in this sure-fire media draw should call Michael Pierone at (201) 827-5226 who will be coordinating rides.

## FEAR Wins Access to Forfeiture Files

Under intense pressure from *John Paff*, an NJLP member and chairman of a newly emergent national organization known as FEAR, the Somerset County prosecutor bowed to his demands to have access to the county forfeiture files.

Forfeiture Endangers American Rights (FEAR), in just about two months, has already established chapters in a dozen states and more are coming on board regularly. In New Jersey, FEAR is challenging the state's use of the forfeiture statutes and is seeking legislative changes to the law to guarantee due process.

At a recent Somerset County freeholder meeting, Paff publicized FEAR's concern that the authorities were abusing

the law by seizing assets only remotely connected with the commission of a crime, or from innocent parties.

Paff had attempted to obtain access to the

## Largest Tax Cut in State History Enacted

Ignoring charges that rolling back the sales tax would play havoc with the budget, the Republican-dominated Senate and Assembly voted overwhelmingly in favor of the tax cut and then by equally wide margins, overrode the Governor's conditional veto.

"This is a victory for the taxpayer, declared NJLP Chairman *Michael Pierone*, following the historic vote to override. "It puts more than \$600 million back into the wallets of the taxpayer--where it belongs!"

Pierone noted that the rollback of the sales tax from 7% to 6% amounted to approximately \$608 million--the single largest tax cut in the history of New Jersey. It was also the first time in a decade that the legislature overrode a gubernatorial veto.

"The job is only half done, however," continued Pierone. "The Republicans ran election campaigns suggesting they would repeal all \$2.8 billion worth of tax hikes. Now's

# Chairman's Column

## "One Good Libertarian in One Good Race"

All we need to "make it happen" is to have one good Libertarian running for one good, winnable office. In 1993, we have 121 chances to do it!

Following every Census, the legislative districts are reapportioned and all 120 seats are contested twice in two years.

It is a prime opportunity of which the NJLP absolutely must be ready to advantage. For not only will we have 40 Senate and 80 Assembly seats at risk, but the Governor's term in office also is at an end. What we need to do right now is to look at all 121 races and see where is the most vulnerable one.

Under normal circumstances, Libertarians usually reserve the place of a footnote in these races but next year can--and should--be different. Why? Because after two years of Democratic dominance, New Jerseyans were saddled with \$2.8 billion in taxes, and after two years of Republican dominance, the only cuts they could muster the courage to vote for were a measly one-cent rollback in the sales tax and \$400 million in spending.

We must also be ready to point out that the mandate the Republicans received was *fortax repeal*. They still left the remaining \$2.2 billion in tax hikes in place! Had they done what they were elected to do, the budget would be in the area of \$12 billion instead of \$15 billion.

So what are Libertarians to do? Capitalize on the situation. A well-run race needs good planning. That requires about 18 months of research and

strategy and coordination. Now is the time for us to start on '93!

Can we win 10 or 20 or more seats? Who knows? But certainly one good Libertarian running in one good race is doable. It may be a Senate or Assembly seat. Or it may be a run for the Governor's office. Believe it or not, we may soon have someone with us who could be catapulted to the forefront, grabbing headlines and bringing the words "Libertarian Party" into every home in the state--and many more across the country!

1993 is, perhaps, the most exciting election year the NJLP faces in a long, long time. But we need to begin work on it right away.

Yet let's not forget those who are running this year for Congress. We should be doing all that we can to help their campaigns which can lay the ground work for next year. Each race is a brick in the foundation for Liberty. Each is equally important to the whole structure and essential for their being a firm base for the future.

We have candidates in every congressional district--a feat unparalleled in more than a decade. As the story on page 8 notes, there are individuals contributing their products and services to their campaigns and an offer has been extended for this newsletter to serve as a clearinghouse for others interested in doing the same.

Perhaps our theme for the remainder of this year and all of next ought to be "One Good Libertarian in One Good Race!"

## Celebrate Liberty July 3! General Membership Meeting & Picnic

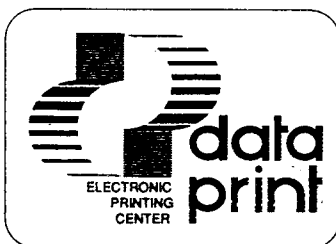
The annual July 3 picnic and general membership meeting will once again be held at the home of *Len and Ginny Flynn* in Morganville.

## Libertarians Oppose Curfew 12-Year Old Libertarian Testifies

Calling the measure intrusive and probably unconstitutional, Libertarians mounted a strong protest against a proposed curfew which would allow parents to be fined for the otherwise legal actions of their children.

A highlight of the Judiciary Committee hearing was the testimony of 12-year old *Larla Maloney* of Highland Park, who was incredulous.

"I know little kids who

get up early and take a walk. Would they be arrested for that?"

The Senate sponsor, Ronald Rice (D-29), ridiculed Larla as "utopian."

"I come from the real world," he said. "This is serious business."

The bill, S.53, was approved by the committee. Also testifying against it were *John Paff, Lou Stefanelli, Ray Babecki* and *Michelle Maloney*.

- Tends to be excessively serious to the point of being hostile in most interactions with other people.

- Gets upset with "frivolous" activities.

- Expects others to follow him or her blindly.

- Makes numerous commitments and then gives excuses when they are not met.

- Treats ideas as a kind of religious dogma and treats any disagreements as signs of "heresy."

- Forgives even intentional acts if the person shows he or she regrets the action.

- Tries to be friendly toward others.

- Recognizes there is no reason why activism cannot also be fun.

- Has a well-thought-out plan which is used to sell others on why they should take the proposed line of action.

- Is cautious about making commitments, but does what is promised.

- Knows what is important and has the patience to discuss disagreements over philosophy or strategy without becoming personal or failing to listen to what the other person has to say.

It is harder to be a good activist than a bad one. But if the Libertarian Party is going to accomplish anything, we need a real "gold standard of activists" to defeat Gresham's Law of Activists and not put up with bad behavior.

# Gresham's Law of Activists: "Bad Activists Tend to Drive Out the Good Ones"

There are some in the libertarian movement who are bad activists. Even though they may be "ok" ideologically, they do not forward the cause of freedom. Even if they do make positive contributions, on balance they actually harm the Movement.

It is not always easy to spot a bad activist at first glance. No one is perfect and many outstanding activists slip into bad habits from time to time. Nonetheless, the bad activists tend to be remarkably consistent.

Virtually every bad activist puts his or her personal (or factional) interests ahead of the purpose of the organization or cause. The good activist expresses his or her individuality through the choice of joining the organization if it identifies with his or her personal interests. The bad activist will sacrifice the interests of the organization for power, status, enrichment, or some other form of short term ego gratification.

There are some ways to spot a bad activist as opposed to a good activist:

## BAD ACTIVIST

- Tends to be argumentative, insulting, obnoxious, and is indifferent to the effect her or she has on others.

- Tries to take credit for any accomplishments, even ones which are primarily the results of someone else's efforts.

- Has delusions of grandeur and makes sure everyone is aware of his or her titles and status.

- Tends to be secretive and cliquish.

- Never listens to what other people have to say.

- Reacts to any disagreement with angry outbursts, condemnations, or personal attacks. Is quite willing to disrupt meetings and alienate bystanders in the process.

## GOOD ACTIVIST

- Tries to be reasonable, polite and considerate.

- Is more concerned about getting results and is anxious to give credit to others as a way to encourage them to continue what they are doing.

- Is basically modest and recognizes the importance of the cooperation of others.

- Wants other activists to participate in the decision process whenever possible and to understand what is being done and why.

- Is always interested in new ideas and encourages involvement by others.

- Tries to disagree without becoming personal or being disagreeable.

# State Committee Meeting Highlights

Held at John Paff's house, the May State Committee meeting was called to order by vice-chairman Len Flynn.

Present were Emerson Ellett, secretary; Lou Stefanelli, treasurer; Ben Grindlinger, Spencer Layman, and Jerry Zeldin, members at-large; Bergen County Representative Dan Karlan; and Mercer County Representative Carl Peters.

- April's meeting minutes were approved and the Treasurer's report was received.

- Dan Karlan was delegated the duty of custodian of the by-laws by the Secretary as Karlan has kept the by-laws current in the past.

- A motion to amend the by-laws to reduce the number of State Committee meetings from 4 to 3 and Steering Committee meetings from 10 to 8 failed.

- A motion to amend the by-laws to change the phrase "does not believe in

or advocate" with the word "opposes" as well as to eliminate the quotation marks passed unanimously. The amendment will be considered at the July 3 general membership meeting.

- A motion to recognize the fact that the word "opposes" and "does not believe in or advocate" are equivalent as they relate to membership certification also passed unanimously.

- State committee reports were received regarding various activities.

- John Paff and Ken Kaplan were reported working with the ACLU on allowing Libertarians to register as such. Doug Stoxon has also been doing independent research on the issue.

- A motion to allow Len Flynn to spend up to \$60 on supplies for the general meeting was approved.

- Len Flynn reported he would be ordering 13 copies of *Liberty Primer* at a cost of \$81.25 was announced.

- The meeting was adjourned.

- Tends towards factionalism and is inclined to purge activists who are not included in the faction.

- Devotes considerable time and effort to criticizing other people in the organization.

- Is constantly being "offended" and is inclined to hold grudges.

- Is inclined to recognize good work by anyone and ignore the rest.

- Keeps criticism to a minimum and always has positive suggestions.

- Is inclined to give people the benefit of the doubt, does not get upset with inadvertent and unintentional slights, and will

Freeholder Director Christopher Bateman applauded Paff's efforts, noting "It appears that you have done your homework and it appears that you raise some very valid questions."

Paff, who has only been given an audit of the files and not the files themselves, has stated he will review the information and follow up on the county's handling of forfeitures as well as money which has been seized.

the time for them to deliver on their campaign promises!"

Following the election landslide, Republican party leaders began to claim that only the sales tax rollback was the target of their cuts. The balance of the tax hikes have yet to be considered.

Pierone warned Republicans that the voters would give them the same message they gave the Democrats. "No new taxes! It's a very libertarian

message, yet the Republicans' failure to grasp this concept will be the reason for their downfall." He predicted Libertarian candidates would do very well in the state legislative elections next year as it has become apparent that there is little difference between the two major parties.

"We offer a real message of change," said Pierone. "We are the real outsiders for which the voting public is clamoring."

## South Jersey Libertarians Active in Cowtown

Despite the threat of inclement weather, a core group of Libertarians attended the Cowtown Flea Market on June 6 and ran a successful OPH booth that even signed up a new LP member on the spot.

Doug Stoxen, a Pennsville Libertarian; John Hill, the South Jersey LP coordinator; and Roger Bacon, who is the LP's congressional candidate in the Second district manned the booth from early in the morning until late afternoon.

Choosing a spot that offered the best protection in the event of the threatened rain showers, the trio handed out 88 quizzes to passersby, 72 of whom took the "World's Smallest Political Quiz." It was estimated that a 1,000 people walked by the booth, although there were approximately 4,000 to 5,000 people at the fair.

their kids drawing cartoons about it. (Street scene, at edge of town, with a sign: "Welcome to Edison, where you can look like a pig and act like a pig, but you just can't be a pig.") The council was deluged with about 75 letters a day from the public.

- Research, research, research. You can't count on results unless you work hard. The Dombrowskis got experts to attest to the mini-pigs' safety, cleanliness and temperament.

## Libertarians Launch Single-Issue Drives

Stating that "people who might support the libertarian movement on a given issue balk because of all the others that come with it," Americans Against Prohibition (AAP) announced the launching of a major drive to united diverse and disparate individuals behind "single issue projects."

The first issue this group is tackling is also, perhaps, one of the most thorniest: drug relegalization.

"Liberals hate the drug war," AAP's President, Perry Willis writes in the outreach letter. "It's intolerance, disregard for the Bill of Rights, and cruelty." So while much libertarian outreach is aimed at conservatives, this issue can bring so-

called liberals on board as well.

AAP also points out that relegalization also has a broad coalition behind it, including William F. Buckley, Milton Friedman, Baltimore Mayor Kurt Schmoke and former Secretary of State George Schultz--liberals *and* conservatives!

To achieve their goals, AAP hopes to go beyond the "Gutenberg Galaxy," as they call it, the list of books, magazines and seminars on the issues.

Americans Against Prohibition will be going high-tech: using various electronic media techniques, including television ads and audio tapes.

AAP is, of course, seeking contributions to
