Not Just A Basketball Game

Imagine watching a basketball game without referees: only safety officials, sitting on the sidelines, their sole mission to insure the safety of the game. Imagine each player, a referee unto himself, standing ready to freely admit to any infraction of the rules. Imagine a player calling a foul on himself; he raises his arm and waves his hand with two outstretched fingers. A player from the opposite team goes to the foul line and begins taking foul shots. How is this game proceeding so orderly without the control and supervision of referees?

The league operates under a CHARSALOR philosophy in which a person's character is very highly valued. A team could win a game on points, but lose, in the eyes of fans and fellow athletes, on character. In this league, the referee's constant pressure upon the athletes to play the game fairly has been removed. For the game to proceed harmoniously, each athlete must generate from within himself the motivation to behave civilly and morally. It is this internally originated moral behavior that builds real character and results in the admirable on-court behavior illustrated above.

The Libertarian political philosophy operates on a concept very similar to charsalor. Libertarians advocate <u>the</u> <u>controlled removal of most government pressures</u> that force moral and civil behavior. Having removed these external pressures, the character of the citizenry is free to grow and fill the vacuum left by the government. The idea is to grow character, an essential component of a free people, and believe me; character and freedom will not only grow, but will flourish, when not crowded out by a coercive government.

In recent times, we have witnessed the most self-centered, thuggish, un-sportsmanlike behavior of professional athletes clearly suffering from a severe character deficit. The public is fed up and ashamed of such behavior. There is now a critical mass of parents who would encourage their children to participate in charsalor type sporting activities: basketball, baseball, hockey, etc. The benefits of children in charsalor sports to the Libertarian movement are immense, because charsalor sports conditions a child for an adult life of Libertarianism. Who will establish the first charsalor-type sporting league? Are you the one — that one very special person — with the drive, imagination and organizational skills to start the ball rolling?

Major Howcott was born in Mount Vernon, New York. In 1961 he enlisted in the USAF as a basic trainee. After reaching the grade of Staff Sergeant and, while still in the military, he attended Arizona State University, obtaining a Bachelors Degree in Electrical Engineering. In 1968, he was commissioned a 2nd Lieutenant and assigned to Patrick Air Force Base in Florida. He worked at Patrick, during the inception of our space program, in booster and ICBM research and development and later around the world in fixed and tactical communications.

He has been stationed in various parts of the United States, England, The Philippines and Korea. He left the military in 1982 when cellular communications was in its infancy and took employment as a mobile communications systems engineer. In this capacity, he designed paging systems and one of the world's first cellular communications systems. He subsequently founded Intrafamily Communications, Inc, publishers of the <u>National Communications Site</u> <u>Directory</u>, a first of its kind technical directory used nationally by cellular and PCS radio frequency engineers. He retired from engineering in 2002 to pursue his real interest, political philosophy.

Major Howcott is now on an unalienable Rights campaign. His immediate goal is to establish the importance of understanding and properly applying the concept of unalienable Rights.

He has acquired a unique outlook on politics, society, religion, and the relationships among these three entities. Unalienable Rights lie at the foundation of his philosophy. Civil liberties and Patriot Act

In this piece, two writers from two political perspectives look in dismay as this nation continues to allow an erosion of civil liberties that were so proudly developed by our forefathers in 1787 when they ratified our Constitution.

Tony Federici is a former chair of the Sussex County Libertarian Party, while Bill Weightman has been a candidate for the Assembly as a Democrat. They often have differing perspectives on issues. such as the minimum wage. free trade, and gun control. Since Sept. 11, 2001, there has been a tendency in government to abridge civil liberties. Even the recent commission on those events noted that tendency in its recommendations and indicated the need for debate and dialogue on the Patriot Act and other actions that will allow the Executive Branch to increase in its powers over the other two branches of government.

A Democrat View

Some years ago, politicians were loudly trumpeting the notion that "Big Government" was over; what is worrisome now is the era of "Big Brother" in govproment might only be growing tronger, stealing our freedoms, and weakening our spirit. That is why we focus today on a very inpatriotic act - The Patriot Act. These words are borrowed rom a very distinguished American, who has served this nation and 11 presidents.

In a recent book, "Losing America" by Sen. Robert C. Byrd. the dean of the Senate, the folowing notion is stated: "The USA Patriot Act is a case study in he perils of speed, herd instinct. and lack of vigilance when it somes to legislating in the face of a crisis. The only thing worse han hurrying with a major and ar-reaching piece of legislation ike the Patriot Act is hurrying out of a sense of panic." In passng this piece of legislation after iept. 11, Congress allowed the Executive Branch to trample the alues of freedom, justice and quality. The hopolotice was recent to

go the 1978 Foreign Intelligence n d a Surveillance Act (FISA), which set up a corresponding court to consider

requests. It did indeed go beyond those tenets, which liberals and conservatives can agree. Bob Barr, a former Republican member of Congress, has noted that "the Fourth Amendment is a nuisance to the administration, under the parameters of the Patriot Act, and if we allow government unfettered monitoring of citizens whenever it wants, without cause- and if that happens, it is the end of liberty."

The Patriot Act has increased a vast array of new powers in the Executive Branch. while decreasing judicial oversight. Briefly, Section 802 of the Act creates a new crime of "domestic terrorism," which includes any dangerous acts that "appear to be intended ... to influence the policy of intimidation or coercion." Our fear is that this can be ultimately used to silence any political dissent critical of the government. Under this Act. government is authorized to make secret arrests, unfairly target immigrants, and allow foreign governments, including dictatorships to seek searches and seizures of American citizens and their property, allow extradi-tion of citizens without treaty or Senate authorization.

Below are quotes from critics of the Act:

Henry Schneider, Pennsylvania Sportsmans Association, has noted that "the administration and Congresss actions in passing this act has prompted a number of gun owners to recoil." while Kevin Starrett, executive director, Oregon Firearms Association, noted "that if the Clinton administration had proposed the Patriot Act, which is a real scary thing for gun owners. Republican-controlled the Congress would have been

well as such nonviolent acts as fund-raising for suspect organizations. On the surface that might not trouble you, but the next section allows for the detention of non-citizens with little or no judicial review. This allows the attorney general and secretary of state too much latitude.

The following are troubling:

· A dismantling of court reviews of surveillance, such as terminating court limits on police spying on religious and political activity by allowing such authorities to obtain court records and even library records secretly and without judicial oversight.

· The Act allows the FBI to investigate an American citizen because of the books they read, which allow surveillance of libraries and other entities, which abridges our First Amendment rights. This is listed in Section 215.

These are only some of the problems. Tony in the next section will continue the discussion from his perspective.

A Libertarian View

Was the interventionist foreign policy of the American government on the minds of foreign terrorists, when they launched their aggression with three hijacked planes on Sept. 11?

Thomas Jefferson said. "The natural progress of things is for government to gain ground and for liberty to yield." Will freedom in America continue to be lost? Is the Patriot Act an effective security tool or is it unnecessary? Is it indeed constitutional?

These questions and others are important for thinking Americans to mull over. They are difficult, require time and effort.

As a Libertarian, I advocate free markets, private property, limited government and individto share my thoughts on the Patriot Act, I knew where my predispositions were.

Let me begin by saying the purpose of government is to defend life, liberty, and property. This includes stopping domestic and foreign predators. The domestic types we call criminals, who would murder, rape, rob, and assault us. The foreign types are terrorists who belong to no regular army. They usually operate in small groups or cells. What is clear from their perspective is that they mean to cause Americans harm. The USA Patriot Act is supposedly an aid in stopping them.

Check out the real name of the law "Uniting and Strengthening America bv Providing Appropriate Tools to Intercept and Obstruct Terrorism." I have heard that the bill, which is well over 100 pages, was quickly pushed through Congress. My concern is that there was no open discussion and no final hearing in which opponents could testify. If my information is correct, this was a sad day and reason enough not to pass the bill into law.

The Patriot Act expands the federal government's surveillance, wire tapping and detention authority. Library and bank records can be obtained without probable cause. The Fourth Amendment seems to be effectively thrashed. Is there any reason to believe additional police powers will help stop terrorists, or will innocent people tend to be "rounded up?"

The FBI has to focus on its task. It doesn't have to dilute its efforts by investigating a lone family that lives on a mountain called Ruby Ridge. It doesn't have to squander resources viewing prostitutes in some Southern city, as I recall they were doing around the time of 9/11. They should actively focus on credible warnings of terrorist attack where there is probable cause that something may happen. Let us protect our Constitution, leave peaceful immigrants alone, along with librarians and bankers.

Finally, if Switzerland can Stay out of trouble" and defend itself why can't the United

Patriot Act debate turns to privacy rights

What was billed as a threeway discussion of the pros and cons of controversial legislation passed just over a month after the Sept. 11 attacks turned into a discussion of privady rights and the roots of terrorism Saturday at Sussex County Community College.

"We are too easy to give up our civil rights," said Hardyston resident Bill Weightman. "Nineeleven was horrible, but you do not throw away your civil liberties."

Weightman, whose role on the SCCC panel was to say the Patriot Act needs alterations, sounded more like the civil fibertarians calling for its repeal.

The Patriot Act, which was approved by an overwhelming majority in both the House and the Senate, was billed as an aid to U.S. intelligence agencies and law enforcement in the war on terrorism.

Opponents of the act have argued that it weakens civil liberties by entitling the U.S. government to conduct searches and gain information in ways that violate the Constitution. Much of Saturday's discussion, which drew nearly 60 people, centered on civil liberties.

Tony Federici, former chairman of the Sussex County Libertarian Party and the SCCC panel's anti-Patriot Act member, said the law robs Americans of their liberties.

"How can you be free when the FBI can knock on your door to ask why you got a book to learn Arabic?" Federici asked. "Or when the government can get at your e-mail with relative ease?"

Federici cited 200 municipalities that have passed resolutions condemning the act as "not only unnecessary, but unjust."

The panel's moderator, SCCC sociology professor Stacy Golin, filled in for the panel's Patriot Act defender, who failed to show.

She said the act increased communication between agencies in order to combat terrorism and said warrants are necessary before the privacy of electronic sources can be violated.

Weightman and Federici said

the Patriot Act was rushed through Congress and the Senate without the necessary discussion, and that it was motivated by fear.

"Roosevelt was right when he spoke about fear," said Weightman, referring to Franklin D. Roosevelt's statement that Americans had "nothing to fear but fear itself" during World War II. "Fear should never be the motivation for legislation." The discussion prompted observations on terrorism from two members of the audience.

Wolfgang Pfeifer, of Vernon, said Saturday's discussion was irrelevant without clearer definition of a "terrorist."

"We are trying to fit a shoe on a foot that we never even measured," he said.

Sean Twomey, an Irish immigrant who came to the United States in 1958, said his father was active in the Irish Republican Army. The British consider the IRA a terrorist organization.

"The difference between a terrorist and a soldier," Twomey said, "is that a terrorist completely believes in what he's," fighting for."

According to Twomey, as long as there are people around the world with no rights and no recourse, terrorism will continue.

Noble intentions don't yield noble results

New Jersey campaign finance laws: They were ratified by the state legislature with the "noble" intentions of rooting out corruption and limiting the influence of money in politics.

However, regrettably, they have given power to millionaire candidates (e.g.Jon Corzine and Doug Forrester); they have strengthened the hands of party bosses and professional fund-raisers; they have banned contributions from groups and individuals who do business with the state (namely those involved in gaming, banking, and insurance and contracting); they have made it difficult for candidates of average means to raise money to compete in elections; and above all else, they have strengthened the hands of incumbent politicians in state government.

There are some who are trying to remedy this problem by introducing public financing of elections. In two New Jersey legislative districts, a pilot program has been introduced to provide public funds to candidates running in these areas.

This is a travesty. Taxpayer monies should never be used to fund ideas, positions or candidates who may hold views people may or may not agree with.

It is insulting, and in the words of Thomas Jefferson, it is "sinful and tyrannical."

So what should be done? I am of the opinion that all campaign-finance laws should be changed or henceforth eliminated. I believe that individuals and groups should be allowed to donate how much they desire to the candidate of their choosing. I further believe that to bar certain groups and individuals from donating and engaging in the political process violates not only the right of association, but the spirit and totality of the U.S. Constitution's first-amendment guarantee.

I also believe that the standard should be lowered to allow third-party candidates to not only compete in the gubernatorial elections, but to be allowed in the gubernatorial debates. At this time, the way the system stands, third party candidates are allowed to qualify for the debates provided that they have raised \$270,000 or more. The threshold should be lowered to \$160,000 for that purpose.

Even if the intentions are considered "noble" by some, when laws suppress the freedom of the people to engage in the political process, it is the people who lose and it is those in power that gain and become victorious.

The people of the state cannot afford that and it is they who should always be alert and on guard. It should always be the people who have the power not the other way around.

Damned if they do...

In reading the article in *Suburban Trends* of Nov. 24 on Ringwood's efforts to limit the size of homes in that town, one issue was not mentioned.

That issue is, that like it or not, many people resent the wealth and success of others.

Planners and Zoning Board officials will talk endlessly about the "character" and "aesthetics" of residential neighborhoods, but I think this is just a mask they wear in order to pander to the anti-wealth mentality of many citizens.
