

Bob has a BS in Metallurgical Engineering and an MS in Industrial Management. He is married and has three sons who share his drive and skills.



His reputation as an entrepreneur is backed by successful companies and enterprises that he founded and managed. Jackson has been honored for his achievements by community, business, and professional groups. Bob says "Washington is broken both financially and operationally because the federal government has far exceeded the powers granted by the people in the Constitution... We need a Professional Engineer in the White House who has business experience."

Wayne Allyn Root

Wayne Allyn Root (WAR) is a television sports celebrity known to millions of American male sports fans and gaming enthusiasts. His rags to riches story is born a son of a butcher, Wayne has morphed into a high-profile small businessman, CEO and entrepreneur; self-made millionaire; best-selling author; TV host and spokesman; and an outspoken "Libertarian-conservative version of Rush Limbaugh meets Bill O'Reilly."



He is the author of six books—including the best selling political book *Millionaire Republican*, and the creator, Executive Producer and star of shows such as "King of Vegas" on Spike TV and "Wayne Allyn Root's Winning EDGE." Wayne says he is a "Media Magnet" and has been profiled by many magazines and other media, plus is a frequent talk show guest.

George Phillies

George Phillies writes of himself: I'm a long-time Libertarian Party activist. I was Massachusetts state party Executive Director in 1996, ran for Congress as a Libertarian in 1998, and was elected Party State Chair in 2007. In the mean time I published the monthly Libertarian magazine "Let Freedom Ring!" (<http://cmlc.org> for back issues), and wrote two books on Libertarian strategy and history: *Stand Up for Liberty!* and *Funding Liberty* (<http://cmlc.org> or 3mpub.com/phillies). I also launched a state Libertarian PAC, a Federal Libertarian PAC, and the Libertarian 527 organization Freedom Ballot Access. I declared for President in 2006; I'm already running radio ads, placed Adwords and Facebook ads (18 million impressions to date), set up a web site ChooseGeorge.Org, and recruited a wonderful crew of volunteer supporters.



My Physics doctorate is from MIT and I now teach at Worcester Polytechnic Institute. I'm a long-time board game collector, and own about 3500 strategy games. A few years ago WPI launched a computer game major. Suddenly my collecting hobby became a profession: I teach our course on designing games using the two textbooks Tom Vasel and I created. I've also published two science fiction novels: *The Minutegirls* is a subtly libertarian perspective on alternative national defense. Thanks to frugal saving and careful investing, I'm a millionaire, a millionaire Libertarian.

Daniel was born in Boston, Massachusetts on March 9, 1958.



John Paff and Friends March On

John wins attorney fees from Toms River Twp.

In a January 30, 2008 decision, the Government Records Council (GRC) ruled that John was "a prevailing party entitled to an award of a reasonable attorney's fee" pursuant to the Open Public Records Act (OPRA). The GRC referred the case to the Office of Administrative Law (OAL) to determine the amount of the fee and additionally to determine whether the custodian (Toms River Township, Ocean County) "knowingly and willfully" violated OPRA.

John believes that this is the first time since 2006 that the GRC has awarded attorney fees. Hopefully, this will encourage more attorneys to take record cases before the GRC.

The order stated explicitly that "The access sought by the Complainant came about due to the Complainant's filing of a Denial of Access Complaint and as such, the Complainant is a prevailing party entitled to an award of a reasonable attorney's fee Thus, this complaint should be referred to the Office of Administrative law for the determination of reasonable prevailing party attorney's fees.

The GRC forcefully added this conclusion to its order: "Therefore, it is possible that the Custodian's actions were intentional and deliberate, with knowledge of their wrongfulness, and not merely negligent, heedless or unintentional. As such, this complaint should be referred to the Office of Administrative Law for determination of whether the custodian knowingly and willfully violated OPRA and unreasonably denied access under the totality of the circumstances."

Open records advocate wins fight with Madison schools

District can't charge \$30 fee for \$1.50 audio tape recording of public meetings

An article by Jake Remaly in the March 5, 2008 *Daily Record* describes the Government Records Council finding that the Madison Board of Education's records custodian unknowingly violated the state's Open Public Records Act by charging \$30 for an audiotape copy of a board of education meeting. The GRC also ruled that the board needs to pay the prevailing complainant's attorney a reasonable fee. The fee has not been determined. The Government Records Council ruled the board's records custodian, Charles Milewski, was "negligent and heedless" of his legal responsibility in charging \$30 for the tape. The board is limited to charging the actual cost of the audiotape, or \$1.50. The board's outside attorney said board members were "delighted that they didn't find any knowing or willful violation" and that "of course the district will comply" by modifying its policies to follow the Open Public Records Act.

Milewski has until March 10 to send the complainant, Martin O'Shea, an audio copy of the meeting at the actual cost, and provide confirmation of compliance with the Government Records Council. O'Shea, an open records advocate who lives in Sussex County, first requested a copy of the audio recording of the most recent meeting of the Madison Board of Education on June 25.

When he was told the recording would cost \$30, his attorney, Walter Luers, sent a letter to Milewski saying \$30 seemed extraordinarily high and that the law requires government agencies to charge the actual cost of copying a public record in the same medium. The board later contended that because meetings are recorded at half-speed and a member of the technology department needs to convert the recording to full-speed, which takes about an hour, a special service charge of \$30 was authorized, because members of the technology staff is paid about \$30 an hour.

Before O'Shea filed the complaint, Milewski said in a July 25 letter to O'Shea that the board would bring the fee down to \$10. O'Shea maintained that the audio of the meeting should be available at the actual cost of the cassette. "I think it's sneaky," O'Shea said. "They tried to undermine my complaint with the GRC by dropping the fee from \$30 to \$10. I think that's a sign of people who are really trying to keep information from the public."

O'Shea filed a complaint with the Government Records Council on Aug. 6. O'Shea, a retired newspaper reporter and editor including at the *Daily Record* for a few months in the early 1990s, has been an open government activist for about 10 years. "I think every record should be free," he said. "I think there should be no fee whatsoever—certainly for people who pay property taxes in Madison."

10 towns face suit over public records

A *Bergen Record* article for Saturday, March 8, 2008 by Staff Writer Ashley Kindergan reported that open-government advocate Martin O'Shea has sued 10 Bergen County municipalities and clerks, contending that they have not complied with New Jersey's open public records law. In October, O'Shea and his associate, John Paff, requested the annual police internal affairs summary report from the municipal clerk in each Bergen County town with a police department. The document lists the number of complaints the departments received for violations such as use of excessive force.

All but 10 municipalities gave him the documents. The others improperly stonewalled, denied, ignored or only partially complied with his request, O'Shea alleges. "We didn't go into this expecting that kind of lawsuit," said O'Shea, a resident of Stockholm in Sussex County. "The public has a right to know these kinds of things." Under the state Open Public Records Act (OPRA), citizens are entitled to quick access to public documents, with several exceptions such as personnel records and documents related to ongoing investigations.

Citizens are entitled to a written response to their requests within seven business days. Most of the clerks reached Friday said they passed O'Shea's request on to the police departments that kept the records. "The police handle their own records," said Deborah Fehre, municipal clerk in Englewood Cliffs. "He gave the request to me, and I forwarded it to the police. I believe they were in contact with the proper authorities for guidance about what they actually were or weren't supposed to do." O'Shea said he got a call from the clerk's office in Englewood Cliffs after sending a reminder letter that a deadline to provide documents was approaching, but never heard back.

OPRA states that municipal clerks are considered custodians of records for municipalities, but that a municipality can designate other custodians, including the police chief, said Chris Donnelly, spokesman for the state Department of Community Affairs. Technicalities often hampered the requests. Marie Elena Macari, the clerk in Saddle River, said she told O'Shea that he had to use the borough's OPRA form. "I remember calling, and I said you had to fill it out on the forms the borough uses, and then I never heard a word ever again," Macari said. That didn't cut it for O'Shea. "The Saddle River clerk, as a custodian, is obligated under OPRA to respond to me in writing, not a phone call, and she didn't do that," he said.

The lawsuit, filed in state Superior Court in Hackensack, asks the court to compel the municipalities to turn over the records, pay legal fees and assess civil penalties on the municipalities and clerks.

Union Prosecutor requires faster approval of meeting minutes

On March 5, 2008, John Paff complained to the Union County Prosecutor regarding the length of time it takes the Springfield Township Committee to publicly disclose its meeting minutes. On March 8 he received a letter from Union County Assistant Prosecutor Ann R. Rubin.

John's position was that there is no lawful reason why meeting minutes need to be formally approved before public release. Ms. Rubin, however, focused on the excessive amount of time that elapses between the date a meeting is held and the date that the meeting's minutes are approved.

She determined that there is no reason why the Springfield Township Committee, which meets every two weeks, cannot have its meeting minutes prepared and ready for approval at the very next meeting. John would have preferred, of course, that she would have found that formal approval of meeting minutes is not a necessary prerequisite to publicly releasing them, but said her decision is "clearly a step in the right direction."
