## New Officers Elected, Bylaws Changed at Annual Picnic and General Meeting

Picnic goers enjoyed the beautiful amenities of Polanka Park on July 9<sup>th</sup>, 2005, and also tended to pressing business for the NJLP. Much needed changes to the party's bylaws were voted on, and three interim officers were replaced by newly elected State Chair Ken Chazotte, Vice Chair Jay Edgar (top right) and At-Large Representative Bull Hunsicker (middle right). The services of Interim Chair Ken Kaplan, Interim Vice Chair Pat Bontempo and Interim At-Large Jeannie Macron were acknowledged with gratitude. Helping the party was nothing new to these activists, and, their duties as "pinch hitters" at an end, Ken Kaplan writes on Page 4 that he has "no intention of lessening my commitment to achieve a more libertarian society in my lifetime".

## “THIS IS A TRUE LIBERTARIAN PICNIC”

SOUTH RIVER, NJ - That was the proclamation Jeff Pawlowski, the New Jersey Libertarian Party's Gubernatorial Candidate 2005, delivered to the membership assembled for its annual picnic and general meeting on Saturday, July 9, 2005.

“Welcome to Polanka Park: 17 acres of beautiful space”, said Jeff Pawlowski as he greeted NJLP members. “The government didn't spend one friggin' penny on this. This is what you call a 'home town effort'. And, this is why it's so symbolic that we're here”.

Polanka Park, where the NJLP held its 2005 annual picnic and summer general meeting, was wholly funded and constructed by Polish and other eastern European veterans of WWII. It is fully shaded, with several large gazebos and plenty of sheltered seating. Its facilities include a roasting/barbeque pit, dual kitchens, children's play area, restrooms, and ample parking. It is located a short distance from Interchange 9 of the NJ Turnpike, and can be reached easily by members from across the state.

Henry Koszalka, Commandant of Polanka, arrived at 6 AM to help Jeff set-up, and start roasting the pig. Henry lamented, “I fought war in Europe. I came to United States for freedom”. Many Polanka leaders were prisoners-of-war or interned in Russia's Siberian labor camps. Henry added, “Today, communism is going away in Europe; but communism is growing in America”. Henry is the father of Chris Koszalka. Chris ran for Sayreville Council last year along with Jeff; the NJLP supported their campaign.

Jeff explained how the picnic came together as a real collaborative libertarian effort.

“I said to Jay Boucher: ‘Jay, we ain't got no music’. So, Bob Hull brings an amplifier and speakers, and we have music. We didn't need a bonding issue!

“Then I asked Jay: ‘Jay, we ain't got no beer?’ So, Jay funded that. I saw we didn't have a pig, so, I funded that”. Jeff invited the crowd: “If anyone else wants to contribute, we got room for you!”

About 60 NJLP members, including their children and guests, attended the picnic. They dined on roast pork - hand-carved by Jeff - from a whole roast pig on a rotating spit. To ensure no one went hungry, there were also plenty of hamburgers, hot dogs, and potato salad. The picnic also served bottled water, soda, and genuine Polish beer to wash it all down. Several members commented favorably about the whole roast pig, insisting it was important for people to actually see where their food came from.

This general meeting had to be the longest one in NJLP history: nearly 4 hours! Yet every minute was necessary. The membership had to resolve issues raised by the May 15 Special meeting: they had to debate several proposed Bylaws amendments, and elect new officers to replace the interim officers. The assembly also had to conduct routine party business, officer and committee reports, county caucuses, etc.

The business meeting was divided into 2 parts - and it wasn't on the agenda! After the body discussed the NJ Ballot Access Lawsuit, and business rules, Jeff Pawlowski was asked to talk about how his campaign was going.

“The sun's out - it's a beautiful day! Yesterday, it was raining like anything”. Earlier that week, the temperature and humidity had been oppressive, and on Friday, remnants of Hurricane Cecil had soaked the area. Jeff's words had barely left his lips when clouds began to form, and a distant rumble of thunder was heard coming ever closer. Interim Chair Ken Kaplan called for a break in the meeting, so everyone could go eat without being drenched. It was a good thing he did.

Shortly after 3 PM, the skies opened as an unexpected thunderstorm loomed overhead. But the picnic wasn't a washout. After a nearly hour-long soil-soaking downpour, the clouds parted, and the sun beamed down once again. Within minutes, the ground dried out enough for children to run and play again, and everyone enjoyed the rest of the day.

Jeff continued talking about his run for Governor. "The campaign's on-board. We have an active Blog that's updated 6 to 7 days a week, and our web site gets 75-100 hits per day". While radio spots are being developed, Jeff issued a call-to-action to the members: "Everyone needs to send one letter-to-the-editor between now and Election Day".

Jeff described how personal his campaign is to him. "I just bought a new pickup truck. I paid \$1,500 in taxes. On the bill, I see '\$12.50 Tire Tax'. For 5 new tires, they charged me an extra \$2.50 tax per tire! This is double taxation!" Jeff was livid. "This is a crisis in NJ. The system's over; and it's time for a change". He shamed the members present: "If we don't make the difference, don't blame anyone else".

County caucuses were held, Bylaws amendments were debated, and elections were held to replace the interim leadership (see the Official Minutes section). A hat was passed for a contribution to the Morganville First Aid Squad. More than \$50 was collected; \$50 was allocated to thank them for allowing us to hold the May 15 Special Meeting there. A '50/50' raffle, run by several of the children, was held to raise money for the NJLP.

Mike Dixon, Chair of the Libertarian National Committee, attended the picnic and meeting. He reported on relations between the NJ and National LP, and commented on the 'Pawlowski for Governor 2005' Campaign. You can read Mr. Dixon's remarks in the accompanying story "Why Are You Up So Early?".

Despite an attack of killer mosquitoes, the party continued long into the evening. All food was consumed, including the entire pig from head-to-tail. The last guests finally bugged-out around 10 PM. Jeff, his wife Carol, and Jay cleaned-up, and closed the park by 11 PM. It was a long day. But, it was a great day! Everyone who came had a blast, and plans are already being made for next year's picnic and general meeting.

If you missed this picnic, you don't know what you missed. So make sure you set aside your weekends in July 2006, and we hope you can make it next year.

Our thanks to Polanka Park, Carol & Jeff Pawlowski, Chris & Henry Koszalka, Bob Hull, Jay Boucher, and others for their hard work to make this picnic such a great success.

## **"Why Are You Up So Early?" "I've Got To Go To New Jersey"**

It was 4 AM, and Mike Dixon, Chair of the Libertarian National Party, wasn't joking. His bags were packed. He said goodbye to his sleepy spouse and headed-out into the darkness. His destination: New Jersey.

Mike boarded a flight to Baltimore from his home in North Carolina. He then drove another 4 hours to attend the New Jersey Libertarian Party's annual meeting and picnic. The picnic was held at Polanka Park in South River, NJ, and was hosted by the 'Pawlowski for Governor 2005' Campaign.

"This is a great event!" said Mike Dixon. "Other states do this, too; but this is the best one I've ever seen. This is a place where families and their children can enjoy themselves". He wasn't exaggerating; nearly 60 people and their kids attended!

Mike didn't show up just to have a burger. He was there to shine a spotlight on the ONLY libertarian gubernatorial candidate in the country this year: 'Pawlowski for Governor 2005'.

"We have good people at National. But I told the staff that they wouldn't get any more support until they fixed the database. Well, the database problems have been fixed". Mike then offered the Pawlowski Campaign access to National's 20,000-member list.


"But New Jersey has its work cut out for it", said Mike. He was referring to a lawsuit the NJLP had entered into with other 3rd parties against NJ's draconian ballot access laws. "I think it's great that you're addressing this point. This is the kind of thing that could change the world of politics. You want to be the ones to make it happen".

Jeff Pawlowski then took a break from his hosting duties to join Mike at the meeting. Jeff reminded the audience that the 1st hurdle - petitioning and ballot access - had been surmounted. But, the 2nd hurdle - raising and spending sufficient funds to ensure that Jeff has a voice in the NJ Gubernatorial Debates - was far from complete.

"This is an easy crowd," Mike quipped. But, he spoke too soon. NJLP Life Member Tony Federici of Sussex County, rose to issue a challenge to Mike: "Have you made a donation to the Pawlowski Campaign, yet? If not, I will match any donation you make up to \$1,000.00".

Mike accepted Tony's challenge, and immediately pledged his own contribution. But, Mike stressed that he was speaking for himself, and that National could not officially endorse, fund, or get involved with any libertarian candidate.

## From the Chair



I have recently completed my term as Interim Chair, an opportunity that came about unexpectedly. I am gratified at the way the party came together in the face of adversity. We elected Ken Chazotte as the new Chair at the July general meeting, and I trust that a reinvigorated party will move forward toward the November elections under his stewardship.

I have a few reflections about the party that I want to convey to you. First, I want to emphasize that this has always been and remains an open party. If you have a concern about party activities or direction, communicate with your county representative or one of the officers, or attend meetings. New blood and new ideas are always welcome.

I have stepped down as Chair, but remain active as an Assembly candidate, and have no intention of lessening my commitment to achieve a more libertarian society in my lifetime. I look forward to working with all of you in the future.

## News from the Back Office (Wherever that is)

For those of you intrigued by internal operating procedures, I have good news: the NJLP and the National Office have made significant strides toward resolving our problems with our membership processes.

To recap for those of you just tuning in, the NJLP and the National Office had experienced problems with the processing of membership dues sent by the NJLP to National in 2004. In addition, National converted to a new membership data base system in late 2004, but the conversion was not done properly and the new system did not provide correct or useable information to state affiliates, like the NJLP. The data base problem was particularly serious for the NJLP because our by-laws recognize as NJLP members, anyone from New Jersey who pays dues and sends a membership statement to the National Party. The loss of useable data from National meant that the NJLP was slowly losing its ability to know its current members if they sent their dues to National instead of to us.

On our side of the equation, the NJLP has taken the following steps:

- 1) We have identified and resent dues to National for anyone who's membership was lost in process in 2004. If this is you and you haven't tried renewing again through us or the National Office, you should now have a membership that extends to July of 2006. If this was you and you renewed again sometime between then and now, you should be getting an extra year tacked on to your membership. Thanks to all of you for your continued support and patience while we worked this out.
- 2) The technical wizards who maintain our data base system and data base, have managed to work with National's data dumps to squeeze out the good stuff and process it into our data. They have joined a consortium of state affiliates to pool resources on working out some of the technical issues involved with processing these data. We are getting close to being able to once again process on a routine basis. Many thanks to Chris Weimann, Robert Hull and Jay Boucher for doing the heavy lifting on this part of the solution.
- 3) We have successfully completed one renewal cycle (and hopefully, by the time you read this, a second cycle): we sent dues and information to National; National processed and sent information back to us; we processed that information into our data base. It may not be rock and roll, but we like it anyway!

As for National's part, they have taken a lot of steps, including:


- 1) They have taken on new, qualified staff and trained them in the mysteries of processing memberships.
- 2) They have reworked their conversion from the old system, recovering much important information that had been lost in the original conversion.
- 3) They have rejoined the discussion groups where state affiliate data base people hobnob over data descriptors and record flags and such--things we mere mortals can only marvel at.
- 4) They have revised their data transmission to include really useful information for state affiliate parties and conducted a conference call on its proper use, care and feeding.

So the bottom line is we are almost there: we have survived the conversion and it is starting to look like it works!

Before I leave this scintillating topic, I need to offer my heartfelt thanks to Michael Dixon, the National Party Chairman, for traveling all the way from North Carolina to spend the day with us at the July picnic and General Meeting. Mike answered all of our questions about the membership problems and what National was doing to remedy them. It was a pleasure to meet him and chew the fat (after all, there was a whole pig roasting).

I also want to thank Dan Karlan for having the brilliant idea to invite Mr. Dixon to join us and making it happen. This seemingly small thing was like taking a giant step in improving communications between the leadership of the NJLP and the National Committee, and it was fun to boot. So kudos, Dan.

## Draft Minutes of the NJLP General Meeting of July 9, 2005

The meeting and picnic were held at Polanka Park, South River, NJ

A quorum being present Interim Chair Ken Kaplan called the meeting to order at 1:33 pm.

Approval of Agenda: Passed

The Steering Committee minutes of June 12, 2005 were approved.

The treasurer's report was received.

The Acting Chair welcomed Mike Dixon, LP chair, who had traveled to the meeting from his home in North Carolina.

Unfinished business.

RESOLVED: the NJLP donate \$50 to the Morganville First Aid Squad for the use of their building for the General Meeting of May 15, 2005. CARRIED.

Retainer Fee for Election Law Challenge. RESOLVED (John Paff, seconded by Dan Karlan): the NJLP authorize the Election Law Challenge committee (consisting of Elizabeth Macron, Len Flynn and Ken Kaplan) to negotiate the expenditure of up to \$4000 for challenging New Jersey's election law. CARRIED.

Procedure for conducting party business online. Karlan's motion to refer Ken Kaplan's motion to the Bylaws Committee CARRIED. RESOLVED; the Steering Committee shall pass no resolutions or make any decisions by email. CARRIED.

Campaign Report: Jeff Pawlowski thanked the membership for meeting the first challenge, getting him on the ballot. The next challenge is to raise \$300,000 so that he can participate in the gubernatorial debates. The campaign plans to run radio ads on 101.5 FM at \$450 a minute. In addition to donating to his campaign he asked every person present to write a letter to the editor mentioning his website.

Bylaws Committee Report. Bob Hull, committee chair, presented several proposed amendments.

1. The MOTION to change 5.c.4.c to read: The term of office for a County Representative shall be until the conclusion of the next State Convention or when successors are elected CARRIED.
2. The MOTION to change 5.d.1 to read: The Steering Committee shall consist of the NJLP Officers and three at-large members elected by the State Convention for a term to expire at the conclusion of the next State Convention or when successors are elected CARRIED.
3. The MOTION to change para. 6 (second sentence) to read: They shall be elected at the State Convention for a term to expire at the conclusion of the next State Convention or when successors are elected CARRIED.
4. The MOTION to delete the last sentence of Business Rule 8 CARRIED.
5. The MOTION to change 5.d.2 to replace "give advice and consent to" to "approve" CARRIED
6. The MOTION to add the following to Business Rule 2: No Officer or member of the Steering Committee or State Board shall be a candidate for public office FAILED and was replaced by the MOTION: Pursuant to N.J. Election Law no candidate for state or local office may participate in the management or control of the NJLP State Fund, which CARRIED.
7. The MOTION to add the following sentence to 5.c.5: Wherever Steering Committee approval is specified, State Board approval shall suffice CARRIED.
8. The MOTION to add the following to para. 14: The Standing Business Rules may be amended by a majority vote at any General Meeting was REFERRED to the Bylaws Committee.

## Draft Minutes, Continued

1. The MOTION to add 5.3 to read: Openness Policy

All NJLP meetings are open to NJLP members and such attendees may offer their comments on the business of the meeting, if time permits. On rare occasions when a meeting must deal with confidential matters, PART of a meeting may be closed for cause by a three-fourths vote. Members excluded by such an executive session shall be provided with an explanation for the exclusion and the remaining meeting participants will provide a summary of actions decided to those excluded after the executive session is concluded. Members of the public are usually welcomed to attend NJLP meetings as guests of NJLP members. Such guests may speak, if the members of the meeting by majority vote wish to hear the guest CARRIED.

10. The MOTION to change Business Rule 8.b to read: Newsletter Editor, who must be a member of the NJLP CARRIED.

11. The MOTION to add Business Rule 8.c to read: Announce e-list moderator, who must be a member of the NJLP CARRIED.

12. The MOTION to add Business Rule 8.d to read: Activists e-list moderator, who must be a member of the NJLP CARRIED.

13. The MOTION to add Business Rule 8.e to read: Candidates e-list moderator, who must be a member of the NJLP CARRIED.

14. The MOTION to add Business Rule 8.f to read: Webmaster, who must be a member of the NJLP CARRIED.

15. The MOTION to add Business Rule 8.g to read: Membership coordinator, who must be a member of the NJLP CARRIED.

16. The MOTION to add 5.f to read: Special Committees. Any Special Committee may be constituted by the submission to the Secretary of a petition containing the name and purpose of the committee to be formed, the composition of the committee (including Chair), the date at which the report of the Committee will be presented (after which the Committee will be discharged) and the signatures of \_\_\_% of the membership plus 5 members FAILED.

17. The amended MOTION to add a sentence to 5.d.2, to read: A financial review of the NJLP shall be conducted at least biannually under the direction of the Steering Committee and the results distributed at the subsequent State Convention CARRIED.

County caucuses: Middlesex, Somerset, and Union Counties elected Ray Babecki Middlesex county's representative to the State Board. Monmouth elected Dan Hurley State Board representative, pending his membership. Ocean County selected Pat Bontempo as its State Board Representative.

Motion to purchase printed copies of bylaws. Deferred to the next meeting.

Election of officers to replace interim officers (Chair, Vice Chair and Steering Committee member-at-large).

Ken Chazotte was nominated Chair.

A MOTION to suspend the rule requiring paper ballots CARRIED.

Ken Chazotte was elected Chair.

Bill Hunsicker and Jay Edgar were nominated Vice Chair. The first ballot was a tie, 11-11. Jay Edgar was elected 11 to 12 on the second ballot. None of the above received zero votes.

Bill Hunsicker was elected At-Large member to the Steering Committee. None of the above received zero votes.

Emerson Ellett thanked Ken Kaplan, Pat Bontempo and Jeanne Macron for their assistance to the party as Interim Chair, Vice Chair and At-Large member, respectively.

Because Bill Hunsicker was elected member At-Large he could no longer be Mercer County's representative to the State Board. A MOTION to suspend the rules to enable Mercer County to caucus CARRIED. Mercer elected Margaret Hunsicker Mercer's State Board representative, pending acknowledgement of the receipt of her membership.

### Announcements:

Len Flynn announced Project Full Slate, the goal being to field a full slate of 13 Congressional candidates for the 2006 U.S. House of Representatives.

The Middlesex, Somerset and Union County LP will meet July 15 at 7:30 pm at the Lone Star Steakhouse on US 22 in Scotch Plains.

PLAINSBORO The New Jersey Government Records Council found Thursday that Township Clerk Patricia Hullfish violated sections of the Open Public Records Act.

According to the council's findings, Ms. Hullfish violated the act by denying access to a copy of the Township Committee's executive session minutes without providing a specific explanation for the denial.

The Township Committee is permitted to deliberate in executive session on issues involving personnel, land acquisition and litigation, but minutes of those sessions are considered public records.

The state council also found the township does not violate OPRA with its practice of releasing public meeting minutes after they have been approved at the next month's meeting.

The state council typically handles 20 to 30 OPRA-related complaints at each of its monthly meetings.

John Paff, chairman of the Open Government Task Force for the Libertarian Party of Central New Jersey, filed the complaint against Plainsboro on Feb. 10 after the clerk failed to provide him with executive session minutes for Sept. 11, 2002, Sept. 25, 2002, and Oct. 27, 2004.

His task force goes to municipalities throughout the area and requests documents under OPRA.

"The main goal is to try to bring the towns into compliance," Mr. Paff said, noting that Plainsboro provides easier access to documents than many of the municipalities with which he has dealt.

Still, Mr. Paff said there is room for improvement in the township.

"I want to see it where when the average person comes in there, they're not dissuaded from seeing the information they have a right to see," he said.

Township Administrator Robert Sheehan did not comment on the council's findings, which he had not seen Monday. In general, he said, "We've always been very open about providing this information."

However, he noted, some government records are more sensitive than others.

"The release of certain closed-session information needs to be done carefully, because it could, in certain situations, disadvantage the township," Mr. Sheehan said.

Mayor Peter Cantu, who said the township is committed to complying with OPRA, also said the confidentiality of executive session minutes should be protected until the reason for confidentiality no longer exists.

"The reason it's done in executive session is to protect the community's interest," Mayor Cantu said.

Upon receipt of the Government Records Council's findings, the township clerk will have 10 business days to provide the requested executive session minutes, providing a detailed and lawful basis for each section that is left out.

## Developer built a house on Passaic man's vacant land

One day in January, Charlie Shennett, a 60-year-old disabled mechanic, went to Passaic City Hall to find out why he hadn't received a tax bill for the vacant lot he owned on Summer Street.

Shennett, who has lived in an apartment on Dayton Avenue in Passaic for decades, had dutifully paid taxes on the site of his childhood home since it burned down in 1987.

At the tax collector's office, Shennett was surprised to learn that he no longer owned the property. Without his knowledge, the city had taken it several months earlier as part of a redevelopment effort.

Later, he would discover the city set aside \$14,730 as compensation for him, then turned around and sold the lot for \$60,000 to developer Wayne Alston, a former city councilman who went to prison in the 1990s on corruption charges.

"I asked them, 'How can you do this to me? I paid my taxes,'" Shennett said. "They were like, 'We don't know, we don't know. It's the city.'

Everybody went running."

Shennett had no idea that he had become part of a raging debate over the use of eminent domain to remake urban America. Last month, the U.S. Supreme Court ruled in a Connecticut case, *Kelo vs. New London*, that towns have a right to take private property and hand it over to private developers.

The practice has become increasingly common in New Jersey, with towns turning their old industrial, warehouse or residential sections into large-scale development projects. Towns argue they need the threat of condemnation -- long used to take property to build roads, schools and other things -- to prevent a few holdout property owners from spoiling large-scale redevelopment plans.

In Passaic, the city has used its powers to lean on the owners of dozens of properties deemed to be rundown to force improvements. Mayor Samuel Rivera trumpeted this sprucing up of the city in his successful campaign for re-election this spring.

Attempts to reach Alston were unsuccessful, but an official at the Passaic Redevelopment Agency defended the taking of Shennett's property as part of the larger effort.

"I don't believe we stole this property," Donna Rendeiro, the agency's executive director, said in an interview. "We did what we were legally required to do. It wasn't for lack of trying that we failed to contact him."


