#### Libertarian candidate's fusion of Right and Left

Ask Kenneth Kaplan why he is the Libertarian Party's candidate for governor of New Jersey and he'll tell you he's a "child of the '60s" who "believes in individual liberties." In the category-defying case of the Libertarian Party, those range from doing away with most taxes and opposing gun control to approving same-sex marriage and legalizing the medical use of marijuana.

"Most Republicans and Democrats would say they believe in individual liberties, too, but they really don't," Kaplan said as he sat in his real estate office in Parsippany. "They believe in bigger government that controls more and more of what we do, and I don't believe in that. I believe in voluntary relationships between individuals rather than relationships imposed by the government."



The Libertarian Party's State Committee unanimously selected Kaplan, president of KenKap Realty Corp., as their candidate last month. It's an admittedly uphill climb: In the 2005 gubernatorial race, eight third-party candidates combined to claim just 3.5 percent of the votes cast. Kaplan is realistic about his chances. Talking about his youth in

West Orange, where he attended the Jewish Center of West Orange (now B'nai Shalom), he mentioned that he was president of United Synagogue Youth. "It was one of the few elections I won," he joked.

### Campaign Update: Kaplan for Governor

New Brunswick - On Sunday, April 26 the NJ Libertarian Party State Board unanimously selected Kenneth Kaplan to be the party's candidate for Governor. Born in Newark, the 61 year old Kaplan grew up in West Orange but currently resides in Parsippany. He is a graduate from Brandeis University and NYU Law School. For twenty-two years, he was associated with the Archie Schwartz Company but currently serves as President of KenKap Realty Corp., a company he founded after a six year term at Edgerton Realty.

As Governor, Kaplan's priorities are to phase out the state income tax and reduce the size and cost of government. Addressing affordable housing is one way he plans to solve this problem. Kaplan offers a creative solution to the decade's long quest to create affordable housing in New Jersey. He wants the state to enact legislation to supersede local zoning ordinances, removing zoning barriers.

"The current system prevents owners of single family homes from converting them to two family homes and the owners of two family homes from converting them to three families," stated Kaplan. "This will solve the affordable housing crisis not just for

But Kaplan is serious about the positions his party represents, many of which, he said, are derived from his own Jewish and political roots. Kaplan, 61, was born at Newark Beth Israel Medical Center. His grandfather had emigrated from Romania, rented a pushcart, and eventually owned a store. It evolved into a family business, Milt Kaplan's Men's Wear in Orange, which Kaplan ran after his father's death. "My parents lived through the Great Depression. That shaped them and that shaped me. I am careful with a dollar," the candidate said.

As he grew up in a family of New Deal Democrats, Kaplan said, he perceived Republicans "as a country club party that was not for Jews." I admired John Kennedy. I wanted to be elected president, and I thought it was important that a Catholic be elected if a Jew had any chance in the future.

"Then I admired Barry Goldwater, the 'conscience of a conservative."

In his first year of college at Franklin and Marshall in Pennsylvania, Kaplan helped organize a chapter of Hillel and was active in the movement to support Soviet Jewry. Currently he is a member of Temple Beth Shalom in Livingston and a board member of its men's club. "I have a long history of support of Jewish causes," he said.

After Kaplan transferred to Brandeis University in Massachusetts, he became an opponent of the war in Vietnam. He campaigned for Eugene McCarthy, the Minnesota senator who ran in the 1968 Democratic primaries against President Lyndon Johnson. But Kaplan said he became "very disillusioned" when the Democrats "abandoned the antiwar movement" that year.

#### 'The right thing to do'

Then, in 1973, he saw a Libertarian Party ad on television. It was for candidate Fran Youngstein, who was running for mayor of New York. "It was the fusion of everything I had ever believed in—the capitalism I got from Goldwater and the lifestyle liberalism I got from the Democratic Party," Kaplan recalled. "I said, 'Wow! That's it!' and I've been a Libertarian ever since."

Among the "key issues" on his platform is a proposal to abolish local restrictions preventing single-family homeowners from dividing up their properties into two- and three-family units. He would allow marijuana to be legally prescribed by a doctor for people with "cancer, multiple sclerosis, glaucoma, and other ailments. It is a humanitarian issue. I want the sick people who need it to get it."

He said he believes abortion "is a woman's decision between her and her doctor. However, it comes down to people's own views as to where and when life begins. I think reasonable people can disagree on that, but I don't think the state should be involved. But because some people do hold such strong views against it," Kaplan said, "I would not use tax dollars to pay for abortions."

And a strict believer in the Bill of Rights, Kaplan opposes gun control. "Religious freedom and freedom of speech and freedom of the press are all in danger if you start saying the Second Amendment is not an absolute. Then you can say, 'The First Amendment only applies to Christianity, not to Judaism or Islam."

Kaplan, a divorced father of two, is strongly in favor of legalizing same-sex marriage. He said he has "both an ideological and a personal interest in its passage. I think it is the right thing to do as a civil rights issue, and I have a son who is gay. Every Jewish parent can relate to the idea of wanting equality for their children, and I want equality for my son." His son, David, is an engineer in Baltimore. His daughter, Kimberly, lives in New York, where she is a staff member of ABC News' Nightline.

When the subject turns to Jewish causes, Kaplan again demonstrated a Libertarian's independent streak. He suggested that the New Jersey-Israel Commission, which fosters trade and cultural relationships between the state and the nation, "isn't necessary." He said: "Commercial interests need to represent themselves."

people moving into the new units, but also for the owners, many of whom might be senior citizens, who may now be able to remain in houses that had become too large and too expensive for their needs. This will solve the affordable housing problem without the expenditure of any tax dollars.

Kaplan also wants to address key issues, such as same-sex marriage, education, and healthcare. He would push for enactment of a marriage equality law to allow same sex couples to marry. "I see it as a civil rights issue, where all citizens should enjoy the same right," stated Kaplan.

Additionally, he also wants to see a state constitutional amendment to allow for greater flexibility in education. He views vouchers as an immediate way to give parents more choice in where their children attend school. Most importantly, Kaplan champions patients' rights and seeks to pass a law that would allow medical marijuana to be grown or purchased legally, when prescribed by a doctor.

According to Kaplan, "We have many people in New Jersey suffering the effects of cancer, multiple sclerosis, glaucoma, and other ailments. The humanitarian and compassionate thing to do is allow them legal access to a drug that could help them."

## 2009 NJLP State Convention Report

The meeting was called to order at 9:00 A.M on March 29, 2009 at the Wyndham Conference Center in Plainsboro, New Jersey. Quorum was satisfied by at least 15 convention delegates being present.

#### **Election of Party Officers and Candidates**

Sean Colón was elected State Chair, Walter Luers elected Vice Chair, Derek Demarco elected Secretary, Kevin Ferrizzi reelected Treasurer, and Ken Kaplan, Paul Tahan, and Jay Edgar were elected Members At-Large. In each case the NJLP membership without objection waived the secret ballot and all were elected by general consent over None of the Above (NOTA), who is the permanent opposition candidate in all NJLP elections.

At 9:45 A.M. a recess was taken for County Caucuses to elect County Officers and County Representatives to the NJLP State Board. At 10:20 A.M Sean Colón read the list of newly elected County Officers and Reps. submitted by the County Caucuses in attendance.

At 10:31 A.M. the delegates began the discussion about NJLP candidates for the 2009 election. Lou Jasikoff mentioned that Jason Scheurer and Jeff Pawlowski expressed interest in the nomination for Governor but neither could make a decision at the moment due to personal issues. Darryl Brooks spoke about his possible nomination for the candidacy of Governor.

Lou Jasikoff spoke about setting a date in the future for the officers to recommend who will be Governor. Sean Colón recommended two weeks to decide the Governor nominee. Lou Jasikoff recommended the date of April 30<sup>th</sup>. Kara Lysandra Colón recommended a questionnaire for the several candidates to answer. Jay Edgar recommended the formation of a committee to decide what questions will be on the questionnaire. Len Flynn stated that the bylaws provide that, if a candidate is not chosen at the NJLP convention, then the Steering Committee can choose a candidate for the vacant position."

Jay Edgar made a motion to table the nomination for Governor at the State Board Meeting, no later and form an ad-hoc

committee to create a questionnaire. Sean Colón called a vote on the motion made by Jay Edgar. The motion passed 16-2.

Sean Colón nominated Walter Luers to run for a seat on the Committee in Oxford Township as a New Jersey Libertarian Party candidate. Walter Luers responded and accepted Sean's nomination. Sean Colón called a vote to approve the nomination of Walter Luers as the candidate. Walter was accepted unanimously 18-0.

#### **New Business**

At 11:21 A.M. Jay Edgar read the three proposed changes to the Bylaws to be voted on as they were proposed and published in the Jan-March issue of the *N.J. Libertarian*. They are:

- 1. Remove the "Inc." from the name of the organization as specified in Article 1.
- 2. Split Article 2 into two distinct articles. The current first paragraph would remain as the entirety of Article 2: Purpose, while the remainder would be grouped under Article 3: Fiscal Policy. No changes to the content of the relocated section are proposed.
- 3. Add a self-reference to the protection of the Statement of Principles in (current) Article 3: Statement of Principles and Platform.

At 11:27 A.M. Len Flynn made a motion to vote an all three changes to the bylaws together. The motion passed unanimously 18-0.

Point of information: Trustees need not be elected anymore—the NJLP Bylaws define the Trustees as the three "junior" NJLP Officers (Vice-Chair, Treasurer, and Secretary).

Lieutenant Governor nominations were discussed. The two candidates are on one ticket and the Lieutenant Governor is not on the petitions.

At 11:49 A.M. Frank Warren made a motion to suspend the rules and revisit New Business to vote on the Governor and Lieutenant Governor candidates. Len Flynn seconded the motion and Ken Kaplan spoke against the motion. At 11:52 A.M. the motion failed by a clear majority vote of delegates by raised hands.

#### **Future Meetings**

At 11:53 A.M. Sean Colón discussed setting a meeting schedule and the next State Board meeting. A motion to adjourn was made and Jay Edgar seconded the motion. The next meeting will be a State Board meeting to be held at 1:00 P.M. on Sunday, April 26 at Tumulty's Pub 361 George Street, New Brunswick, NJ 08901, Tel: 732-545-6205. At 12:00 noon the meeting was adjourned.

## **Happy Earth Day!**

As a Scoutmaster and backpacker I care deeply for our natural environment. As a libertarian I realize that achieving a healthy environment requires policies that are rational and based on science and economics. This Earth Day I describe some effective and ineffective policies and practices.

#### The Industrial Revolution

In the 18th and 19th centuries, the world experienced an seismic shift in economies from a mostly agrarian economy to an economy based on manufacturing. Prior to the industrial revolution, farmers suffered long working hours for very little pay. Life in the cities was even worse. Our cities were overcrowded, sanitation barely existed, and cities were breeding grounds for cholera and yellow fever. People's diets were very limited. Smog and pollution from the limited heating choices of coal or wood filled the air above our cities.

Technologies like the steam engine and motor vehicles improved sanitation, increased food production, and improved the diet through faster transport and refrigeration. In 1798 Thomas Malthus predicted that we would not be able to feed a growing population, but he did not account for human ingenuity. Modern farming allows us to extract more food out of the land with less labor and less input. Between 1948 and 2004, agricultural output grew 170% while input (fertilizers and chemicals) has dropped 2%.

Better sanitation, a more varied food supply, more productive working hours, improvements in medical care, and a better environment have all contributed to changing the life expectancy of just 35 years in 1800, to 47 years in 1900, to 77 years today.

More importantly, the expansion of the economy has provided our society with the ability to be able to afford to take care of the environment. Globalization is now providing other countries with more wealth for them to protect their own environment.

#### **Effective and Enforceable Property Rights**

Proper stewardship of land and resources results in effective and enforceable property rights. Logging companies spend enormous amounts of money caring for and reseeding land they own. Clear cutting is avoided because it destroys the underlying soil. As property owners, these logging companies have a stake in the future value of the land they own. Around the world individual fishing quotas (IFQ's) are being found as the way to manage fish stocks.

#### The Endangered Species Act

In 1973, the United States enacted the Endangered Species Act. The problem with this law is that it creates a perverse incentive for landowner's to destroy habitat. The endangered species act has had very little success. Of the 1400 species placed on the list, only 8 have been saved.

#### Socialism

Whenever property is communally or governmentally owned environmental degradation occurs. Lack of property rights destroys any incentive to care for the land. Socialism lacks the market mechanisms that discourage excessive use of resources. If resources are running low, the bureaucratic planners simply demand that more of it gets mined. Socialist producers have no incentive to produce products efficiently. Waste is rampant. In a free market system, if the resources are low, the price goes up affecting demand, and conserving resources.

Here in the United States, the worst polluter by far is the federal government itself. The Department of Defense ignores environmental laws. Perchlorate, a by-product of rocket fuel, is leached out into the environment around hundreds of defense installations.

#### Conclusion

Libertarians believe that a clean safe environment is achievable. Polluters must be forced to clean up messes they make. Incentives matter. Policies that discourage environmental protection must be reformed. Socializing the costs of environmental remediation discourages individuals from behaving in ways that protect the environment. Innovations in manufacturing and resource use must be encouraged. A healthy environment requires a wealthy society.

## Fred Stein's Songs

#### Economic news is music to his ears

The state of the economy, in the past several months, has been a major focus of news reports, government policies, everyday conversations ... and **Fred Stein**'s lyrics. The singer/songwriter, who also plays the acoustic guitar, says he has been performing and selling his CDs in coffee shops and on college campuses for the past 10 years. A real estate appraiser by day, Stein says his purpose in writing music is to make a better world where people can communicate, do things voluntarily, help others and try to stimulate the economy through free trade and a free market. The South Brunswick resident says his musical influences include

the Beatles, the Rolling Stones, the Who, Motown classics and, more recently, Flight of the Conchords.

Stein talked to The Star-Ledger about his songwriting. What made you decide to focus on the economy in your songs? "I do write some romantic songs, but when people get married or are no longer in the singles market, one of the most important things is money. The economy is a very major factor in our society, especially now because everyone's concerned about losing their job. The world is more unpredictable now. It's moving at a much faster pace."

"Some of my song titles include 'At The Mall,' 'Billionaire,' 'She's The Shopper,' 'Working All The Time and 'Yield Bond Curve.' What are the topics of some of your other songs? "I wrote a song called 'Connected,' which warns people about technology. I believe technology is good, but sometimes it keeps people from interacting on a human scale. People wouldn't say bad things about a person in person, but on the computer they may not be as polite or civil. Also, with technology you never get to leave the workplace. You can never really get away and enjoy yourself during leisure time. I finished my first CD in August 2001 and my second in October 2008. On both of my CDs, I have songs about cats. That's something no other musician is writing about. I also have a song promoting the Shore town Keansburg. Another song, titled 'Turn your Enemies into Friends,' I believe could be the answer to war and a step toward world peace...."

## John Paff's Dilemma—"Mission Creep?"

On April 23, 2009 John reported to the NJLP leadership by email about his recent project in which he posted a new type of issue on some of the public blogs. The new category involves appeals filed by municipal and county civil service employees because of discipline imposed upon them. See the example of his posting below.

I am advising the activists and officers of this in case there are any objections. I realize that just because something is public information doesn't automatically mean that posting it is a good thing, politically, for the Libertarian Party to do.

#### **Hamilton Police Lieutenant Appeals Suspension**

In an appeal filed earlier this year, Hamilton Police Lieutenant Lawrence M. Sweeney contested discipline--probably a suspension--imposed against him for "verbally berating" a female "Public Safety Telecommunicator" named Laurel MacKenzie. According to "charges and specification" leveled against Sweeney, he is accused of berating MacKenzie on October 27, 2007 "over the volume of the television while a priority job was taking place on the street." The "charges and specification" are on-line at

While it is not completely clear, it appears that Lieutenant Sweeney was disciplined for yelling at a dispatcher who had the television on too loud while on duty. Sweeney and MacKenzie are listed on Gannett's "DataUniverse" site as having been in public service for 20 and 25 years and having made \$120,328 and \$55,136 in 2007, respectively.

Even though the incident occurred in 2007, the appeal was filed with the State Department of Personnel in December 2008 and transferred to the Office of Administrative Law (OAL) in early 2009. The OAL has assigned Docket No. CSV198-09 to the case, and, unless it settles, the matter will eventually be heard by an administrative judge, who will make a recommendation to the Department of Personnel affirming, modifying or reversing the discipline that Hamilton imposed.

#### ABOUT ME AND WHY I'M POSTING THIS

I chair the New Jersey Libertarian Party's Open Government Advocacy Project which seeks to increase governmental transparency and accountability, particularly at a local level.

As part of my work, I routinely check administrative Civil Service appeal dockets. Most often, the public does not get to see these records. I post them on-line for several reasons: a) because they sometimes reveal official wrongdoing by a government employee, b) because they sometimes suggest that a government agency is using the disciplinary process to retaliate (i.e. file trumped up charges) against an politically or otherwise unpopular employee and c) because these appeals and the underlying disciplinary charges cost public money and the taxpayers ought to be aware of how their money is being spent.

John, for what it's worth, I can't imagine that this would be objectionable. In fact, I think that the privacy implications of this are rather less than the publicizing that you've already been doing. That is, finding that (say) a town council disciplined a maintenance worker would "out" that employee. On the other

hand, publicizing that worker's appeal might serve as a bit of vindication for him, allowing him to air his side of the story.

So doing this provides balance so that we aren't subject to a claim that we're on a witch hunt against public workers. This is really an additional check on the government institutions themselves by shedding light, as you say, on retaliation against whistleblowers. To this degree, it actually supports the rights of those public workers.

## **Tribute to Billy Ver Planck**

Long time NJLP member J. Billy Ver Planck fought a year-long battle with lung cancer and died peacefully in Hackensack Hospital on Tuesday, June 2, 2009. Known as Billy throughout the music world, he was born in Norwalk Ct. in 1930. He began his musical career at age fifteen playing trombone with the Jess Stacey Band. He went on to play and write arrangements for all the big bands of his generation, culminating his road days with his idol, Tommy Dorsey. For the next forty years he was one of the busiest studio arrangers and conductors in New York, writing everything from jingles, films, and documentaries, as well as producing 20 CDs and hundreds of arrangements for his wife, singer Marlene Ver Planck.



Billy and Marlene were virtually inseparable for 52 years. They loved working in many countries and traveling the world together. Billy enjoyed life to the fullest, and he was a relentless fan of the New York Mets. Plus his biography declares "He was a diehard advocate of free enterprise and tried to convert anyone who would listen to his beliefs."

#### Here is what Billy wrote supporting the NJLP in 2006:

Life means one can do what is peaceful and creative as long as he respects others with these same rights. Private Property is the complete use and disposal of what is yours that you have obtained through honest work or trade with consenting others. As we live in today's America the United States government has by default become the legalized version of the criminal gang.


