#### Recent Court Ruling Holds Great Potential By Pat Bontempo, Monmouth County Chair

New Jersey Libertarians won a significant victory, and our party gained an important organizing tool in September when the Appellate Division of Superior Court ruled we have the right to register as Libertarians. Unfortunately procedures for implementing the ruling have yet to be put in place.

Until now, voters have only been able to register as Democrats, Republicans, Independents or Unaffiliated. This has been a serious handicap for us.

At our peak we have about 80 current, dues-paying members here in Monmouth County. With no little work we've been able to keep track of lapsed members and those contacting us for information, giving us a mailing list of a few hundred.

But this is only the tip of the iceberg. Last year, for example, well over 3,000 Monmouth County voters pulled the LP lever for our Freeholder candidate, Len Flynn. Past returns indicate we have a base of support of at about 1.4% of the county electorate.

Who are these people? We have no idea. We have no way to identify them and contact them to let them know about our candidates in the next election or to invite them to join in the process of building the Libertarian Party here in Monmouth County.

To be sure, many of these are protest votes. And it would be naive at best to think that even most of those voters would ever register as Libertarians. The overwhelming majority of Democrats and Republicans don't even register as such.

But if just 5% did, for example, that would be 150 newly identified Monmouth County libertarians. That's close to double our peak membership. And the county would keep track of them as they moved and we would be able to obtain an up-to-date registration list for organizing purposes.

In September of last year a lower court ruled in favor of granting us the right to so register. It was part of a lawsuit brought by the Coalition of Alternative Political Parties and individual plaintiffs, of which Libertarians were a part. Its significance is demonstrated by the fact that not only did the State of New Jersey appeal that ruling; it was joined by the Republican and Democratic State Committees.

On Sept. 10 the Appellate Division of Superior Court upheld that lower court ruling. A recent check with the Monmouth County Board of Elections, however, revealed that the administrative procedures county boards will have to follow to implement this ruling have not yet been promulgated.

## Why Democrats and Republicans Hope Libertarians Won't Fill County Election Slates



We've won the right to register as Libertarians! The Attorney General declined to appeal the unanimous appellate court decision upholding that right, and on September 10 the ruling became final.

But we can't stop now.

Our next legal battle will be to challenge the Democrat and Republicans' exclusive use of columns 1 and 2 on the ballot. But in order to overturn that particular odious privilege our lawyers need legal standing to challenge the law. A full slate of Libertarian candidates will constitute standing. With a full slate in hand the lawyers representing the Council of Alternative Political Parties, of which the NJLP is a member, can argue that the election law reserving the first two ballot columns to Rs and Ds is clearly discriminatory and therefore unconstitutional. That victory would be a major milestone because the first ballot position is allegedly worth 3% of the votes cast. An additional 3% of the vote would help us toward the 10% rule that will qualify us as a political party as defined by NJ election law. It could even help us to lower or knock down the 10% threshold altogether.

In 2002 a full slate will consist of U.S. Senate and House candidates and all state or county offices up for election in a particular county.

Local candidates do not count toward a full slate for this purpose because they are listed on separate municipal ballots only. That is not to say that we don't value local candidates. We desperately need local candidates too!

Our registration victory was made possible only because we have run county, state and federal candidates over a period of many years. Our lawyers cited that fact in their successful brief that permits voters to register as members of a party other than D or R. We owe a tremendous debt of gratitude to the candidates who ran in the past, and to those who ran this year.

So hats off to our 2001 candidates: Tom Abrams, Jay Boucher, Jennifer Carter, Jay Edgar, Mark Edgerton, Diane Hittner, Robert Hull, John Taylor and Chris Toto. They also have helped strengthen our hand in the legal battle for electoral freedom.

The question is: which counties will give us legal standing? Which counties will field a full slate of candidates in 2002? Monmouth County under Chair Pat Bontempo and Election Coordinator Jay Edgar is definitely a contender; they fielded candidates for six of eight offices this year. Ned Kelley has pledged that Hunterdon County will surely try. But what about our other counties? The more full slates we can muster the stronger our case will be. Contact your county chair (see page 18 for listing) and help get the ball rolling today.

## Citizens must comply with police instructions By John Paff

TRENTON - On September 28, 2001, the Appellate Division held that a citizen attending a public meeting must leave that meeting when so instructed by police, even if he has good reason to believe that the police officer's instructions are based on incorrect information or are otherwise unreasonable.

While addressing the Teaneck Town Council last year, William Brennan got into a heated exchange with the mayor and members of the council. The mayor ordered Brennan to sit down because his allotted three minutes had expired. Brennan, claiming that council members interrupting him had used much of his three minutes up, refused to sit down until he was finished speaking. Heated exchanges continued. Finally, Brennan sat down. The meeting went into recess.

The mayor pushed a silent alarm button under his desk and the police arrived. One of the officers testified that the mayor told him that "Mr. Brennan was acting irrational and that they had to stop the Council meeting and that they wanted -- they wanted him to be removed from the meeting. . . [and that]. . . Mr. Brennan had gone beyond his allotted time, was using obscenities and using an alarming conduct of voice towards the Council members, and that he was interfering with the meeting and that, you know, they would like him to leave the meeting." The police admitted that they did no further investigation and accepted as true what mayor had told them.

Several times, the officers asked Mr. Brennan to leave the meeting and told him that he would be arrested if he didn't obey. Brennan was defiant, stating that he "had a right to be there" and that the police would "have to drag [him] out." Brennan was arrested, handcuffed and removed from the meeting. He was charged with Defiant Trespass and Disrupting a Meeting. He was later acquitted of the Disrupting Charge and convicted for Defiant Trespass, which conviction was appealed.

Brennan's main issue on appeal was whether he had actually been been disruptive and whether the mayor and council acted unreasonably or maliciously by asking police to remove him from the meeting. The Appellate Division ruled that unless the police used excessive force, Brennan was obliged to follow police instructions, even if they were based upon faulty information or the mayor's impure motives. The court summed it up as follows: "A private citizen may not resist an announced arrest by one he knows to be an authorized police officer, even if the arrest is illegal under the particular circumstances."

According to the Court, even if the "mayor's scenario [as he explained it to the police] was inaccurate or ill-motivated, defendant had remedies available to him through appropriate legal channels. Similarly, if defendant's First Amendment rights were impinged by his removal from the meeting, that deprivation could be addressed at a later time. The remedy that was not available to defendant was the defiance of a police officer's direction given in the lawful course of the officer's employment."

#### **Learning from the Edgerton Campaign**

Former Campaign Manager Takes a Hard Look

There were a number of mistakes made during Mark Edgerton's gubernatorial campaign. This summary should help to keep libertarians from repeating these mistakes in the future. Appropriately, there are 13 major categories of blunders.

- 1. Fundraising
- 2. Knowing Your Opponents
- 3. Treatment of Volunteers
- 4. Doing Dirty and Grunt Work
- 5. Letting members know what is going on
- 6. Reality versus Delusion & Arrogance
- 7. There are no magic bullets
- 8. Knowing what you do not know
- 9. Campaign Organization & Planning

- 12. Positions on Issues
- 13. Practicing how you sound to the media & public

#### 1. Fundraising

Mark thought fundraising was beneath him. The candidate must be the main fundraiser. The candidate must work hard at fundraising. This is probably the most unpleasant aspect of campaigning, but if a candidate is not willing to put lots of time and effort into fundraising, the chances of success decline dramatically.

Fundraising must start as soon as the campaign starts. Edgerton's campaign went on for four years, and he did ask for small contributions early on, which was very good, but there was no follow up. Several of us got together on March 6th, 2000 at Ed Weissmann's (the party chair at that time) behest to write a fundraiser for Mark. We wrote one, but Mark for various reasons, none of them valid, decided against sending out the fundraiser.

Fundraising has to begin at the beginning of the campaign and continue throughout the campaign. Also, the campaign *must* send thank you notes to all contributors. I asked Mark if he had done that, and he said no and that he was not interested in doing it.

#### 2. Knowing your opponents

You must know who your opponents are and where they stand on the issues. When I asked Mark what he would do if Schundler won the primary, he stated that Schundler did not have a chance in the world and that it would not change his campaign anyway. As a third party candidate, you win votes and influence people by where you stand on the issues and how different your positions are from the other candidates. Of course, not knowing where your opposition stands on the issues basically sabotages your own campaign.

Look at McGreevy. After Schundler won the primary, he had to completely change his campaign to fit Schundler, rather than Franks. To do otherwise would have been suicidal. He came up with a plan to portray Bret as an extremist and excuted the plan very well. Schundler, although vastly outspent and sabotaged by DiFrancesco, blundered in his plan by backing down and saying, 'please, I am not that extreme.' He should have stated that if choosing a school is extremist, if letting people keep more of their own money is extremist, if letting law abiding citizens defend themselves is extremist, then I am proud to be an extremist.

Campaigns do not take place in a vacuum. It is critically important to respond to your opponents attacks and positions.

#### 3. Treatment of Volunteers

This was one of Mark's biggest failures. One statement he made to me said it all. I said, "Mark, not all volunteers will have the same level of enthusiasm as you do about your campaign." Mark replied, "Well, I do not want those people working on my campaign then." He got his wish! Mark was rude, arrogant and demanding of unpaid volunteers. He would often lose his temper and yell and scream at them. He expected them to do all the dirty work while he went and made speeches in front of important people and large groups. As I stated before, the crewman on the H.M.S. Bounty were treated as well by Captain Bligh as Mark treated his campaign workers.

This is a recipe for disaster. Like Captain Bligh, Mark ended up in a tiny boat with few supporters in a huge political ocean, where he garnered just .22% of the vote.

Volunteers are a campaign's most important asset. They are very easy to lose and alienate and very hard to find and motivate. They must be treated as customers, because that is what they are. They are the most important customers, along with contributors, that are buying into the candidate's campaign. If a business treated its customers the way Mark treated his 'customers' it would be out of business in no time, as was his campaign.

#### 4. Doing Dirty & Grunt Work

Mark thought that all dirty and grunt work was beneath him. He adamantly stated that his only duty was to put his face in front of people, and that others had to do all the dirty and grunt work. This arrogant and elitist attitude, treating volunteers as peons to serve the candidate wouldn't fly in the major parties, never mind in a group of individualistic libertarians.

In order to successfully launch a campaign, the candidate and his immediate staff must do almost all the necessary dirty and grunt work to get the campaign off the ground. Mark was too busy to even help to stuff envelopes for his fundraiser. Needless to say, with Mark's attitude, much of the essential dirty and grunt work never did get done and Mark's campaign never did get off the ground, never mind soaring into the atmosphere.

#### 5. Letting members know what is going on

While Mark's campaign manager, I stated it was very important to let members know what was going on, what our campaign plans and strategies were. This is of course necessary to get contributions and volunteers and to motivate the volunteers. Mark absolutely and adamantly refused. He stated that the Republicans and Democrats would use this information to sabotage his campaign. Besides being delusional and arrogant, it is dead wrong.

The lesson learned here (I learned it five years ago in East Brunswick!) is that you must follow a police officer's "reasonable" order even if you're sure that you have a legal right to do what you're doing. You must obey, and then sue in civil court for the deprivation of your rights.

One small problem arises. The officer may later claim that his or her spoken words were not really an "order" but rather a "request" that you could have complied with or ignored at your option. If the court believes the officer, it may dismiss your suit for "lack of standing" even if your facts are otherwise correct.

I suppose then, that before obeying or defying a police instruction, one should ask the officer, in front of witnesses, to clarify whether his or her spoken words are in the nature of a "request" or an "order." Beware, however, that that question, in itself, may be considered "defiance" justifying arrest.

#### As sheriff, they will answer the public

Somerset hopefuls agree to field questions

With a little nudging from a legal watchdog, both candidates for Somerset County sheriff have agreed to unprecedented public accountability, although with different limitations.

When Republican Frank Provenzano and Democrat Richard Z. Voorhees visited the Somerset County 4-H fair in August, John Paff of Franklin Township buttonholed them about his idea.

Paff suggested the sheriff appear regularly at freeholder meetings to answer questions. Over the years, sheriffs have occasionally appeared at the meetings but usually at budget time for brief discussions on spending.

"While this might not seem such a big deal at first blush, I don't ever recall having the opportunity to pigeonhole the sheriff with a hot question at any public event with media in attendance," Paff said.

Over the years, Paff has raised plenty of questions in public. He sparred for years with county and state officials over the forfeiture policies of former Somerset Prosecutor Nicholas Bissell, who eventually was convicted on federal corruption charges and killed himself.

As an elected official, the sheriff also should appear regularly at public meetings to field questions on whatever comes up, Paff said. "People are already at the freeholder meetings," making that the logical forum, he said.

Voorhees, a former Bridgewater police chief currently serving as undersheriff, called a public question-and-answer session "a great idea".

"It's important that we have communication between the public and the sheriff's department, and the freeholders too," Voorhees said.

Provenzano, a retired Bridgewater police captain, said the sheriff does not necessarily need to attend freeholder meetings but should use other means to reach the public.

"From time to time when things are occurring in the sheriff's department, we will hold press conferences," Provenzano said.

To improve morale, the sheriff should highlight promotions and also outline new programs, such as his proposal to assign officers to a county fugitive task force, he said.

But Paff said that's only a start. In a September 24th letter, Provenzano wrote, "I am committed to holding open town hall style meetings," and Paff said that is what he expects.

Voorhees has proposed increased security measures at county facilities, and said he would limit the information given out about them. But other program or personnel changes are fair game, and residents should be able to put questions directly to the sheriff like they do to the freeholders, he said.

First, the Republicans and Democrats are arrogant and would probably totally ignore Mark if he ran a real campaign with real money. They are concerned with each other, not a Libertarian.

Second, even if the Republicans or Democrats tried to sabotage Mark's campaign, he is assuming that they would do something intelligent that might actually hurt that campaign. Odds are that anything they did would give Mark more publicity and help his campaign by making any voters paying attention angry. So Mark's adamant stand on this issue was dead wrong in multiple ways.

#### 6. Reality versus Delusion & Arrogance

There is a big difference between a positive attitude and delusional arrogance. Mark thought that once he had been anointed as our gubernatorial candidate, the libertarian masses would swarm around him like obedient worker bees and exhaust themselves to get him elected. He never realized that he had to do anything like motivate them and treat them well and give them something to work for. I have more respect for Murray Sabrin four years ago. He worked extremely hard in a short period of time to raise a lot of money and get a campaign off the ground. Most of us did not realize the time and effort that required. Mark thought that since he had 4 years and Murray only had 6 months, that it would be a cakewalk, and that all he had to do was fun things like show his face and make speeches. And of course asking for money was beneath such an exalted candidate as Mark.

#### 7. There are no magic bullets

Mark had the idea that if he hired Doug Freidline, Doug would make Mark the Governor. It takes a lot more than a good campaign manager to make a good campaign. Mark thought that any campaign planning he did before Doug came on board was wasted effort, since Doug would know best. Mark also stated that he would do whatever Doug told him to do. Mark stated that if Doug told him to jump off a bridge, he would ask Doug if he should jump head first or feet first. This was not the case at all. Mark still mostly did what he thought was best anyway, listening to Doug only slightly more than he listened to me.

#### 8. Knowing what you do not know

Let me be blunt. Mark knew next to nothing about running a campaign. Most of what he thought he did know was wrong. The few times I talked with Doug Freidline, we were mostly in agreement on what should be done, but on this issue we were in total agreement. The following is just a partial list of what Mark thought was necessary. Next to each of Mark's convictions is the reason that he was dead wrong. Doug told Mark about many of these things, but Mark would not change.

- **A.** Always appear in a suit. This makes you appear elitist
- B. Never eat or drink in public. This makes you appear elitist & aloof
- C. Don't let members know what is going on Makes it very difficult to get contributions and volunteers if there is no information to motivate the contributors or volunteers.
- **D.** Be vague on issues This may work for a Democrat with no Republican opposition or vice-versa, but for a third party candidate trying to change voters' minds, it is suicidal and moronic. If we are the party of ideas and principals and you do not enunciate any ideas or principals, how are you going to influence anyone to vote for us?

#### 9. Campaign Organization & Planning

Campaign organizing and planning is not rocket science. For real political campaigns, there are a number of tasks that should always be done. Mark thought that no one in the Libertarian Party was capable of running his campaign, since no one in our party had won a race. He thought that hiring Doug Freidline would instantly solve all these problems. What he did not realize was that even an excellent campaign manager needs an organization and a basic plan, especially if the manager is out of state. After three years of campaigning, when Mark had no money, no organization, no plan and few volunteers, it became obvious to many people that Mark's campaign was floundering badly. At this point, with many potential supporters and volunteers already insulted, turned off or skeptical, even a Doug Freidline could not save it.

There are a number of basic laws in campaigning that never change. Things that involve organization, volunteers and fundraising are often constant between any real campaigns for any parties. What differs is the message and how that message is delivered.

When you start a campaign, the first thing you do is have a campaign plan. Then you start fundraising to implement that plan. Then you get an organization to implement your plan. Last year at this time, after three years of campaigning, Mark had no plan, no organization and no fundraising. Even though I told him that this should have been done long ago, he would not do it. He was waiting for Doug Freidline to save the day. Unfortunately, Doug was only human and was unable to jump start a campaign from scratch, especially a campaign that was already more than three years old.

#### 10. Campaign Colors

I had told Mark that he needed 'different' colors for his signs and other campaign literature. He refused, stating that he was going with Red; White and Blue like the Republicans and Democrats. Only when Doug Freidline agreed with me, did Mark consider changing his colors. As a tiny third party, your campaign needs to be different to get noticed.

#### 11. Campaign Websites and obscure political Internet sites

When I was briefly Mark's campaign manager, he was constantly asked me to log onto obscure political websites and write messages about how wonderful Mark was, messages that no one but a few wienies would ever read. He wanted a county coordinator for each county of some obscure web site. At that time, Mark's own website was a mess as far as content was concerned. Mark or someone like me had to enter interesting and pertinent content, but Mark was totally uninterested in his own website, but fanatical about writing messages that no one would ever read on obscurepolitics.com.

Today, your website is one of your most important advertisements. It is critical to have a professional website with content that will make voters take notice of libertarian ideas and principles. In the end, Mark had a professional website, but its content was bland and designed so that no one, even a dedicated totalitarian socialist, would be offended. I am sure that Mark's website did not offend anyone, but it inspired no one, and it certainly did not motivate any libertarians either.

It appears the best the county board can do is provide anyone who asks with a postcard-size form in which you indicate you want to switch registration and how. Its wording seems inappropriate for our purposes, since it refers to primary elections, but that is what you get. When you hand it in your change of registration is held pending future directions from above.

Presently about four Monmouth County voters have indicated a desire to be registered as Libertarians, presumably all party members. Anyone who wants one of these forms can contact Pat Bontempo (775-7263; PDB10752@aol.com; 315 8th Ave., No. 208, Asbury Park NJ 07712).

Having members register is of limited benefit. True, it will help us keep track of them as they move or as their memberships lapse. But what we really need is to be able to get as many as possible of that larger group of Libertarian voters to register.

That will have to wait until final registration procedures are put in place. Once that is done we can start letting the general public know, and clearly they will not find out unless we tell them.

Nonetheless members are encouraged to request a change in their voter registration. If less than a handful does so it could appear that the arguments made in the lawsuit were hollow. If many do so it could constitute pressure on the State Division of Elections to put appropriate procedures in place quickly.

This victory in court will not automatically translate into a victory at the polls. But it is a building block in the pricess of constructing a viable Libertarian Party here in Monmouth County and throughout New Jersey.

#### 12. Positions on issues

Mark had no positions on any issues except the Drug War. Doug Freidline and I agreed that it was of critical importance to have a specific education plan. Mark had no specifics on any issues. I do not know why he thought he could change peoples' minds when he did not offer anything different from a typical sleazy and vague major party politician.

#### 13. Practicing how you sound to the media & the public

If you are running a real campaign, you must practice how you will sound in the public and with the media. About June, Mark called me up and asked me to listen to an interview he did. Bret Schundler did a similar interview. Mark stated he did much better than Bret. Another Libertarian called me and stated that Mark sounded awful. He was vague and evasive and was someone he would never vote for, if this were his first introduction to the candidate. He thought Bret did a much better job. I listened and agreed. Mark was the type of weasly, vague politician that I cannot stand. Mark evaded answering the questions, no matter how many times the interviewer asked them. I asked another Libertarian to listen to the interview. He got so disgusted with Mark and thought Mark was so awful that he could only listen to 1/3 of the interview before he turned it off.

Anyone can have delusions about what sounds good. That is why it is critical to review and practice your speeches and interviews with others, including non-libertarians.

#### **Monmouth County Results Show A Small Improvement**

Vote totals for the Libertarian Party candidates for Monmouth County Freeholder and Sheriff in the November 6th General Election showed a small improvement as the party fielded a particularly strong local ticket.

In the past few races the LP countywide candidates have received about 1.4% of the vote. This time Freeholder candidates Jennifer Carter and Jay Edgar won 1.73% of the vote polling 3,352 and 2,504 votes respectively. Sheriff candidate Jay Boucher received 1.64% of the total or 2,839 votes.

Once again Upper Freehold Township gave us strong support. Carter and Edgar, who are from the Cream Ridge section, won 4.7% while Boucher polled 4.5%. Our countywide candidates, in fact, fared best in the 30th District, which includes Upper Freehold, which gave us 3.12% of the Freeholder vote and 3.15% of the Sheriff vote. Results from all five Monmouth municipalities in the district were well above average.

Other good showings in the Freeholder race included Farmingdale, 3.8%; Shrewsbury Twp., 3.4%; Howell, 3.1% and Millstone, 3.1%. In the Sheriff's race the other top towns were Long Branch, 5.1%; Englishtown, 4.9%; Farmingdale, 3.8% and Shrewsbury Twp., 3.7%.

In Tinton Falls Boucher's 90 votes were greater than the margin of difference between the locally victorious Democrat (2,144) and the Republican (2,129). Countywide Republican Joe Oxley won the race.

In the 11th District Assembly race Robert Hull received 673 votes and John M. Taylor 657 for 1.14% of the total. The Republicans won with 55.42% followed by the Democrats at 42.95%. An Independent received .49%. In the 13th District Diane Hittner, who ran without a running mate, won 867 votes or .74%

While not fielding a full slate, the ticket was strong enough to win us Column Three on the ballot. That plus the lack of third-party opposition in the countywide races helped boost the final numbers. It also gained us a dramatic increase in press attention this year.

In the balloting for Governor, Mark Edgerton received 694 votes in Monmouth County, the most raw numbers of any New Jersey county, or .4% of the vote. According to figures available at this writing Edgerton received 4,613 votes statewide or .2%.

It appears the fuller ticket we had in some legislative districts did not significantly help vote totals for our Freeholder and Sheriff candidates who were on the ballot in every municipality in the county. For example the five towns in the 30th District (Allentown, Farmingdale, Howell, Roosevelt and Upper Freehold) produced returns well above the countywide average in both races despite the lack of Assembly candidates: 3.15% versus 1.64% for Sheriff and 3.12% versus 1.73% for Freeholder.

Similarly the 12th District municipalities (again, no Assembly candidates) gave our Freeholder candidates 1.95%. It appears other factors were far more important. For example that our Freeholder candidates came from Cream Ridge and received good press coverage throughout the district helped. And no doubt having the third column boosted vote totals across the board. It should be noted, however, that having the fuller ticket is what gained us that third column.

Dear Mercer Libertarians and Friends,

Tom Abrams and I thank you for your votes. While we didn't get huge vote totals this time out, we did achieve some notable "new positives" that have not happened in Mercer before. My web site for local issues platform and policy commentary is <a href="http://members.aol.com/votetoto/index.htm">http://members.aol.com/votetoto/index.htm</a>>.

Tom and I ran in the 15th district. No one volunteered for the 14th district except Ray Cragle but we didn't get word about Windsor getting switched to the 14th district until Ray had collected all his petitions signatures for the 15th district. Ray started out with the idea that his residence in West Windsor meant he lived in and could run in the 15th. Despite several calls to the NJELEC and the County, we got no word till the last minute. Just another fringe benefit of our modern official "bureaugeoisie" class, one more official screwing to rob us of electoral opportunity. The Fifteenth District includes all of Mercer, even Schluter's hometown in Hopewell Twp, which used to be part of the old 23rd district that ran up into Hunterdon County. The 14th district is now mostly Hamilton Twp, Hightstown and the Windsors.

No Libertarian candidates have run simultaneously in Mercer for Governor, Senator and Assemblyman within memory, if ever. This year was a first. No LP candidate in Mercer ever had a web site before, never had a platform based on local NJ issues, never had a flyer based on such issues. We basically never had any specific publicly posted policy answers to local/state problems before. More new "firsts."

The ballot arrangement for our area was good, as it placed Tom Abrams for Senate directly above my own name for Assembly. If there is a next time for  $\epsilon$  gubernatorial candidate, we will ask the County clerk to either group all Libertarians next to each other, or will ask for a separate column.

Tom got 539 votes and I got 586. There are only about 120 dues paying NJLP members in Mercer, as far as I know. Tom and I spent barely any money, and we went only to a few community groups meetings, were thrown out of one, the Iles forum held on public property, at the Mercer Community College. We actually were almost *pestered* by some newspapers to contribute information to get essentially free publicity.

I think we should learn a few *positive* things for next time.

I think it might be better to run one Assembly candidate instead of two per district. Running two dilutes the percentage for Libertarians of the total at-large vote count. As future vote totals for libertarians grow it would be better for us for Assembly candidates to wage a five way contest instead of six. I think it's a bit better to run one Senator candidate and one Assembly candidate instead of two Assembly candidates. Better to ask libertarian-ish voters to vote only once for the LP Assembly candidate. Focus on getting one Assembly LP person elected per district. All we need is one or two LP Assembly persons to break through the "wall of silence" in media on policy issues.

Get your "local NJ issues" platform in order far ahead of running a campaign. These issues won't change much from election to election because the Incumbent boobs won't be solving anything. Once you've got a platform set this year, you're ready for next election. Don't stop running for election; keep running for 2003 or whatever.

Don't throw out the solicitations from all those community groups that wanted to poll your positions or wanted you to participate in their forums this past election. Keep them as the basis of your local "press kit" to send chronic updates of your positions on current issues, events, topics. Use this list as the beginning of your press list; add new community groups as you go along.

Use your newly existing platform and flyers to "sell" your "Dutch Uncles" on donating some serious dollars to your campaign for next election. Ask them in person, up front, in private discreet meetings. Get the money early so you can "leverage" the money with the most time to use it.

Scan the current events and issues NOW for your next campaign. ORGANIZE coalitions NOW to get freebie publicity during the next few years before the next election. Each county could have its libertarian "contact person" for the different coalition issues for local press consultations, phone calls and more freebie, chronic press coverage, more name recognition. Form web sites for coalitions NOW as universal gathering places for people who want to help. Ask for coalition help now, and keep it up until next elections. Ask for money now, form non-profit issue corps. Use the money for the coalition issue AND for getting name recognition, media publicity.

This essentially is the "back door" for getting funding & support for independent candidates from people who don't see themselves as strict libertarians. We have to realize that we will rarely be able to get massive amounts of funding in short term burst requests for donations. We need to institute permanent, on-going requests for monetary support, labor support, and freebie publicity support from media. We need to organize now and permanently. We need to construct permanent "social funnels" to attract help and attention to us, even if we must use "Single Issues" to funnel society's support to us generally. We need to recognize how our society works a la Hayek, and use the "spontaneous organizational" behavior of civil society in our favor instead of working against it.

Examples of top current statewide issues: Coalition Against Arena Welfare (CoAW) "Stop Milking the TaxPayer CoAW NOW!"

Coalition Against Taxing Non-Users of Schools (I haven't thought of anything catchy yet. Maybe "Learn No Tax Tolerance for Non-Users.")

Coalition Against Coercion of Auto Insurance (CACAI) "CACAI wants to stop the politicians auto insurance "caca." "

Coalition For Jury Rights. Or Coalition for Fully Informed Justice.

Example of an umbrella group we could organize to push most single issues: Productive Taxpayers Union, or PTU. The non-profit tax status could be vested in one group, possibly the PTU, and it could serve as the funding/organizing conduit for all sorts of "closet libertarian" single issues. Perhaps we should focus the contributions of the few "Dutch Uncles" that we do have for funding the institution and organization of a "Productive Taxpayers Union." (This could be especially useful acronym to counteract the PTAs and PTOs which basically are parents and teacher lobbying unions to suck more money out of non-users of public schools.

Parents who use public schools and their Teachers, Administrators are organized; the opposing common cause interest is NOT organized. Thus public school budgets grow with little effective opposition voice. Obviously, the NJEA and NEA are organized generations in advance of us; we at least need to get a clue that we need to ORGANIZE.)

A web site page for the umbrella group, and separate pages for each "single issue" with factual reference material, policy analysis, past events and future event plans would be very helpful features. Forum email lists would galvanize communications and planning dramatically for the different issues. Libertarian "contacts" should be featured prominently, to start the name recognition process.

A few "well placed calls" to certain talk-radio personalities should be part of a previously planned strategy.

We have to learn how to take existing discontent and magnify it, and to whip it in the direction of our benefit. We have to concentrate a few ripples that disturb the waters of society's surface and focus it into tidal waves.

An exciting book found by Dan Sullivan is called "Organizing For Social Change." The Seven Locks Press publishes it and its ISBN is 0-929765-94-X. It is written by "lefties" so you need to ignore some of their biases but on the whole it is very factual and practical. I'm only part way through it, but it's excellent so far.

We also need to learn about special interest researching which is how you find out about all the "dirt" on the defacto conspiracies to exact political privileges at the expense of equal liberty. Supposedly a person named Saul Alinsky or Aulinsky has written a lot of stuff about this. Digging up the "dirt" on Privilege Seekers and Takers and posting it on web sites for public display is one more way to whip up public discontent and media publicity. Every commentary article should have some libertarian's name as author, preferably someone who is "in the running" for next election cycle.

Please note that all the issues I've mentioned are integrally bound up with both statewide and local organizational and protest activities one can do. Monmouth County libertarians do a nice job of staging occasional protest activities. Integrating "organizational" objectives with "protest demonstrations" builds social funnels to bring new people, new help, new additional attention to our causes and beliefs.

I hope we can use this thread of discussion to add and organize ideas that can be integrated into an organized plan for more efficient, greater return on our efforts. It also could be a way to increase our hopes for actually getting significant, positive returns on our efforts. I know that I'm personally reluctant to heap tons of personal effort into "the cause" if I have little hope, little reason to think our cause will reap any reward. But if we have a practical, productive plan for attacking our adversaries and issues, many others and I will gain confidence and will magnify our efforts and support. We will have a "business plan" to take to our "Dutch Uncles" to get big contributions, if they know they are not pouring their wealth into "poor" plans that will have no positive returns.

A word of "caution". The rough organizational issues plan that I have just outlined is precisely what our opposing Incumbent politicians fear. This is precisely what all their campaign financing legislation is designed to defeat; grass roots organizing that culminates in overturning the political status quo. Previous legislation is not really designed to block special interest lobbying that is already solidly in the pockets of the political establishment.

That is why non-profit, tax-exempt corporations are so strictly regulated to prevent funding of political campaigns, to prevent grass roots efforts to organize, to whip up discontent and funnel it against the status quo. The literature and media press release products of such an organization should probably not ever mention capital "L" libertarianism or NJLP candidates as such. But our enemies have not yet figured how to block plain vanilla grass roots organizing without blocking their own special interest biased non-profit tax-exempt organizations.

Our enemies have simply been very lucky up to now, that most libertarians have wallowed in ignorance about social organizing, about interactions with a "society that doesn't exist" as many libertarians like to prate on about. The jig is up. The spell of our own self imposed blindness is over. The hoax that individualists can't engage in social cooperation is over. Libertarians need to learn social organizing, need to embrace it, need to learn how to cooperate with that "society that doesn't exist" to benefit libertarian causes, to incite libertarian social tidal waves.

We must organize to integrate social dissent in cooperation with the libertarian paradigm. Othewise dissent is muted, confused, diverted, distracted by the false alternatives of the Republican-Democrat dialogue.

Now, for local organizing. David Trend and I have decided to ask you in Mercer to tell us when is the best time to have Mercer County official meetings and informal social get togethers. Instead of Sunday afternoons that interfere with NFL, perhaps Saturday or Friday evenings might be better? Perhaps Saturday or Sunday brunches? We want to settle on one regular day for every month. Call or email David or me. We have "honed down" our normal official meetings to a minimum, for those who haven't visited us in a while.

Is there anyone out there who would volunteer their home or office for regular or occasional meetings? Meeting at private homes frees us up from constraints of public places.

Is anyone interested in a Central Jersey Speakers Forum? Pat Bontempo came up with this idea, and I think it's a winner. Perhaps the members from various Central Jersey Counties could meet at the Happy Apple Inn in Imlaystown to invite Speakers or host mock debates, real debates, panel forums to "roast" sitting politicians or journalists? We could lure them in with promises of a free dinner and booze. How could they resist a chance to mooch off productive libertarians? I live near the Trenton Train station and could pick up speakers from the Main Line and haul them to Imlaystown. Wednesday night is Prime Rib Special night. They have an all you can eat salad bar, a bar with a player piano, authentic Colonial Rustic ambience complete with real pot bellied stoves, post and beam construction, and their own dammed mill race lake to ponder imponderables. Oh yeah, they have a second story upstairs that is nearly always empty, just begging for a Libertarian Invasion.

Give us a jingle will ya? Let us know "you're out there. "Voyage to the Last Unknown Frontier" for Libertarians, the monthly Mercer libertarian meeting. It might be scary at first, or boring, but it can be exciting if we cooperate to plan exciting counter-establishment things to do. 

Comments from Condy Rice that the bombing campaign is not to blame for While certainly the Afghan this are hardly believable. population's economic hardships have existed before the bombing, the exodus from the bombing areas is a logical response to the bombing campaign, unless Rice wants the Afghans to welcome the bombs that sometimes are not too "smart". There hardly has ever been a war where a civilian population was welcoming bombs and thanked the bombing nation. The use of cluster bombs was too similar to another undeclared war that occurred just two years ago. While the deaths of seven millions Afghans from starvation still remains a possibility, the bombing campaign is hardly helping, since the bombing campaign makes the air delivery of food supplies problematic.

The Afghanistan's ruling Taliban regime has certainly no respect for civil liberties, however the same can be said of the US ally, Saudi Arabia and the Northern Alliance which according to some human rights groups is even worse than the Taliban. The Taliban harbors the terrorists, though the same can be said of Saudi Arabia (none of the 9/11 terrorists were Afghans, but most were Saudis) and even the United States, if we are to assume that the network still operates on our home territory. The fact that it was known before 9/11 that the terrorists were on US soil and nothing was done about it, makes the meaning of "harboring" slightly more controversial. Afghanistan wasn't even on a list of nations that sponsor terrorism.

When I wrote that the terrorists must be punished, I did not imply the "collective guilt" to be extended to the entire country. After all, if this undeclared war, according to the President, is about replacing the Taliban regime with a stable government then what does that have to do with catching bin Laden, which according to General Franks isn't one of the missions of Operation Enduring Storm?

There seemingly is no clue about the whereabouts of bin Laden, so one would think that the letters of marque and reprisal could be a useful tool in bringing the terrorists to justice. Unfortunately, the mission has gone from the talk of "smoking the terrorists out" to "smoking the Taliban out". The humanitarian crisis Afghanistan and the ensuing "collateral damage" are the negative consequences of this undeclared war, which has bred nothing but anger from the Afghans themselves. Even if the Taliban is toppled. the WH seems to indicate that the US will participate in nation-building which in a country like Afghanistan brings to mind the Somalian debacle, despite the previous assurances from Secretary Rumsfeld that nation-building was not on the agenda.

For the sake of the rule of law, if this government plans to continue the campaign, Congress must declare war against Afghanistan. It is strange that the Administration's comments about the necessity of the bombing as a measure of preventing bin Laden from escaping was meant for the public, since it was already reported that we don't know where bin Laden is. Nor does it seem like the Taliban is preventing US forces from finding bin Laden. And yet, the Administration has decided to stamp the sign of "collective guilt" on the map of Afghanistan. The initiation of force came from the terrorists not the Taliban government and its civilian population, and if this government does not differentiate that, than why would anyone even ask the terrorists to differentiate between the American government and its people?
