Free State Project What is the Project About?

The Free State Project is a plan in which 20,000 or more liberty-oriented people will move to the state of New Hampshire and work within its political system to reduce the size and scope of government.

The Project will reduce burdensome taxation and regulation; reform state and local laws; opt out of federal mandates; and press for the restoration of constitutional federalism.

The Free State Project will show the world what liberty can accomplish!

Free State Project Liberty in Our Lifetime

We don't want to wait decades for most citizens in the US to realize that the nanny state is an insult to their dignity. For those of us who already understand the debilitating effects of a government bent on reducing liberty rather than increasing it, the Free State Project aims at liberty in a single state.

What do we mean by liberty? We believe that being free and independent is a great way to live, and that government's maximum role should be to help individuals defend themselves from force and fraud.

Free State Project Where & Why?

The state where we will move was decided by a vote of the FSP membership after we reached 5,000 commitments. Population was the critical factor. NJLP Steering Committee Meeting Minutes

(DRAFT)

State Chair Suspended, General Meeting Called

254 Tennent Rd., Morganville

April 17, 2005

Prior to the SC meeting the Secretary validated the Steering Committee At-large petition of Robert Hull. Mr. Hull's petition contained 42 signatures, 40 of which were valid. Victor Kaplan presented a single petition nominating three individuals containing 29 signatures, 28 of which were valid, one being invalid because the signatory had subsequently signed Mr. Hull's petition. The petition submitted by Mr. Kaplan was rejected as invalid, by the Secretary, pursuant to the By Laws 4.d.7., which states that "No member may sign more than one such petition at one time...."

Call To Order: 1:42 pm. Quorum Count: Attending: Emerson Ellett, Lou Stefanelli, Liz Macron, Ginny Flynn, Len Flynn, Bob Hull. Absent: Brian Phillips, Tom Abrams, Bill Goerke. Six present constitutes a quorum.

In the absence of the Chair and Vice Chair, the Secretary, Mr. Ellett, conducted the meeting. Mrs. Flynn was asked to record the minutes.

Approval of Agenda:

As a Point of Information Mr. Stefanelli informed the meeting that at his recent meeting with ELEC, he learned that candidates are not permitted to be members of Continuing Political Committees, such as the NJLP State Fund. He confirmed that he has therefore withdrawn as an Assembly candidate and recommended that other Officers who are also candidates do the same.

Mr. Flynn added to the Agenda item 8e State Fund Business. Mr. Ellett added item 9 Member Recognition. The Agenda was approved with these two additions.

Minutes of the NJLP Convention were accepted as presented. Minutes of the State Board meeting immediately following the close of the Business Session of the Convention were accepted.

Treasurer's Report: (Attached)

Mr. Stefanelli reported that the NJLP was solvent. The NJLP Convention broke even. So far this year \$3,355 in new contributions has been raised for the State Fund.

Mr. Stefanelli then reviewed the problems the NJLP has been having with National LP. Briefly, in September, 2004 National began using a new data base. Since that time, Mr. Hull has been unable to extract reliable (if any) information from the "dumps" of information sent monthly from National—dumps containing as many as 6500 entries. In the past he received weekly updates of new National members who lived in NJ and also acknowledgment of the list of National members he sent them with a check for dues. Payment for recent memberships has been delayed for this reason. Mr. Stefanelli reported that the amount of money involved is about \$400. Also, Mr. Stefanelli reported that National has not cashed the dues checks Mr. Hull sent in August and November 2004. Other state affiliates have experienced similar problems. At present, Chris Weimann and Jay Boucher have been working with the data and are hopeful they will be able to extract useful information soon. Mr. Ellett noted that our LNC Rep, Dan Karlan, had been asked to bring these problems to National's attention. Mr. Karlan mentioned that Georgia and Michigan have overcome their difficulties with the data. Chris Weimann pointed out that Georgia and Michigan are both UMP states so their methods may not work for NJ.

Unfinished Business:

Dues issue:

In light of the previous discussion regarding the National dues, and specifically because our web volunteers believe they will be able to read the data in the near future, Mr. Flynn made the following motion:

Resolved, that the NJLP remit the members' portion of dues to the National LP due as of the March membership report.

Discussion on the motion considered whether or not the NJLP should resume regular payments to National. It was determined that such a conclusion was premature and that the Committee had the responsibility to monitor National's progress in accurately crediting our members' dues payments. If significant progress is not discerned, the Committee will consider other options, such as ceasing the collection of National Dues, and a ByLaw change to decouple the NJLP membership with that of the National Party.

The motion passed unanimously. (6-0)

CAPP Lawsuit:

Ms. Macron reported that she, Mr. Flynn and representatives of the Green and Conservative Parties met in New York City at an attorney's office. The attorneys arguing the lawsuit regarding NJ Election Law reform are requesting a retainer and fees of about \$3000 from each party. The Green and Conservative Parties indicated they would be able to meet this figure. The retainer request has not yet been received but should be sent to Mr. Flynn imminently. Ms. Macron suggested that this can be discussed at our next meeting. The NJLP has enough funds to meet this expense, but a special mailing to the membership asking for donations to offset this expense might be advisable.

Committee Reports:

Candidate Support Committee

Darren Young has resigned his position as Chair. Mr. Flynn reported that he has been assisting this effort by providing phone scripts for recruiting new candidates.

Platform Committee

Ms. Macron reported that the work of this committee is ongoing. Their next meeting is scheduled for 1 pm, April 29, 2005 at Tony Federici's home.

New Business:

Ms. Macron introduced the following motion:

Resolved, that the Steering Committee suspend the authority of the Chair pursuant to New Jersey Non-Profit Corporation Act (NJSA 15A : 6-16a).

Discussion followed. Ms. Macron reported that the statute provides that any officer elected by members may only be removed by a vote of the members, but the board does have the right to suspend an officer's authority to act as an officer, for cause. She provided a list of 13 examples of cause. (Copy attached). This means the Chair will still be a member of the Steering Committee and will retain the title of Chair, but will be unable to exercise any of the duties of Chair as outlined in the Bylaws, Section 6, Officers, part a. Also, all powers cited in Title 15 will be removed.

Various recent actions by the current Chair were enumerated by members of the Steering Committee. An NJLP member who was in attendance stated that he had phoned the Chair to discuss the upcoming campaign website and the problems with National LP. When the member questioned certain statements, the Chair hung up on him.

The motion passed unanimously (6-0).

Mr. Flynn introduced the following motion:

Resolved, that the Treasurer be directed to send a letter to Michael Dixon, National LP Chair, enclosing the dues payment and asking Mr. Dixon to address data base deficiencies.

Dan Karlan offered a friendly amendment to include that copies of the letter be sent our regional LNC Rep (himself) and LNC alternate (Mark Cenci). Mr. Flynn accepted it.

Final motion: Resolved, that the Treasurer be directed to send a letter to Michael Dixon, National LP Chair, with copies to our Regional LNC Representative and Alternate, enclosing the dues payment and asking Mr. Dixon to address data base deficiencies.

The motion passed unanimously. (6-0)

There was a call for a Special General Membership Meeting on Sunday, May 15, 2005 at 1 pm to consider removal of the Chair from office according to NJLP Bylaws Section 4,a, part 4. The meeting place will be the Morganville First Aid Squad building at 273 Tennent Rd., Morganville.

This passed unanimously. (6-0)

Ms. Macron made the following motion:

Resolved, that a Special Mailing be authorized to all party members, at no expense to the NJLP, for the purpose of explaining our actions with respect to Mr. Brian Phillips, NJLP Chair, and to describe the problems we have encountered with the National LP's data base.

Passed unanimously. (6-0)

State Fund discussion:

NJ ELEC rules state that candidates may not sit on continuing political committees. The NJLP State Fund is such a committee. Mr. Flynn proposed a new Business Rule:

When State Fund business is addressed at State Fund NJLP meetings members who are candidates shall be excluded from the discussion.

Mr. Stefanelli said he was not sure that this would solve the problem. The proposal failed.

A motion was made to send Mr. Flynn's proposed new Business Rule to the Bylaws Committee.

The motion passed.

Member Recognition:

Mr. Ellett recognized Jay Edgar for coordinating our State Convention. It well attended, informative and fun. A great job! Mr. Edgar was also recognized for his 2004 Congressional race.

**MOTION TO SUSPEND AUTHORITY OF THE CHAIR PURSUANT TO
NEW JERSEY NON-PROFIT CORPORATION ACT (NJSA 15A : 6-16a)**

THE STATUTE PROVIDES THAT ANY OFFICER ELECTED BY MEMBERS MAY ONLY BE REMOVED BY A VOTE OF THE MEMBERS , BUT THE BOARD DOES HAVE THE RIGHT TO SUSPEND AN OFFICER'S AUTHORITY TO ACT AS AN OFFICER FOR CAUSE

MOTION TO SUSPEND THE CHAIR'S AUTHORITY IS FOR CAUSE AS ILLUSTRATED BY THE FOLLOWING :

1. Making public statements about potential improprieties in NJLP business operations without any facts or foundation.
2. Claiming the existence of a special investigative committee appointed without advice or consent of the Steering Committee.
3. Insulting and alienating loyal members who have contributed countless hours and thousands of dollars to the NJLP, in violation of Strategy 19 and 20 of the Strategic Plan.
4. Presuming illegality and malice on the part of former party officials, in violation of Strategy 19 and 20 of the Strategic Plan.
5. Overt hostility to the Newsletter Editor.
6. Making threats to expend party monies in excess of his authority if his will is not obeyed.
7. Commanding the party's listmaster to make changes in the nature and operation of the party's email contact lists that would violate the party's ByLaws.
8. Making false statements in communications to members of the party.
9. Attempting to silence debate and discussion among members of the Steering Committee and the membership, at large.
10. Demanding personal loyalty and inflicting retribution where it was not forthcoming.
11. Attempting to close the Steering Committee meeting without the consent of the Steering Committee.
12. Attempting to move the location of the Steering Committee meeting to his own home on one day's notice, in violation of the notice requirements of the ByLaws and without the consent of Committee members.
13. Impugning the reputations of the NJLP leadership and casting a cloud of suspicion over the state LP, at a time when we are attempting to recruit a full slate of assembly candidates and raise funds to support them.

From the Editor

Like many NJLP members, I have been anxiously following the internal party controversy involving Brian Phillips, Suspended State Chair, on forums such as liberty-talk@wallnet.com, and www.jerseypolitics.org.

Initially, I had planned for this issue of the New Jersey Libertarian to include some items related to the situation, written by several NJLP members in addition to Mr. Phillips. However, it has been pointed out to me that some of these items, although publicly released on varying internet forums, still constitute libel, and that reproduction in the newsletter would expose the NJL to the same legal action that may apply to the original writers.

I have therefore decided that, at least for the time being, only official party records regarding this unfortunate situation will be included in the New Jersey Libertarian. Meeting minutes, motions, resolutions, etc., are the responsibility of the NJL to communicate to NJLP members. Any items not included in the scope of the NJL's responsibility will have to go unpublished in the newsletter. - *Deb Sackett*
