Bylaws Change to be Considered at General Meeting

At the May 18, 2003 meeting of the State Board, a motion was proposed and passed regarding a change to the Bylaws.

The motion was made to place on the agenda for the July General meeting the following bylaws amendment:

4. a. Membership is open to anyone who lives or works in the state of New Jersey who certifies in writing that he or she opposes the initiation of force as a means of achieving political or social goals. Thereafter, such a person shall become a member upon payment of dues to the NJLP or to the National Libertarian Party, or upon declaration of party affiliation as 'Libertarian' as provided by law.

Discussion: The proposed change alters the last sentence of section 4.a. which currently reads: "Thereafter, such a person shall become a member upon payment of dues to the NJLP or to the National Libertarian Party." The change would extend membership to those people who choose to affiliate (register) as Libertarian without the payment of dues. The purpose of this amendment is to include those people as members who might not otherwise join because of fiscal reasons.

Libertarian activist Bill Schetlick saved taxpayers in the New Jersey town of Flemington several million dollars -- and all it took was two telephone calls.

Town voters rejected a school bond issue that would have added "several additional millions of dollars in debt" to the town budget. The vote against the bond issue was 1,304 to 1,302.

That two-vote difference was thanks to Schetlick, who had decided to do a little telephone lobbying on April 15 — the day of the vote.

"I telephoned two retired folks who generally go to the polls to vote on such matters," said Schetlick. "When I got through to them, they told me that their car was in the shop and that they would not get to the polls that day.

"I offered to drive them myself, opining that every vote would surely count in this matter. They agreed, and I drove them to and from the polls. They voted. Nice folks."

The next day, Schetlick read the news that the bond issue had failed by -- yes -- exactly two votes.

"Funny how that stuff happens sometimes," he said. "I'm feeling pretty good."

Schetlick said he decided to make the phone calls because "typically, fewer than 20% of the total registered voters in the town show up to vote in these plebiscites; therefore, each vote carries added significance.

"Boy, it was really true this time..."

The bond issue, had it passed, would have raised "several additional millions of dollars in debt, concurrently increasing our property taxes, to build some new and additional facilities for the local public high schools," said Schetlick.

"The local educrats, teachers, administrators, and construction unions -- those that stood to directly gain if the bond issue was passed -- were all in favor."

Unfortunately, said Schetlick, the bond issue may not stay defeated: The same issue will be on the ballot again in September.

"I'll have to go out again and start all over," he said. "Count on it."

Schetlick, 51, is a retired lawyer and longtime Libertarian Party activist. He joined the party "circa 1973-74," and served as New Jersey LP State Chair in 1974-1975. He also ran for State Assembly in 1976.

Now, he said, he spends "a great deal of time and effort attempting to influence and hopefully redefine the parameters of the political debate in the N.J. media. And to a more or less degree, they are listening."

Schetlick has also recently started attending Flemington town meetings -- and he is now known as "that Libertarian guy who's always smiling, politely disagreeing, and otherwise making trouble," he said.

"So be it. You only live once."

Jury Sides with Gun Industry

NEW YORK (May 15) - A federal jury has determined that 45 gun manufacturers and distributors shouldn't be held liable in a lawsuit brought by the NAACP alleging their products fuel street violence that victimizes minorities.

The jury deliberated for five days before reaching its verdict Wednesday in the closely watched case, which now goes to the judge for a final decision. The panel was unable to reach a verdict regarding 23 other defendants.

Chris Cox, chief lobbyist for the National Rifle Association, called the ruling "common sense" and said the lawsuit was "aimed at bankrupting a lawabiding American industry by holding them liable for the actions of criminals."

The verdict followed more than five weeks of testimony in the National Association for the Advancement of Colored People's lawsuit against 68 defendants, including Smith & Wesson Corp., Glock Inc. and other major gun makers and distributors.

The defendants argued it was unfair and unlawful to hold them liable for the criminal use of a legal product. They also said legislatures - not courts - should set standards for gun sales.

`The jury understood that these law-abiding companies had done absolutely nothing to cause a public nuisance," said Lawrence Keane, general counsel of the National Shooting Sports Foundation.

NAACP attorney Elisa Barnes said the verdict showed the case was too complicated for a jury to decide. The judge could still rule in favor of the NAACP based on ``the facts and the record," she said.

The lawsuit alleged the firearms industry knew corrupt dealers were supplying guns to criminals in minority communities and did nothing to stop the practice. Rather than monetary damages, the NAACP sought injunctions that would place sweeping restrictions on buyers and sellers of handguns.

The plaintiffs built much of their case on previously sealed data - provided by the Bureau of Alcohol, Tobacco and Firearms under court order - detailing sales histories of weapons recovered at crime scenes in New York state from 1996 to 2000.

An expert witness for the NAACP testified that an analysis found 11 percent of handguns sold in 1996 were used in rapes, robberies, assaults and murders by 2000.

The defendants knew they were feeding a pool of illegal handguns and "purposely turned their head away from the problem," Barnes told the jury. "They said, "It's not our worry."

Defense experts claimed the analysis was flawed. They said their own studies found that most guns used by criminals come from a secondary market of used or stolen guns.

``Nobody wants to have someone selling to criminals," James Dorr, attorney for Sturm, Ruger & Co., said during closing arguments. ``This industry certainly doesn't."

Since 1998, more than two dozen cities, counties and states have sued gun makers, many claiming the manufacturers allowed weapons to reach criminals because of irresponsible marketing.

Many suits have been dismissed or dropped, but Congress is considering legislation backed by the White House and the NRA to protect gun makers and sellers from lawsuits arising from the criminal or unlawful use of their products.

If everyone nominated this year gets on the ballot we'll field thirteen state legislative candidates, one freeholder candidate (Len Flynn, Monmouth County) and one local candidate (John Taylor, Highlands Borough Council).

Bob Hull is certainly doing his part to get the Libertarian Party name in front of the voters. Not only is he running for Assembly himself, but at his own expense he is mailing petitions to members in the districts where we have candidates. If everyone who receives a petition gets signatures and returns it to Bob properly notarized we'll have no problem at all in getting on the ballot. Unfortunately people sometimes forget to take action. Last year, for example, a candidate missed the ballot by a tiny number of signatures because his fellow Libertarians failed to respond to the petition-by-mail campaign. Now don't forget, y'all!

Election 2004 and federal campaigns are coming up fast, so it's worth mentioning that candidate support is available not only from the NJLP but from national as well. National has sent a campaign packet to each of our candidates this year. "Libertarian Political Action" is a 40-page compendium of techniques for effective campaigning. It covers everything from preparing to run, petitioning, organizing the campaign team and reaching the voter. Other National materials include an 18-page booklet on current issues, and information on raising money, campaign activities and outreach materials for sale. We assist candidates financially via our State Fund, and later this year we'll be asking for your help to fill the coffers. (We have a Federal Fund for U.S. House and Senate candidates as well.)

How many of you got a tax refund from your rich Uncle in DC? Want to spend it on freedom? Several companies have campaign management software that will enable us to run professional campaigns. But unless you'll be using the software yourself I recommend you make your gift contingent upon someone volunteering to use it. So go for it! Your offer could be just the thing to ignite someone's enthusiasm, maybe even your own!

Chris Wuestefeld is doing a great job in Hunterdon County fighting the Delaware Valley school board which plans another referendum on a \$30 million proposal identical to the one rejected by voters in March. Chris helped write a 36-page "Minority Report," which he said the school board did not seriously consider. The board vote rejecting it was predetermined. "Had it been anything more than a staged event, there should have been some discussion among them," he was quoted as saying in the April 30 *Express Times*.

We have a ton of members to be proud of. Bob Heitner is cheerfully fielding questions from people who call our 800 number. Rob Tannen has offered to host a welcome party for new members. Andrea Nalodny with an assist from Vic Kaplan has developed a Libertarian Student Organization flyer for college students; for a master copy contact Andrea at cyrelia@clubaa.com. County chairs and candidates need on-line access to members in their area? They'll have it, thanks to Jay Boucher's programming skills. Elizabeth Macron has added Mary Ruwart to the speaker's roster for our Convention next March. The indefatigable Bill Schetlick is busy educating pundits and politicians about the principled application of rights to societal problems. Bill was quoted in Paul Mulshine's May 1 column as saying "politicians have no idea of what rights are anymore," a truism to libertarians but apparently news to Star-Ledger readers. Good going, guys!

But the assault on freedom continues. A2587, a bill to raise the NJ smoking age to 21, is just one of the anti-youth rights bills introduced in the NJ Legislature. Assemblyman Cryan, the co-sponsor of A2587, also introduced A1611, a bill to prohibit the sale or purchase of pesticides by minors. Wanted – someone else we can be proud of, someone who can lend a hand in opposing such legislation.

The Strategic Plan and the New Jersey Libertarian Party

This month's strategy is at the center of a controversy, and I hereby invite NJLP members to participate in the discussion swirling around it. The strategy – # 14: Develop and implement an internal program of ideological education – was formally removed from the National Strategic Plan at the LNC's most recent meeting. There was no prior indication that such a move was to be proposed, and several SPT members on the LNC voted against the motion (including our Regional Representative). With this month's column, I hope to open the discussion that appears to have been lacking at the national level.

When SPT members were polled on their views on the Libertarian Party's strengths, the overwhelming favorite was "Core Philosophy." But there is some concern that new recruits to the party over the years, unaware of this integrating core philosophy, have attempted to 'dilute' our message, either for political or other reasons. It was the recognition that we cannot afford to risk diluting the fundamental strength of the Party that impelled me, and most other SPT members, to incorporate Strategy 14.

But the possible tactics listed constitute a much smaller list than for most of the other strategies, and appear on the face to presume a degree of unfamiliarity with our ides that might be perceived as elitist – veterans contrasted with rookies. To the extent the strategy comes across as perpetuating or imposing a division between those within the party who 'really' understand the philosophy and the innocent newcomers, we can quickly turn away people, rather than growing. The "hard core" versus the "pragmatist" faction also is embodied in this Strategy and the recent controversy.

So several nagging questions remained. The wording of this Strategy was a compromise, but there have been no attempts to improve the language. Is the proposed strategy really the best way to sustain the core philosophy? Would an alternate wording make it clearer what the Strategic Planning Team was trying to express? And at the state and local levels, how might this strategy, assuming some kernel of the idea is worthwhile, be promoted?

Thoughts, people?

Strategy 14: Develop and Implement an Internal Program of Ideological Education

SPT recommends that the national LP develop a formal program of internal education for the LP support base. The support of the LNC, state, and local LP organizations is critical in delivering this program to the LP's support base.

SPT's desire to welcome anyone in the "libertarian quadrant" into the LP carries with it a need to make sure that those drawn to the LP understand and identify with our ideas as fully as possible. SPT believes that exposing new LP supporters who are somewhere in the "libertarian quadrant" to a variety of libertarian ideas will – over time – lead individuals to hold beliefs more fully consistent with our ideology.

Possible Tactics:

- Educate members about core libertarian ideas
- Educate members about the application of core libertarian ideas to practical policies
- Keep core documents in view of the LP support base

As the national LP – and, it is hoped, its affiliates – implements plans to welcome warmly individuals whose political views fall within the "Libertarian quadrant," SPT urges affiliated state and local parties to join the national LP in adopting internal programs to provide ideological education to these newcomers.



Hunterdon, Del Val court voters again

ALEXANDRIA TWP. -- Delaware Valley Regional High School officials will ask voters again to approve a \$9.8 million renovation and expansion project defeated in a December referendum.

Voters in Delaware Valley's five sending school districts will go to the polls Sept. 30 at the same time as voters in the Hunterdon Central Regional High School District. School officials there are reworking a \$30 million bond proposal voters shot down in March.

Both districts have been embroiled in a contentious debate over what the high schools need to cope with enrollments that are projected to grow in coming years.

Delaware Valley Regional school board members, at a meeting Monday, addressed the concerns of an opposition group contained in a 36-page document dubbed "The Minority Report."

School board President Bill Martin said the board found no compelling arguments against the construction project it had proposed in March. Although the proposal was defeated with a 2,009-1,856 vote, the board voted Tuesday to make an identical proposal in September.

Martin said making no changes ensures that the district will receive the same promise of a \$3 million grant under New Jersey's Educational Facilities Financing Act.

"If we modified the program at all, we would have to reapply to the state (for the grant) and there's no guarantee that we would get anything," Martin said.

But a chief opponent of the proposal said the school board did not seriously consider the findings in "The Minority Report" and that Tuesday's vote had a predetermined outcome.

"Had it been anything more than a staged event, there should have been some discussion among them," said Chris Wuestfeld of Alexandria Township, who signed the report.

Wuestfeld was one of 40 members of district facilities expansion committee that met during the summer of 2002 to develop a proposal for the last referendum. The committee's proposal was drastically scaled back from a \$24 million plan defeated in March 2002 and a \$26 million plan rejected in December 2001.

Wuestfeld, Holland Township resident Tom Ganley and four other members of the "minority" objected to the inclusion of plans to expand the school's kitchens, add new art, science and foods rooms, create a large media center and add eight general purpose classrooms.

At the meeting Tuesday, Martin and other school board members said all of those items are required to serve a student body that exceeds the school's capacity according to state education department standards and is projected to keep growing.

Delaware Valley currently enrolls about 750 students from Alexandria, Holland and Kingwood townships and Frenchtown and Milford. The enrollment is projected to grow to 860 by September.

"The fact of the mater is that every room is being used at or above capacity," Martin said.

Wuestfeld called the board's response to the report a "fig leaf" to cover its accountability to the public as it proceeds with the fourth referendum.

"If they didn't say anything and just went out for a fourth vote that would put them in a very bad position," he said.

Wuestfeld said that he and other opponents of the expansion plan to campaign against it again as the election day approaches. Martin said the school board will use a number of methods to educate voters on the need for the expansion project.

"We're most certainly going to try to convince them," Martin said.

Hunterdon Central officials announced Tuesday that they will also hold another referendum in September but how the proposal will differ from the one defeated March 11 is unclear, school board Vice President Joan Wolsiefer said.

The \$30 million plan relied on a \$10.5 million state grant and \$3 million from the sale of a building to Hunterdon County Polytech to offset the cost to taxpayers.

Still voters rejected the proposal's \$16.5 million local share, and district officials suspect a plan to build a new auditorium was one of the main reasons. The new plan will likely call for the renovation of the existing auditorium, but the district still needs more classroom space, Wolsiefer said.

The district enrolls about 2,700 students from Delaware, East Amwell, Raritan and Readington townships and Flemington. Hunterdon Central's enrollment is projected to grow to 3,000 by 2007, Wolsiefer said.


