GOODSON for GOVERNOR!

John A. Goodson of New Brunswick was unanimously voted the gubernatorial nominee at the first state convention of the NJLP. Goodson is 38 years old, a high school guidance counselor, and member of the state and national parties. Ralph Fucetola III and Philip DeBlock were nominated unanimously for Assembly seats in Essex and Hudson counties, respectively, while Oscar Johannsen was endorsed as an independent candidate for the state senate.

Approximately 25 attendees heard party chairman Robert Steiner deliver the opening remarks, in which he warned against nominating candidates who were not Libertarians, as this would compromise the principles of the party and negate our reason for existence.

A platform was adopted, consisting of the statement of principles drawn up by the national party.

Dr. Murray Rothbard delivered a talk after lunch, in which he outlined the general drift of Nixon's second term. Prof. Rothbard expressed optimism that a shift to the right in public opinion would slow collectivism, and said he was encouraged by the spread of libertarian ideas.

In other business, party officers were elected for one year terms as follows: Chairman-Robert Steiner, Vice-Chairman-Joe Salerno, Treasurer-Don Meinshausen, Recording Secretary-Elizabeth Butler, Executive Secretary-Lydia Longinotti. Grace Shamy, Jerry Bernsohn, and Ralph Fucetola III were elected as party trustees for 1, 2, and 3 year terms respectively.

The main concern for the party over the next month or two must be getting our candidates on the ballot, which increases vote total an estimated 10 times over a write-in effort. 800 signatures for John Goodson are required to be delivered to Trenton by April 24th, which means they should be collected by the party before April 16th to allow time to get them notarized. We have only a limited number of petition forms, so if you're really serious about rounding up names, contact the party at its address, or call Lydia Longinotti at 775-2877, and we'll arrange to get the forms to you for a period of time. Then beg, plead, implore, cajole, but get those signatures-collecting names is a drag, but if we are to have any impact at all, we must get on the ballot. And while you're petitioning, be on the lookout for new members.

The next general meeting of the party will be on March 24th at 1:30 p.m., at 301 Joan St., South Plainfield. Purpose of the meeting will be to complete formulation of by-laws (approved thus far through (5), plus (6)b.4)) and the creation of campaign committees. Progress of the petition efforts will also be a major topic of discussion, and party members who have not signed a petition can do so at the meeting.

RIPON SOCIETY GETS NEW PRESIDENT

PREMISE has taken an "unlibertarian" position in its article "Cruel Punishment?" in the February issue.

The libertarian theory of justice is that after an act of aggression, the victim must be made whole again. This holds whether the act was not intended (auto accident) or was intended (assault). The sole purpose of a system of justice is to put victims, as nearly as possible, in the same position they would have been had their rights not been violated. To do this, the victim and his agents have the right to use only as much force as may be absolutely necessary to reestablish the victim's rights. No one has the right to inflict "punishment". There is no such thing as jail or "criminal" law in libertarian theory, which is not to say that the freedom of a wrongdoer may not be restricted while he recompenses the victim -- but only if necessary and insofar as necessary.

Your article did not use the libertarian theory of justice as its premise. Had it done so, your conclusions would have been opposite to the conclusions printed. Reasons; MOST PRISONERS HAVE DONE NO WRONG-- they have not committed acts of aggression against the person or property of another and are themselves the victims of the state's aggressive laws: ALL PRISONERS ARE BEING "PUNISHED" as opposed to being required to recompense victims; and lastly, we as libertarians should support any rule which puts the "onus" on the state to prove it has the "right" to keep any person in its cages. As far as the "you can murder anyone you like" argument, the best defense against potential murderers is NOT to depend on the state to "protect" you, especially by "punishing" your murderer after you are dead!
