To the Editor:

I read a copy of the "Brick Town Reporter" article on Libertarianism, reprinted in the September <u>PREMISE</u> with great interest: small town papers often best reflect the public's misconceptions. The article misconstrues our position on monopolies and, as usual, confuses Libertarianism with Ayn Rand's libertarian philosophy of Objectivism (or as Kathy calls it, 'Randian Collectivism').

The primary area in which I think we fail to make our strongest case is in the area of economic monopoly. It is not enough to suggest that the market works and that all the bad monopolies (like AT&T and the Post Office) are either specifically ordained by the state or belong to it. We must bring the recent discoveries of the Revisionist historical school to the public attention. The Revisionists have shown that 1) every successful monopoly/oligopoly came about through government intervention; 2) every government intervention was either initiated or given its final push by big business monopolist interests; and 3) the free competitive market of necessity leads to decentralization of economic power and more equality of economic circumstances. Thus, the modern 'liberal' goal of greater economic equality can only occur in a true free market, which is the same system that does not force equality. Positions (1) and (2) above are in direct contradiction to Rand's essay on "Big Business-America's Most Persecuted Minority".

Thus the writings of Spooner and Tucker, wherein they blame big business for the bloated state and call for an end to the monopolies as the only road to freedom and greater equality (not to mention the works of the world's greatest Libertarian Theorist, Murray Rothbard), should be given at least equal emphasis as the writings of popularizers such as Rand and Tuccille.

This is all to point out that one of our chief goals as a Libertarian association should be to gain better knowledge of our libertarian heritage and the recent advances by historians which prove it correct, rather than to stagnate in the limited knowledge of political games and parties and such. I

hope that after the election we may continue with the job of internal as well as external education.

- Since Mr. Fucetola's letter is almost totally inaccurate, one hardly knows where to begin.

If Mr. Fucetola had not failed to goet the required number of signatures to make the ballot, he might have been subjected to the edifying experience of the newspaper interview. The Revisionist historians were stressed during the interview, but what came through in the story was the reporter's own opinion. If Mr. Fucetola can suggest some way in which we can "control" what the newspapers print, we'd be interested in hearing it.

Also, the article in no way confuses Libertarianism with Objectivism (which is never even mentioned), but merely states that "many" of our positions "derive.. from the work of...Ayn Rand", which is certainly true. It is a fact that both of our party's major figures were closely associated with Miss Rand, and that almost every person at the NJLP organizing meeting said they came to libertarianism through Ayn Rand.

To continue, Mr. Fucetola wrongly pictures the Revisionist school as monolithic, and the conclusions he ascribes to that school are either untrue or not representative. Specifically, with regard to (1), there are many monopolies which have not needed government coercion; for example, the National Football League, Hewlett Packard's scientific pocket calculator (which no one has duplicated for several years now) and the Polaroid camera (unless protection of intellectual property through patents constitutes government coercion). Anyone who reads the sports pages knows (2) is incorrect, since Congress recently passed a law forcing the NFL-to-broadcast home games against the wishes of the NFL. The third conclusion is in no way ascribable to the Revisionists, most of whom are Socialists or leftists who do not deplore controls, but only contend that they have been misused in favor of big business, rather than "the people".

Mr. Fucetola's comments on Ayn Rand's essay can only mean he hasn't read it. The essay emphasizes that businessmen are unjustly persecuted (which Mr. Fucetola's letter proves), and even says that "another kind of businessmen...made fortunes by means of special privileges granted to them by the government". It is irrational to believe that all, or even most, successful businesses got that way through government intervention, rather than productivity.

Finally, Mr. Fucetola derides "political games" and wants us to go back to talking to ourselves, to continue our "internal education". We certainly hope he takes his own advice.

Goodson on porn and public schools

ASBURY PARK — John A. Goodson, the New Jersey Libertarian Party's candidate for governor, recently outlined — in no uncertain terms — his views on two disparate but equally controversial issues.

On the financing of public schools, Goodson had this to say:

"It is certainly clear that our state educational system provides an apallingly low level of learning and that our public schools have become cesspools of crime, drugaddiction and violence. All this is the inevitable result of state control.

"Instead of wondering how we can raise the money to continue this Frankenstein. we should be pondering whether to continue it at all. The question 'Should we have complusory, tax-supported schools?' really means 'Should the state be permitted to confiscate the taxpayers' money, use it to remove children from their homes, with or without the consent of their parents, and subject them to training and indoctrination of which the parent may or may not approve?'. To anyone with a shred of regard for individual rights, the answer is a thundering NO!

"We should not be searching for new ways to shore up the state's sagging education empire. We've got to concentrate on getting the state out of the schoolroom. Period. The constitution should be changed so that the state will no longer guarantee to each child a 'quality education'. We can then not only eliminate all talk of an income tax, but repeal the sales tax as well.

"The free market will provide the best possible instruction, and burning issues like busing, prayer and sex-education will dissolve when people can freely select the schools they wish to support."

And on the issue of pornography, Goodson made these remarks:

"H. L. Mencken defined a guardian of the public morals as a person who wakes up at midnight with the cold fear that someone, somewhere is happy. It is not pornography that is the crime, it is censorship.

"If a panel of judges can watch a movie to determine its value, then why not ordinary citizens? No adult is sufficiently godlike to tell another adult what to read or see, least of all the incompetents who infest Trenton. The state does not have the right to tell us what we may or may not look at, any more than they have the right to prescribe our eating habits. Imagine the Supreme Court attempting to determine whether bubble-gum has socially redeeming value. The same attempt with printed matter is no less absurd.

"It is proper that parents should control what their children read and see, but it is not proper that the state should take over that control when we grow up. Haven't we had enough paternalism during our youth? Must we be treated like 10 year-olds by the very same people who delight in covering our eyes with one hand, while raping our wallets with the other?

"The only proper function of government is to defend people against violent invasion of their person or property, not to enforce anybody's idea of personal morality. All antipornography laws must be repealed!"

Candidate refuses offer of TV time

TRENTON — The pubernatorial candidate of New Jersey's newest political party not only plans to keep ins campaign promises, but will sign a contract to that effect.


