# **INSTRUCTIONS:**

- 1. Read Petition carefully and fill in all blank spaces where required.
- 2. Petitioners must sign in their own handwriting matching the signature in the voter registry records. They must provide their correct residence or post office address in the presence of the Affiant/Circulator. The circulator/witness must sign the inside of the petition and check the line number where his/her signature appears.
- 3. For local elections, the Mayor must file a separate petition from Council.
- 4. For a joint petition, place the names in the order the way they are to appear on the ballot.
- 5. The person in whose presence the Petition was signed MUST be one of the signers of the petition and make an affidavit as Affiant before a notary or other officer authorized by law to take affidavits.
- 6. The Candidate(s) must sign the Certificate of Acceptance stating that he/she/they is/are qualified for the office in the Petition. Candidate must be a registered voter and resident of Burlington County 1 year prior to the date of the next General Election. (Chapter 94 Laws of 1980)
- 7. The Petition must be signed by legally qualified voters of the State of N.J. residing in the County of Burlington if the Petition is for County Office and/or residing in the Municipality if the petition is for Municipal Office. The Petition must be signed by at least 2% of the legally qualified voters of the votes cast for Members of the General Assembly at the last preceding General Election for which nominations for the General Assembly were made in the County in the case of County Officers or in the Municipality in the case of Municipal Officers provided that no more than 100 signers are required in any case. (N.J.S.A. 19:13-5).
